George Soros, John D. Rockefeller IV, and the Koch brothers are funding an Iranian influence operation that tipped off the New York Times about the attack on Quds commander Qassem Soleimani

In a New York Times article that was published hours before the American bombing of Iranian Quds Force commander Qassem Soleimani, Quincy Institute analyst Steven Simon posits this scenario:¹

> What if the former commander of Iran's Revolutionary Guards, Qassem Soleimani, visits Baghdad for a meeting and you know the address?

Given that Soleimani was not the subject of the article, observers have noted that this looks like a lastminute attempt to leak information about the airstrike to the Iranians. Let us take a closer look at Simon's organization, the Quincy Institute.

The Quincy Institute was only founded late last year but already had a stable of experts.² That means that they were already organized.³ Its funding comes from the Open Society Foundation of George Soros, the Charles Koch Foundation, and other individual donors. The five co-founders are Andrew Bacevich, Eli Clifton, Suzanne DiMaggio (Chairman), Trita Parsi, and Stephen Wertheim.

- Trita Parsi was accused of being an Iranian agent⁴ after Parsi's National Iranian-American Council (NIAC)was caught coordinating its work with an Iranian ambassador and two agents of Iranian intelligence.⁵ This is public information and Parsi's poor reputation is well known, so the financiers have reason to know that they are funding an Iranian propaganda shop.
- Eli Clifton is another jihad propagandist who has followed the hardline Islamist party line throught his career, often working with Ali Ghraib⁶ to denounce the political opponents of Iran and its client terrorist organizations as "Anti-Islam".

The other members do not have such an obvious and well-documented affiliation for America's enemies. The Quincy Institute can therefore be seen as an Iranian influence operation in which the propagandists are hired to persuade the others within the organization to see them as fellow experts in their field and follow the Iranian agenda.

One of the Quincy Institute's fellows, Asli Bali, is on the Middle East Studies Association⁷ which is another vehicle to legitimize extreme views. The association's board includes jihadist propagandist Lisa Hajjar⁸ and jihadist activist Ted Swedenburg⁹ who has actively worked to have Jewish speaker Phyllis Chesler banned for opposing antisemitism. Board members Jillian Schwedler and Beth Baron work for the Graduate Center of the City University of New York whose fellow Katherine Cross is a board member of Feminist Frequency.
