Allen said he was there between 1:30 and 3:30 p.m. on Feb. 13. He said he saw three females while at the Freedom Bridge and then he walked from the Freedom Bridge to the Monon High Bridge. Allen told Dulin he did not take any photos or video while on the walk."

I am officially requesting through this Court the immediate payout of the larger portion of the Delphi reward fund now long overdue to me in the amount of somewhere around \$250,000 +/- or thereabout, nobody really knows for certain the exact amount of my funds currently being withheld because the Indiana State Police continually refuse to share that precise information with anyone, much less myself, so who really knows what they're actually doing with the funds and or how much actually made it into the reward fund that's been sent in over all these years now that is under their sole care - <https://www.youtube.com/watch?v=ovZRDw4hBXs> and specifically <https://www.youtube.com/watch?v=ovZRDw4hBXs&t=270s> - and an amount which was payable in full as of the "arrest" only of the lone suspect in the crimes, Mr. Richard Matthew Allen, who was also already long ago charged in the crimes, and who has since been held in multiple locations within the Indiana Department of Corrections awaiting trial, and a trial that has been delayed multiple times so far, since his arrest on or around October 28th, 2022.

No, because that's clearly not the problem nor the responsibility of the person(s) helping to solve crimes that rewards are meant for in the first place.

Are there rewards offered for "Ten Most Wanted Fugitives"?

At a minimum, a reward of up to \$250,000 is offered by the FBI for information which leads directly to the arrest of a "Ten Most Wanted Fugitive". In some instances, the reward amount offered is more than \$250,000. (*emphasis added) and, yet again, nothing about a "conviction" ever being necessary for the payout of up to, "At a minimum, a reward of up to \$250,000" for the "arrest" alone of a suspect.

"By offering cash rewards for information leading to felony arrests, the program encourages otherwise reluctant callers to provide information."(*emphasis added) and clearly nothing whatsoever about a "conviction" being required as well there that I can see.

"The community board of directors meets regularly to discuss Crime Stopper-related news and events, evaluate arrests, and decide on the amount of rewards to be paid. Rewards are then distributed in a private manner to the callers." (*emphasis added) yet again, not a word, not even a peep, about also requiring a "conviction" for the payout of the reward(s), just the "arrests", and I could keep going on and on and on with like examples proving this point, but I think that will more than do it for now.

The entirety of the Delphi reward fund is being, and has always been, held by the Indiana State Police Alliance (ISPA) under the guidance and direction of its current sitting president, Mr. Scott Krueger, and who well knows that what he and others in Indiana law enforcement, Indiana government and Indiana news organizations, among other such usual suspects, are doing to me here, as well as putting this whole case into fatal legal jeopardy by doing so, is terribly wrong, it's, really for all intents and purposes, immoral, if not downright illegal, for them to continue to withhold my rightful funds from me as they have, the public's direct funds of all those who had faithfully donated to the Delphi reward fund, simply due to their bruised egos and hurt pride, and which can then possibly make an individual who has that thin of skin with a gun, badge and some authority a

From the IndyStar article above: "Indiana State Police announced Monday an anonymous donor chipped in \$100,000 toward the Delphi Investigation reward fund, bringing the total to \$325,000. The reward is reserved for anyone who provides information leading to the arrest and conviction of the person behind the deaths of Williams, 13, and German, 14."

From the WTHR article above: "An anonymous donor has given a \$100,000 gift to the Delphi investigation reward fund to help discover who killed Libby German and Abby Williams in 2017. According to the Indiana State Police, the fund now has a total of \$325,000.

Anyone who can provide information to police that leads to an arrest and conviction in the case will receive the reward."

From the Journal & Courier article above: "An anonymous donor recently contributed an additional \$100,000, Indiana State Police announced Monday.

"The reward will be given to anyone who can provide information that leads to the arrest and conviction of the person responsible for the deaths of Abigail Williams and Liberty German," Indiana State Police said in a news release that emphasized that a conviction is necessary for the reward money to be distributed."

And here above in that last article from the Journal & Courier you will notice that the Indiana State Police emphasized that a "conviction" is necessary for that \$100,000 portion only of the Delphi reward fund money to be distributed, again, clearly a personal condition specifically made by the anonymous donor(s) of that portion of the reward funds only, and nothing more.

"The reason why I love the state of Indiana is because Hoosiers are a family. When you mess with one of us, you mess with all of us." - former Indianapolis Colts kicker Pat McAfee concerning the Delphi case, and from my point of view that attitude of a pack mentality apparently also extends against someone such as myself, except for the fact that I'm not truly "messing" with anybody here who doesn't more than deserve it at this point.

For all of you in the news organizations and so forth included herein within the BCC of this correspondence, and which does not include either the defense nor the prosecution, and therefore must now legally be forwarded to both by this Court, as well as immediately be placed in its entirety directly into the public record for this case, well, this will give you all yet another viewpoint of what's truly been going on here with all of this over all these years.

I did not want to do it this way, not at all, but clearly, and especially at this point, there is apparently no other way of going about it without making it really ugly and really public, any further than it all already is, and now over 1-1/2-years and counting since Mr. Richard Matthew Allen's arrest, it is well beyond time that I am finally paid for my stellar technical work on the case, and paid immediately too, I've more than earned it, no doubt about that whatsoever.

I'm not going to play nice anymore after this, so please do not make me do this again with publicly entering the official court record in the case as I now have been forced to do because with the next one I will really be hitting out hard at absolutely everyone involved in all of this, and especially folks like ISP Superintendent Douglas Carter, whom I will not allow to let simply ride off quietly into the sunset with his full pension and benefits when he retires out with his current boss, Indiana Governor Eric Holcomb, at the end of the year 2024 here, and who had also long ago blocked me on email because his fragile governor's feelings had gotten hurt over all of this, so, again, and in closing, to be nothing but absolutely crystal clear here, I want my rightful Delphi reward funds, at least the larger portion of it already long overdue and owed to me, right now, I simply goddamn demand it! Do not upset me again. Thank you. 😊
