

My Offkai experience

It's come to my attention that I've been accused of some serious stuff that allegedly happened while I was at Offkai. I'm making this document to tell my side for anyone who cares enough to know it and to address what people are saying as best I can.

The first point I will address is a streamer I was formerly associated with almost 2 years ago called Neko Mikki. I was removed as her moderator for having a disagreement with one of her community members in which case she decided to remove me from the moderation team. After this happened I resigned to only lurking streams until I was eventually banned with no solid reason given. I have since only acknowledged her existence when asked why I was banned from her community. She has now recently accused me of stalking her at Offkai which I did attend. The only thing I knew she was doing was a performance at the pixelated party which I did go to. I was asked to go and then informed of her performance specifically so I could avoid her.

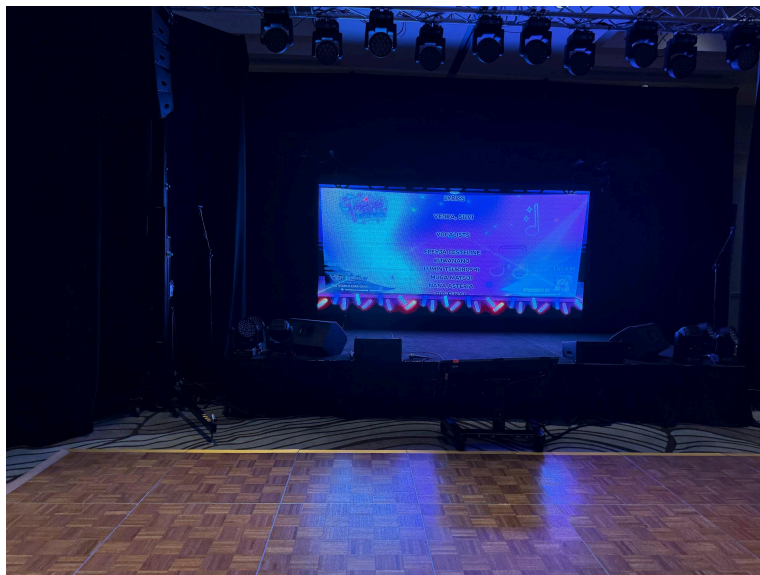
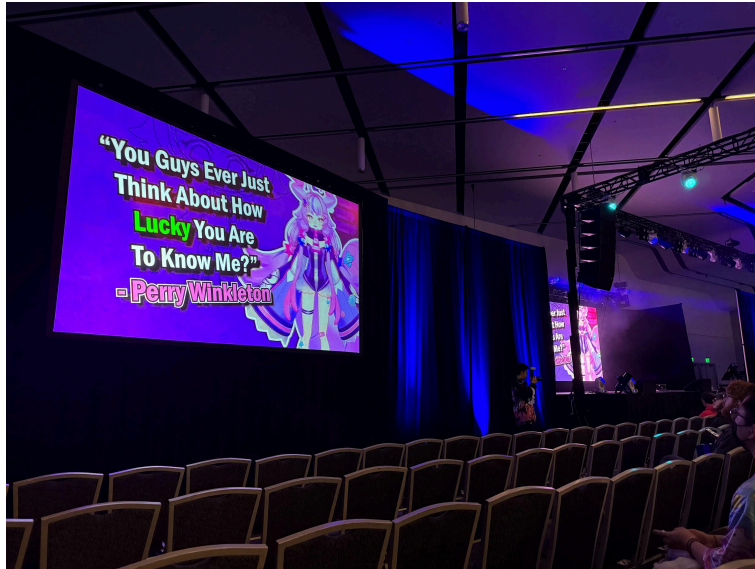

I also left the party early to attend a different event called the oshi bar. I have evidence that I was at that event since I took a short video and met up there with another person that will be mentioned later. In conclusion, I never engaged with or tried to engage with Neko Mikki in any way during the con, never searching for information regarding her location, never asked anyone about her, never approached her in any way and conversely actively wished to avoid her as much as possible. I will include a few pics/vids of events at the con I went to, since if I was at these events and she was not then it at least partly shows my innocence.

HARASSMENT ACCUSATIONS

Second point, I've been accused of sexually harassing vtubers through a collab server as stated in a post by FroggyHoppins [here](#). I'm not sure who all this is meant to be referring to and I doubt I'll ever find out, but these allegations come with no evidence to support them. I only had significant interaction with a few people from the server. The claim was made that the harassment occurred in vc which puts the argument to a I said

they said situation. Obviously I can't somehow prove that I never said anything over the line in a vc because I do not record any vc activity. I do wonder how no one happened to get any kind of evidence of this despite vtubers very commonly having OBS open at all times making it a simple click to start recording anything if needed.

WARNING ADULT THEMES

Third point, Finally the most serious accusation comes from someone I had attended Offkai with. As a last minute change in my plans I was asked by a Vtuber named chachachilla if I could share a room. I had informed her that there was only one bed but that I was willing to share and she took no issue with this. When the first night came I had gone to sleep on my back arms at my side to avoid rolling. I woke up at some point in the middle of the night feeling her skin pressed against my hand. I will not go into detail about what happened following this to keep her privacy and only mention the important points of information. A.) I did not engage in any activities until I was certain she was both awake and engaged B.) She gave me instructions/asked me to do specific things during the activities C.) When she said she wanted to stop I did not do anything further to her making sure she would be ok with anything that happened. The following day she told me that it felt rushed to which I apologized and the following night she made it clear she did not want to engage and so I did not.

This explanation is a response to the [google doc](#) they released where they accuse me of SA and claim they were stuck with me for the rest of the time trying to avoid me as much as possible. The reality is that she regretted what happened the first night, which I can understand, however it's completely unneeded to spin this tale to make it seem like this was somehow all me. I don't even mind not wanting anything to do with me afterward but feeling the need to make up a whole story like this . I will now show more context of dms showing that she wasn't exactly avoiding me during the con like she said and I actually took the time to help her anytime she needed it buying an uber to take her to whatever she wanted to go to even though I had no plans of doing so. I took lots of pictures throughout the day of standees and merch as well as I looked around

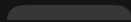
