18 U.S. Code § 1956 - laundering funds from Russia and the states of the Organization of Islamic Conference to agents of the foreign powers of the Organization of Islamic Conference, including the Osama bin Laden network

15 U.S. Code § 1 - forming an illegal conspiracy in restraint of trade with the intent to form a commercial monopoly under the control of the Osama bin Laden network

18 U.S. Code § 2381 and 18 U.S. Code § 2382 - Treason in enforcing the foreign laws of Russia and the Islamic states on all employees within this monopoly, and in dismissing employees who question the validity or usefulness of these foreign laws, and Misprision of Treason in failing to notify the courts of these activities

18 U.S. Code § 641 - embezzlement of public funds from the people and crown of England, France, Germany, the United States, and Israel toward acts of espionage and racketeering against the domestic political opponents of this endeavour

18 U.S. Code § 241 and 18 U.S. Code § 242 - conspiracy against rights, and the deprivation of rights under the color of law, in using law enforcement resources to engage in espionage and racketeering against the domestic political opponents of this endeavour

18 U.S. Code § 201 - Bribery of public officials

Co-Conspirator A: The Osama bin Laden network

Hassan Turabi of Sudan served as a propagandist for Saddam Hussein's Iraq before and during the Gulf War of 1990-1991.

After the war, Hassan Turabi organized the Popular Arab and Islamic Conference in the Sudan to form a global network of terrorist organizations.

The members of the Popular Arab and Islamic Conference included Abu Sayyaf, Hamas, Hezbollah, Egyptian Islamic Jihad, Palestine Islamic Jihad, the Palestine Liberation Organization, the Popular Front for the Liberation of Palestine, the Muslim Brotherhoods of several states, the al-Nadha (Ennahda) party of Tunisia, the Islah party of Yemen, and state representatives of Iran, Iraq, Libya, and Jordan.

Hassan Turabi directed Osama bin Laden to develop a money laundering network to replace the Bank of Commerce and Credit International (BCCI) which had been shut down in 1991.

Osama bin Laden had a pre-existing financial network known as the Golden Chain.

The Golden Chain included Sulaiman Abdul Aziz al-Rajhi who sponsored the SAAR Network of Virginia, also known as the Safa Group or the Barzinji network.

The SAAR network includes the All-Dulles Area Muslim Society (ADAMS), American Muslim

Council, Council on American-Islamic Relations (CAIR), Fiqh Council of North America, Graduate School of Islamic and Social Sciences (GSISS), International Islamic Charitable Organization, International Islamic Relief Organization, International Institute of Islamic Thought, Islamic Society of North America, Muflehun, Muslim Students Association, Muslim World League, North American Islamic Trust, PTech, Taibah International Aid Association, World Assembly of Muslim Youth, and numerous other subsidiaries.

The Golden Chain included Yousif Jameel of the Abdul Latif Jameel group.

The Golden Chain included Ahmed Yamani, the founder of Investcorp.

Osama bin Laden expanded this network to over 130 businessmen whose identities remain unknown to the public.

Hassan Turabi toured Pakistan, England, and the United States to raise support for this network.

Hassan Turabi was an invited guest to the Royal Institute of International Affairs, known as Chatham House.

The Royal Institute of International Affairs formed an alliance with the Osama bin Laden network and accepted as members Petrofac CEO Ayman Asfari, Saudi British Bank CEO Lubna Olayan, and Investcorp CEO Nemir Kirdar.

Ayman Asfari sponsors a professorship at the American University in Beirut for Fateh Azzam of al-Haq, which was founded by members of the Popular Front for the Liberation of Palestine (PFLP).

Fateh Azzam is a member of al-Shabaka which promotes the interests of the Palestine Liberation Organization and which includes key staff at Ford Foundation, McKinsey, and International Crisis Group.

In the United States, Hassan Turabi was a guest of Sami al-Arian of Palestinian Islamic Jihad.

Hassan Turabi's followers included the brothers Hassan and Maher Hathout who founded the Muslim Public Affairs Council.

The Hathout brothers were sponsored by the Pacific Council on International Policy which gave a charter membership to Maher Hathout.

The Palestine Liberation Organization operates the front Middle Eastern Childrens Alliance whose board has included Ibrahim Abu Lughod of the PLO, Yasser Arafat's brother Fathi Arafat, James Abourezk and James Zogby of the American-Arab Anti-Discrimination Committee, and several Soviet loyalists.

The Middle East Childrens Alliance founded the International Solidarity Movement (ISM) and International Act Now to Stop War and End Racism (ANSWER) as fronts for the PLO.

The PLO was banned from the United States by the Anti-Terrorism Act of 1987.

## Co-Conspirator B: The Union of Soviet Socialist Republics

During the First World War, Germany was at war on two fronts with the Triple Entente of England, France, and Russia.

Germany and its partners in the banking houses of New York and London raised an army of foreign Jewish mercenaries to disrupt the government of Russia and soften the eastern front.

The Jews successfully invaded Russia, murdered the Tsar of Russia and his family, and established the Union of Soviet Socialist Republics (USSR) which immediately made peace with Germany.

The Jews thereafter massacred and starved the Russian and Ukrainian people, killing tens of millions, until they were purged by Joseph Stalin.

Joseph Stalin and his successors led the USSR as a totalitarian dictatorship that continued to follow the Communist principles of the foreign invaders.

The Union of Soviet Socialist Republics operated the Communist International as an alliance of political parties under Soviet Union control.

The Union of Soviet Socialist Republics sought to expand the Communist movement into a global government and to eliminate all competing forms of social organization.

The Union of Soviet Socialist Republics invented the word "racism" to denounce the people of Eastern Europe who resisted foreign occupation, and to justify massacres of them.

The Union of Soviet Socialist Republics overthrew the governments of Rhodesia and South Africa by raising armies on the principle of black racial supremacy and calling for the massacre of white settlers.

The Soviet propaganda of black racial supremacy came to the United States as the "Helter Skelter" ideology of the Charles Manson cult and the Weathermen, was adopted in South America by Paolo Freire and his followers, and merged with the black supremacist theology of the Nation of Islam to become what is now called Critical Race Theory.

The Union of Soviet Socialist Republics formed an alliance with the Palestine Liberation Organization (PLO) and in 1969 created the myth that the PLO is a "Palestinian people" deserving of a homeland.

The Union of Soviet Socialist Republics established large spy networks in all Western countries to advance these agendas, and these networks were not arrested after the Soviet Union collapsed in 1991.

## Co-Conspirator C: The Organization of Islamic Conference

During the First World War, England and France defeated the Ottoman Empire, seized much of its territory, and ended the Ottoman Caliphate that had ruled the Islamic world.

When Amin al-Husseini led deadly riots against the Jews of Palestine, England rewarded Amin al-Husseini with the position of Grand Mufti of Jerusalem, granting him religious authority over all Muslims in Palestine.

Amin al-Husseini made alliances with other Muslim leaders to wage a global war against the Jews who were seeking to establish a Jewish state in Palestine.

In 1969 the heads of 23 Muslim states founded the Organization of Islamic Conference to promote their ongoing war against the Jewish state of Israel, adopting the Soviet rhetoric that al-Husseini's forces and their descendants are a "Palestinian people" and are "victims of oppression and racial discrimination".

In 1999 the Organization of Islamic Conference proposed that the United Nations adopt a resolution forbidding "Defamation of Islam".

The OIC's proposal was passed as Resolution 16/18 in March 2011.

U.S. Secretary of State Hillary Clinton chaired a meeting called the Istanbul Process with the Organization of Islamic Conference in December 2011 to promote the implementation of this resolution within the United States.

In 2012 the OIC Secretary General Ekmeleddin Ihsanoglu clarified that the resolution forbids "insulting", "denegrating", or "mocking" Islam, and that it forbids artists from drawing representations of Islam's founder Mohammed.

Co-Conspirator D: Avaaz

In 2007 the organization Avaaz was founded by Thomas Pravda of the United Kingdom Foreign and Commonwealth Office.

Avaaz advocates for the terrorist organizations of the Osama bin Laden network, including IHH and Hamas.

Avaaz co-founders include Ricken Patel of Res Publica, J Street, and the International Crisis Group.

Avaaz co-founders include Andrea Woodhouse of the World Bank.

Avaaz co-founders include Eli Pariser of MoveOn.org, Res Publica, and J Street.

Avaaz co-founders include former U.S. Congressman Tom Perriello of Virginia.

Avaaz co-founders include Ben Brandzel of MoveOn.org, GetUp!, and 38 Degrees.

Avaaz co-founders include David Madden and Jeremy Heimans of GetUp!, Purpose, and B Team.

Avaaz co-founders include the Service Employees International Union.

Avaaz has a headquarters within the offices of Unilever corporation in London.

Avaaz senior campaigner Fadi Quran is a member of al-Shabaka and of al-Haq which was founded by the Popular Front for the Liberation of Palestine.

The advisory board of Res Publica included Clare Short of the Israeli Committee Against House Demolitions.

The advisory board of Res Publica included Zainab Bangura of the Open Society Institute.

The advisory board of Res Publica included John Podesta, the former chief of staff to President William Jefferson Clinton and the founding head of the Center for American Progress.

350.org was founded by Avaaz members Jonathan Warnow, Gillian May Boeve, Kelly Blynn, and Jameson Henn.

B Team was founded by Sir Richard Branson and is headquartered in the offices of Unilever.

Co-Conspirator E: The Blavatnik School of Government

Alfa Group is an alliance of Russian Jewish billionaires with a combined net worth of over \$50 billion.

Alfa Group is part of the Russia International Affairs Council which includes representatives of the current Russian government of Vladimir Putin.

Leonard Blavatnik of Alfa Group finances the Blavatnik School of Government at Oxford University in England.

As of 2013 the Distinguished Practicioners of the Blavatnik School of Government included Lord Mark Malloch Brown, United Nations undersecretary Rima Khalaf, Trevor Manuel of South Africa, Montek Singh Ahluwalia of India, and Ernesto Zedillo of Mexico.

As of 2013 the International Advisory Board of the Blavatnik School of Government included William Jefferson Clinton who was then the husband of Secretary of State Hillary Clinton, Google executive chairman Eric Schmidt, Bank of England governor Mark Carney, Bank of Israel governor Stanley Fisher, Banco de Chile governor Andronico Luksic, Blackrock vice chairman Philipp Hildebrand, Nigeria finance minister Ngozi Okonjo-Iweala, Persio Arida of BTG Pactual, John Browne of Riverstone Holdings, Maria Ramos of Absa Group and Barclays, and George Weidenfeld of the Institute for Strategic Dialogue.

The activities of the Blavatnik School of Government were known to Queen Elizabeth of England who granted Leonard Blavatnik a knighthood for "services to philanthropy".

Co-Conspirator F: Inclusive Capitalism

In 2014 the City of London and the E.L. Rothschild corporation sponsored the Conference on Inclusive Capitalism.

The keynote speech at the conference was given by Mark Carney of the Bank of England.

The conference's co-sponsors included the Financial Times and the Edelman public relations firm of Chicago.

The conference's supporting organizations included the Blavatnik Family Foundation, the Ford Foundation, the Rockefeller Foundation, the Tony Elumelu Foundation, Gatsby, the Entrepreneurial Citizenship Institute (ICE) of Brazil, and China's Sunshine Kaidi New Energy Group.

The Inclusive Capitalism Working Group constitutes a commercial conspiracy.

Laden's organizer Hassan Turabi.

Omar Qirem has served as director of Edelman Middle East, Edelman Saudi Arabia, director of communications for Abdul Latif Jameel, and press officer for the British Ministry of Defence.

Co-Conspirator G: McKinsey

The board of the McKinsey Social Initiative includes Dominic Barton of the Inclusive Capitalism initiative.

Wirth, Fabio Barbosa of Santander Brazil, Infosys founder Narayana Murthy, Elizabeth Cousens, and Richard Parnell. Also present on this board is Ariadne Getty, the granddaughter of J. Paul Getty.

Phumzile Mlambo-Ngcuka of the McKinsey Social Initiative was granted control of UN Women.

The United Nations thereafter adopted a policy of "gender mainstreaming" which required all UN bodies to adhere to the demands of UN Women.

The United Nations Alliance of Civilizations formed partnerships with Silatech and Soliya.

Silatech is based in Qatar and its board included Nemir Kirdar of Investcorp whose founder Ahmed

Yamani was on the Golden Chain list of al-Qaeda financiers, Sir David Bell of England, and Martti Ahtisaari who was the chairman of the International Crisis Group.

Soliya is chaired by Suhail Rizvi, the lead investor in Twitter.

The advisory board of Soliya includes Muna Abusulayman, representative of Prince Alwaleed bin Talal of Saudi Arabia and the daughter of Abdulhamid Abusulayman of the International Institute of Islamic Thought, a part of the SAAR network that was the headquarters of al-Qaeda in the state of Virginia.

The United Nations Counter-Terrorism Centre was established by Saudi Arabia in 2011.

The United Nations Office of Counter-Terrorism is led by Vladimir Voronkov of Russia.

The United Nations Counterterrorism Directorate includes Raffi Gregorian, the son of Vartan Gregorian of the Qatar Foundation International.

The United Nations Counterterrorism Directorate runs Tech Against Terrorism in partnership with Amazon, Microsoft, Facebook, Google, and Twitter.

Tech Against Terrorism is "launched on the margins of RightsCon".

RightsCon is sponsored by Global Affairs Canada, the UK Foreign and Commonwealth Office, and the US State Department.

RightsCon Toronto director Brett Solomon was the executive director of GetUp! from 2005 to 2008 and was campaign director at Avaaz.

#### Co-Conspirator I: The Global Philanthropy Project

Several longtime employees of the United Nations authored the Yogyakarta Principles in March 2007 to form the basis of the Transgender religion.

The Yogyakarta Principles were adopted by Human Rights Watch in 2008 and also received early promotion by a group including Hivos, Dreilinden, and the Fund for Global Human Rights.

Hivos, Dreilinden, and the Fund for Global Human Rights are members of the Global Philanthropy Project which shares the office address of the Astraea Lesbian Foundation for Justice.

The "longtime head" of the Astrea Lesbian Foundation for Justice was Katherine Acey, the chair of the National Executive Committee of the Palestine Solidarity Committee and an advisory board member of the Open Society Foundation.

The Fund for Global Human Rights was co-founded by Mona Younis who is a member of al-Shabaka.

Other members of the Global Philanthropy Project include American Jewish World Service, the Arcus Foundation, the Ford Foundation, the Global Fund for Women, Mama Cash, Open Society Foundations, Sigrid Rausing Trust, The Other Foundation, UHAI East African Sexual Health and Rights Initiative, Urgent Action Fund for Women's Human Rights, and Wellspring Philanthropic Fund.

Ghislaine Maxwell's father Robert Maxwell was part of a British-Israeli spy ring that stole the Promis software from its American developers Inslaw, leading to the suspicious death of the journalist Danny Casolaro who was investigating the matter.

Ghislaine Maxwell is a business partner of Jeffrey Epstein.

A lawsuit by Charlene Latham alleges that Epstein has a relationship with "Qatar Investment Authority".

Barry Diller operates InterActiveCorp whose board includes Chelsea Clinton, the daughter of Secretary of State Hillary Clinton.

Hillary Clinton appointed Ghislaine Maxwell's nephew Alex Djerassi as chief of staff at the State Department's Bureau of Near Eastern Affairs, where he served from 2009 to 2012.

During this time the State Department covertly aided the Osama bin Laden network in overthrowing the government of Egypt, previously an American ally, and used the forces of the Osama bin Laden network to overthrow Libya and start a revolution in Syria.

Frank Giustra is the chairman of the Endeavour Financial group of Canada and a board member of the Clinton Foundation.

Demos chief executive Polly Mackenzie was director of policy for Deputy Prime Minister Nick Clegg from 2010-2015 during the time that Clegg was Lord President of the Queen's Privy Council.

Demos operates the Centre for the Analysis of Social Media and Microsoft's Voices for Civility project.

Demos operates the police union Common Purpose which has been accused of racketeering.

The leaders of Common Purpose include Charles Manby of Goldman Sachs, Anthony Salz of NM Rothschild and the BBC Board of Governors, David Loyn of the BBC, and BBC News business editor Robert Peston.

Demos trustee Nick Claydon is the CEO of Teneo.

Teneo operates Techsnabexport or TENEX as a joint venture with Russia that is staffed by ex-KGB agents.

Teneo employed Huma Abedin, the assistant to Secretary of State Hillary Clinton.

Demos operates a subsidiary in the United States.

Demos USA board member Heather McGhee is a board member of the Rockefeller Brothers Fund and Indivisible.

Demos USA chair Amelia Warren Tyagi is the daughter of Elizabeth Warren.

Demos USA treasurer Ruth Wooden was president of Public Agenda whose co-founder Daniel Yankelovich was a member of the US-Muslim Engagement Project.

Other members of the US-Muslim Engagement Project included Stephen Heintz, Shamil Idriss, and Madeleine Albright.

Demos USA secretary Connie Cagampang Heller runs the Groundswell Fund with Jonathan Heller of the Center for Community Change.

The Groundswell Fund is a subsidiary of the Tides Foundation.

Demos USA board member Janet Dewart Bell is a board member of the Women's Media Center which was founded by Stacy Smith and Marc Choueiti of the USC Annenberg Center for Communication.

Demos USA board member Gina Glantz is vice president of Oxfam America Action Fund.

Demos USA board member Van Jones is a member of Standing Together to Organize a Revolutionary Movement (STORM) and is the founder of Dream Corps, Rebuild The Dream, Green For All, the Ella Baker Center for Human Rights, and Color of Change, and is a fellow at the MIT Media Lab.

The Belfer Center for Science and International Affairs hosts R. Nicholas Burns who is a member of Chatham House, a board member of the Rockefeller Brothers Fund, and serves on America Abroad Media with Madeleine Albright.

The Belfer Center for Science and International Affairs hosts Juliette Kayyem who chaired the Dubai Initiative that took money from the United Arab Emirates to promote the Muslim Brotherhood, who has advocated in support of Qatari state media al-Jazeera, and who denounced Congresswoman Michelle Bachman for seeking an investigation into Huma Abedin who was employed by Teneo as a foreign spy.

The Belfer Center for Science and International Affairs hosts Rami Khouri who is a member of the advisory board of Soliya.

The Belfer Center for Science and International Affairs hosts Erekat Saeb, a member of the Palestine Liberation Organization.

The Belfer Center for Science and International Affairs has co-hosted cybersecurity meetings with the People's Liberation Army of China, thereby transferring knowledge and techniques to China.

The Belfer Center for Science and International Affairs hosts Farah Pandith who served as Special Representative to Muslim Communities.

Co-Conspirator HH: Farah Pandith and associates

Farah Pandith served as moderator for a meeting of the British Council's Prince Alwaleed bin Talal Islamic Studies Program, "Discourses after the Boston Bombings and the Woolwich Murder".

Farah Pandith has been accused of facilitating meetings between the American and European branches of the Muslim Brotherhood in the 2006 meeting "Muslim Communities Participating in Society: A Belgian-U.S. Dialogue".

Farah Pandith attended the Citizen Dialogue Group at the Islamic Institute of Boston in 2014.

The other members of the Citizen Dialogue Group included Yahya Basha of the SAAR Network.

The other members of the Citizen Dialogue Group included Mehdi Alhassani, former president of the Muslim Students Association at Georgetown University, chief of staff at Palantir Technologies, and Special Assistant to the the chief of staff at the National Security Council.

The Muslim Students Association was co-founded by Jamal Barzinji of the SAAR Network.

Farah Pandith, Lisa Monaco, and Alejandro Mayorkas partnered with the Muslim Public Affairs Council to create a "global research and action network focused on youth-oriented hate speech online" at the Berkman Center at Harvard University.

The Muslim Public Affairs Council was founded by Maher Hathout, a follower of Hassan Turabi who had hired Osama bin Laden to finance his international terrorist movement.

Farah Pandith led the Women in Public Service project of the Woodrow Wilson Center, also known as the 50x50 Movement.

Farah Pandith and Hillary Clinton co-founded the movement Generation Change which employs Wajahat Ali and Humera Khan as trainers.

Wajahat Ali and Faiz Shakir are the co-authors of the Center for American Progress report "Fear Inc.: The Roots Of the Islamophobia Network In America" which denounces all opposition to al-Qaeda.

Faiz Shakir had raised funds for the Hamas front organization Holy Land Foundation while he was a member of the Harvard Islamic Society, and was later employed by Nancy Pelosi as a senior advisor and new media director.

Humera Khan is the executive director of Muflehun which is run by Mohamed Magid and Suhail Khan of the Islamic Society of North America, part of the SAAR Network.

Co-conspirator II: Nancy Pelosi

As established by the America the Inclusive meeting, Muslim Advocates operates in concert with the SAAR Network.

As established by their activities with the Media Action Grassroots Network, Muslim Advocates has persuaded several state Attorneys General to order Facebook to ban the speech of their political opponents.

On December 10 2019 Muslim Advocates hosted a meeting with Nancy Pelosi to conspire to overthrow the government of the United States of America by impeaching President Donald Trump on fabricated charges.

The attendees of the meeting included Ibraheem Samirah whose father is a spokesman for the Jordanian Muslim Brotherhood.

The attendees of the meeting included the CEO of the Emgage Foundation which was founded by Khurim Wahid, a member of the Council on American-Islamic Relations that is a front for the terrorist organization Hamas.

The attendees of the meeting included a representative of the Open Society Foundations.

President Trump was impeached eight days later, on December 18 2019, on the charge of asking the Ukraine to reopen an investigation into the corruption of former Vice President Joe Biden, which Biden had ordered closed by threatening to withhold foreign aid.

Co-conspirator JJ: Peter Warren Singer and associates

In 2002 the Brookings Institution began holding the the Doha Conference on U.S. Relations with the Islamic World, later known as the US-Islamic World Forum.

The conference was sponsored by the al-Thani family who are the rulers of Qatar.

The attendees of the 2002 conference included Yusuf Qaradawi, one of the leaders of the global Muslim Brotherhood.

The attendees of the conference included Rami Khouri of the International Crisis Group.

The American representatives of the conference included Hady Amr, Martin Indyk, Shibley Telhami, Peter Warren Singer, Fareed Zakaria, and Thomas Friedman.

Martin Indyk is the director of the Saban Center that was financed by Haim Saban.

Haim Saban's wife Cheryl Saban is a board member of the Clinton Foundation.

Peter Warren Singer was the coordinator of the Brookings Project on U.S. Policy Towards the Islamic World.

At the 2002 conference, Peter Warren Singer called for the "integration of Islamist parties into political system rather than exclusion" in reference to those parties of the Muslim Brotherhood and the Osama bin Laden network that had been banned by Islamic countries as terrorist organizations.

The 2002 conference was subtitled "An Agenda for Action", suggesting that the statement of Singer was the agenda of the conference attendees.

The Brookings Institution partnered with Qatar to found the Doha Center.

Hady Amr is the founding director of the Doha Center.

Doha Center director Salman Sheikh is a member of the World Congress of Muslim Philanthropists and a board member of Crisis Action.

Crisis Action has received rewards from the MacArthur Foundation and the Skoll Foundation.

Crisis Action UK director Nicholas Martlew has endorsed Tom Pravda.

Doha Center fellow Sahar Aziz arranged a meeting in October 2011 between Department of Justice Assistant Attorney General Thomas Perez and Mohamed Magid of the Islamic Society of North America.

Peter Warren Singer and Fareed Zakaria are members of the board of the New America Foundation.

Co-Conspirator KK: Qatar Computing Research Institute

Ethan Zuckerman has performed work in concert with Qatar Computing Research Institute as a co-author of papers Finding News Curators in Twitter and Transient News Crowds in Social Media.

Patrick Meier is the Director of Social Innovation at the Qatar Computing Research Institute, founder of Civil Resistance 2.0, co-founder of the Digital Activism Research Project, a member of the Strategy Group of the Meta Activism Project, director of applied research at DigiActive, a member of the Harvard Humanitarian Initiative, a fellow of the Rockefeller Foundation, and New Media Advisor to Development Alternatives Inc. of Boston.

A lawsuit filed by August Cabrera has accused Development Alternatives Inc. of financing the Taliban.

The Meta-Activism Project is financed by the MacArthur Foundation Research Network on Youth and Participatory Politics, the Open Society Institute, and the Berkman Center for Internet and Society.

The advisory board of the Meta-Activism Project includes Wikimedia Foundation board members Ersa'a Al Shafei and Clay Shirky, and Hardy Merriman.

Hardy Merriman is president of the International Center on Nonviolent Conflict and served as an advance planner for Hillary Clinton's Senate campaign in 2000.

Co-conspirators had the motive, means, and opportunity to use the facilities of the Qatar Computing Research Institute to develop lists of political enemies derived from Twitter activity.



The Qatar Computing Research Institute has the capabilities to identify influential Twitter users and the relationships between them, and to identify opposing sides in a political debate.

Kiran Garimella was employed by Yahoo Research and the Qatar Computing Research Institute.

In an interview with Juha-Matti Mäntylä, Kiran Garimella mentioned performing this sort of research on Gamergate, the Twitter hashtag used by political opponents of the attempt by the Avaaz network to form a monopoly of marketing in the video game industry.
