6 killed in UP village over land dispute, 14 detained

MANISH SAHU LUCKNOW, OCTOBER 2

SIX PERSONS, including five of a family, were killed over an almost decade-old land dispute that flared up Monday morning at Fatehpur village in Deoria district of Uttar Pradesh.

According to police, a former zila panchayat member, Prem Yadav (53), was attacked with blunt objects and killed by his rival Satya Prakash Dubey and his family members when he went to his house. In retaliation, a group of people killed Satya Prakash, his wife and three children, including two daughters. One son survived the attack and



Reiterating this in Gwalior later, Modi said: "In Rajasthan, throats are slit in the open and the government keeps watching. These opponents of development (vikas virodhi) also bring appeasement wherever they go. This makes goons, criminals, rioters and corrupt people uncontrollable. Atrocities on women, Dalits, backward classes increase in states ruled by them."

Kanhaiya Lal was killed by two men in his shop on June 28 last year, for allegedly sharing remarks made by former BIP spokesperson Nupur Sharma on the Prophet. The accused had posted a video of the killing online.

In Rajasthan, Modi accused the Congress government led by Chief Minister Ashok Gehlot of "destroying" the state's reputation. "What kind of image of the brave land of Rajasthan has been presented by the Congress to the world? It is not possible to celebrate any festival in Rajasthan peacefully. Nobody knows when riots will break out or when a curfew will be imposed," he said.

"The Congress has created such an environment in Rajasthan that the common man is worried about life, the busi nessman is worried about business...This anti-development environment has to be changed. Be it rioters or criminals, only a BIP government can fix it," he said. Whether it is crimes against women, Dalits, or riots, Rajasthar

Referring to the Opposition as "opponents of development", he said: "MP's development cannot be done by those who have neither any thought nor a roadmap.. These people have only one job, to hate the country's progress, to hate India's schemes."

"India has become the fifth economic power in the world in nine years, but these opponents of development are lying to prove this did not happen. Modi has guaranteed that in the next term, India will be among the top three economies. This causes pain in the stomach of some people who are

Indian mRNA vaccines for Covid-19 were late to arrive in India, but as more research is being done, we expect to develop vaccines for other diseases using this technology, Dr Sanjay Singh, CEO of Pune-based Gennova Biopharmaceuticals, the company that rolled out India's first mRNA based vaccine, told

nation and how their scientific discovery saved the world. Now going further, this technology can be used to fight many more diseases," he added. The team at Gennova had a breakthrough when they managed to stabilise the mRNA vaccines between 2-8 degree Celsius, unlike others that required temperature around minus 70 degree Celsius, that is not only costly but also complex to maintain in Indian conditions.

The company's Gemcovac-19 was rolled out only in 2022, and the Gemcovac-Om, a booster vaccine specific to the Omicron variant, was introduced earlier this year. By this time, most of the Indian population had already been vaccinated against Covi-19, but Singh said it was extremely important that a vaccine based on this technology was innovated in India and reached the market.

Dr Vinod Paul, member, NIT Aayog, said the mRNA pathway for vaccines has opened new doors. "mRNA technology can be deployed for vaccines against TB dengue, foot and mouth disease Nipah, Zika, etc., and indeed for novel treatments for infections and cancers. This is an epochmaking technology and Indian scientists have mastered it with improvements. India also produced the world's first human DNA vaccine. The R&D of both the mRNA and DNA vaccines was supported by government funding through mission Covid Suraksha." Dr Paul told *The Indian* Express.

was admitted to hospital with critical injuries. Both the attacks took place in less than 30 minutes, police said, adding that 14 people have been detained. Heavy police deployment has been made in the village considering that the dispute involves two castes.

Taking note of the incident, Chief Minister Yogi Adityanath sent Principal Secretary (Home) Sanjay Prasad and Special DGP (law and order) Prashant Kumar to the village. Superintendent of Police Sankalp Sharma said a preliminary inquiry found Prem Yadav had bought 10 bighas of land from Satya Prakash's elder brother Gyan Chand Dubey in 2014. Satya Prakash objected, and took the matter to court. A few years after selling his land, Gyan Chand moved out of the state.

Although the matter is still pending in court, things got ugly on Monday morning when Prem Yadav went to check the land he bought, located close to Satya Prakash's house. Satya Prakash also reached the spot and made some remarks against Prem Yadav, police said. After this he returned home. Later, Prem Yadav reached Satva Prakash's house and got into a heated argument. The matter escalated and Satya Prakash's family members allegedly attacked Prem Yadav with blunt objects leading to his death.

As word about the murder spread, a group of around 10-15 people marched to Satya Prakash house and attacked him and his family members with sharp weapons, police said. Satya Prakash (54), his wife Kiran Dubey (52), daughters Saloni (17) and Nandani (10), and son Gandhi (15) died in the attack. Another son, Anmol (8), was injured.

Deoria District Magistrate Akhand Pratap Singh said the authorities got information about the incident around 8 am. "The incident occurred after an altercation between two groups... a person from one group was found dead and six others were found in an unconscious state, of whom five were declared dead at the hospital," he said. "The cause behind the incident is stated to be a longstanding land dispute be-

tween two families of the village." Special DGP Prashant Kumar confirmed that 14 people have been detained. Fathepur village, about 20 km from Deoria district headquarters, is dominated by Yadav and Nishad castes.

With Muslim percentage counted at 17.7%, Lalu Prasad's core Muslim-Yadav (MY) constituency stands at over 32%. This underlines the MY plank as the one to beat, with Nitish's core constituency of the OBC Kurmi and Koeri group (Luv and Kush) at 2.87% and 4.21% respectively. If EBC Dhanuk (2.13%) are clubbed with this, his 10% loval

vote bank still falls far short. ■ With the caste survey putting the general category, or "upper castes", at 15.52% – just slightly higher than expected – there were no great surprises for the BJP, which commands their loyalty. Of the upper castes, Brahmins are at 3.67%, followed closely by the Rajputs at 3.45% and the Bhumihars at 2.89%.

■ Among SCs, Ravidas and Dusadh (Paswan), with allied castes of Darahi and Dhari, are almost evenly matched, with re-

spective populations of 5.21% and 5.31%. While Chirag Paswan will take heart from data, former CM Jitan Ram Manjhi now has a number to his Mushahar clout: 3.08%.

All this comes when the BJP has made significant gains among EBCs in large parts of north India. Since 1993, when an alliance between the SP and BSP in Uttar Pradesh trumped the BIP despite a Ram Mandir wave, there was a perception that caste is the counter to Hindutva. However, this was shaken around 2014 when the BJP, with its outreach among backward castes, struck deep roots within these social blocs. Aware that the so-called upper castes may not think of any option apart from the BJP, the Opposition is again focusing on the revival of Mandal discourse.

"Right now, the data mentions only the population of each caste. The Bihar government had also talked about an economic survey of each caste and category but those figures have not been released," former Union Minister and Rashtriya Lok Samata Party chief Upendra Kushwaha told *The Indian Express.* "Only if we have data about numbers as well as economic status, representation in government jobs, etc, can schemes be initiated for those who are more deprived."

Swept into sea, Gujarat boy found

According to his family, the boy, Lakhan Devipujak, was playing at the beach with his younger brother Karan (12) and sister Anjali (8), and their grandmother Sevantaben Devipujak, on the afternoon of September 29 when the waves dragged the two boys in. "Karan was struggling but Lakhan managed to get hold of him and bring him near the shore. Suddenly, Lakhan was pulled back into the sea. This was around 1.30 pm. His grandmother shouted for help and some youths waded into the water, but could not find him. The fire department and Dumas police were alerted and a search was conducted, but there was no sign of Lakhan," his uncle Vijay Devipujak told *The Indian Express*.

Around 3 pm on September 30, Rasik Tandel (48), a fisherman from Bhat village in Navsari district, was on a boat far off the coast, accompanied by his assistants. "We couldn't get a good catch so we sailed ahead, up to 12 nautical miles. At a distance, I noticed something suspicious. We decided to go closer and found someone waving his hands. We were confused how a boy was in the middle of the sea with no boat and only a wooden seat. We threw him a rope and pulled him in. We admire the grit it must have taken to survive 26 hours like that," he

told The Indian Express. "We gave him water and tea, clothes, and a blanket. He told us how he got swept away while saving his brother. He shared the numbers of his father and uncle. Govt teacher travels 45 km daily to teach a single student in Pune

PUNE, OCTOBER 2

FOR ALL intents and purposes, the single-storey primary school building on gateless compound in Atalwadi appears closed — the playground is covered in overgrown weeds and all the classrooms in the front are padlocked. The only "sign of life" are faint

murmurs from a single classroom. The murmurs belong to 40-yearold Mangala Dhawale, the only primary teacher deployed at the Zilla Parishad school as she teaches her sole charge — Class 1 student, Siya Shelar. Six days a week since June 15, Dhawale has been travelling 45 km from home to the school in Atalwadi, a small settlement in Andgaon village that is 50 km from Dhavari in Pune.

The Atalwadi school is among 21 of 3,638 primary schools in Pune district with a single student and single teacher. Most of these 21 schools are located in the district's hilly talukas. Residents blame the lack of students on locals migrating to cities due to nonexistent employment opportunities in these areas.

Six-year-old Siya is the only child in the settlement in the 6-9 age group. Her elder sister Rasika, a Class 6 student, walks to Andgaon, a few kilometres from Atalwadi. Like Siya, Rasika was the only student at the Atalwadi school when she was in Classes 3 and 4. Their younger brother Samarth is just 3-year-old.

Though he accompanies Siya to school at times, Dhawale doesn't mind his presence in class. "It's good for Siya to have some company. Samarth also learns a few things in the process. Since there

is no anganwadi in the village, she did not have any elementary education when she started here. She was so shy that she didn't speak for first eight days. Her mother accompanied her till she grew comfortable," the teacher said.

Siya's mother Sarika added, "Siya seems to be doing well in school. She likes going to school On days when school is closed, she asks, 'Madam yenar naahi ka? (Is madam not coming today)'."

Dhawale, who has been teaching for 17 years, joined the Pune Zilla Parishad as shikshan sevak in 2006. Before Atalwadi, she taught at Zilla Parishad schools in Bhode and Bharekar Wadi. "I was transferred here after the previous teacher retired. This is my first stint at a single-teacher school and that too with just one student," she said.

The other challenges she faces include spotty Internet connectivity, and no electricity in the school since power was disconnected over non-payment of bills a few months ago . "Siya's grandfather promised to get some locals to help me remove the weeds after sowing season," she said.

THE THREE alleged ISIS operatives arrested by the Delhi Police Special Cell were "learning bomb making" through exchange of videos with their "trans-national handlers" on encrypted messaging apps, according to intelligence sources aware of details related to their interrogation.

Terming Shahnawaz Alam (31) the key player for allegedly planning to carry out terror strikes in northern India, sources claimed since the trio were "just starting out", their handlers were sending them instructional videos on bomb-making followed by assessments of "videos of their work".

"Alam to receive instructional videos on configuring Improvised Explosive Devices (IEDs) from his handlers who had further tasked him with sending them real-time videos of putting the devices together," a source claimed, citing his interrogation.

"Apart from assessing videos of the couple constructing IEDs so they could correct him and fill in any gaps in creating them, the handlers also asked them to

could check if the device had detonated properly for feedback on making effective ones," the source also claimed. In addition to being in contact

with handlers in "Pakistan as well as Syria" through popular messaging apps, sources claimed, the three had charted out potential targets ranging including "temples, government installations and local BJP leaders". "Shahnawaz had led the recce of several locations across the country and shared information of locations that could potentially be targetted with his handlers who are based in more than one international lo-

cation," sources claimed. Shahnawaz's wife, whom sources said was also "a potential threat, was also part of the IED assembling and assessment exercise. "Shahnawaz got married just three years ago to a woman in Aligarh," police claimed.

The couple had, according to police, taken to making IEDs in Delhi until they found some suitable contacts to be able to migrate to Afghanistan. These IEDs, police claimed, were tested by them at several locations in Delhi, Rajasthan and Uttarakhand.


'Weren't paid a paisa for our labour:' MGNREGA workers from West Bengal ready to protest today

NEW DELHI, OCTOBER 2

"OUR FAITH in the central government is lost," says Budhanrui Das (45), a day labourer from Jamuria, Paschim Bardhaman, West Bengal, who has been waiting for his MGNREGA wages since 2021. He and many other beneficiaries of the MGNREGA (Mahatma Gandhi National Rural Employment Guarantee Act) scheme have been trickling into Ambedkar Bhawan in Jhandewalan, in buses arranged by the All India Trinamool Congress (AITC), to demand their

pending wages. On Tuesday, they will join the protest led by AITC national general secretary Abhishek Banerjee at Iantar Mantar against the alleged withholding of funds for MGNREGA workers.

A temporary tent has been set up to house the 4,000-odd beneficiaries and party members, mattresses line the floor as far as the eye can see and fans whir fruitlessly trying to beat the

humid September afternoon

Teams of doctors, who are also AITC party members, make rounds in the camp. The beneficiaries have travelled by road for

three days straight and some have fallen sick with dehydration and heat fatigue.

First, they travelled by bus from their districts to Kolkata. There they were housed in Netaji Indoor Stadium for another day while party members attempted to make arrangements for buses to the national capital.

According to Shreshta, a member of the AITC's student wing, the party had applied for a special train but it was rejected. The party then arranged around 50 private buses to bring people to Delhi. "We have done all the work

the 100-day scheme asked of us - deepened and cleaned ponds, constructed roads, made canals and embankments," said Bappa Bauri (35), another day labourer, adding, "But we weren't paid a paisa for our labour."

"They sent so many people

from Delhi during the 2021 elections but could not make a dent in our votes," said Ivotirmov Mandal (40), a day labourer from

Khargram, Murshidabad.

However, Mandal's troubles go beyond politics. He owns 2.5 acres of land on which he cultivates paddy, wheat and mustard. Of late, even agriculture has not kept his financial burdens at bay, but added to them. "After paying for labour, fertilisers, seeds and tractor rent I'm left with only Rs 6,000-7,000," he said.

According to Md. Rahul Sheikh (32), a small business owner from Khargram, some women in Murshidabad turn to beedi-making to earn some extra money. Here too the wages are sparse — Rs 220 per 1,000 beedis. "The woman has to leave every other responsibility and devote her whole day to making

beedis," he said.

NEW DELHI, OCTOBER 2

WITH THE paddy harvest and instances of stubble burning having picked up pace in the northern districts of Punjab, and winter around the corner, how is Delhi's air quality likely to fare this winter?

According to experts, the meteorological factors that helped keep Delhi's air cleaner than usual last winter may not extend into the upcoming winter.

Gufran Beig, founder-project director, System of Air Quality and Weather Forecasting and Research (SAFAR), said, "Last year, there were natural factors that came to NCR's rescue. Wind speeds were higher for a majority of the time. But this year, that is unlikely because La Nina conditions are not there. Last year, due to La Nina conditions, winds in the northern part of India were faster, while it was calmer over

worsened. But in Delhi it was better relative to the previous year. This is unlikely in an El Nino year. This year, festivals are also around the time when it is colder. Steps will have to be taken."

La Nina refers to abnormally cool sea surface temperatures in the equatorial Pacific Ocean, while El Nino is the phenomenon of warmer waters in the Pacific Ocean.

Last year, on the day after Diwali for instance, higher wind speeds had helped disperse pollutants, and Diwali was in October, when colder conditions had not yet set in.

According to an analysis by the Centre for Science and Environment, last winter, the average PM 2.5 level in the city was the lowest from 2018-19 onwards. In November 2022, the daily peak contribution of stubble burning to PM 2.5 levels in Delhi was also lower than previous years, standing at 34%. This figure was over 40% in 2021,

Meanwhile, satellite data from the Indian Agricultural Research Institute (IARI) shows that Punjab has recorded 456 crop residue burning events so far this season, while there have been 120 such instances in Haryana.

VK Sehgal, Principal Scientist, IARI, said that in Punjab, the instances are mostly in Amritsar and Tarn Taran.

"Harvesting has begun and peak of harvesting would come somewhere around the last week of October and first week of November." he said.

Delhi's AQI was 146 in the 'moderate' category on Monday. According to the Air Quality Early Warning System for Delhi, the AQI is likely to remain in the 'moderate' category from October 3 to 5.

The Graded Response Action Plan (GRAP) came into effect on October 1, which means that measures under GRAP can begin to be invoked when the AQI is in the 'poor' category (201 to 300).

Out for taekwondo practice, teen run over by truck on Dwarka expressway

AN EARLY morning run and exercise session by a group of Taekwondo players took a tragic turn after one of them. a 15-vearold girl, was mowed down by a truck and four others suffered severe injuries. The incident took place early Sunday on the Dwarka Expressway.

The victim, Najafgarh resident Arundhati Kumar, and her friends attend Taekwondo classes in the area. The group decided to run on the expressway as there was not much crowd in the morning hours, said police. Around 5.30-5.40 am, they were doing warm-up exercises on the under-construction portion of the expressway when the truck

hit them, killing Arundhati on the spot.

The injured claimed they were in an area away from vehicles but the truck driver came speeding and hit them. He didn't even honk in warning or stop for a moment, they alleged.

BJP state president Samrat Choudhary said, "Nitish government released the caste survey report only after we applied pressure on them. We deserve equal credit for it." He, however, voiced dissatisfaction over the survey "not giving an idea of the changed social and economic realities."

Welcoming the release of the caste survey findings, Congress leader Rahul Gandhi said the exercise has proved that 84 per cent of people in Bihar are OBCs, SCs and STs and their share should be according to their population.

Asking the BJP government to leave politics behind, Samajwadi Party president Akhilesh Yadav said, "Caste survey is the path of the country's progress, and it has become amply clear now that PDA (Pichchde, Dalit and Alpsankhyak) will decide the future course of politics in the country."

BJP ally SBSP general secretary Arun Rajbhar said, "RJD and JD(U) should also release data on how much political representation their government has given to various backward castes like Rajbhar, Rajwanshi, Pal, Prajapati, etc.."

ALTHOUGH FINDINGS of the Bihar caste survey were released on Monday, the Nitish Kumar government's decision to conduct the exercise has been challenged in the courts and is still awaiting final outcome before the Supreme Court. It has been challenged on the grounds that it violates the Supreme Court's privacy judgment and is actually a census in the garb of a survey, which is beyond the legislative competence of the state government. Petitions opposing the exer-

cise were initially filed in the Supreme Court in January but it refused to entertain them and asked the petitioners to approach the High Court if they had any grievance. Subsequently, petitions were filed in the Patna High Court urging it to quash the notifications issued for the survey. Hearing the matter on April 18, the High Court orally rejected the prayer for interim relief. On appeal, the Supreme Court

on April 28 noted that the plea was pending before the High Court and asked it to decide the petitioner's fresh application for interim relief at the earliest.

Counting the gains: How the survey puts Nitish back in focus

DEEPTIMANTIWARY

NEW DELHI, OCTOBER 2

WITH HIS ties with the INDIA alliance coming under strain in recent weeks, Nitish Kumar appeared a bit distant from the Opposition bloc and in search of political preeminence. On Monday, the Bihar Chief Minister once again took centre stage in national politics following the release of the state caste survey data.

The findings of the survey are likely to help Nitish strengthen his position as a champion of the Extremely Backward Classes (EBCs), non-Yadav Other Backward Classes (OBCs), and Mahadalits — vote banks that no party can ignore ahead of the parliamentary elections next year.

According to the data, the EBCs constitute the biggest vote block with a population of 36.01%, followed by 27.12% OBCs, of whom 14.26% are Yadavs, the singlelargest social group. Dalits, according to the data, constitute over 19.65% of Bihar's population against 15% recorded by the 2011 Census. The EBC and OBC data also include Pasmanda Muslims.

Notably, it was Nitish who created the political constituencies of EBCs and Mahadalits to compensate for the inadequate numbers of his own caste, Kurmis,

who the survey has enumerated to be around 3% of the population. This social engineering, achieved in his first term itself, held Nitish in good stead politically for over a decade. As his social base once again shows signs of drifting away, the caste survey could be used as a glue to keep his flock together.

"Rahul Gandhi is today going around the country speaking about caste census. But Nitish Kumar raised it three years ago, followed it up with action, fought a court battle and got it done. As the champion of the EBCs and non-Yadav OBCs, it puts him leaps ahead of other leaders in the Hindi heartland. This message is not just going to impact Bihar but even percolate to UP in the context of the 2024 polls," said a senior leader of the ID(U), the CM's party.

According to the functionary, during the first INDIA meeting in Patna in June, Nitish said caste census should become one of the key agendas of the alliance and asked for the bloc to announce that if INDIA wins the parliamentary elections it would cal importance in the state is on conduct a caste census. The survey data's release also holds significance in light of Nitish's depleting strength in the state. In the last Assembly polls, though the JD(U)-BJP combine won the polls, the tally of Nitish's party fell to 43 from 71 constituencies in the 2015 elections. The BJP with 74 seats became the senior partner in the alliance. Now with the RJD, which has 75 constituencies, he is again CM with far fewer seats than its partner.

"While Nitish Kumar's politithe wane, he continues to command anywhere between 5% and 7% votes on his own. Whichever way he swings could significantly benefit that alliance. He will naturally claim credit for the caste survey and it may even shore up his importance. But these polls are not going to be fought on just the caste survey. Price rise and unemployment are the issues," said an RID leader.

Former Bihar Deputy CM and BIP leader Sushil Kumar Modi said, "When this decision was taken, we were part of the government. This is actually our baby. Conversely, in the women's reser vation Bill, everyone knows what has been RID's historical role."

A senior BJP leader said the survey numbers did not throw any surprising data as political parties had always attributed similar numbers to the castes in their internal calculations. "As of now, caste census is not an issue among the people. It may be politically used to demand greater reservation for OBCs and EBCs That can make it an electoral issue. In Bihar, EBCs have a reservation of 20% in panchayat elections. There has been a demand for increasing it and BJP supports it. The one thing it will show though is that Nitish Kumar always knows how to remain po-

RESUMING MINING AT BICHOLIM BLOCK

Union Environment Ministry defers decision on Vedanta's Goa mining proposal

EXPERT Appraisal Committee (EAC) of the Union Ministry for Environment, Forest and Climate Change has deferred its decision on a proposal to grant environmental clearance to M/S Vedanta Limited for the resumption of iron ore mining at Bicholim mineral block in Goa. In a recent meeting, the EAC

for environmental appraisal of non-coal mining projects directed the project proponent to submit a letter from the Goa government's Directorate of Mines and Geology, clarifying "whether any illegal mining within the mine lease area has been carried out or not and whether the same has been carried out by M/s Vedanta Limited or not".

Bicholim Mineral Block-Block 1, which has an area of 478.5206 hectares, is spread across the villages of Bicholim, Bordem, Lamgao, Mulgoa, Mayem and Sirigao in North Goa's Bicholim Taluka. It has a proposed production capacity of 3 million tonnes per annum (MPTA).

Goa Chief Minister Pramod Sawant had said in the Monsoon Session of the legislative Assembly that the iron ore mining operations, which had been stopped since 2018 in the state,

would start by November 2023. According to the minutes of the 20th EAC meeting held on September 21-22, the EAC said that there was no clarity regarding the involvement of forest land within the mine lease area as contradictory information was given by the project proponent. The EAC observed that since the mine lease area shared a common boundary with Mayem Forest, the project proponent needed to submit a letter from

the state forest department. The EAC noted that there is a need to ascertain the ground reality regarding the handling of waste; settling ponds; the location of waste dumps with respect to habitation, schools and river; forest, temples, caves and fort; mineral transportation route; and traffic congestion.

The EAC noted that in the public hearing for the grant of environmental clearance, 4,708 written objections were submitted against the project, while 5,183 letters were received in support of the project. The EAC said that a site visit needs to be conducted by EAC members and officers from the Union ministry.

A spokesperson for Vedanta Sesa Goa said: "Vedanta Sesa Goa is committed to adherence to regulations and to resumption of mining in Goa in a responsible and transparent manner".

Abhishek: Centre withheld payments because people of Bengal rejected BJP

TRINAMOOL CONGRESS general secretary Abhishek Banerjee on Monday targeted the Narendra Modi government, saying that it spent Rs 1,500 crore on a new Parliament building but was not releasing dues of the poor in West Bengal. He said it was doing so because it wants to punish the people of the state for rejecting the BJP.


"You have spent Rs 1,500 crore on the new Parliament and you are not paying Rs 1.5 lakh (each) for people's houses (under the PMAY). People who have worked two years ago (under MGNREGA) and have dues ranging from Rs 10,000 to Rs 15,000 have not been paid. You have withheld payments because the people of Bengal have defeated you and rejected you. And this is something the BIP is not able to tolerate," he said following a meeting of top party leaders at MP Sudip Bandopadhyay's residence.

Banerjee is in Delhi along with party leaders to protest against delayed payments to MGNREGA job card holders and PMAY beneficiaries in Bengal. The state has accused the Centre for not clearing dues for close to two years.

On Monday, Banerjee held a two-hour sit-in protest at Rajghat job card holders to Delhi.

will begin at 1 pm and continue till 5 pm following which Banerjee along with senior party leaders will march to Krishi Bhawan to meet Minister of State (Rural Development) Sadhvi Niranjan Ivoti and put forth their demands. They said they had sought an appointment with Development Minister Girirai Singh but were granted a meeting with Jyoti at 6.30 pm.

On a question if Giriraj Singh, who is away in Begusarai in Bihar, was avoiding meeting the TMC delegation, Baneriee said, "It is clearly understandable and visible from the optics we have seen so far that he does not want to face the delegation.... Because he does not have the answers...."

On Singh's allegations of corruption in implementation of the MGNREGA scheme in Bengal, he said, "I challenge him to sit with

us... The West Bengal government has replied to every query they have sent within 48-72 hours. There is not a single matter which is pending with us. Still they have deliberately withheld the state's rightful dues because they want the people of Bengal to suffer." On Singh suggesting a CBI

probe into alleged irregularities, he said, "If there is a CBI inquiry into MGNREGA, Giriraj Singh must be the first person to be arrested. An investigation can happen but it must be a court-monitored probe... If handing the case over to CBI would ensure the disbursal of funds for common people, I welcome it."

Banerjee accused the Centre of only collecting taxes from Bengal but giving it nothing back. "By releasing the funds you will not do any favour to us. This money belongs to the people. You

collect Rs 1 lakh crore from Bengal and give just Rs 20,000-30,000 crore. You keep 70% of all the money. That money funds your propaganda," he said. According to Banerjee, the Centre owes Rs 1.15 lakh crore to the West Bengal government and under MGN-REGA and Awas Yojana, they have withheld nearly Rs 15,200 crore.

The TMC also alleged that attempts were made to stop the protest at Rajghat. "...The CISF, CRPF, and Delhi Police personnel kept assaulting everyone, including our women leaders, consistently," Banerjee alleged.

After Banerjee completed his speech, Delhi Police officers asked the protesters to vacate the area. "Your protest is causing inconvenience to the public...," said DCP Central Sanjay Sain. He then gave directions to the security personnel remove the protesters.

Bihar's caste survey is welcome but it should be used to increase opportunity, not as a primer for deepening faultlines

HE RELEASE OF the caste survey data in Bihar is a much-needed and longoverdue step for the state's politics and policy. Caste numbers can provide a critical reality check for governments that make "samajik nyaya" or social justice their calling card, or claim to. Data can help fine-tune efforts to address historically embedded backwardness and inequality. A wider political churning was touched off in the 1990s with the implementation of the Mandal Commission report at the Centre — it inaugurated and then routinised such a politics in the country's north (the states of the south had already taken a lead) by mobilising historically neglected constituencies, empowering new parties and players, and expanding quotas in education and jobs to include the OBCs. Counting caste numbers is a logical next step that, at the national level, has been delayed much too long. That's why the Bihar numbers, even as they promise to fill a gap in the state, will also resonate beyond it.

Within the state, by assigning the highest percentage of all caste groups, 36.01 per cent, to the Extremely Backward Castes (EBCs), the survey promises a new dignity, if not coherence, to the mostly small and scattered groups, seen as politically footloose, in this category. For long, the dominant Backward versus Forward cleavage in the state relegated these groups to the margins, and the absence of a unified EBC leadership has meant that political parties ranging from the RJD and JD(U) to the BJP, that have sought to coopt them, have struck bargains that assign their concerns less than their due space and role. The politics of the EBC may well receive a new fillip now in Bihar. Ahead of the general election in 2024, Bihar's survey will also amplify other calls for enumeration outside the state

— the women's Bill has just been passed by Parliament with the question of quota-withinquota still hanging; the Justice G Rohini Commission recently submitted its report on the sub-categorisation of OBCs; the Modi government is reportedly discussing a proposal for sub-categorisation among SCs; the Opposition alliance, INDIA, is pushing for a country-wide caste census, ostensibly to counter the BJP's Hindutva consolidation, and many states are pushing for independent caste-based surveys in their own jurisdictions.

Even as a caste headcount is necessary and desirable in a deeply stratified society, in which caste-based reservation has become an important instrument to address historical injustice, the data must be handled with care. The challenge, going ahead, is this: The data must not become a weapon for deepening faultlines and increasing polarisation to win elections. It should not lead to the splintering and shrinking of the very notion of representation in a large and diverse democracy. Politicians will need to remind themselves of the larger purpose: Caste must be counted in order to strengthen efforts to transcend it. In a changing India, in which education and technology are important equalising forces, caste-based affirmative action, fine-tuned with the help of caste numbers, can spur larger conversations on aspiration and ambition, freedom and opportunity, and the need for an eco-system in which citizens are neither unfairly privileged nor straitjacketed by their identities. A series of recent electoral verdicts have driven home the fact that the people may be ahead of their politicians in recognising the future citizenship — while party campaigns all too often play upon fixed identities, voters are increasingly crossing caste and community lines and voting for moveable concerns, shared ideas and dreams.

BAD AIR PLAN

Delhi has done well to prepare for pollution in advance. The early start must be used to devise long-term solutions

N SUNDAY, THE Delhi government began implementation of the Graded $Response\,Action\,Plan\,(GRAP)\,to\,check\,the\,city's\,notorious\,winter\,pollution.$ Like the past seven years, the plan is a combination of preventive and punitive measures. The plan indicates a welcome awareness of the need to collaborate with Punjab and Haryana to check stubble burning. But the mere expression of intent will not be enough. A coordination mechanism between Delhi and its neighbouring states to make sure that the air in the region doesn't turn foul during the winters has been in the works for far too long. Delhi's latest plan indicates that people could be at the mercy of emergency measures even this year.

Last year, the Commission for Air Quality Management underlined the need for a round-the-clock air quality monitoring network in the NCR. It stated that for NCR districts, the CPCB and state pollution control boards need to identify new sites to monitor pollution. But as a report in this paper, last week, pointed out, half of these stations in the region are in Delhi. Going by the CPCB's list, at least nine of the monitoring units do not work. Only 20 of the 65 manual monitoring stations have the capacity to keep a continuous track of PM 2.5. Going ahead, NCR governments will have to identify monitoring shadow areas and plug the gaps.

The Delhi government claims its policies have led to 40 per cent reduction in pollution since 2015. It's right to an extent. But the fact also is that the plans have been found wanting several times when meteorological conditions turned unfavourable. Last year, Delhi experienced its cleanest Diwali in seven years, largely because winds blowing at 6-7 km/h prevented the accumulation of pollutants. In less than four days, any hope of the smog not keeping its date with the capital was belied. Less than two months later, in early January this year, Delhi's residents were breathing toxic air again. Like in the past two years, the Delhi government has done well to frame its action plan at the beginning of the season. This early start must now be used to frame long-term solutions.

THE NEW PLAYERS

Power of 'influencers', with their reach and sway over the young, cannot be ignored. Baiyanpuria's video with PM is no oddity

N THE ONLINE universe, where a great deal of influence is wielded by those who purvey fitness, make-up, financial and other kinds of advice, Ankit Baiyanpuria is a person of some renown. The 25-year-old fitness "influencer" has a following of over 5 million on Instagram and 1.82 lakh on YouTube. These impressive numbers no doubt contributed to Baiyanpuria's appearance in a 'Swachhata hi Seva' campaign video, released on the eve of Gandhi Jayanti, alongside Prime Minister Narendra Modi. In the parlance of celebrity culture of the pre-digital era, Baiyanpuria has "hit the big time".

Critics of social media often use the pejorative "influenza" to describe those like Baiyanpuria. But this can also be read as a grudging acknowledgement of their reach, wide enough to have caught the attention of brand managers, marketers, filmmakers and politicians. Many, like Kusha Kapila, Ranveer Allahbadia and Bhuvan Bam now have the kind of recognition that was once the preserve of blue-chip stars. In the new media landscape, where influencers are seen as moving into a space that traditional media has failed to seize

or been forced to vacate, Baiyanpuria's video with the PM is no oddity. For the influencers, this recognition of their power can translate to movie roles and book deals, the opportunity to make a splash on red carpets and exclusive interviews. That these credentials are not of the traditional kind seems to matter little, especially at a time when conventional qualifications are — often correctly — being criticised as the product of privilege. For a nation hoping to make the most of its "demographic dividend", it may not be wise to dismiss the power of today's youth idols.

Canada's hollow moralpolitik



Its entrenched culture of self-righteous posturing is on display in current crisis with India

STRANGE AS IT may seem today, India and Canada were once bound by shared idealism and a liberal internationalist commitment to a normative global order. That era ended in the mid-1970s, and since then, Canada has found it hard to build a sustained and productive relationship with India. If Ottawa takes a fresh look at Delhi and begins an engagement rooted in realpolitik, the current crisis in bilateral relations might yet serve a purpose. One thing that puzzles the Indian foreign policy elite about the current crisis is Ottawa's utter unwillingness to take a political look at the character of the Khalistan militants operating on its soil.

External Affairs Minister Subrahmanyam Jaishankar's frequent reference to Canada's permissive "vote bank politics", which have become especially acute under Prime Minister Justin Trudeau, explains one part of the problem. There is another source of the Canadian establishment's inability to hear, let alone understand, India's concerns about the criminal violence of the Khalistani groups operating on its soil. It is Canada's entrenched culture of selfrighteous posturing.

The American scholar and columnist Walter Russell Mead, who has written perceptively about the US and the Anglo-Saxon engagement with the world, drew attention to this when he moderated Jaishankar's talk at the Hudson Institute in Washington last week. Mead recalled the comments by Dean Acheson, US Secretary of State during the early years of the Cold War, on Canada's tendency to moralise. As the US embarked on a muscular foreign policy aimed at taking charge of the world in the aftermath of the Second World War, it had to endure endless lecturing from its northern neighbour. Discussing international affairs with Canada, Acheson said, was "like listening to the stern daughter of the voice of god". Acheson was, of course, no American redneck. (The myth of "nice Canadian" versus "boisterous American" endures to this day). He was the son of English migrants from Canada and was quite familiar with its culture.

Canada's moralpolitik had some utility. It helped define a Canadian identity — after all, it is not easy to live in the shadow of the US. It is also quite easy to be "principled" when you are not responsible for anything, let alone running the world. With the luxury of a strong

military alliance and expansive economic relationship with the US, Canada could often grandstand on global issues and differentiate itself from Washington. Ottawa, for example, established full diplomatic relations with China in 1970, nearly a decade before the US. Ottawa also reached out to Cuba with some fanfare in 1976 when Pierre Trudeau visited Havana and met Fidel Castro. Although the trip seemingly defined Canada's independent foreign policy, it was facilitated by the US decision in 1976 to loosen the embargo on Cuba.

The episode, however, is emblematic of an enduring narrative - the US is a "mischiefmaker" and Canada is the "helpful fixer". If the US relies on blunt instruments of military power, Canada would focus on diplomacy and engagement. The US, with its burden of "securing the world from communism and other evils", had to dirty its hands. Seizing the high moral ground allowed Ottawa to present itself as the "White Knight" of North America.

Independent India, it turned out, loved Canada's moralpolitik because Delhi was in the same mode in the 1950s and '60s. Delhi and Ottawa were in the same corner preaching the virtues of a normative global order when the great powers were spoiling for a war that could turn nuclear. If the US was taking care of Canadian security interests in the Cold War era, Jawaharlal Nehru believed Delhi faced no security threats. That provided a basis for an interesting convergence on global issues in the early Cold War from the Korean War to the Suez Crisis. Nehru and his Canadian counterparts — especially Louis Saint Laurent and Lester Pearson — would call for restraint in and occasionally help defuse conflicts.

Although Canada was a founding member of NATO and India the leader of the Nonaligned Movement, the two sides found it beneficial to work together. For India, an empathetic Canada was a valuable partner when its relations with the West were under growing strain. Canada could carve out a global niche by acting as a bridge between India and the US and between the West and the developing world. Beyond this, Ottawa's liberal internationalism saw Canada become a major partner for India. Under the Colombo Plan, Canada offered significant developmental assistance to India. It also empathised with newly independent India's ambition to de-

velop advanced technology, especially nuclear. Canada helped India build a research nuclear reactor, CIRUS, that would hone India's skills to produce plutonium that could be used in nuclear weapons. Canada also joined hands with India to design and develop a heavy-water natural uranium power reactor (CANDU) that would be the foundation for India's nuclear electric power generation. If nuclear technology outlined the expansive horizons for the India-Canada relationship, it also became the focus of the breakdown in bilateral relations. Canada reacted with ferocious anger to India's first nuclear test in 1974. India's moralpolitik claiming it a "peaceful nuclear explosion" did not calm Ottawa's claim that Delhi betrayed Canada's support for civilian development of atomic energy. Canada was among the last nations to come to terms with the US effort to end India's disputes with the global nuclear order during 2005-08.

Even as the nuclear contentions peaked and receded, Canada's minority politics at home began to cast a shadow over bilateral relations since the '80s. The effort to manage this negative dynamic showed some promise when conservative Stephen Harper was in power from 2006-15, but began to break down when liberals under Justin Trudeau took charge. But Canada's India relationship, which holds great economic and strategic potential, is not beyond repair. In the last few days, India has been pointing the way out. Delhi has clarified that the assassination of terrorists abroad is not India's policy and will cooperate with Ottawa based on credible intelligence-sharing. India, in turn, expects Canada to stop empowering the Khalistani extremists, end the current political impunity they enjoy, and crack down on their violent activities.

RAHUL GANDHI'S RECENT article on Hinduism/Sanatan Dharma ("Satyam Shivam Sundaram", IE, October 1) is, tragically, largely based on fear. 



A plan for the winter crop

Better technology and policies must be deployed to ensure farmers get their due. Abrupt export bans or stocking limits are not the best way forward



THE INDIAN MONSOON (June to September) has ended with a 5.6 per cent deficit compared to the long-period average (LPA). This is a notch lower than the normal rainfall — 96 to 104 per cent of the LPA. Despite the wide deviation in its temporal spread, especially in August — the driest since 1901 — the area planted under paddy and sugarcane is higher by 1.9 per cent and 7.64 per cent respectively, compared to last year. But the area under pulses is significantly down, by 4.2 per cent, especially arhar (tur) which has seen a 4.9 per cent fall in cultivated area. In the days to come, one will have to watch the price inflation in tur — already raging at 32 per cent in August. The only way to tame tur price inflation seems to be a million tonne of imports from African countries and Myanmar.

In Delhi, as we brace for smoke from the stubble burning from paddy fields during October-November, it is also time to plan for sowing of rabi crops. The Ministry of Agriculture and Farmers Welfare (MoA&FW) organised the Rabi Conference on September 26, under the leadership of Manoj Ahuja, Secretary MoA&FW. The Secretary of the Department of Fertilisers and the Director General of ICAR were also invited. They assured us that the country has ample fertilser stocks to take care of the demand of the rabi season. Wheat is the main rabi crop, and it is susceptible to a heat wave. Himanshu Pathak, DG ICAR, assured us that his organisation has released numerous heat-resistant wheat varieties, which are likely to cover roughly 60 per cent of the sown area — up from 45 per cent last year. In the last nine years, India's

agri-research system has released 2,200 varieties of different crops, of which 1,800 are climate resilient. Going by these assurances, another "record" rabi crop is in the offing.

Against this backdrop, I will raise a few queries and offer some suggestions so that MoA&FW can move from a highly "production-centric" approach to a "food systems" approach — a topic on which I delivered a keynote address at the rabi conference.

Here are some questions to ponder with respect to wheat in the last two years. As per the MoA&FW, wheat production in 2021-22 was 107 MT and in 2022-23, it was 112.7 MT. But the trade estimates for these two years are far lower, below 100 MT in 2021-22 and below 105 MT in 2022-23. This huge gap in the GoI's estimates and trade estimates creates inflationary market expectations.

We also know that in 2022, wheat procurement plummeted to less than 19MT, a drop of more than 50 per cent from the previous year. As a result, retail prices of wheat came under pressure. GoI put an export ban on wheat on May 13, 2022, fearing that the Russia-Ukraine war could escalate prices. Wheat inflation, less than 10 per cent in May, climbed to 15.7 per cent in August. When the GoI banned atta exports, the inflation did not stop there. It kept going up and in December 2022, it climbed to 22 per cent and further to 25 per cent in January 2023.

The wholesale wheat prices in mandis are hovering around Rs 2,700/quintal, while the minimum support price (MSP) for the coming marketing season of wheat is Rs 2,125/quintal. The FCI has unloaded its stocks at prices way below its economic cost, fearing that it would not be able to procure enough for the public distribution system (PDS). This was literally "dumping" to beat the market prices down to MSP levels. Offloading 3.4 MT in February-March ensured that market prices were down to MSP, and FCI was able to procure about 26 MT of wheat. Its success cost wheat farmers Rs 40,000 crore (Policy Brief 15 on ICRIER website has details of this). This is a transfer of resources from producers to consumers and indicates a typical pro-consumer bias in the

policy framework.

My question is: When more than 800 million people already get free wheat or rice (5kg/person/month) under the PDS, who is the government trying to protect? The urban middle class at the cost of farmers? Is that a rational policy to incentivise farmers to produce more? Certainly not. This is what economists Ann Krueger, Maurice Schiff and Alberto Valdes called the "plundering of agriculture" in their classic work, Political economy of agricultural prices.

The story is not very different in the case of rice which faced export restrictions when there was a complete ban on non-basmati white rice exports. Then export duties were imposed on parboiled rice and a minimum export price was set for basmati rice. The whole effort has been to beat market prices down to the MSP, even if that involves "dumping". FCI's economic cost of rice is around Rs 3,700/quintal, but it is selling rice at below Rs 3,000/quintal. If some other country had been dumping its products in India, the government would have taken the dispute to WTO. But what can farmers do when the FCI dumps its wheat and rice at way below their economic costs?

As we go further into the rabi season, we not only need better and more accurate estimates of production, but also need to monitor the prices that farmers get. At a time when technology can track each moving car, why can't we monitor the progress of crops every week — if not daily? We need to upgrade our patwari-based production estimate system to one that is based on high technology. This will help settle crop insurance claims, and also give enough lead time to the government to import in time if there is likely to be a shortfall.

Overall, my submission to MoA&FW was that we need better technology and better policies to ensure farmers get their due. Only then India can emerge as a powerhouse in agriculture. Abrupt export bans/stocking limits are not the best way forward.

Yet, FDI has been falling the case of Indonesia, flows stood at around \$10 billion during January-June this year,

roughly similar to levels seen last year. The decline in FDI is, however, not an indictment of India's prospects. After all, companies in the Apple ecosystem like Foxconn and some others are indeed taking a huge bet on India by ramping up their investments in the country. And, foreign portfolio investors (FPI), who represent a different type of capital, have upped up their investments in the country: Since January, FPIs have poured in around \$15 billion in the Indian markets, after withdrawing \$16.5 billion in 2022 (calendar year).

But, this does raise the question: If India is indeed the alternative for companies looking to diversify away from China, if the country is the "one" in the China plus one strategy, if the PLI scheme of the government serves as a strong enough incentive to draw in investments, and if the growth forecasts projecting its rise over the coming decades do rest on solid foundations, then shouldn't every category of investor be long India? Or, does this decline reflect something deeper?

Is it the case that certain sections of foreign capital are perhaps more comfortable playing the India story, not directly, but indirectly through investments in the larger domestic companies who are better able to manage the environment? And, that some of those diversifying away from China consider other countries — some for electronics, others for textiles — a more attractive proposition?

Several possible reasons could explain the reluctance among multinationals, and also the hesitation among domestic firms to invest in India — but along with the wellknown impediments to investments, investors now also have to contend with policy uncertainty. After all, an uncertain business environment, an uneven playing field, and the fear of the rules of the game being arbitrarily changed midway, act as powerful deterrents.

Another possible explanation now could be the absence of the country from major trading blocks. While India has signed and is currently negotiating a few bilateral free trade agreements, it does not have a trade agreement with the European Union, nor is it part of RCEP, the trade agreement between the 10 member states of ASEAN and their free trade agreement partners — Australia, China, Japan, New Zealand and Korea. And as economic integration between these countries, which are at the centre of manufacturing supply chains, will deepen further with RCEP, not being part of such agreements and the supply chains that run through these regions places India at a further disadvantage in this manufac-

turing ecosystem. FDI flows are more likely to gravitate towards countries with broader and deeper trade agreements. After all, lower tariffs, among other benefits, negotiated through FTAs incentivise foreign investment. It is thus possible that the fall in FDI flows to

India reflects this. This would suggest that while India may well be a compelling story, it is not the only one. This calls for a more sober assessment of the country's prospects.

ADMITTEDLY, I SOUND like a party pooper, but the hurrahs and hype over the passing of the women's reservation Bill should be viewed with a pinch of scepticism. In the race to score brownie points with women voters, few dared to dwell on the cynical manner in which a bill of such far-reaching dimensions was hustled through. The Modi government's introduction of the Bill in a five-day special session at the fag end of a 10 year-term, taking everyone by surprise, was no doubt a political coup. The Bill was shrouded in such secrecy that it was not listed in the session's business agenda or even mentioned at an all-party MPs' meet. It was kept under wraps until Prime Minister Narendra Modi made his dramatic announcement on the second day of the special Parliament session. Within two days flat, the Bill was passed with almost total unanimity in the Lok Sabha and the Rajya Sabha.

The government deserved congratulations for clearing a bill which for 27 years was on hold because of the silent and not-so-silent resistance by male MPs, who feared that the ground would be cut from under their feet. This time, the Opposition, particularly the Congress, was more concerned with trying to claim credit for being the first to suggest the proposed reform, rather than questioning the unseemly haste and complete lack of consultation. In the game of optics, questioning any aspect of the women's reservation Bill was like criticising mother's milk or the tricolour. With time not on their side, the Opposition did not, as should normally have been the case, even insist on referring the Bill to a special parliamentary committee where MPs could study the clauses and suggest improvements to a piece of legislation which will have a major impact on the electoral character of our democracy. Home Minister Amit Shah acknowledged that the hastily drawn up legislation might have flaws, but remarked breezily that any shortcomings in the Bill would be "rectified along the way". The government, while basking in the glory of taking this historic step, has left the task of fine-tuning the Bill and translating it into a reality to future governments — a post-dated cheque with the actual time for encashment left uncertain.

It was politically savvy to peg the actual implementation of the Women's Reservation Bill to the process of delimitation of constituencies. Delimitation is a mine field which is bound to evoke an outcry in southern states and explains why, for the last 50 years, all governments have avoided wading into this bog. Redrawing and increasing Lok Sabha constituencies on the basis of population will mean that south India gets short changed as the proportion of seats in the BJP-ruled cow belt states in Parliament automatically rises. The southern states have long maintained that they cannot be penalised for practising family planning. If the implementation of the women's reservation Bill gets delayed further than 2029, it will likely be blamed on the complexities of delimitation. Indian women have come a long way from when Ram Manohar Lohia described them as "bachche banana ki machine". But strangely, in contrast to the impressive number of Indian women in higher education and specialised fields once reserved for men, the percentage of women in Lok Sabha has never crossed 15 per cent. This is far below the global average of 25.5 percent. In our highly patriarchal rough-and-tumble political milieu, it is difficult for an aspiring woman politician to break through without the help of male mentors. In recent years, among the few women MPs to rise up the political ladder entirely on their own steam are the late Sushma Swaraj and Mamata Banerjee. Most of our prominent women politicians were and are dynasts. The late Sharad Yadav argued that his staunch opposition to the Bill was that "parkati mahilayen (women with

short hair)" would dominate the quota. His fear was misplaced. Today's ruling party tends to select its candidates on regional considerations, caste and religion, not elitism or education. A greater danger than upper-caste and upper-class women dominating is that many women candidates could be ciphers, selected for their pliability and family links to powerful male politicians.

The double standards of political parties who claim to have been fighting for women's empowerment for years is exposed by their failure to voluntarily allot tickets for elections to women (Though the BJP must be credited for amending its party constitution to ensure 33 per cent reservation for women within its organisational framework). Two politicians who stand out in genuinely attempting to empower women are Navin Patnaik and Mamata Banerjee. In 2019, Patnaiks's BJD allocated a third of Odisha's 21 Lok Sabha seats to women, Banerjee fielded 17 women in West Bengal for 42 Lok Sabha seats. Probably the road ahead for empowering women would be quicker and smoother if all parties agreed to adopt this doable first step in opening doors for women.



900 gifts, mementos presented to PM Modi put up for e-auction

NEW DELHI, OCTOBER 2

A 12-FEET-LONG Paresh Maity canvas – capturing a typical Banaras landscape with the ghats and boats – covering an entire wall of the exhibition hall at National Gallery of Modern Art has been put up for the month-long e-auction of gifts and mementos received by the Prime Minister, that started Monday. The painting, 4.5 metre in height and weighing around 30 kg, was presented to PM Narendra Modi by the noted artist after one of his creative sojourns to Varanasi. At a base price of Rs 64 lakh, the artwork will be up for e-auction along with over 900 other such objects this year.

The month-long online auction has 912 such gifts and presents going under the hammer, out of which, 150 are on physical display at the gallery. While the Maity canvas is the most expensive item of the lot, the lowest reserve price is Rs 100 for some digital prints that were presented to the PM during his trips within the country. This is

the fifth edition of the auction, and the proceeds will go to the Namami Gange programme. Minister of State for Culture Meenakshi Lekhi said around Rs 33 crore has been collected through such auctions over the years, and all the proceeds have gone towards the rejuvenation of the river Ganga.

Officials say around 7,000 such mementos have been auctioned during consecutive editions, starting January 2019, and people from across the country have participated and bid for them. While foreigners are not allowed to bid, the presents received by the Prime Minister during his foreign visits are also not part of the auction, officials added. The products on display also

represent various Indian art forms, and include paintings, sculptures, handicrafts, and folk and tribal artefacts, besides replicas of architectural buildings such as Modhera Sun Temple and Vijay Stambh of Chittorgarh. There are also angavastrams, shawls, headgear, and ceremonial swords that were presented to Prime Minister Modi on different occasions.



THE R21/Matrix-M™ malaria vaccine developed by the University of Oxford and the Serum Institute of India, leveraging Novavax's adjuvant technology, has been recommended for use by the World Health Organization(WHO) after meeting required safety, quality and effectiveness standards.

The Serum Institute of India has already established production capacity for 100 million doses per annum, which will be doubled over the next two years. the statement said.

The vaccine was developed by the Jenner Institute at Oxford University and Serum Institute of India with support from European and Developing Countries Clinical Trials Partnership ('EDCTP'), the Wellcome Trust, and the European Investment Bank ('EIB').

This is the second instance of a state-run hospital reporting high number of deaths in a single day after a similar incident was reported in August when 18 people died at the Thane Municipal Corporation-run Chhatrapati Shivaji Maharaj Memorial (CSMM) Hospital in Kalwa.

In a statement issued by the hospital, among the adult patients who died, there were four cases of heart disease, one case of poisoning, one case of gastric disease, two cases of kidney disease, one case of obstetric complications and three cases of accidents. Among the child patients, four were in a terminal stage and were referred from private hospitals.

"In recent days, more critical patients, especially those in terminal stages, have arrived from the district and other areas. The dedicated medical team and staff are diligently attending to their needs. This medical college and hospital have a longstanding history of providing excellent services to the community, and all admitted patients are receiving the necessary care," reads the statement.

A doctor from the hospital said, "While our capacity is 600 beds, at present we have over 800 patients admitted. We are the sole tertiary-care hospital in the district and we often receive patients in critical condition." In Mumbai. Chief Minister

Eknath Shinde termed the fatalities "unfortunate" and declared a thorough investigation into the incident, even as the Opposition criticised the state government over the condition of public health facilities in the state.

Maharashtra Medical Education Minister Hasan Mushrif said that he will visit the hospital on Tuesday and senior officials have been instructed to conduct a thorough inquiry. "Based on the report, further action will be decided. Seven deaths were of critical patients. Two were due to snake bite and poisoning. I have asked our director to visit Nanded. I will also be going there. Inquiry has been ordered," he said.

Agencies asked to find details of terror-related activities in Pakistan

NEW DELHI, OCTOBER 2

THE MINISTRY of Home Affairs recently held a meeting of of multi-agency centre (MAC), a common counter-terrorism grid, and sought details of specific instances of radicalisation in mosques/madrasas in Pakistan, misuse of NGOs and civil society organisations to raise funds for terrorist purposes in Pakistan, sources of mobilisation of funds from Pakistan to the cadres of terror outfits from Afghanistan, Pakistan and PoK, it is learnt.

The meeting of MAC, which functions under the intelligence bureau, last month was attended by senior officials of Military Intelligence, BSF, National Investigation Agency, Intelligence Bureau and Research and Analysis Wing (R&AW). "They were directed to find out the details of safe houses of Lashkar-e-Taiba (LeT), Jaish-e-Mohammed (JeM), Al Qaida and Islamic State of Iraq and the Levant (ISIL)-associated groups in Pakistan, along with the details of Pakistan nationals who perform/have performed command roles in various listed terror groups targeting India and

FORMER CHIEF Minister Basavaraj Bommai on Monday slammed Deputy CM and Water Resources Minister D Shivakumar for misleading the people of Karnataka regarding inflows to Cauvery river. Speaking after participating in a protest held at Mandya over releasing water to Tamil Nadu, the Bharatiya Janata Party (BJP) leader said that officials were pegging the inflow to Krishnarajasagar (KRS) reservoir at 2,000 cusecs. "Shivakumar was misleading people by saying there was a large inflow (towards Tamil Nadu). Why is he talking so lightly?" he said.

Bommai's remark came a day after Shivakumar said that there was no need for Karnataka to release water from KRS as the rainfall in Bengaluru and surrounding districts had surged the outflow to Tamil Nadu to around 6,500 cusecs. "Though the state has not released any water to Tamil Nadu through the KRS dam, 6,500 cusecs of water was flowing due to rainfall in Bengaluru and other districts," the DyCM said Sunday, Earlier on Monday, Shivakumar accused the BJP of politicising the Cauvery row, rather than putting pressure on the Central government for a solution. A PRIVATE hospital in Tundla town of Uttar Pradesh's Firozabad district was sealed and its director was arrested for allegedly terminating the pregnancy of a woman patient in her thirties without her or family's knowledge, police said.

Chandni Yadav, who was four months pregnant, was taken to Gopi Ram Hospital last Wednesday after she complained of pain in her lower abdomen, it is learnt.

Chandni's family claimed that Dr Rohit Chak, the hospital director, examined and discharged her after the treatment the same day. But hours after reaching home, she had excessive bleeding and her family members rushed her to Agra, they claimed.

"After examining her, doctors at the Agra hospital informed the family that the foetus had been

aborted and her uterus was

damaged," said Tundla SHO. The family members came to Firozabad and created a ruckus at the Gopi Ram Hospital, blaming





Philippines, allies start naval drills amid tensions in Asia-Pacific

Manila: Forces from Manila. Britain, Canada, Japan and the United States kicked off on Monday two weeks of joint naval exercises in Philippine waters as a "show of force", amid flaring regional tension.

With more than 1,800 participants, the drills follow last week's move by Beijing to block Philippine fishermen from Asia's most contested maritime feature, the Scarborough Shoal, held by China in the South China Sea.

Kyiv brushes off US and Slovakia wobbles as EU leaders convene

EU FOREIGN ministers convened in Kviv for their first ever meeting outside the bloc on Monday. broadcasting their support after a pro-Russian candidate won an election in Slovakia and the US Congress left Ukraine war aid out of its spending bill.

Kyiv brushed off the wobbles on both sides of the Atlantic, especially the prospect that the US Congressional vote, which excluded aid to Ukraine from an emergency bill to prevent a government shutdown, represented a deeper change in policy.

"We don't feel that the US support has been shattered... because the United States understands that what is at stake in Ukraine is much bigger than just Ukraine," Foreign Minister Dmytro Kuleba told reporters as he greeted the EU foreign policy chief, Josep Borrell.

As for the election win of pro-Russian Slovakian ex-Prime Minister Robert Fico, Kuleba said it was "too early to judge" impact on politics there, noting that a new leader would still have to form a coalition.

Monday's meeting in Kyiv was touted by Borrell as an historic first, and provided striking photo opportunities for a succession of ministers in front of EU flags in the war-time capital.

The shorter piece of the scroll, known as The Remaining *Mountain*, about 51 cm long, is at the Zhejiang Provincial Museum. Taiwan's National Palace Museum has kept the 640-cm long *Master* Wuyong Scroll since the 1950s.

The two pieces were reunited in 2011 when China lent fragment to the Taiwanese museum for two months during warmer ties as Taiwan pursued policy of economic rapprochement with China.

'Constitutionally bound': Nepal President backs move to pardon convicts

KATHMANDU. OCTOBER 2 NEPAL PRESIDENT Ram Chandra

Poudel on Monday refused to accept any lapses on his part after a delegation of opposition Rashtriya Swatantra Party (RSP) members arrived at his office to level allegations against him for approving pardon to 670 criminals, including murder convicts.

The 78-year-old President skirted the issue and shifted the blame on the Nepal cabinet, saying he is constitutionally bound to approve its recommendation.

London's Pointe Black ballet school aims to break racial barriers

IT WAS a pointed comment about her Afro-braided hair that spurred Ruth Essel to carve out what she calls a safe space for Black dancers.

The founder of Pointe Black Ballet School in London said when she was a child, teachers and assistants all but punished her for not fitting the traditional ballerina mould, as if she was using her race

as some kind of rebellion. "I'll never forget my first time about to dance on a West End

stage," said Essel, describing when, aged 10, she started a final rehearsal at a theatre proudly wearing the braided bun her single mother had spent her last 100 pounds on.

Her pride turned to shame when her teacher pointed at her in the lineup of an almost allwhite group of dancers, saying, "You're going to take all of those zigzaggedy things out of your hair because it looks a mess."

That was just one of several instances when Essel was made to feel that being different was "like a defiant choice by me," she said. "These are all things that happened before I was 16 years

old. and I didn't know any better." Those challenges inspired Essel, a deputy programme manager at a unit of the Royal College of Psychiatrists, to establish Pointe Black in 2020 at the age of 26.

"I wanted there to be a Black environment. I wanted there to be people who looked like me. I wanted there to be a teacher that looked like me," she said.

It was empowering, she recalled, to finally wear black tights and shoes, rather than the traditional pink for ballerinas, "because it was closer to my colour." The iconic image of a ballet

dancer remains light-skinned,

even though the artform - which

originated in the Italian Renaissance as court entertainment - has expanded globally with stars from Asia, South America and Cuba. And classical ballet companies strive for a uniform look especially in works like "Swan Lake," making it harder for dancers of colour to get hired or promoted.

Some 2.2% of dancers at the UK's top four ballet companies are of Black heritage - roughly consistent with the country's Black population at 3%, said Sandie Bourne, a committee member of Britain's Society for Dance Research, in her 2017 doctoral thesis.

BEHIND STATE GOVERNMENTS DEMANDING BETTER PENSION PAYMENTS

State govt employees regularised mid-career blame NPS for lower pay

AANCHAL MAGAZINE NEW DELHI, OCTOBER 2

AMID THE ongoing debate over

the switch to the Old Pension Scheme (OPS), states are learnt to have flagged concerns over a high number of government employees who were regularised into government service mid-career, resulting in a lower pension payout due to less amount of contributions, compared with full-service government employ-

Some states, such as Himachal Pradesh, Chhattisgarh are facing this issue as they have a large number of employees whose total years of service is around 10 years, an issue that has also been raised in the discussions of the Centre-appointed committee to look into improving the National Pension System (NPS) for government employees, people in the know said..

This is being viewed as one of the significant reasons for an inaccurate representation of the estimate of the returns and the pension payout under the NPS amid rest of the government employees, especially serving employees who are yet to retire. Concerns have been triggered af-

ter the regularisation of employees, such as panchayat workers, teachers as regular government employees is seen to be the reason for a surge in the number of estimated beneficiaries from the pension scheme in the states. The contention is that the regularised employees have a lower contributory period for availing the pension and hence, will get a lower payout as against the regular government employee.

"In many of the states there are Panchayat employees, teachers etc who originally were not government employees and then at some point they get regularised or converted into government employees. So they come

into government service, let's say, at the age of 50 years. If you come in at 50 years and you retire at 60 years, then in a contributory scheme, you will obviously get a very low pension compared to a flat 50 per cent for a full service. The normal government employees get recruited by examination and come at an age of let's say 30 years or below...they usually have a minimum 25-year career. The outcome of NPS with a 25-year career is very different from the outcome of an NPS when somebody has a very short career of a few years. But the peo-

ple who have actually retired till

now are people with very short

services and those with NPS,

which came in 2004, would not have retired as of now...many people are comparing the pension of NPS with this and saying it is much lower than the normal pension. The point is these are people who have only 5-10 years of service. Obviously, their pensions will be very low," a person aware of the discussions said.

About two-three states including Chhattisgarh, Himachal Pradesh are learnt to have provided their insights on the issue of the regularisation of government employees and the low pension payouts to such employees in their discussions. People aware of the Centre-state discussions insist this issue is different from the debate over the assured returns and market uncertainty for returns under the NPS.

"On an average they might actually get a decent pension (under NPS). But the people who have less than the full service, it is in the nature of a contributory scheme that if you don't contribute for enough years, you won't get a good pension. So the problem seems to have become more noticeable for people because they are seeing these examples (of regularised employees) and those examples have very low pensions compared to

OPS. They (regularised employees) are the ones who are retiring of late, nobody from NPS would have retired yet as the system itself came into place in 2004. They give their example to somebody saying they are getting only some amount of pension, which creates a sense of alarm among the serving people. But it may not be that bad for a full career government employee. For the majority of the employees, it will be much better," the person said.

The demand for switching to the Old Pension Scheme has flared up again ahead of assembly polls scheduled in several states and Lok Sabha elections next year. Thousands of government

employees — teachers, doctors, clerks, peons — and those working in the PSUs from Uttar Pradesh, Uttarakhand, Rajasthan, Madhya Pradesh, Chhattisgarh, Himachal Pradesh, Haryana, and other states participated in the "Pension Shankhnaad Rally", organised by National Movement for Old Pension Scheme (NMOPS) at Ramlila Maidan in Delhi on Sunday urging the BIPled NDA government to reinstate the Old Pension Scheme before

SEBI extends deadline for listed companies to confirm or deny market rumours

THE SECURITIES and Exchange Board of India (SEBI) has extended the deadline for listed companies to confirm or deny market rumours to February 1, 2024 as part of mandatory disclosure requirements. The deadline has been extended for the top 100 listed companies by market capitalisation to February 1, 2024, from October 1 this year at present, according to the latest circular by the Sebi.

According to SEBI, for the top 250 listed entities, the rule will kick in on August 1, 2024, from the current requirement of April 1, 2024. The rule is aimed at strengthening the corporate governance of listed entities. There were many instances in the past where manipulators floated rumours in the market to rig share prices.

"It has been decided to extend the effective date of implementation of...the LODR (Listing Obligations and Disclosure Requirements) rules for top 100 listed companies by market capitalisation to February 1, 2024, and for top 250 listed companies by market capitalisation to August 1, 2024," SEBI said. Earlier in June, SEBI notified rules asking these listed companies by market capitalisation to confirm, deny, or clar-

These companies will have to confirm, deny or clarify any reported event or information in the mainstream media, which is not general in nature and which indicates that rumours of an impending specific material event" are circulating amongst the investing public within 24 hours from the

reporting of the information. The Industry Standards Forum, led by K V Kamath, worked on pilot basis on some of the provisions of SEBI LODR Regulations and submitted the first set of draft recommendations last week. The engagement will continue to include consultations with industry members, facilitated by the NSE and the BSE, industry bodies said in a joint statement. After the receipt of draft recommendations of the Industry Standards Forum, the regulator has decided to postpone the implementation of the provision pertaining to rumour verification, which was to come into effect from October 1, 2023. The consultation process with the regulator on the draft recommendations will now continue further, industry bodies said.

In a joint statement, Ajay Singh, President, ASSOCHAM, R Dinesh, President, CII, and Subhrakant Panda, President FICCI, said, "We appreciate the unique initiative taken by the SEBI to form the Industry Standards Forum and involve industry bodies to design the implementation standards for various regulations It is a constructive and inclusive approach designed to foster collaboration and enhance ease of doing business, thereby leading to better compliance."

In August, SEBI had invited the three leading industry associations together to work in consultation with the regulator to assist in designing the implementation standards on a pilot basis in coordination with the stock exchanges. Pursuant to the invitation, ASSOCHAM, CII and FICC came together and constituted an Industry Standards Forum under the Chairmanship of KV Kamath.

India Inc salary bill up 14.3%, sees fastest jump in 10 years

INDIA INC'S total salary bill went up by a good 14.3 per cent to about Rs 9.4 trillion in FY23, the fastest increase in 10 years. Moreover, the average salary in the organised sector rose by nearly 10 per cent, an eight-year high and much above the rate of retail inflation in the country.

A study of 7.5 million employees across 1,800 listed entities by Jefferies revealed the increase has happened on the back of substantial pay hikes by the IT sector. Excluding for salaries in the IT sector, the rise in pay packets drops to 6.8 per cent, which is in line with the 10-year average.

The estimated increase in salaries per employee is even higher at an effective 15.6 per cent,

also an eight-year high, when the data is adjusted for the recruitment of juniors and retirees.

In absolute terms, employee numbers rose by a reasonably good 4 per cent to 7.5 million on the back of a 7 per cent increase in FY22, a year in which the economy had not fully recovered from the effects of the pandemic. The study by analysts at

Jefferies showed that the deceleration in hiring by IT firms was by and large offset by more recruitment in the BFSI (banking, financial services and insurance) space.

The headcount in this sector went up by 8 per cent whereas the increase for the IT sector was 6 per

Between them, the two sectors contributed about 85 per cent to the incremental jobs created in the year. Interestingly, the analysis showed that state-owned un-

dertakings continued to shed jobs in FY23. The rising incomes and employment will boost consumption demand in the coming quarters, economists point out.

While the significantly better growth in private consumption in the June quarter of 6 per cent y-oy compared with just 2.8 per cent seen in the March quarter, was partly the result of easing inflation, fatter pay cheques have also helped.

The growth in CPI inflation moderated to 6.83 per cent y-o-y in August from a 15-month high of 7.44 per cent in July.

Much of the growth in employment has been driven by the services sector with a boost from higher capital expenditure yet to be seen. For instance, the number of contract workers at L&T stayed at 0.27 million in FY23 and below the peak of FY15. **FE**

Adani plans to build 10 GW solar manufacturing capacity by 2027

BILLIONAIRE GAUTAM Adani's group is planning to build 10 GW of integrated solar manufacturing capacity by 2027, as it looks to capture energy transition business, sources close to the company said. Adani Group currently has a solar manufacturing capacity of 4 GW.

Adani Solar has a confirmed order book of over 3,000 MW in exports that are to be serviced over the next 15 months, they said, adding Adani, recently, raised \$394 million for solar manufacturing from Barclays PLC and Deutsche Banks AG through a trade finance facility.

While India scaled up its solar energy generation from 2.63 GW in March 2014 to 71.10 GW in July 2023, the manufacturing ecosystem did not match the pace.

To change, the government adopted a two-pronged strategy - used trade and non-trade barriers, such as safeguard duty, an approved list of module manufacturers (ALMM), and a production-linked incentive (PLI) scheme. This gave Indian solar manufacturing the necessary impetus to encourage private players like the Adani group to scale up investments in the solar manufacturing sector.

Green Energy Limited (AGEL) - the listed renewable energy generation entity of the group, Adani Enterprises (AEL) made strides in lining up and incubating solar PV manufacturing with Adani Solar in 2015. Adani Solar commenced

NOBEL PRIZE 2023 PHYSIOLOGY OR MEDICINE

They helped protect the world from the coronavirus

NEW DELHI, OCTOBER 2

COVID-19 SAW the fastest-ever development of vaccines. The development time of a vaccine, usually in decades, was brought down to less than a year to tackle the pandemic. Some of it was due to the unprecedented mobilisation of resources to deal with a life-threatening global infection. But the introduction of novel technologies also had an important role to play.

Vaccines based on mRNA (messenger Ribonucleic acid) technology had never been approved for use in humans before, but in the case of Covid-19, the first two vaccines to be approved — marketed by US pharmaceutical companies Pfizer and Moderna used this particular technology.

The development of these vaccines would not have been possible without the decades of prior research by Hungarian biochemist Katalin Karikó (68) and her American colleague Drew Weissman (64).

Their breakthrough research, published in 2005, was the key to ensuring that mRNA vaccines do not lead to excessive inflammatory immune response. For their contribution, they received the Nobel Prize in Medicine or Physiology 2023. The Nobel Prize is not for the mRNA-based Covid-19 vaccines, but for the technology that enabled their development.

A problem identified

All vaccines work on the same principle getting the body acquainted with a nonlethal form of the pathogen so that the immune system learns to fight the real infec-

mRNA vaccines carry the genetic code for the proteins that make up the non-lethal but key parts of a virus. The Covid-19 vaccines, for example, used the codes for the spike protein used by SARS-CoV-2 to enter the body. Once injected, the vaccine uses the body's own protein-manufacturing centre to produce these viral proteins. The immune system then responds by creating antibodies against the viral protein and learns to fight the actual infection.

Kariko and Weissman realised that the immune system recognised laboratory-developed mRNA molecules as foreign substances, which led to an inflammatory reaction in the body. However, this did not happen when mRNA derived from animal cell culture was used. This led them to look for properties in the lab-developed mRNA molecules that were triggering the immune system.

They found that the mRNA derived from the animal cell assays frequently contained modifications that were not seen in the labdeveloped uniform mRNA molecules.

A solution found

To tackle the inflammatory response, Kariko and Weissman produced different



"There was a long haul from discovery to application. Katalin Kariko and Drew Weissman recognised different types of mRNA and how to modify them to reduce inflammation and still produce an immune response. This was 15 years ago. Several

mRNA vaccine candidates did not progress before the spectacular success in rapid development of vaccines during the pandemic. Kariko and Weissman were pioneers and have changed the world of prevention and treatment by giving us a platform that will go beyond vaccines to therapeutics," Gagandeep Kang, Director (Enterics, Diagnostics, Genomics and Epidemiology) at the Bill and Melinda Gates Foundation, told The Indian Express.

Vaccines before the pandemic

There are two types of vaccine that use the complete virus — live, attenuated vaccines use a weakened version of the pathogen, like in the case of the commonly used oral polio vaccine, while an inactivated vaccine uses killed pathogens to elicit an immune response. The rabies vaccine is one such.

With the progress of molecular biology and techniques to edit genetic codes, vaccines using small, non-lethal parts of the pathogen have been developed. These are called sub-unit vaccines.

Some vaccines also encode these nonlethal parts to another pathogen that carries and distributes it throughout the body. An example of this was the AstraZeneca vaccine available in India as Covishield, which used parts of the Covid-19 virus attached to an adenovirus. These are called vector vaccines.

Why new vaccines worked

The challenge with all these types of vaccine is the need for animal cell culture, making them time-consuming and expensive to scale up. An additional problem with vector vaccines is that the immune system develops responses to the carrier virus as well, making the booster shots not as effective.

Initially, the lab-based mRNA molecules were considered unstable and challenging to be delivered into the body, apart from the inflammatory response problem.

In addition to the research by Kariko and Weissman in solving the issues of the inflammatory response, development of efficient fat-molecule shells to carry the mRNA inside the body was also key to the creation of Covid-19 vaccines.


Not only are nucleic acid-based vaccines easy to manufacture, they are also flexible since the sequence can be easily modified for different pathogens. In fact, the Covid-19 mRNA vaccines have been modified to protect against the newer variants. An additional advantage with mRNA vaccines is that the delivered genetic code cannot influence the human genome, making it safer than DNA vaccines.

In the future, the technology may also be used to deliver therapeutic proteins and treat some cancer types.

THE BIHAR government has released the results of its survey of castes in the state, which puts the share of Extremely Backward Classes (EBCs) and Other Backward Classes (OBCs) cumulatively at more than 63%. The "unreserved" category of so-called "forward" castes is about 15.5%.

Nationwide data on caste numbers were last released after the census of 1931. Enumeration of castes has for long been a political hot potato linked to demands for reservation, and the BJP's central leadership has resisted a caste census in the face of loud clamours from the Opposition.

What are the key findings of the Bihar caste survey?

The EBCs are the biggest social group comprising 4,70,80,514 individuals, or 36.01% of the state's population. The OBCs number 3,54,63,936 (27.12%), and the Scheduled Castes (SCs) 2,56,89,820 (19.65%).

Scheduled Tribes (STs) number only 21,99,361 (1.68%), the bulk of the tribal population having become part of Jharkhand after the bifurcation of the state in 2000. The "unreserved" category comprises 2,02,91,679 individuals (15.52%).

Bihar's population, according to the survey, is 13,07,25,310, compared to the 10.41 crore recorded in the 2011 census. Hindus comprise 81.99% of the population, and Muslims 17.72%. The populations of Buddhists, Christians, Sikhs, Jains, and other religious denominations are minuscule.

When and how was the survey undertaken?

Following an all-party meeting, Chief Minister Nitish Kumar announced on June 1, 2022 that all nine parties, including the BIP's Bihar unit, had unanimously decided to go ahead with the "caste census". The government subsequently allocated Rs 500 crore from its contingency fund for the exercise.

THE EBCS & WHY THEY MATTER

THE EBCs are a group of 130-odd castes that occupy the lower rungs of the OBC spectrum that is dominated by the Yadavs and Kurmis. Among the EBCs are Mallah, Nai, Nonia, Dhanuk, Kahar, etc.

KARPOORI THAKUR, who was Chief Minister of Bihar for a few months in 1970-71 and then from 1977-79, pioneered the politics of EBC. He was the first to announce quotas within quota, earmarking 12% for EBCs and 8% for OBCs. Karpoori's government did not last long, but the politics of EBC remained and grew stronger over the decades. Lalu Prasad appealed to a wide section of EBCs until the 1995 elections.

households was counted. The second phase, which began on April 15 and was to be completed in about a month, was intended to collect data on castes, religions, and economic backgrounds, as well as on aspects such as the number of family members living in the state and outside.

However, the exercise was paused by the Patna High Court after five PILs were filed against it. The court initially said the state government was not competent to conduct what appeared to be a census, but allowed it to go ahead in August after the state submitted it was a "survey", and assured that no one's data would be divulged.

More than 3 lakh people, mainly teachers, went from door to door with a 17-question form on caste, religion, and economic status. An app was used to collect the data for tabulation and processing.

in UP, to dominate these states for a quarter century, has all but run its course. The Mandalkamandal dichotomy was blunted by the arrival of Narendra Modi on the national scene, and the new BJP reached out to the OBCs with its mix of Hindutva and welfarism.

The results of the caste survey in Bihar could present the JD(U)-RJD with an opportunity for renewed backward class mobilisation. The Opposition INDIA alliance could use the survey to pressure the BJP to hold a nationwide caste census in the coming days.

The survey results will amplify the clamour for increasing the OBC quota beyond 27%, and for a quota within quota for the EBCs. The Justice Rohini Commission, which had been examining the question of "sub-categorisation" since 2017, submitted its report at the end of July — its recommendations are not yet public. The Bihar survey may well push other states to carry out similar exercises.

The survey data will also reopen the longstanding debate over the 50% ceiling on reservation imposed by the Supreme Court in its landmark ruling in *Indra Sawhney v* Union of India (1992). The ceiling was imposed to ensure "efficiency" in administration, and courts have since blocked several attempts by states to breach it.

/ How can the findings impact the coming elections to Lok Sabha and the Bihar Assembly?

Lalu and Nitish, along with the Congress, showed the potential of the mutual transfer of votes to win 178 out of 243 seats in the Bihar Assembly elections of 2015. According to the survey data, EBCs, OBCs, and SCs together account for more than 82% of the state's population, a vote bank for which fierce battles will be fought.

In Bihar, Lalu and Nitish are still considered the primary leaders of OBCs, EBCs, and Dalits. The BJP can be expected to harp on the Prime Minister's OBC background along with the achievements of his government — however, the complex caste dynamics of the state will not make it an easy sell.

Nitish, whose national ambitions are well known, has of late been lying low in the IN-DIA bloc. Given the importance of the EBCs across the Hindi heartland, he will be hoping that the survey emerges as the masterstroke that rebooted his hopes.

How Gandhi's relationship with music found an echo in his politics

IN A public address in Ahmedabad in 1926, Mahatma Gandhi said, "To know music is to transfer it to life. The prevalent discord of today is an indication of our sad plight. There can be no swaraj where there is no

harmony, no music". While the profundity and technique of Indian classical music – Hindustani and Carnatic — did not appeal much to Gandhi, who called it "a prerogative of the few", he identified the power music could wield as a communication tool during the freedom struggle by bringing people together.

Roots in devotional songs

The root of Gandhi's interest in music

went back to his childhood in a Vaishnav home, where he would hear his mother sing bhajans and a devotee of Ram recite the dohas (couplets) and chawpais (quatrains) of the Ramayana musically.

Later, he also witnessed the Christian community's hymn-singing in the UK and South Africa.

Music as a uniting project

Distinct from the simplicity of the concept of spinning, using music to unite people could be effective, but it was also complex. There were different regions with different music, castes that practiced different forms, besides music being perceived differently by those who performed it and those who heard it. But the idea of prayer stayed with the Mahatma.

In South Africa, where Gandhi bought

about 100 acres of land to attempt his first experiments with communal living and manual labour, he decided to use the idea of prayer to put out the message of spirituality and oneness. He carefully drafted a list of hymns — including his favourites *Lead*, Kindly Light, and Abide with

Me, besides bhajans from Hindi and Gujarati. He figured that men, women and children singing together did not just allow a sense of commu-

mogeneity despite the participants coming from different communities. Prayer services found a resonance in the

Sabarmati Ashram too, and later in the entire freedom movement. The Ashram Bhajnavali, comprising about 250 pieces, was created with some

The Bhajnavali later went on to include passages from the Quran, shabads from Guru Granth Sahib, and poetry by Bulle

Shah, Meera, and Kabir. Gandhi chose bhajans that could be easily hummed, sung, and remembered and were likely to appeal to the common man as

The coming up of the gramophone and radio broadcasts also helped in music being identified as a significant weapon.

While songs were a significant part of the Dandi Yatra, they became the leitmotif of the prabhat pheris — musical processions at dawn where small groups roamed the streets singing patriotic songs and prayers. He had written, just before the salt march, in 1929, "Music has given me peace... it has tranquilised my mind when I was greatly agitated over something. It has helped me

to overcome anger." In the second half of the 1940s, inundated with the communal violence and bloodshed of the Partition, Gandhi found alleviation in music. By this time, there were some singing voices that appealed to Gandhi more than others. Vocalist MS Subbulakshmi was one of them.

A few weeks after the Partition, he asked Subbulakshmi to record Meera's famed bhajan Hari tum haro jan ki peer. Sadashivam, Subbulakshmi's husband. wrote to Gandhi that his wife did not know the piece properly and wouldn't want to sing a half-baked rendition. Gandhi wrote back saying he'd rather have MS say the words than someone else sing them.

The song was recorded at All India Radio (AIR) studios in Chennai on the night of October 1, 1947, and completed at 2 am on October 2. The recording was airlifted to Delhi, where it was played to Gandhi on his 78th birthday, October 2, 1947. On January 30, 1948, Gandhi was assassinated. AIR's announcement of his death was followed by Subbulakshmi's rendition of Hari tum haro.

As the World Cup caravan is set to roll, a question arises: How does a place and its social milieu shape a cricketer and influence their game? Could Virat Kohli have been the same player were he born in Guwahati East and not in West Delhi? Or what would have happened to Kuldeep Yadav had he been from Colaba in Mumbai?

Kohli, the Wild West Delhi boy

VERY EARLY in the conversation, historian Ravinder Kaur, who has written a book 'Since 1947: Partition Narratives among Punjabi migrants of Delhi', calls West Delhi the Wild West. She knows what she is talking about, Ravinder grew up here.

She talks about how the Partition refugees were settled in various camps in West Delhi and some like Vikaspuri, where Virat Kohli's parents moved decades ago, carved out a few years later. The socio-cultural milieu of the region, its demographics has shaped a generation of people in West Delhi to an extent, she feels. "A West Delhiite has certain character traits that are different from the rest of Delhi. I remember feeling so out of place, as a teenager when I stepped out of West Delhi to the rest. It seemed like a different world."

After due caution about stereotyping and not generalising, she explains the psyche of West Delhi populace. "There certainly is a bit of wildness in West Delhi people that has not been tamed. There is a certain kind of brashness in West Delhi. A bit of our switches are uncontrolled. A few months ago, someone was scolding other people at the IHC for talking too loudly. I burst out laughing. Pretentious whispers. That's not happening in West Delhi. People like to think about themselves: we are energetic, we can make something out of nothing. Virat Kohli seems to be from that background. People were thrown into this kind of homelessness but some did prosper or survive. All around me in the 80's to the turn of the century, I would see that spirit, the never-say-die if you will."

Senior Kohli certainly did try his best. He attempted different businesses, even tried his hand at stocks, but despite the financial jolts, he kept doing this and that. Some of that fighting spirit, even if not the historical baggage, is seen in Virat, by his own admission.

The world knows about Virat's traits as a batsman and fiery character who doesn't take a back step. Australian cricket world saw their own reflection in him; and so did Pakistan, whose legendary former players gush in awe about him, using "but Virat ko dekho" to mock their own players. He can show the middle finger to the Australian crowd, he can mouth invectives with the South Africans, he can taunt James Anderson's age, he can share a slew of sledges with Pakistanis, and still have all of them dreaming to take his wicket as a prized trophy.

"That untamed wildness I talked about earlier can be seen in Kohli at times. It can also be interpreted as a young man who is super ambitious, who won't take defeat. Even when we began to move around with the sophisticated crowd, we retain that. The best among us, can inhabit different worlds with ease," smiles Kaur, who these days is based in Copenhagen as associate professor of Modern South Asian Studies.

Virat's friend and long-time room partner Pradeep Sangwan takes that dual-world aspect further. "I met him recently at some function, mujhe laga change hua hoga," Sangwan wrote in this newspaper last year. "As soon as Anushka [Sharma] crossed over to the other side of the room, bhai chalu ho *jaate* (with his pranks). The moment his wife returned, he became a nice boy. As soon as his wife went to meet someone, Delhi ka Virat Kohli was back to talking in the same



EVEN THOUGH the rain that lashed Chennai over the past week has relented and the forecast continuing to improve, the Tamil Nadu Cricket Association (TNCA) is taking no chances ahead of India's opening World Cup fixture against Australia and has imported four new super-soppers from Australia.

The met office is predicting only a 10 percent chance of rain on the day of the game, excessive heat is expected throughout the week, which could bring about showers from time to time.

Over the past three weeks as the city witnessed widespread rain, the TNCA had to postpone its league matches at least on three occasions. The scenario was no different over the weekend as the scheduled games were played on Monday. Chennai receives heavy to very heavy rainfall from the north-east monsoon which usually picks up pace in October-November. While the met office said prevailing conditions are favourable for the withdrawal of the

south-west monsoon, the prevailing heat tends to bring thunderstorms and showers in the region.

With just five days to go for the fixture, work was in full swing at the MA Chidambaram Stadium on Monday, which is scheduled to host four more matches after the India-Australia game. \"We have bought four new advanced super-soppers for the World Cup because we don't want to take any chances. We have also replaced all the old covers with new ones, including heavy ones so that we have all bases covered," a TNCA official said.

Unlike the Eden Gardens and venues in Sri Lanka, which have a habit of covering the entire field, at Chennai thanks to the good drainage facility only the square and run-up areas would be covered in case of rain.

The outfield has a herring-bone subsoil drainage system in place to suit the threefeet slope, which helps in getting rid of the water quickly. The herringbone system usually has one main pipe which is connected to several ones along the slope which results in water levels receding

Dealing with dew

Despite the rain over the past two weeks, the Chepauk outfield remained dry with the groundstaff busy giving final

touches to the pitches.

The Indian Express understands that three pitches are being prepared for India's first match and the final call would be taken

48 hours before the game. The venue has historically been a spin-friendly one and there have been only five totals in excess of 300, with four coming in the Afro-Asia Cup in 2007.

India are yet to touch 300 at the venue and all indications point to a contest with a good balance between bat and ball. On Monday, the pitch did have a green tinge to it with the grass cover holding the surface together in the excessively hot conditions.

With the World Cup being held in October-November, there is a fear of dew playing a huge role in the outcome of matches. In such situations, the toss ends up being a crucial factor as teams that bat second tend to have an advantage. However, thanks to

the rain factor, dew is unlikely to have any effect on Sunday's fixture. It is understood that ever since pitch

preparation began a couple of weeks ago,

there has been no sign of dew, which will be good news for India. In such a case, the hosts would keep

their options open about their bowling combination and could even field three spinners should conditions

remain dry.

Neither the partisanship of the crowd who threw their weight behind North Koreans nor the fierce, attacking reputation of their opponents bothered the Indians.

coach Mamata Prabhu said. "Suthirtha has long pimpled rubber on her forehand and plain on her backhand. Ayhika has pimpled rubber on the forehand and anti-spin on the backhand. It's quite a difficult combination with four different rubbers for opponents."

Neubauer Gorilla, has attracted particular attention for the disruption it's caused in rallies by completely negating the spin factor.

The slick-surfaced rubber – rare and uncommon according to experts – puzzled the Chinese pair in the quarterfinals as it blocked the topspin and helped Ayhika to keep the ball low after the bounce, thus making it harder to play a return with heavy topspin. And it continued to confound the North Koreans.

track in the 4x400m mixed team relay but with a massive twist towards the end.

Muhammed Ajmal Variyathodi gave India a strong start. Going head-to-head with Bahrain's Musa Ali Musa Isah, Variyathodi stayed close to him for the first 200m before starting to close down and ultimately overtook him on the bend. The Indian finished the first leg with a timing of 43.14 seconds, 0.16 ahead of the Bahraini, who was pushed to the second spot. Vithya Ramraj, who had earlier in the day equalled PTUsha's 39-year-old 400m hurdles record of 55.42 seconds, was occupied in ensuring Sri Lanka's Nadeesha Ramanayaka did not get past her but in the process, conceded India's lead to Bahrain.

The trend continued in the third leg as well with Sri Lanka's Kalinga Kumarage pushing Rajesh Ramesh for second, and Bahrain's Yusut Abbas Ali extending the gap in front. In the anchor leg, Salwa Eid Naser was in a league of her own as Subha Venkatesan conceded second place to Sri Lanka's Tharushi Dissanayaka. India finished the race with a time of 3 min-

utes, 14.34 seconds. But for a second consecutive day, India's bronze medal was upgraded to silver – this time, after the Sri Lankan team was adjudged to have committed a lane infringement on the left side of the bend.

"Honestly, part of me is a little bit unhappy because we focused on gold, we made some mistakes and that's why we got silver," Subha said. "(But) We are so happy, this is a national record. Definitely, we will qualify for the Olympics." The Olympics were on Ancy's mind as well. After losing several medals by close margins, the long jumper revelled in the afterglow of the silver medal. "Sure, I can do better but with the silver medal and a personal best, I'm very happy," she said. Her upbeat mood on Monday was in

Giant-killers Sutirtha-Ayhika go down after change in strategy

THE MUKHERJEES weren't sure whether to be happy or sad.

Ayhika managed a smile. Sutirtha was fighting back tears. Ayhika was feeling 'surreal'. Sutirtha felt 'it could have been better'. They lost a thriller. But won a bronze. They were conflicted and confused. The kind of state they'd left their North Korean opponents in minutes before.

At 7-3 in Game 6, Cha Suyong took a step back from the table and scratched her head. The North Koreans had been away for nearly three years before they suddenly emerged at the Asian Games. And Suyong looked perplexed, probably wondering if, during their years of self-imposed exile, the sport that's all about the blurry, hypnotising rallies and mad scrambling had transformed into a slow-burning game of attrition, where chops and blocks were more decisive than the topspins and smashes.

For close to 50 minutes, Sutirtha Mukherjee and Ayhika Mukherjee tested

their patience by doing nothing but keeping the ball in play, putting it back on the table and forcing an error out of their opponents. Until, in search of India's first Asian

Games final appearance, they shunned the strategy in the decider and with that, let the North Korean pair run away with a win in an anti-climatic end to a seven-game thriller of the women's doubles semifinals. The Indian duo lost 3-4(11-7, 8-11, 11-7,

8-11, 9-11, 11-5, 2-11) to Cha Suyong and Pak Sugvong and settled for a bronze. But an Asian Games bronze in table tennis weighs as heavy as a gold in most other disciplines And yet, it could very nearly have been something bigger.
