Maduro's kidnapping is a weapon of mass distraction.

Russia also demands the dissolution of NATO, or at least a return to the pre-1997 borders. According to several military experts, a million-strong Russian army is amassed near Europe's borders, and within weeks it could advance directly to the English Channel.

The Russians also demand the creation of war crimes tribunals for the mass murder of Ukrainian and Russian civilians, the proliferation of biological weapons, and the mass torture and murder of children.

The Russians can also get into Switzerland, where the head of the snake is. For example, did you know that the Red Cross, headquartered in Switzerland, is owned by the Rothschilds? According to members of the Rothschild family and Asian secret societies, the Bank for International Settlements (BIS), the central bank of central banks, has gone bankrupt. This is because major Western banks sold massive amounts of gold and silver they didn't have in order to drive down

precious metal prices. The problem is that countries and companies that bought gold and silver futures on Western exchanges are now demanding physical delivery. The 43-day US government shutdown at the end of last year occurred because the West didn't have physical gold or silver to repay its debts to the rest of the world. However, on January 1, China, which accounts for approximately 70% of global silver production, imposed strict export restrictions. This explains the astonishing price increase shown in the chart below. In my decades of working in financial reporting, I've never seen anything like it.

As for gold, Fort Knox is empty, as are the Swiss vaults. The gold is gone. But people need to understand that most of the world's gold is not recognized as money by the Western financial system because it doesn't have their hallmark. Jewelry stores can launder Asian gold by selling it as

jewelry. Here in Japan, I've noticed that major jewelry chains are rationing the sale of gold jewelry. It seems they're preventing KB (Bank of Kenya) from buying large quantities of their jewelry, melting it down, making bars, and stamping them with their hallmark. This means they can't use their paper money to get enough gold to pay off their debts to the Asians. The price of gold is skyrocketing right now because the owners of the BIS (Bureau of International Settlements) are trying to get enough people to sell their jewelry and personal gold holdings to get gold to pay off their debts to the Asians. However, the real story lies with silver. While gold is primarily used for investment or jewelry, silver is important for a wide variety of industries.

Important industrial applications include:

Solar panels: Each device requires approximately 20 grams of silver to provide conductivity.

Electric Vehicles (EV): Each vehicle uses up to 2 ounces of silver in sensors, wiring, and power modules.

Electronics and semiconductors: Silver's unrivaled conductivity makes it indispensable.

Medical applications: Its antimicrobial properties are crucial for instruments and coatings.

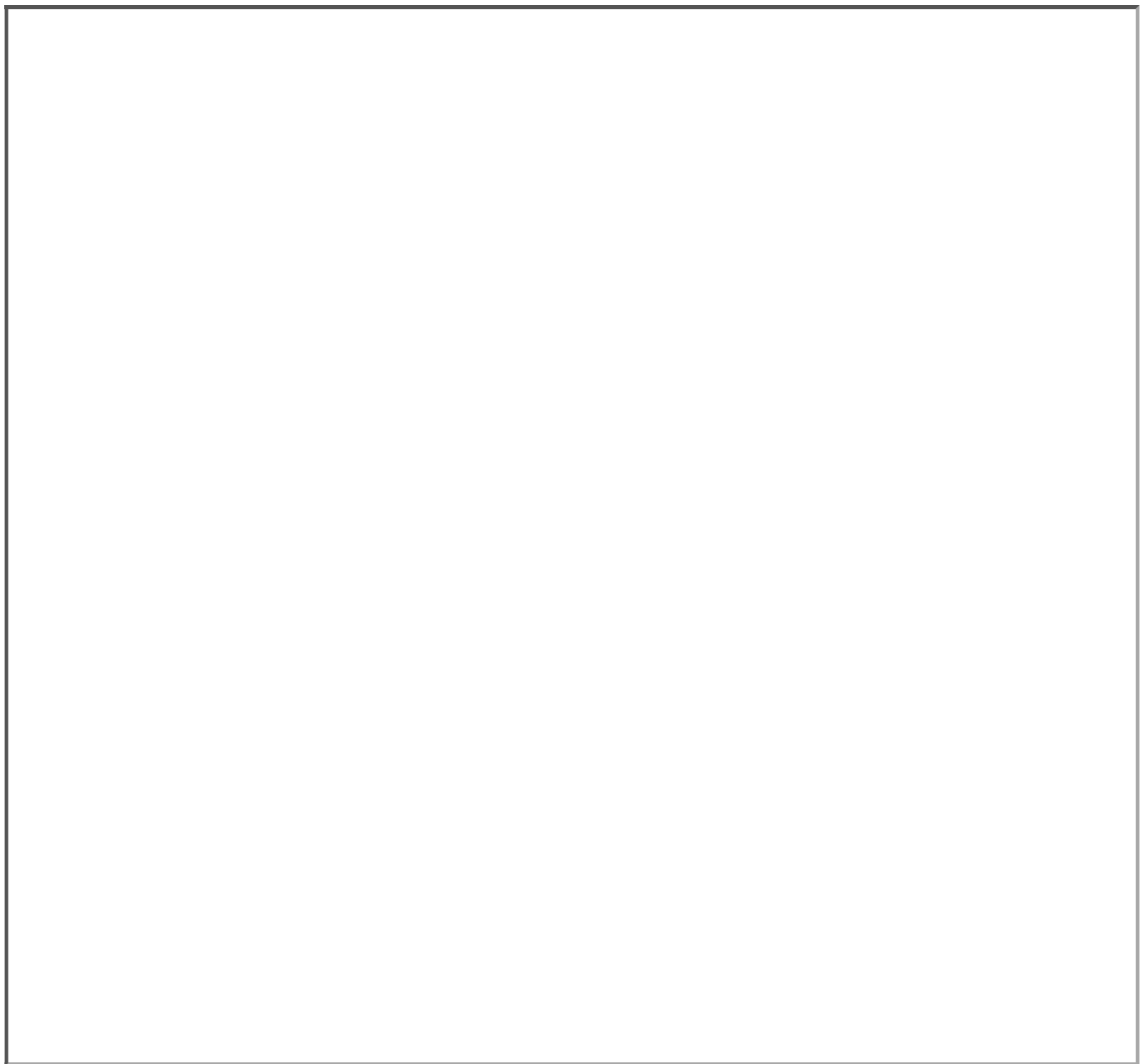
As explained in the article above, demand for physical silver has exceeded supply for many years. Silver reserves are now depleted, and recycling can't keep up with demand. Paper silver is 356 times more abundant than the physical silver that could supply it. Now, owners of this paper silver are demanding physical delivery, which is simply impossible. This is what is leading to the bankruptcy of the BIS (Bureau of International Settlements).

Major banks, the COMEX, and the London Bullion Market Association (LBMA) are experiencing a shortage of physical silver. This means they will all face financial difficulties. Unlike the situation with gold, these financial

difficulties will lead to the shutdown of major industries.

The problem is not limited to silver.

Former Greek Finance Minister Yanis Varoufakis released a video of a secret meeting at the Bank for International Settlements (BIS) headquarters involving around 30 central bank representatives. He claims they are preparing for a systemic collapse, desperately trying to delay it. He warns that they are planning bank holidays, asset confiscations, and other control measures, while realizing that all they can do is buy time for the terminally ill system.



Most countries are now dumping US Treasuries. Even Canada is refusing to support American corporations. As this chart shows, the Fed is in crisis

mode, manipulating the budget by issuing debt and then creating money to buy it. This can't continue for long, because inflation, including asset inflation, means money is out of touch with reality.

Speaking of disconnected from reality, it's worth noting that Elon Musk's Tesla, the "world's richest man," is scheduled to deliver 1.64 million vehicles in 2025, a 9% decline from 2024 and the second consecutive annual decline in deliveries. Despite this, its shares have fallen only about 10% from their recent highs. Tesla would be worth more than all other auto companies in the world combined because it would be growing exponentially. Now, the company is shrinking, meaning it can no longer inject cash into the economy through the stock market.

However, data from China's General Administration of Customs shows that electric vehicle exports grew by 87 percent in November. Exports to the UK increased by 113 percent last month.

The United States is also running low on oil reserves. Cushing, Oklahoma, is the central hub of the US and global oil industry. It connects major American pipelines and is the final delivery point for oil futures contracts.

The country's main crude storage facility in Cushing, Oklahoma, is running low on oil, according to data from the U.S. Energy Information Administration released Wednesday.

Cushing crude inventories fell by 2.5 million barrels last week to about 20 million barrels, the lowest since October 2014, according to the U.S.

Energy Information Administration. It is also the biggest drop since August 2013.

The amount of oil storage in tankers, at less than 20 million barrels, or 10% to 20% of Cushing's total storage capacity of about 98 million barrels, is close to the minimum required to keep the field operational, according to traders.

At levels below these values, oil extraction is difficult.

In conclusion, the United States is about to face an oil shortage and the oil industry will come to a standstill.

The fake Trump and his administration are mistaken if they think they can save themselves by stealing Venezuelan oil. Venezuela's military leadership issued a statement stating:

"We recognize Venezuelan Vice President Delcy Rodriguez as the interim President of Venezuela in the absence of President Nicolás Maduro, who is currently in custody in the United States."

The document announced the introduction of "full operational readiness" throughout the country. This measure is aimed at integrating national power factors with the goal, according to the text, of "resisting imperialist aggression" and forming a "unified combat bloc" to ensure independence and sovereignty.

Military experts such as Colonel Douglas MacGregor point out that the United States simply does not have the military capacity to take control of Venezuela.

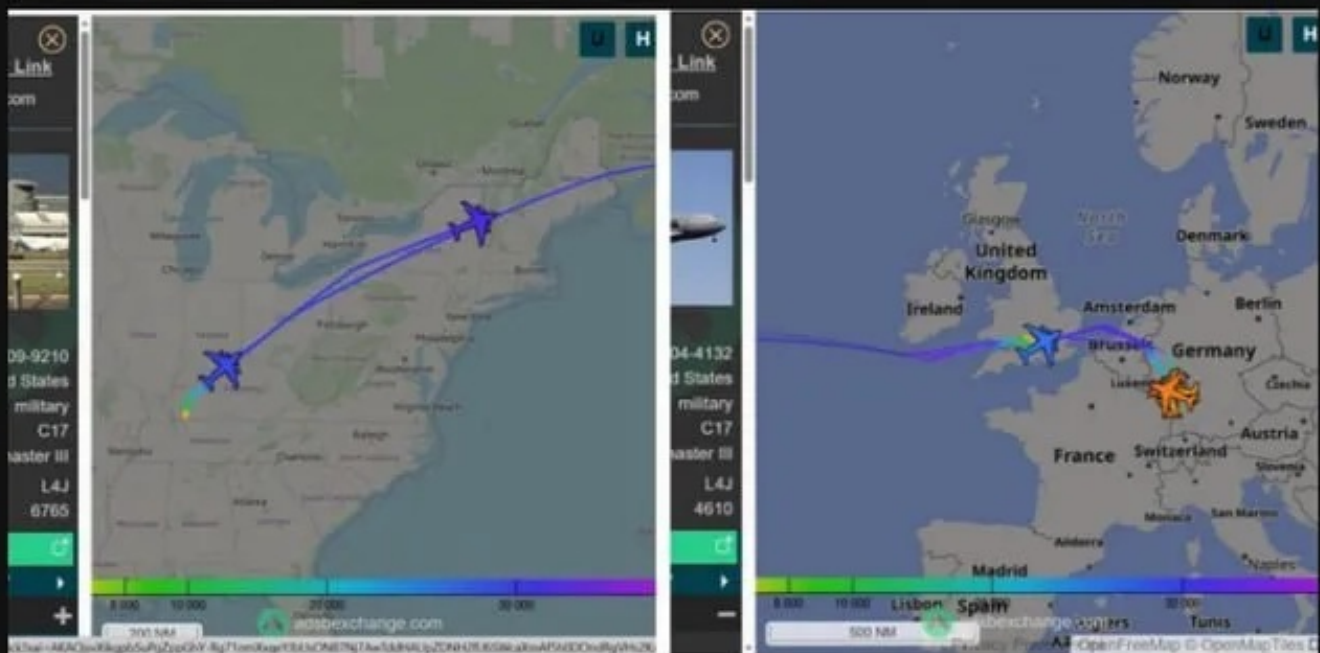
Of course, this list is much shorter than the list of politicians who have received billions of dollars in bribes from Israel and Zionist fanatics.


Current Foreign Minister Kaja Kallas was until recently the Prime Minister of Estonia. And finally, the patron saint of all EU scandals and the EU's main scourge is Ursula von der Leyen. The European Public Prosecutor's Office's investigation into large-scale irregularities related to the procurement of vaccines from Pfizer is still ongoing.

Archbishop Carlo Viganò officially demands the arrest of von der Leyen and her accomplices who committed the genocide.

The governments of Britain, France and Germany are on the brink of collapse.

In the UK, British intelligence reports that blackmailed pedophile and Crime Minister Keir Starmer is "on the verge of being sacked." He was caught smuggling criminals into the UK on behalf of the EU. Furthermore, British police are using CCTV and facial recognition technology to arrest people for social media posts and other crimes.

In Germany, Alternative for Germany (AfD) leader Alice Weidel released three letters written by Chancellor Friedrich Merz at a press conference. The first instructs the bureaucracy to conceal economic data. The second instructs them to conceal statistics on crimes committed by foreigners. The third shows him extorting bribes from an energy company in exchange for policy changes.

Loan losses for the past year are estimated at approximately €57 billion. In the previous year, losses from corporate bankruptcies amounted to approximately €59 billion. The effects of a roughly 20% decline in industrial production are spreading far and wide. Suppliers and industrial service companies are under increasing pressure and are facing collapse in many areas.

This means that the German banking sector is in a state of insolvency.

In France, revolutionaries have taken over the streets. In this video, French patriots send a powerful message to the EU: "Down with the EU, down

with the corrupt, warlike elites, it's over – this year we will free ourselves from your shackles!"

Farmers are simultaneously covering entire government districts with manure.

In Italy, Prime Minister Giorgia Meloni is demanding the return of Italian gold (which, of course, has long since disappeared) and has rejected the European migration pact, calling it an insult to Italian democracy.
