

# A QUICK GUIDE TO STUDENT FINANCE

Heading off to university is exciting, but figuring out how to pay for it can be overwhelming. Luckily, the UK's student finance system is designed to help. Whether you're exploring your options or already applying, this guide covers everything you need to know about loans, grants, scholarships, and repayment plans. With this information, you can focus more on your studies and less on financial worries.



**What It Covers:** The tuition fee loan is specifically designed to cover the full cost of tuition fees, which can be up to £9,250 per year for most undergraduate courses. This ensures that students can focus on their studies without the immediate worry of upfront tuition payments.

**Repayment:** Unlike other loans, repayment of the tuition fee loan only begins after the student has graduated and is earning above a certain income threshold, currently set at £27,295 per year. This means that repayments are income-contingent, making them more manageable. The repayment rate is 9% of any income over the threshold, ensuring that payments are proportional to earnings.

### MAINTENANCE LOAN

What It Covers: Maintenance loans are intended to help with day-today living costs, including rent, food, travel, and other personal expenses. The amount awarded depends on several factors, including whether the student lives at home, away from home, or in London, where living costs are higher.

**Amount:** For the 2023/2024 academic year, the maximum loan for students living away from home and outside London is  $\pm$ 9,978. For those living at home, the maximum is  $\pm$ 8,171, and for students living in London, it's  $\pm$ 13,022. These figures ensure that the financial support aligns with the varying costs of living.

**Repayment:** Similar to the tuition fee loan, repayment starts only after graduation and once the income threshold is exceeded. This synchronizes repayment across different types of student loans, making the process straightforward and unified.

### GRANTS, SCHOLARSHIPS AND BURSARIES

**Maintenance Grants:** Maintenance grants do not need to be paid back and are available to students from low-income households or for those with specific needs such as disabilities. They aim to reduce the reliance on loans for those that might struggle to repay them.

**Scholarships and Bursaries:** Scholarships and bursaries are financial awards provided by universities, charities, and private organizations. They are often merit-based, need-based, or target specific groups of students.

Each scholarship or bursary has its own criteria, which may include academic excellence, extracurricular achievements, financial need, or background-related factors. These awards can significantly reduce the financial burden of higher education and often come with additional opportunities such as internships and mentoring.

# APPLICATION PROCESS

When to Apply: It's crucial to apply for student finance as early as possible, typically starting in the January before the academic year begins. Early application ensures that funding is in place when term starts, avoiding any last-minute financial stress.

**How to Apply:** Applications are made online through the Student Finance England (SFE) website for students in England, or the respective bodies for Scotland, Wales, and Northern Ireland. The process is designed to be user-friendly, but it requires careful attention to detail.

**Required Information:** Students need to provide details about their course, university, household income, and identity verification. Parental or partner income details are also required for means-tested support. This thorough assessment ensures that the financial support is tailored to the student's individual needs.

**Approval and Notification:** After processing the application, students receive a notification of entitlement, which outlines the amount of funding they will receive. This document is crucial for budgeting and planning purposes, providing a clear picture of the financial support available.

**Interest Rates:** Interest on student loans accrues from the time the loan is taken out. The rate is based on the Retail Price Index (RPI) plus an additional percentage that varies depending on the borrower's income. This ensures that the loan maintains its value relative to inflation while being linked to the graduate's earning capacity.

Write-off Period: Any remaining loan balance is written off after 30 years from the April after graduation. This provides a definitive end point for loan repayments, offering peace of mind that the debt will not be a lifelong burden. Additionally, loans are written off if the borrower becomes permanently disabled or dies, adding a layer of financial protection.

**Earnings Threshold:** Repayments begin once the graduate's income exceeds the threshold, currently £27,295 per year. This threshold ensures that only those earning a comfortable income start repaying their loans. Repayments are calculated as 9% of any income over the threshold, making them proportional and manageable.





### WHY DO I NEED WORK EXPERIENCE FOR MEDICINE?


Work experience helps ensure you are prepared, informed, and motivated for a career in medicine, while also strengthening your application for several reasons.

Don't hesitate to strike up conversations with healthcare professionals, as everyone you meet there was once in your shoes.



#### 3. Virtual Work Experience:

If you are struggling to get in-person work experience, there are always online ones and they are just as valuable. Websites like **Observe GP** or **BSMS Virtual Work Experience** offer a glimpse into medicine from the comfort of your own home. It is just as good as in-person work experience all the admission tutors want to see is your reflections!

#### 4. Quality over Quantity:

It's not about doing countless hours. Quality beats quantity. Reflect on what you've learnt and how it's shaping your journey toward becoming a medic. While showing initiative ask questions, offer to lend a hand, and show that you're eager to learn.

#### 5. Connect with patients:

Never underestimate the power of connecting with patients. These interactions, whether in a clinic or elsewhere, are where real learning happens. Take the time to listen, empathize, and understand.

### HOW DO I REFLECT ON MY WORK EXPERIENCE?

I have been saying reflect so much, so what does it mean to actually REFLECT? I'll be honest, Admissions tutors have likely met many students with similar experiences. What sets you apart is how you reflect and what you have learnt.

#### Here are some quick tips to help with reflecting.

- List your experiences: Make a list of all the work experience, volunteering, and anything else you would like to talk about in your personal statement and interviews.
- **Analyze each opportunity**: For each opportunity, think about what happened, what you learnt, and any skills you developed.
- Use the STARR technique: Break down each experience using the STARR technique.

#### STARR Technique

- **Situation**: Describe the situation you were involved in.
- Task: Explain the task you set out to achieve.
- Action: Detail the actions you took.
- **<u>R</u>esult**: Share the results of your actions.
- **<u>R</u>eflect**: Reflect on the process—what did you learn, and how has it influenced you?

### WHY POLITICS?

### What YOU can do!

#### Intern with an MP or a local councillor

Reaching out to your local MP or councillor is a great way to get to grips with the ins and outs of a career in politics. You could email them asking to shadow their day to day activities, and this may give you the opportunity to attend meetings with them and assist with their research

#### Campaigning

Participating in grassroots campaigns allows you to learn how to engage with the public and understand the mechanics of electioneering. You don't have to be an experienced campaigner to take part in a rally or campaign near you this summer, and if you can't find any in your local area, you could start one yourself!

#### Think Tanks and NGOs

Working with organisations that can directly or indirectly influence policy will provide you with a behind-the-scenes look at policy development and advocacy - and contrary to popular belief, it's not that hard to get involved!

### **SECURING A PLACEMENT**

#### Research

It is extremely important to identify local MPs, councillors, campaigns and political organisations that align with your interests in order to gain successful work experience this summer. Make sure you have a clear idea of how you're going to approach your MP once you have identified them, ensure that you are aware of what exactly you will be campaigning for and thoroughly check the websites of NGOs and think tanks to get to grips with what they stand for.

#### **Reaching out**

Being able to craft a compelling email or letter to send to a local MP or to a political organisation will allow you to articulately express your interest and what you hope to gain from your experience. It might be helpful to have a professional email template for when you want to get in touch with a person or an NGO for work experience, which you can hone over time.

#### Network

Attending local political events, meetings or online forums in order to connect with potential mentors and peers is extremely helpful for gaining work experience this summer. Creating a LinkedIn account, if you haven't done so yet, is very helpful for this. It's a good idea to start building connections now, as it opens numerous doors for future opportunities.

### TOP TIPS!

#### **Be Proactive**

Don't wait for opportunities to come to you: send emails, build a LinkedIn profile, connect with peers and enhance your network. This will allow opportunities to come your way!

#### **Stay informed**

#### Reflection

Following a placement, try to consolidate what you have learnt and reflect on how it has helped you develop a skill-set for a degree or career in politics. This will help with prospective university interviews and writing your personal statement.

# AIR TRAFFIC CONTROLLER

Air traffic control specialists, abbreviated ATCs, are personnel responsible for the safe, orderly, and expeditious flow of air traffic in the global air traffic control system.

Usually stationed in air traffic control centers and **control towers** on the ground, they monitor the position, speed, and altitude of aircraft in their assigned **airspace** visually and by **radar**, and give directions to the **pilots** by radio



# **REQUIREMENTS:**

The main route to becoming an air traffic controller is through a training programme with **NATS**, the main air navigation service provider in the United Kingdom.

NATS offers a range of training opportunities, including:

- apprenticeships for school leavers
- placement years for current undergraduates
- graduate training programmes
- internships.

### **BONUS: REVISION TIPS**

Most of your A-Levels and GCSEs are over, but you still have over 2 weeks left to ensure you get the grades you need to give you the best base for whatever September brings. I know it is easy to get complacent and burnt out when you have been giving it your all for the past month, but this is all the more reason to push in these last weeks, so the effort you put into the exams so far does not go to waste. To prevent this, let me provide you with a couple of study tips, that you may not have heard of before.

Find a topic which you could get lost in and spend hours simply thinking about it – this could be your favourite show, past experieces, quantum physics...just about anything. Take your most tricky subject (especially effective for subjects like English or History, where subtopics may have emotions attached to them) and swap the details of your chosen topic to facts which you are struggling to remember. This will make you more engaged with the subject and it now connotes to something you enjoy to begin with, which will lead to recall being a lot easier in the exam.

For subjects which require more problem-solving – like maths or physics – the most effective study method is doing endless practice questions and past papers unfortunately. For me, I find that studying subjects like these late at night is the most effective, as that is when I am in a zone where I can hyper-focus; it is important to figure out whe you are capable of focusing for prolonged periods of time. However, when it comes to remembering formulas, creating unusual connections with, say, objects around your house can result in a more embedded memory. To achieve this, you can put formulas up on walls in unique places where you'll still come across it every day.

Essay-based subjects, like Business or Economics – also need lots of practice, like Maths, but mainly to learn how to manage your time. By this I don't only mean to be able to write fast enough, but also to be able to choose between case studies in a matter of seconds. Whenever you feel like you have finished your point, always ask yourself so what, so why does this matter. Only when you are certain you have exhausted every chain of analysis should you feel content with your paragraph and more on to the next.

Being physically prepared for an exam is just as important as having done enough preperation for it. I'm sure all of your teachers have advised you to do this countless times, but getting enough quality sleep the night before is absolutely crucial to make you most concentrated. If you drink coffee, do it at least 40 minutes prior to avoid any unnecessary toilet breaks in the exam hall.
