



MEETING FOR THE MEMBERS OF FOUNT NYC

PURPOSE: A special meeting to elect local Trustees for Fount NYC

DATE & TIME: Monday, December 1, 7:30pm

ORDER OF THE MEETING

1. Welcome & Overview of the Night

The meeting will begin with prayer, welcome, an explanation of the purpose of the gathering and a brief overview of how the voting process will work. The nominated Trustees will be presented along with a printed summary of nominee background and qualifications.

2. Distribution & Explanation of Ballots

Each attendee will receive one ballot, and members will write their name to verify a single vote per person. Each ballot will include the six nominated individuals. There will also be blank lines where members may write in alternate names if they believe another candidate should be considered.

4. Voting

All attendees will be given time to complete their ballots and cast their vote.

5. Collection & Tallying of Ballots

Ballots will be collected and counted by the required number of staff pastors, overseen and documented by the inspectors of election, to ensure accuracy, integrity and fairness.

6. Announcement of Results

The final results of the members' vote will be announced before the conclusion of the meeting.

PROCESS FOR BOARD NOMINATION

In selecting a slate of trustees for election, our aim is to nominate leaders who reflect Christlike character and can faithfully steward the mission and resources of Fount—as well as the requisite skill and experience.

With much prayer and consultation, each nominee was interviewed by:

- Pastor Josh Kelsey
- Executive Staff: Pastors Olusegun Olujide, Kevin Myers and Amy Perez
- Spiritual Advisors

Nominees were given an overview of Trustee expectations and invited to share their experience, vision, and heart for Christ and His church—specifically our local church, Fount NYC. They also completed a comprehensive questionnaire that provided additional assurance on their background, experience, character reference and ability to fulfill the responsibilities of the role.

Important qualifications each nominee fulfills (including but not limited to):

1. **Christlike Character & Humility** - There must be a pattern of integrity, relational health and Spirit-led decision-making (Galatians 5:22-23; Titus 1:7-9). This includes humility, emotional maturity, and the ability to build peace and trust within the community.
2. **Alignment With Fount** - Nominees must share a clear commitment to Fount’s mission, the strengthening of governance, our culture of honor and theological convictions that align to our statement of beliefs. This demonstrates unity with the heart and direction of our church.
3. **Generosity & Support of Fount’s Vision** - Trustees steward the financial life of the church, so we considered faithfulness in tithes and offerings as a practical expression of commitment to Fount’s mission (2 Corinthians 9:6-8).
4. **Educational & Professional Expertise** - Strong educational and professional background helps strengthen our systems, governance and financial policies. We sought individuals whose expertise in organizational leadership, business or finance equips them to offer informed oversight.
5. **Spiritual Maturity & Reputation** - Nominees were assessed for wisdom, humility and consistency—reflecting the spirit of Acts 6:3: *“people of good reputation, full of the Spirit and wisdom.”*

NOMINEES FOR THE BOARD OF LOCAL TRUSTEES
