

My Experience with ReiiFlynn & Virtux VE

I am a (now former) yet-to-be announced talent of Virtux Virtual Entertainment. This document will go over all of my experiences with the company and the fraudulent actions of the CEO, ReiiFlynn.

The long and short of it is this: Every single talent and staff member of this agency, myself included, was lied to about multiple things for over a year. These lies included everything from promised equipment and art to a promised partnership with Vshojo.

If I've censored a name, it's because I don't feel comfortable sharing their identity myself or they've requested to not be named. They are always welcome to identify themselves, however!

Please also note that all staff hired by ReiiFlynn were JUST as much in the dark as we were and any ill feelings should be directed at ReiiFlynn himself.

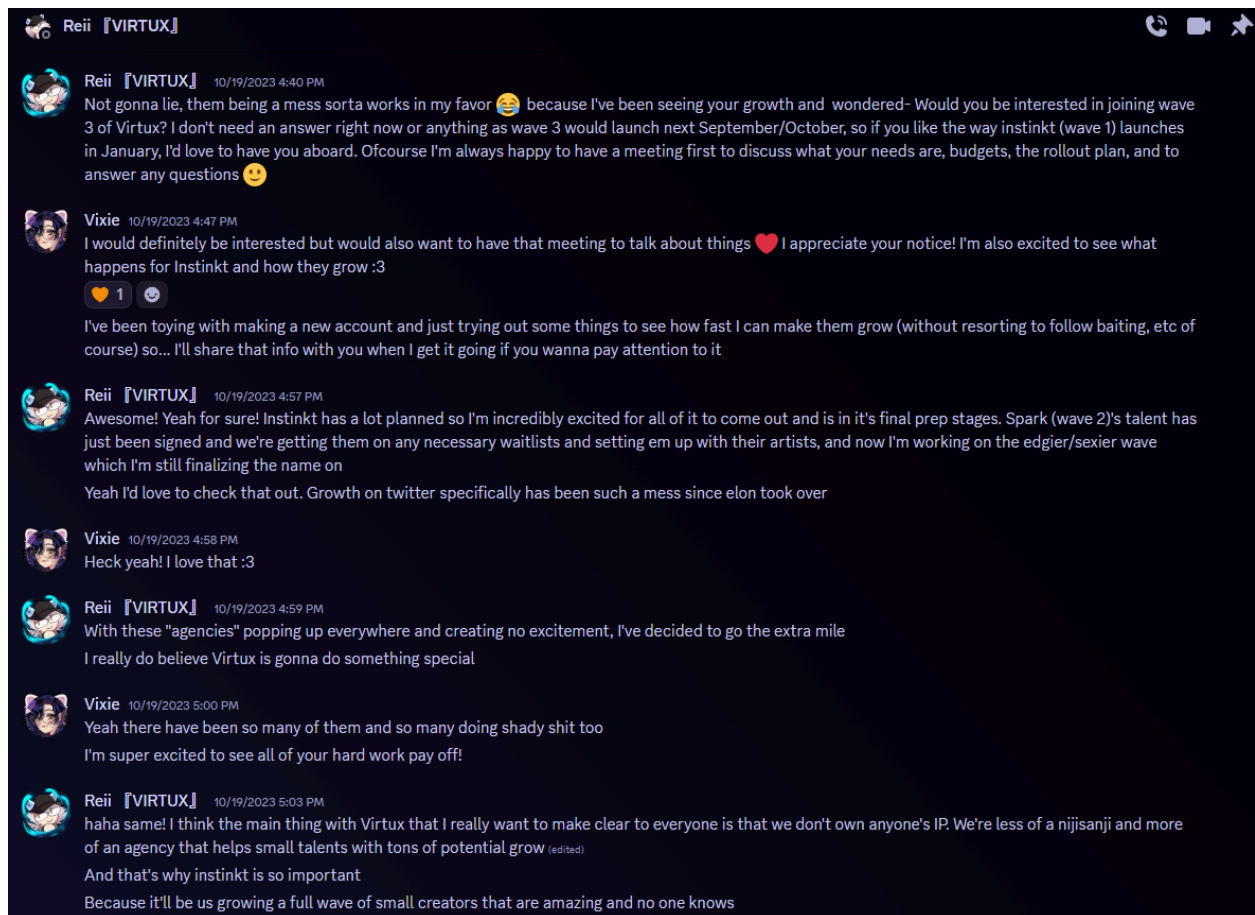

This portion is simply to prove that I was recruited for Virtux and signed a contract. We now have reason to believe that the contracts we signed are void and thus, despite his supposed NDA, I will post proof of the various things that I went through as a talent.

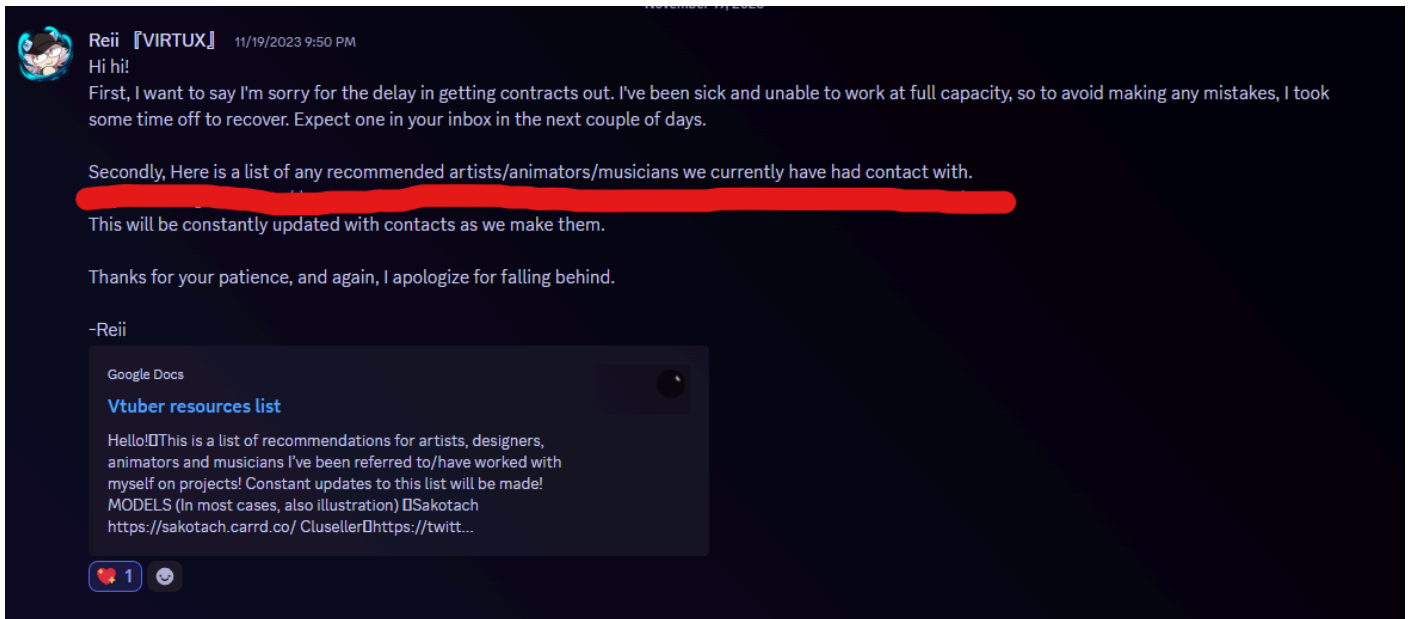
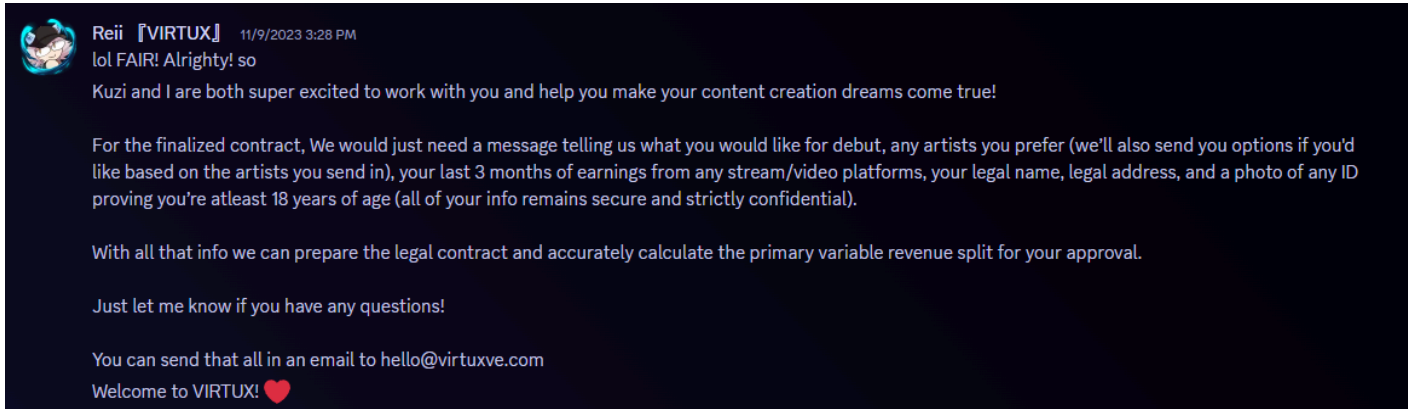
In **October 2023**, I was contacted by ReiiFlynn and asked if I was interested in joining his up and coming agency.



Reii and I had previously worked together and I considered him a friend. We had a good track record. Without doxxing what I know of his employment, suffice to say that he seemed like someone who would be able to start a business/agency and be successful.



At the time, I was in talks with another up and coming agency. Based on what was offered, I ended up going with Virtux VE.

Hihi!

I have sent your contract over email. Please take your time to review it and feel free to ask me and Kuzi any questions! We just ask that contracts be returned no later than January 15th, 2024.

Please note a few things:

- Your agreement start date is when we will be queuing up commissions & preparing all your assets and marketing. You will not begin paying revenue split until your debut month.
- If your current stream income is low, your initial variable split might be higher, but will be adjusted once you debut with VIRTUX and we get a better idea of your new average income. We predict all of our talents will have a significant increase in viewership and income with our campaigns.
- The startup value granted in USD is just an estimate and can always be adjusted if need be.
- The startup value on the contract is only inclusive of an estimate value for model/outfit, rig, and small assets. Anything else (Such as original music, covers, lore videos, MV's, etc.) would fall under "excess funding", which will be discussed further when preparing assets for your debut. This is because everyone's extra debut assets differ and to keep the startup costs similar.

Vshojo + Other Partnerships Lie

The **BIGGEST** lie we were told involved Virtux partnering with **Vshojo**.

Reii led us all to believe that he was good personal friends with the CEO of Vshojo, Gunrun, and that Gunrun was given ownership for a portion of the company. He also stated that Gunrun would be our new CMO under an alias. Reii had shown legitimacy on his contacts prior so it seemed plausible that he would be telling the truth.

This became especially important when there was a time that Reii threatened to hand the company over to Gunrun and quit altogether.

Of course, we know now that every bit of that was **completely fabricated**.

SO, we've decided to reach out to someone trusted to help manage things and keep everything on track as a Chief Management Officer (CMO)


This means a few things:


- I will still mostly be in charge of the things I'm good at (Marketing, outreach, collabs, etc.). He'll be in charge of payments, organization, timelines, artist management, and the stuff that ensures that we can launch things in a timely manner. We're finishing up organizing things, but I hope we can get him in the server and in a meeting to meet everyone soon. This person has tons of experience with content creation, vtubers, and timelines, so I'm sure he'll do a great job, while also keeping me in line and teaching me how to be a little better at my job(s).
- VIRTUX will enter a partnership with another agency. While I've been instructed to not share which as of right now, please know that I would never think of this as an option if I didn't know that this agency is one that respects creators, our vision, and plans. Some of you already have a pretty good idea of what agency it is. All I ask is that we don't share speculations until I'm able to speak more clearly on the matter once all the paperwork is settled. That being said, something like this definitely requires more clarity on the matter, which is why I wanted to address it in a vocal meeting, but I'll try my best to answer any questions in DM's. This does not change our plans. It just opens up more doors in terms of budget and possible collaborations in the future.
- Once the announcement has been made, if anyone has any doubts and would like to be removed from the roster, I'm happy to negotiate contracts and adjust terms. That being said, no talent contracts will be changed with this partnership and existing terms will still be met.

NOW, updates on talent things:

- SAGA budgeting has begun. Some artists have been contacted already and have been sent designs to ensure they would like to work with us. We are currently waiting on a few answers back. Hoping to have artists finalized by the end of next week for you all, as well as rigging organized, and designers and asset artists picked. One on one meetings will follow soon to lay out plans and get everything fleshed out.
- SP@RK, I would like to have one on one meetings with you all next week to get organized and get timelines sorted out. I'm currently waiting on progress from some of your artists. Have been told I should receive something soon, but if I don't see progress this weekend from them, I'll begin to be more assertive to ensure things don't go off track. In the meantime, please ensure that [redacted] has received your preferred asset artists so we can contact them promptly.
- INSTINKT, your editors start next week. Please download and prepare any clips of shorts content you would like edited. If you'd like a meeting for some ideas, let me know and we can sort something out.


EVENTS:
We are launching our first event relatively soon for instinkt; The (really, really cool) Great Heist. featuring our first original song, plus rolling out CYNTH's song, and launching a big campaign for that.
Our first virtux visions is being sent out for editing. Meaning our roadmap will be public soon featuring teasers for both waves and our very first big collab scheduled for September.



I understand that no movement/progress doesn't mean no communication so I apologize for my radio silence since I set up those spark meetings.

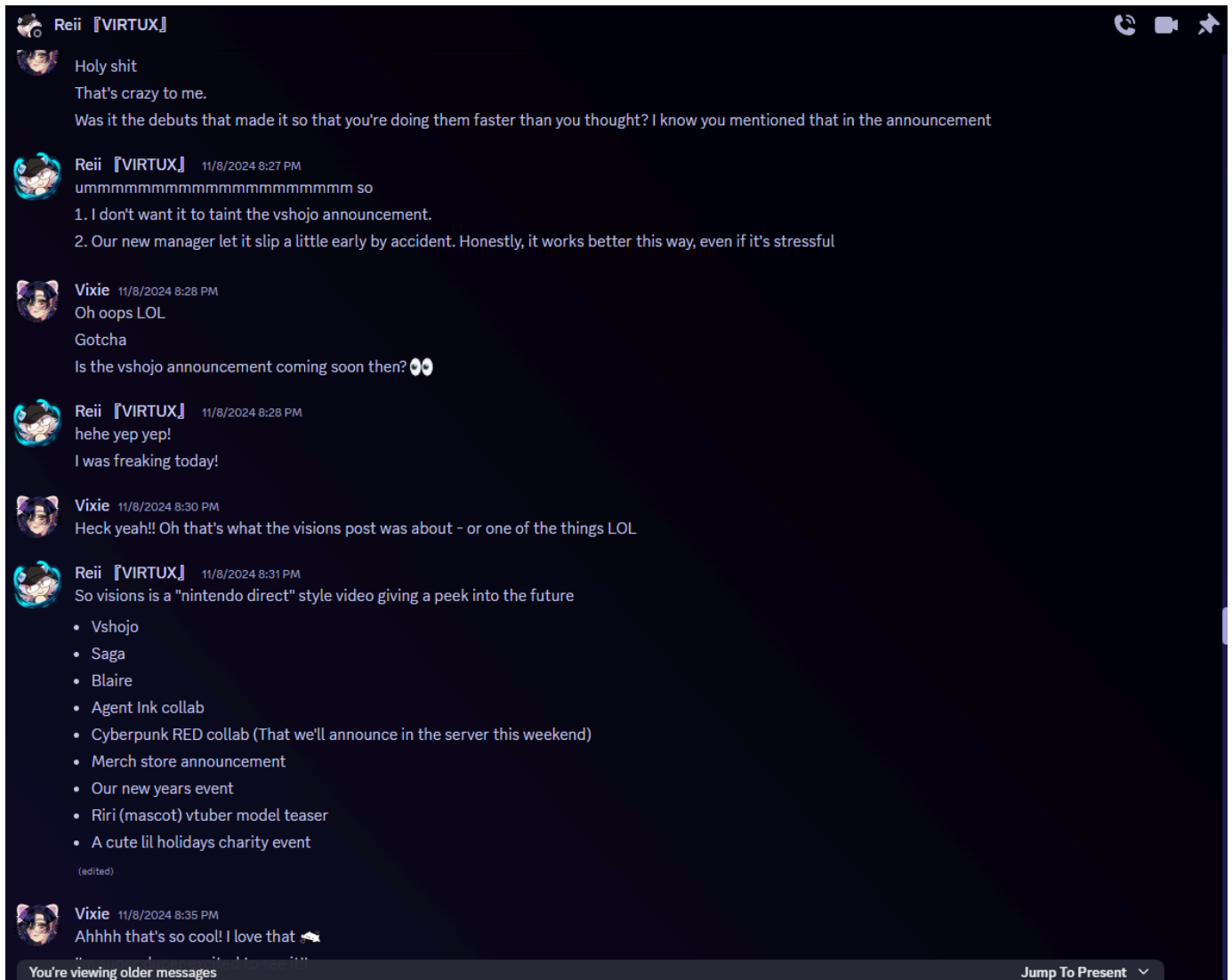

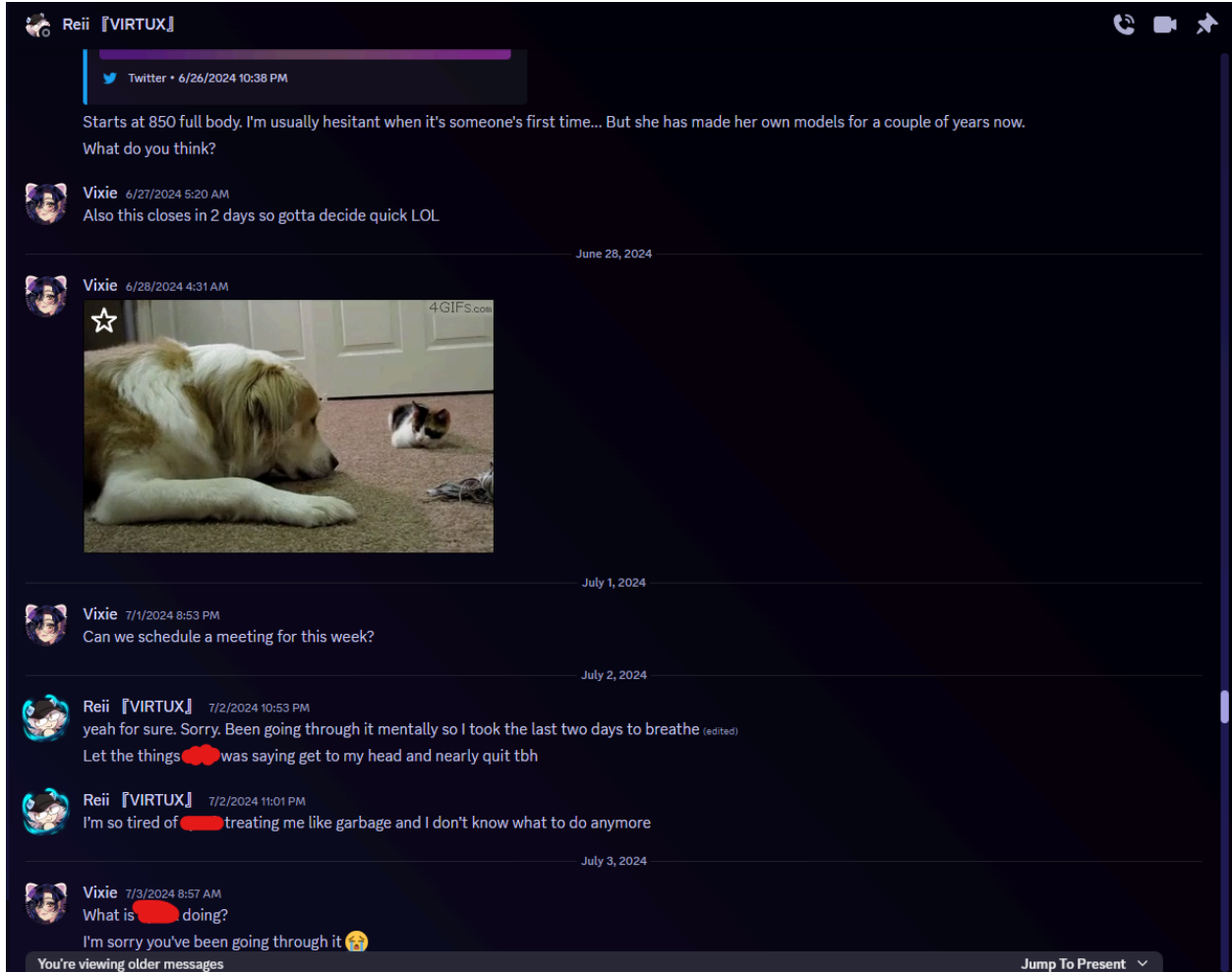
Live2D Model Art Lie

Admittedly finding a model for my brand was difficult because I wanted a Live2D model with a fully nude base and potential NSFW toggles. We went through many different options and they were either not within budget or, according to Reii, they didn't answer him.



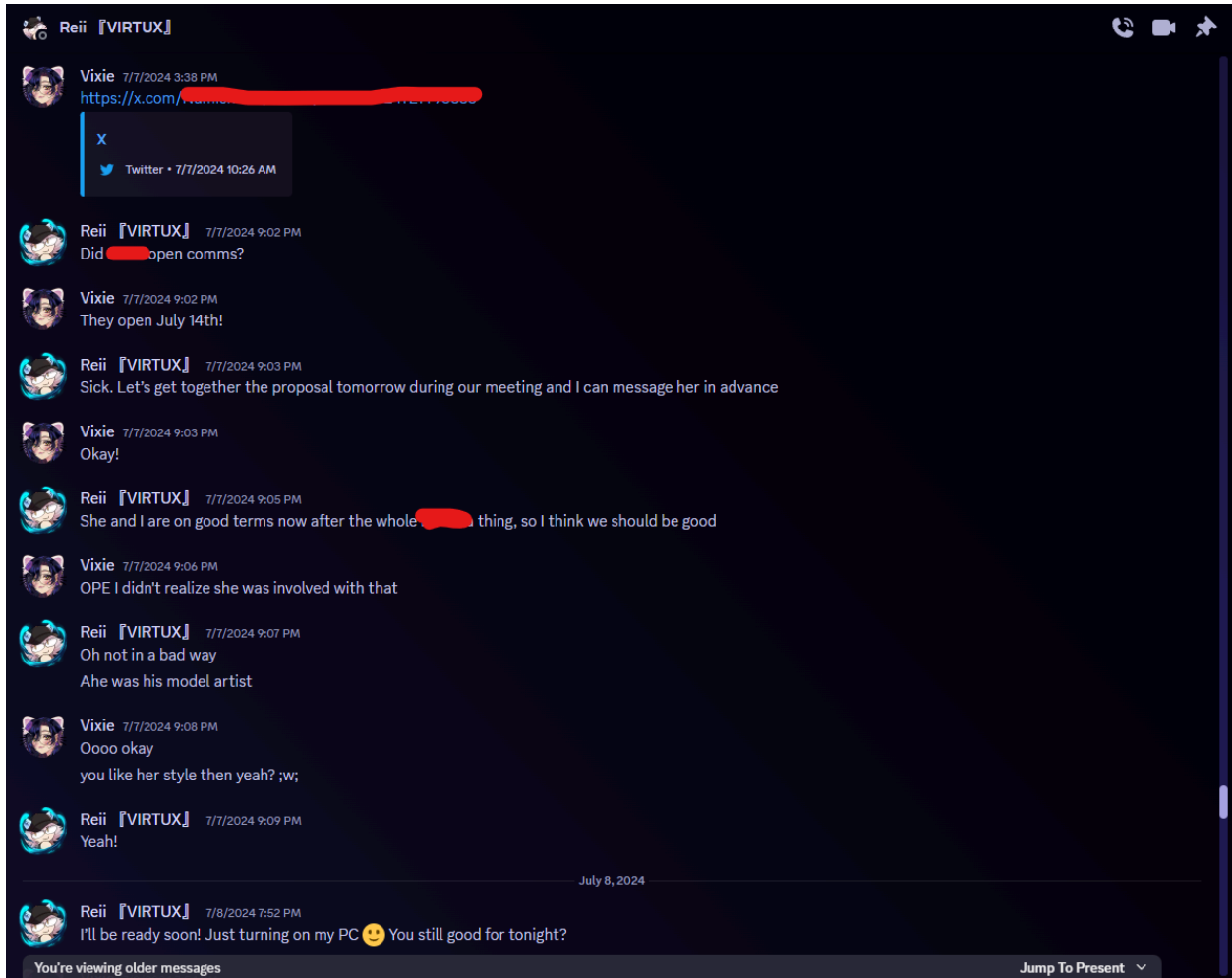
The next message includes a tweet from the artist we were talking about which has been removed to protect their identity.



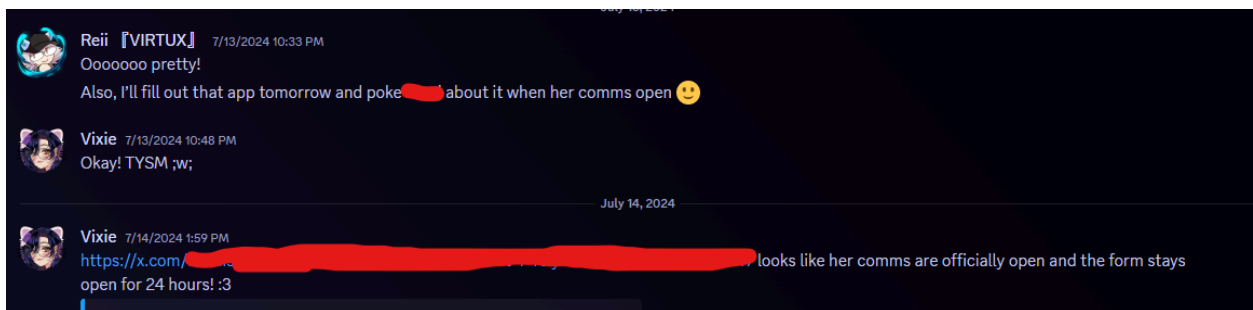


Suffice to say that I sent him a number of artists from around March to July, trying to find an option that would work for a Live2D Model. In Mid-July, we finally found one that we both liked and thought would work.

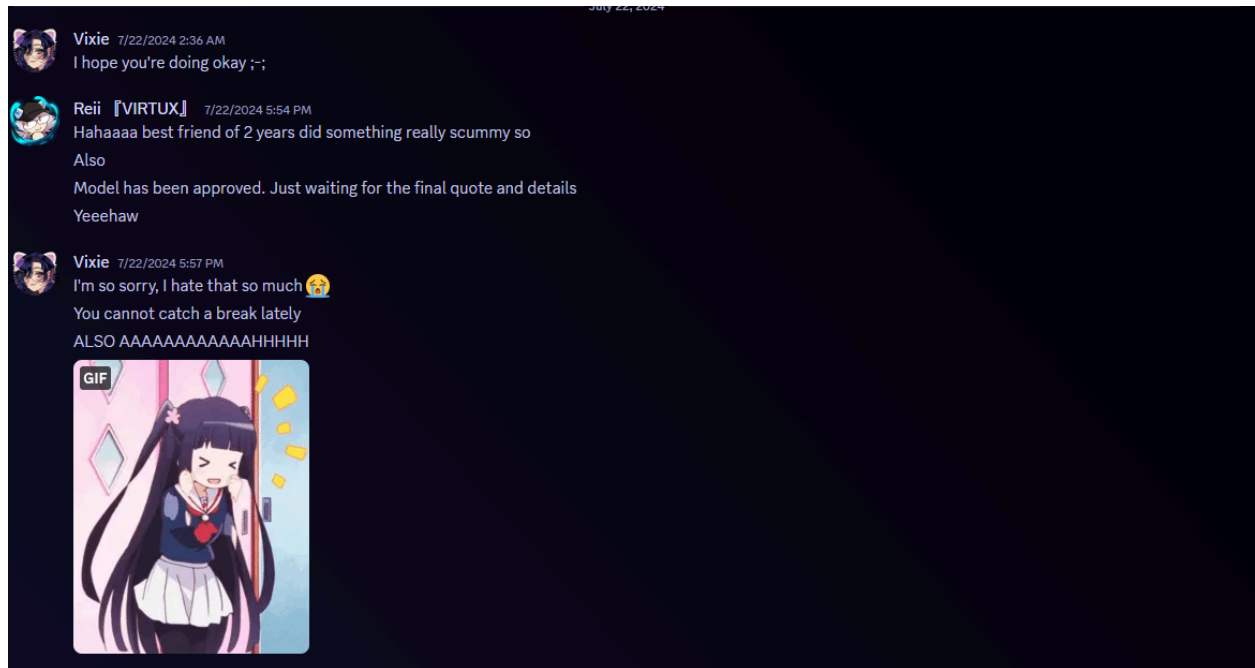
We'll call them A1 or Artist #1.

Model was approved.



On **09/01/24**, Reii reached out to me for an emergency call about switching artists. He told me that another artist, we'll call them **A2 or Artist #2**, had reached out since he had applied to their openings prior. This was plausible to me because I had sent **Artist #2** to him as a favorite and had assumed that he'd actually been contacting the artists I'd sent him.

He said that they were interested in creating a Live2D model for me and could make the requested October 21st deadline if they also did the rigging. I was more attached to **A2's** style than **A1's** and he assured me that he had a friend that could fill my slot with **A1** so as not to screw them over by cancelling.

I agreed to switch.

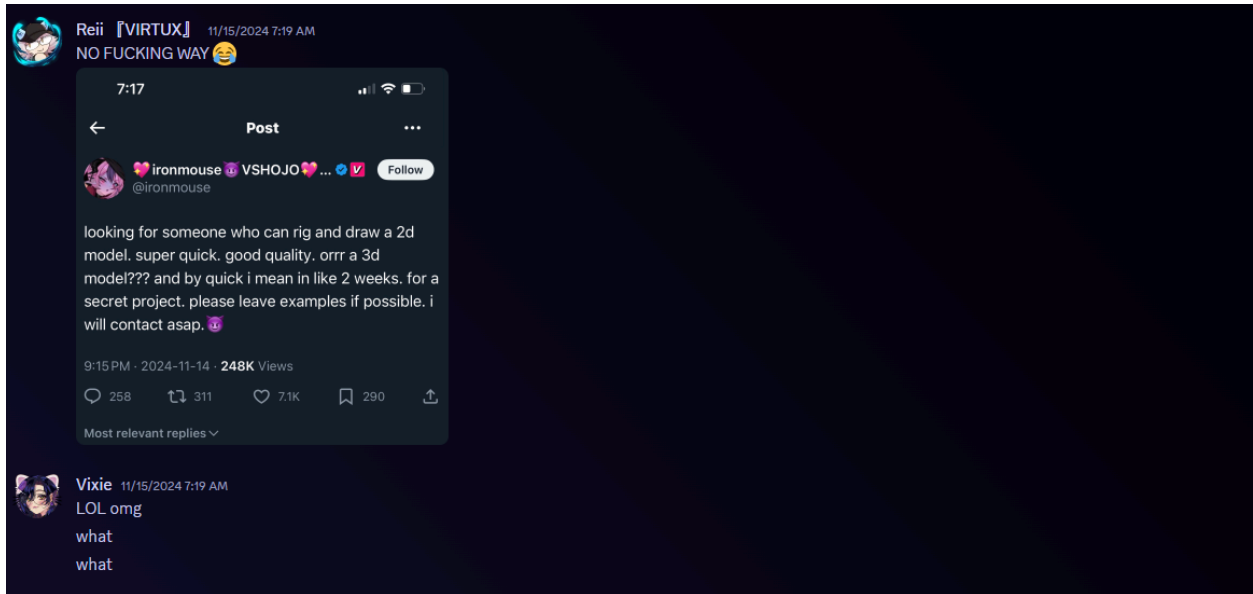
Reii implied that **Artist #2** was now ghosting him and that he was going to get Gunrun involved to make them answer or finish the model.



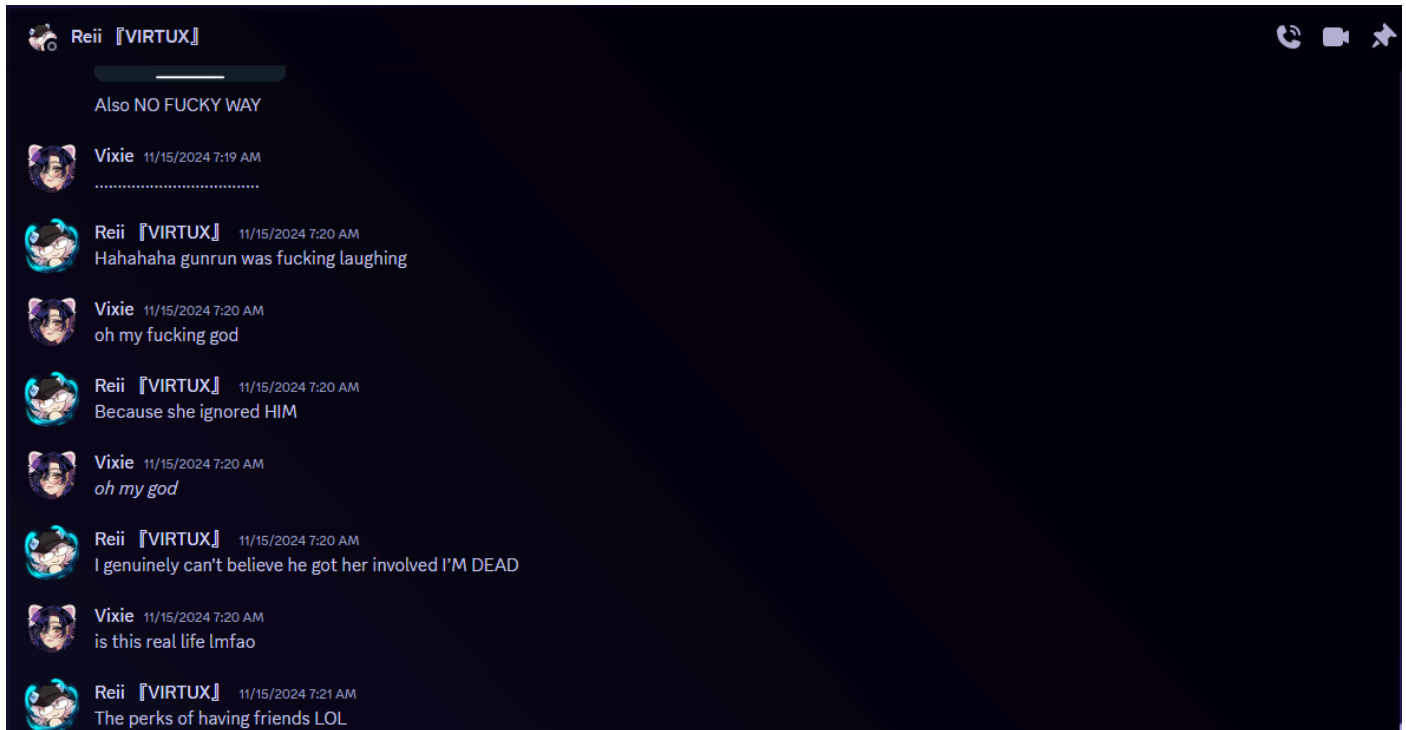
I then had a 5 hour meeting with Reii to try and figure out a backup plan. He originally wanted to try and get a model done within the 3 week timeframe he had allotted for the new debut dates. I was skeptical of that. But we spent a long time searching for artists.

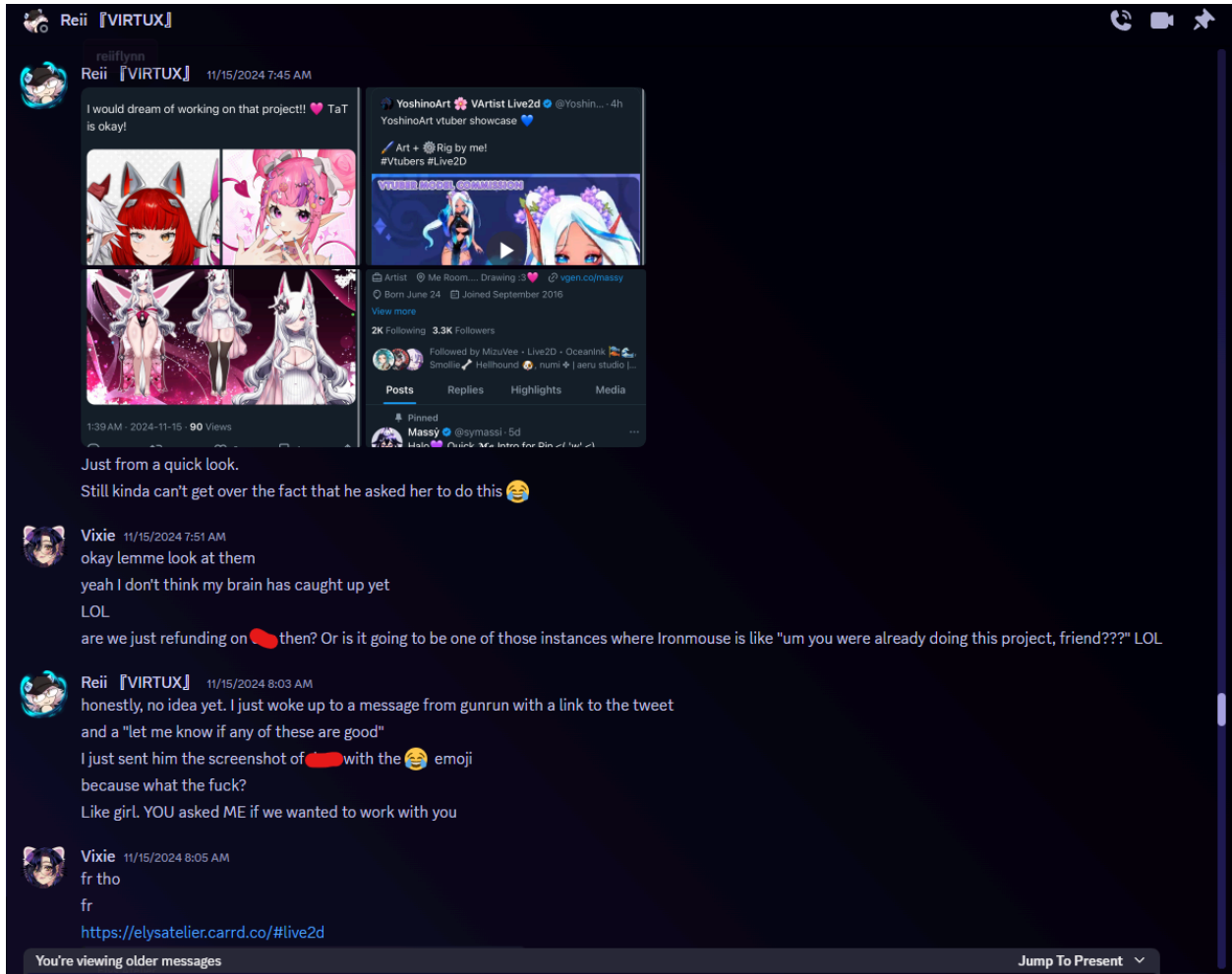


The next morning, he sent me a screenshot of an IronMouse tweet, implying that Gunrun had got her involved to look for a model for me. The timing of this was just crazy.

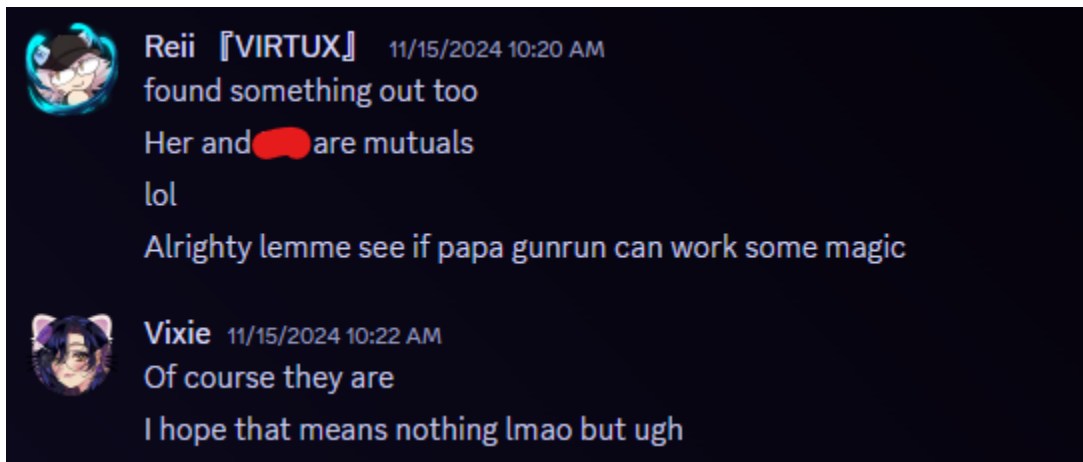


Artist #2 actually responded to IronMouse's tweet. I had been lead to believe, of course, that **Artist #2** was completely ghosting both us and Gunrun. My understanding now is that that tweet was actually about getting a Model for KaiCenat.

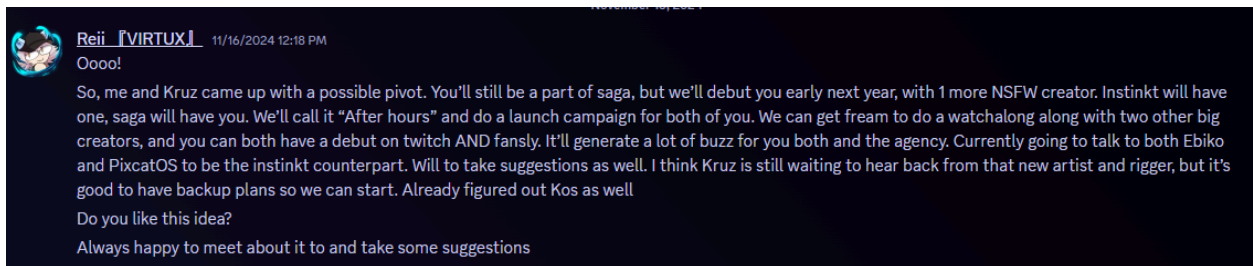
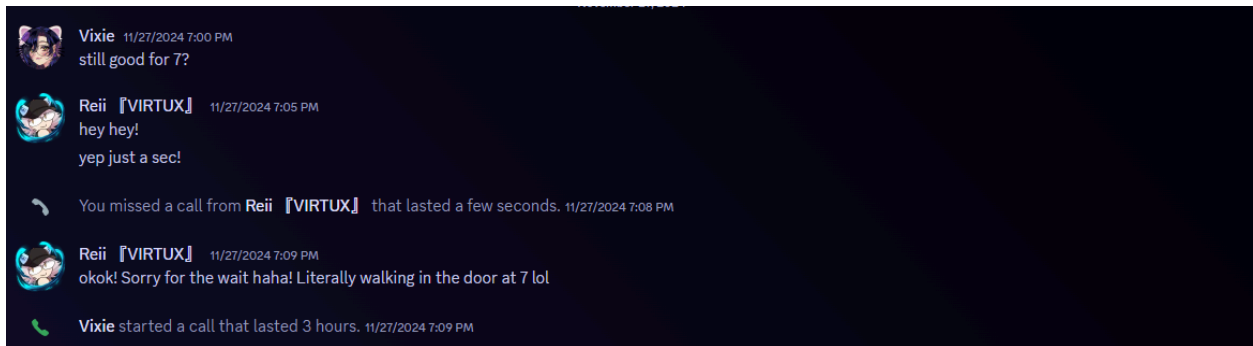




I insisted that **Artist #2** was my favorite and was very sad that they were ghosting us... so he said he hoped that Gunrun could get things figured out.

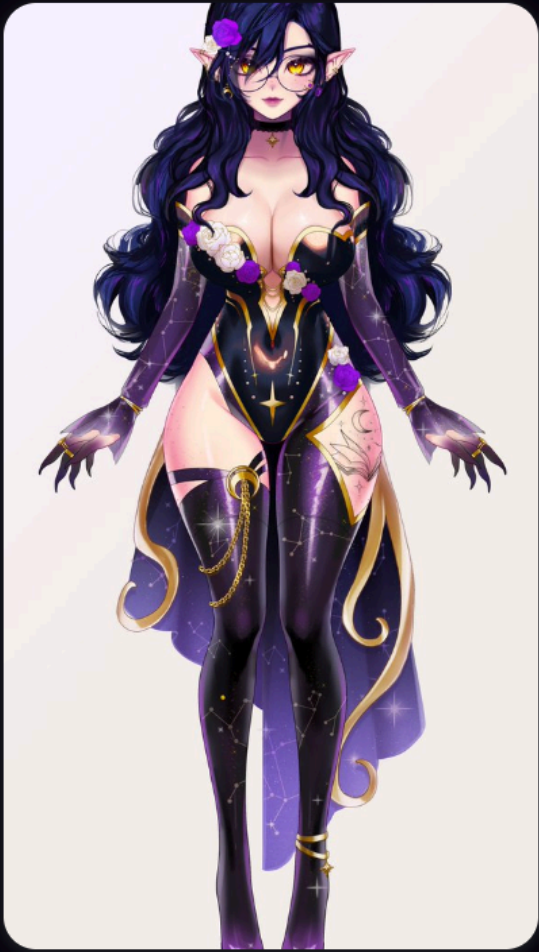


Our next call and meeting, Reii told me that he had filed a paypal dispute with **Artist #2** and that they'd sent the money back to him and blocked him. He then pushed very hard for me to choose another model artist. I would have a temporary model to debut with the agency and then a proper model starting in July to debut toward the end of 2025.



When it came out that Reii had lied about contacting the artist for our alerts, I decided to go ahead and contact **Artist #2** to see what had actually transpired with my model. I had previously considered this as I was growing doubtful but after careful thought, I decided against it on the off chance that something like a Vshojo partnership actually existed.

Turns out my model was never selected and **Artist #2** had NEVER contacted him proactively. Instead, Reii had reached out to them after my project was not selected during the application phase.



Hi [redacted] I wanted to reach out because I feel as though there was some kind of miscommunication.

ReiiFlynn was supposed to have reached out to you to commission a model on my behalf. Could you tell me what happened with that situation?

Please know that I am not coming at you aggressively or with negative intentions, I just want to understand.. because I'm worried I was told an incorrect version of events.

Being an art only project it does lose some appeal to us on a project that would have had a tough competition already, you can apply again on the next commission cycle around January-February if you want but the chances wouldnt be in your favour if the amount of applications remains close to the amount we have been receiving lately considering the low amount of slots we can offer

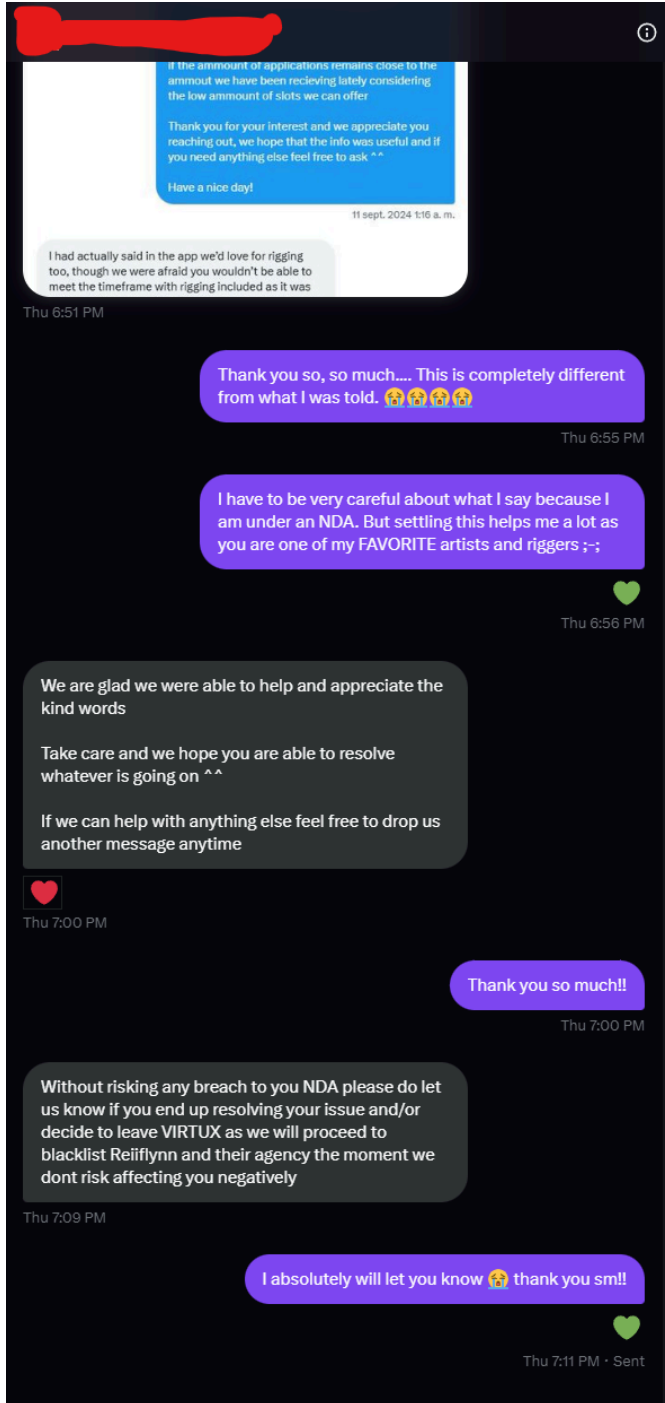

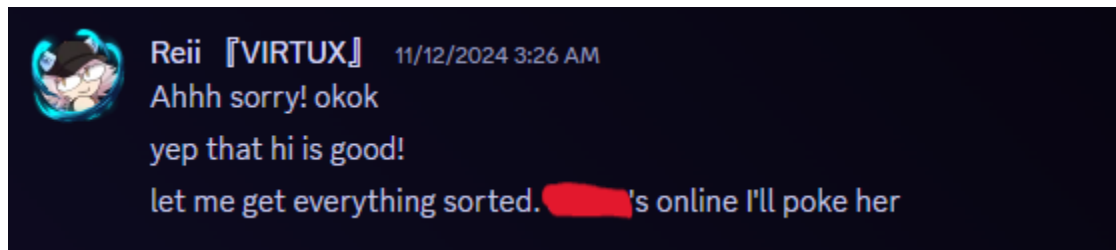
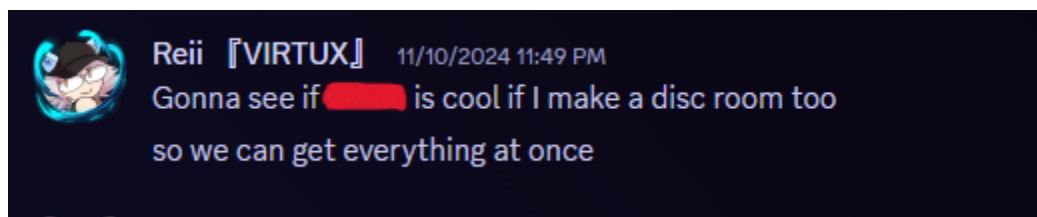
My speculation is that he never actually applied to **Artist #1** and then applied to **Artist #2** in an attempt to cover himself, hence him asking me to switch on **09/01/2024** before he had even heard back. He didn't end up actually contacting **Artist #2** until **09/10/2024** so when he told me things were finalized and he was just waiting on an invoice, it was yet another lie.

So essentially, from **07/22/24** until discovering the lie on **12/04/24**, I had been told that I had a Live2D model in progress. To cover his lies, he went so far as to slander these artists to us so that we would not discover what he had done.

Overlays Lie

Reii told me MULTIPLE times that he had commissioned overlays from a popular graphic designer for a previous talent (who was fired) and that he'd told them to keep the money. He then told me that he would contact them and get them to slot me in since the slots were paid for. And he confirmed that they were in progress.

Unfortunately I don't have concrete screenshots of this since it was mostly said in voice... but I do have some talking about them being in progress.



I reached out to the Overlay artist in question and it turns out that they have never received any communication from him whatsoever. **They don't even know who he is!**

Failure to Pay as Agreed

Reii was constantly late on payments to various artists, contractors, staff, etc. As far as I am aware, only one of the creators contacted to do watch-a-longs for Virtux debuts has been paid. Members of our management team have not been paid since October, with one of them having never received a paycheck at all despite working for 2 months.

I personally split the cost of my emotes with my manager, just to get them done, with the hope that he would be paid back by Virtux for his cost of things. At this time, my logo has yet to be paid for and I'm working to figure out how to pay for that.

I had my background artist reach out to me when they didn't receive payment for months. The balance was actually paid but only after me poking multiple times for the payment to happen. I know that other talents in the agency experienced something similar but I don't want to speak for them specifically.

Please keep in mind that my manager had **ZERO** access to company financials so he was only a go-between. He could not make payments himself.

If you need more time I can understand it and wait but I just need communication and an accurate date that the payment will be made!



Other Various Lies

If any talent of Virtux began to push back against Reii, he would carefully begin to character assassinate them to the other talents. I only experienced a little bit of this in my conversations with him as I kept my head down for the most part.

If someone was terminated, he lied about the reasons why.

I have the unfortunate news to share that after an in-depth investigation, we have discovered that one of our non-disclosure agreements has been violated and have swiftly worked to find the perpetrator. Kuzi, the managers, and I will be dealing with this urgently to ensure the safety of our talent and staff, and security of anything said in the server.

We may ask to meet some of you this week and next to confirm some information, as well as ask about connections to certain creators outside the agency. I want to assure everyone that this does not mean you are being suspected of anything, however we do need to further solidify our evidence in the case that legal action has to be taken. The perpetrator will be made aware that we know of the actions they have taken at the beginning of our meeting with them.


We would appreciate everyone's cooperation in bringing this to a conclusion swiftly, so we can continue building a community where you all feel safe to speak and be yourselves.

We're deeply sorry and incredibly upset that we have to make this announcement and deal with a matter of security like this, but since day one, we have always wanted to be transparent with you all about any actions we take in VIRTUX, as we believe transparency with the talent is essential for creating a community that we're all proud to be a part of.

As for the perpetrator, as I'm sure you know who you are, this is the last chance to come forward privately to me and Kuzi and discuss what has been shared illegally with us, without legal action being taken immediately. If you do not come forward, as you present a threat to the wellbeing of our agency and everyone in it, you will be persecuted to the full extent of your contract and held responsible for any expenses incurred in your time with us.

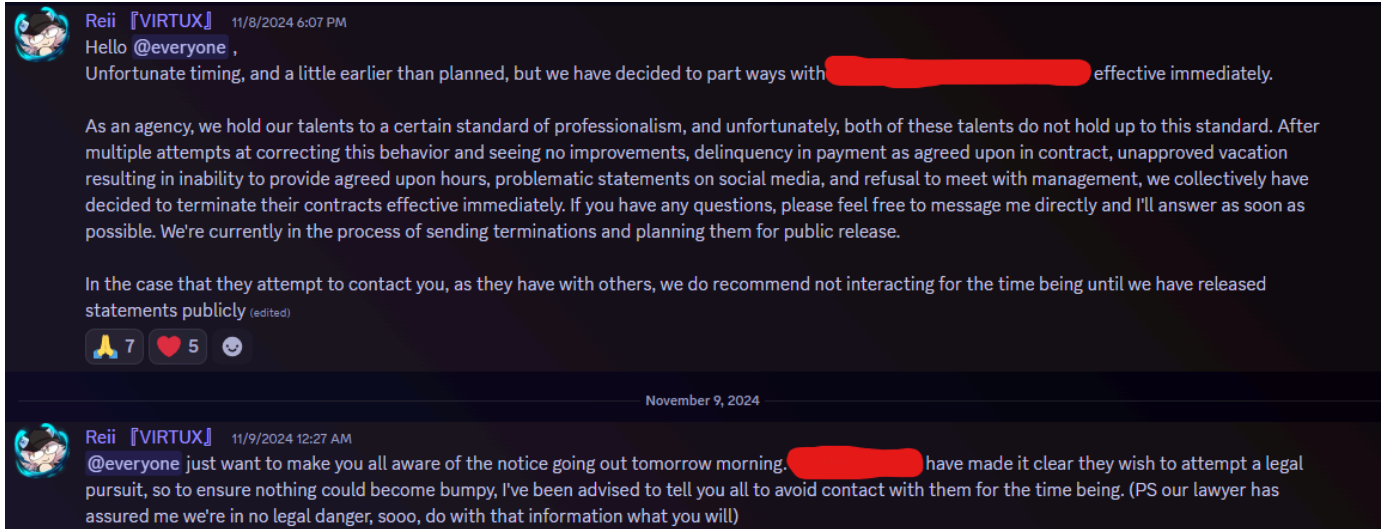

We are extremely disappointed in her and her actions, and hope that you can begin to feel safe again in this server. Thanks so much for your compliance.

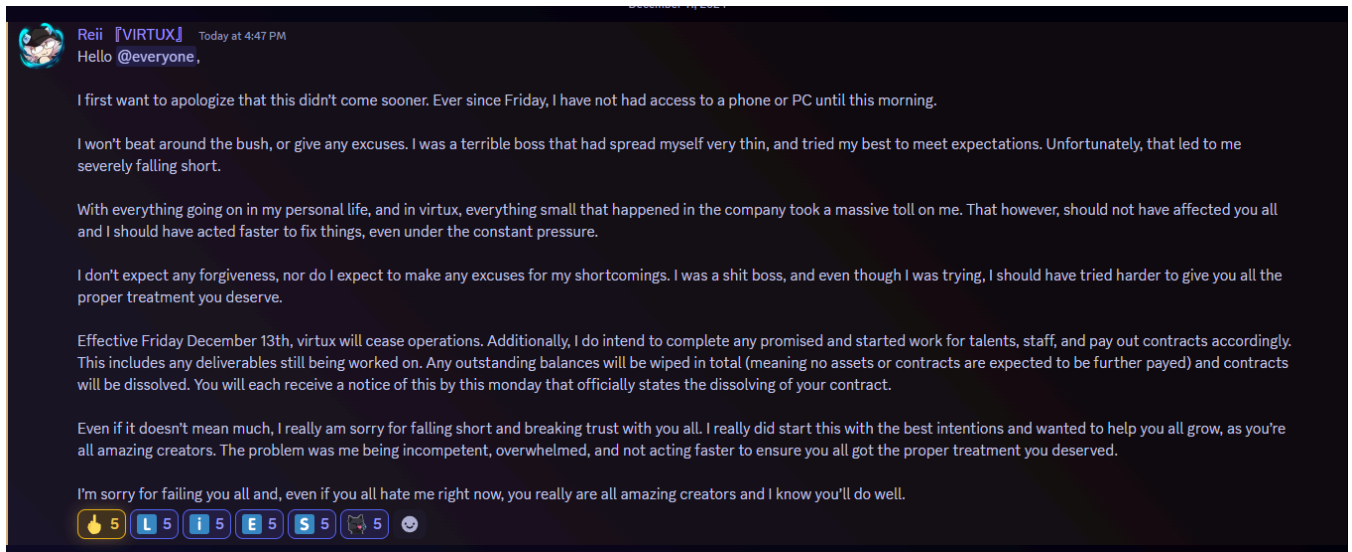

Having talked with the talent this is referring to, they informed me that the reason they were given for their termination was that they made people uncomfortable... not that they had actually breached contract.



Reii was incredibly careful to use the threat of legal ramifications to keep all talents afraid and isolated. We were afraid to reach out to people who had been terminated in the event that something would happen and we would breach our contracts. After people were terminated, Reii continued to character assassinate them to ensure that we did not contact them.

Final Announcement




This was made **12/11/24**.

Reii “disappeared” from contact on **12/06/24**. Later, he ghosted a **12/09/24** Monday meeting with our managers. According to his roommate, he left for a business trip on **11/04/24** and took his PC with him. He returned to the area but has been at a parent’s house since **11/21/24**.

In this announcement Reii states that he hasn’t had access to his PC or Phone from **12/06/24** until **12/11/24**. But I’m friends with him on Steam and he played Marvel Rivals on **12/08/24**. The explanation given to our managers was that he was overwhelmed and checked himself into a psychiatric facility. But if that’s the case, he most likely wouldn’t have had access to his steam account or his PC.

Conclusion

So many people were deceived. This document doesn't even feel like it encompasses everything.

While I personally never gave Reii any of my money as I wouldn't start paying a percentage until my debut, there are MANY people who have lost money due to his deception. And while Reii has promised to fulfill contracts as promised, even after dissolving the agency, many of us know that we will be left to pick up the pieces and cover the payments that he failed to make.

I was originally going to fund my own model and debut earlier this year but as I was supposed to debut with Virtux and things were going to be funded upfront by the company, I waited. I invested over a year into this agency and I barely have anything at all to show for it. The best thing that happened to me was meeting my fellow talents, who are all wonderful people and did not deserve any of this.

I anticipate that many people will question **why** we didn't figure things out sooner... and I understand. If I were on the outside looking in, I'd probably feel the same. But Reii was very skilled at keeping us afraid, isolated, and manipulated information to make himself look in control. He did a lot of conversations over voice and is very charismatic and great at controlling the narrative.

It's only when his hold over things began to fray that we started to see through things. Plus, sometimes he DID actually follow through and that gave him credibility. Especially at the beginning. I, personally, also considered him a good friend and have a history working for him as his own social media manager/PA. I had no reason to think that any of this would be the end result.

Why did he do this? I have no idea... I'd like to hope that he started off with good intentions. But I really have no explanation for why things spiraled the way that they did.

To the other talents who were let go, I ask that you please remember that we were all manipulated. Please don't villainize us for not reaching out as we were all told to cease contact and were under the impression that we were bound by an NDA.

To Reiflynn, I hope that you take responsibility for the overwhelming amount of hurt that you've caused. Words truly cannot describe how much damage you've done.

To anyone reading this: Please be careful. Please be skeptical of the promises of a person or an agency no matter how legitimate they sound. If it's too good to be true, it probably is. I consider myself to be pretty good at sussing out scams or lies but I was still taken in by this. Hindsight is 20/20 and this is honestly just a small chunk of what happened and doesn't cover the **MANY** experiences of my fellow talent.

Thank you for reading about my experience... Please stay vigilant and always advocate for yourself.

TLDR + Extra Details

- Promised a Debut in October 2024
- Promised that my model, overlays, and alerts would be completed in time
- Went through many instances of being ignored or ghosted by CEO
- Discovered that anything I was told about my model, alerts, and overlays were fabricated completely and said artists were slandered in the process
- Heard defamation about other talents multiple times over vc
- Was diminished to just being a moneymaker and porn creator to other talents over vc just because I do NSFW work
- Promised a Vshojo Partnership
- Promised high profile watch-a-longs for my debut with creators like Cottontail or Dokibird
- Essentially threatened into silence and obedience with the implication that putting a toe out of line would result in legal ramifications
- Had to cover portions of the payments for the assets myself
- Logo is still not paid for
- Many people and employees involved in the agency or doing things for the agency have not been paid
- Lied to for months and months and months about so many things
