

# Summary of Problems with RagingBull and LuckyEN

## Intent and Explanation

This document exposes systemic issues within LuckyEn, an unregistered VTuber "agency" led by RagingBull (also known as Rage or RagingBull), based on testimonies from affected talents and collaborators. It is divided into two main sections.

The first section details RagingBull's problematic behavior, including overly controlling management, breaches of confidentiality (e.g., doxxing and gossip), insensitivity to mental health and boundaries, lack of professionalism (no contracts, exploitative deals, and unfulfilled promises), hypocrisy in rule enforcement, and erosion of trust through selective treatment and inappropriate sexual "jokes." Supported by screenshots, recordings, and accounts from talents like Dolly, Saturn\_Senshi, ShirOwan, it rebuts RagingBull's defensive statement and highlights patterns of manipulation and harm.

The second section examines the "defenders" or "blame shifters"- former LuckyEn members (e.g., Starcat, MommaOcco, Mizutamari, Junie, Akuma Miko, Attari) who initially sought help to exit the group via a private "Testimony Server" but abruptly reversed course after a suspicious voice call with RagingBull. It documents their subsequent attacks, lies, and hostility toward facilitators like TheDonOfEverything, Saturn, Shiro, and Nines, using screenshots and timelines to refute claims of threats, overwork, or ulterior motives, revealing a coordinated effort to deflect blame and silence victims.

The original purpose of this document was to expose LuckyEn as a non-legitimate business and highlight its aggressive and manipulative practices, at the request of several LuckyEn members.

However, following subsequent events, including bad-faith attacks, deliberate misrepresentations, and false accusations against individuals who were assisting members in safely exiting the group, the document's intent has been expanded to also address and rebut these distortions.

## Summary of Problems with RagingBull and LuckyEn

**Each of these points have supporting evidence and screenshots throughout the testimonies of this document**

### **1. Overly Controlling and Invasive Management Style**

Demands immediate admin/moderator rights in every server he joins.

Insists on private calls while barring talents' own moderators/friends, then vents about those talents in other servers (e.g., Saturn's VC about Shiro).

Scolds talents in a condescending, parental tone (GIFs, "unbecoming," cursing).

Shows up uninvited on streams and pushes his way into conversations or groups he wasn't invited to.

Makes persistent, uncomfortable "jokes" about talents' personal lives even after being told to stop.

### **2. Repeated Breaches of Confidentiality and Gossip**

Disclosed sensitive information about a well-known talent to Saturn, Moka, and others long before they even knew this VTuber personally.

He allowed - or outright failed to moderate - doxxing in the "Under The Tea" (UTT) server run by Mitzumari, MommaOcco, and Lumi (Luminous Cove/LumLum), where he himself was a moderator and acting representative of LuckyEn. In that server, Nachisu Miku's real name and face were posted, as well as Nines' former adult performer name. These posts remained unaddressed as of 11/21/2025, despite his public claim of having a strict "no doxxing" rule. He was actively present and messaging during these conversations, making it clear he was aware of what happened and chose not to intervene.

### **3. Insensitivity to Mental Health and Personal Boundaries**

Pressures talents into content or schedules they're uncomfortable with.

Pushes talents to disclose deeply personal trauma or mental health issues (e.g., Shiro, Saturn), only to minimize, lecture, or use it against them later.

Disregards talents' real-life responsibilities, commitments, and personal limits.

Mocks or dismisses trauma responses as "self-sabotage," and even jokes that abandoning someone "wouldn't make business sense."

### **4. Lack of Professionalism, Contracts, and Fair Compensation**

Runs an unofficial, unregistered "agency" with no contracts and no IP protection. (No LLC)

Offers exploitative merch/figurine splits (10–20 % to talent, 10 % to himself) while downplaying risks (Nines rejected on advisor advice). (Note from Shiro: "I was unaware of this deal before it went through, despite being the one who was being commissioned for this merchandise. The usage of AI was also not disclosed to the talents, despite RagingBull being aware of this.")

Talks negatively behind the backs of talents he failed to recruit (e.g., Neevin).

### **5. Hypocrisy and Selective Enforcement**

Lectures talents not to "stir the pot" while he gossips and leaks info, but allows certain talents to say whatever they want.

Reiterated "no doxxing" rules in the Under The Tea server but does nothing when they're broken.



## 6. General Erosion of Trust

Talents who don't fit his ideal schedule or who assert independence are quietly sidelined, last-added to promos, excluded from art, or straight-up ignored until they no longer need him — at which point help is suddenly offered.

Multiple members state outright: "LuckyEn just doesn't really serve me at all. I don't benefit."

## Preface: A Necessary Disclosure Regarding LuckyEn and "RagingBull"

**This document is not written out of malice or a desire for drama.** It is written out of responsibility, out of care for the talents who have been hurt, and out of a refusal to let harmful patterns continue in silence simply because speaking up is inconvenient.

In the Fall of 2025, a number of current and former LuckyEn talents, collaborators, and community members began privately comparing experiences with the individual who presents himself as the group's "manager" and sometimes "CEO," known online as RagingBull (sometimes Rage or RageBull). What started as isolated, uneasy moments eventually revealed a consistent and disturbing pattern that affected multiple people in similar ways.

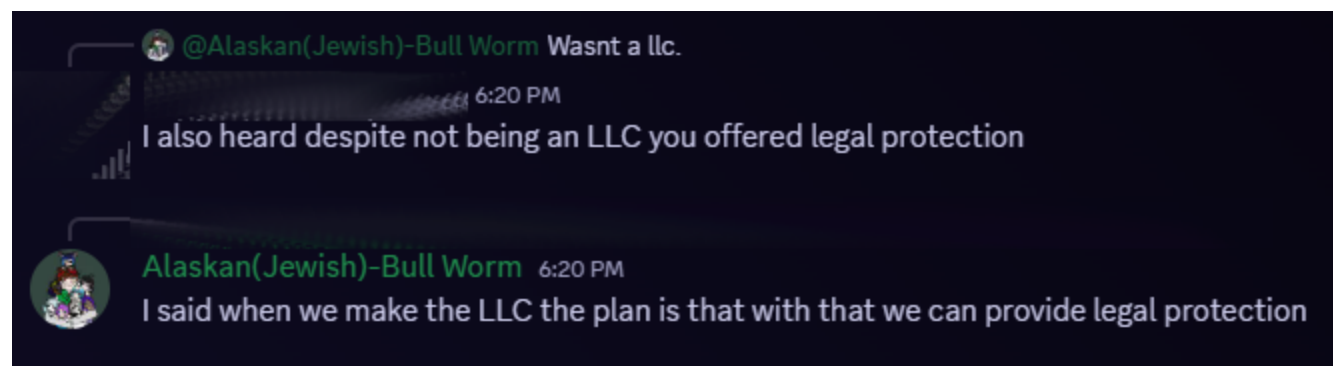
That pattern includes:

- Repeated sexualized "jokes" directed at female talents, even about their real-life relationships, long after discomfort was made clear.
- Casual use of degrading language ("bitch," "femboy," etc.) in both private and public settings, framed as "banter" but never reciprocated or welcomed.
- An intensely controlling management style that demands total transparency from talents while offering none in return; that inserts itself into private discords, streams, and schedules uninvited; that withholds promised assets or support as leverage.
- Chronic breaches of confidentiality: sharing deeply private information (activity in real life of talents that they did not want disclosed, real-life partners, mental-health struggles) with people who had no business knowing it, sometimes before the talent themselves had even told those individuals.
- Selective help and punishment: talents who comply and remain available on his schedule are rewarded; those who have real-life obligations, boundaries, or simply assert independence are quietly sidelined, excluded from art and promotion, or subjected to guilt-tripping and public scolding.

- An environment where doxxing and the circulation of real names/faces have been tolerated in spaces he controls, despite loudly advertised “no doxxing” rules.
- Pressure on mentally vulnerable talents to overwork, to disclose trauma for content, or to remain in the group despite clear burnout, followed by dismissal of their struggles as “self-sabotage” when they push back.

These are not rumors - they are documented experiences shared independently by multiple people: Saturn, Shiro, Nines, Moka, h0b0c0p, Miko, Dolly, and others, backed by a substantial amount of screenshots. When TheDonOfEverything began looking into RagingBull's behavior on behalf of concerned friends (initially at Starcat's request), the information gathered from different individuals in late 2025 revealed an undeniable and troubling overlap. Don first reached out to Miko after both Starcat and Distress expressed concern about how she was being treated inside the so-called “company.” From there, Don contacted Shiro and Saturn - people he already knew well and as more conversations opened, others came forward with their own accounts, forming a consistent picture that could not be ignored.

LuckyEn was never a formally registered LLC; there were no contracts, no IP protections, no defined revenue structures, and no legal safeguards for the talents who invested their time, money, and emotional energy into it. Instead, what existed was one individual's personal vision of control, maintained through a mix of charisma, selective generosity, gossip, and the gradual breakdown of trust.

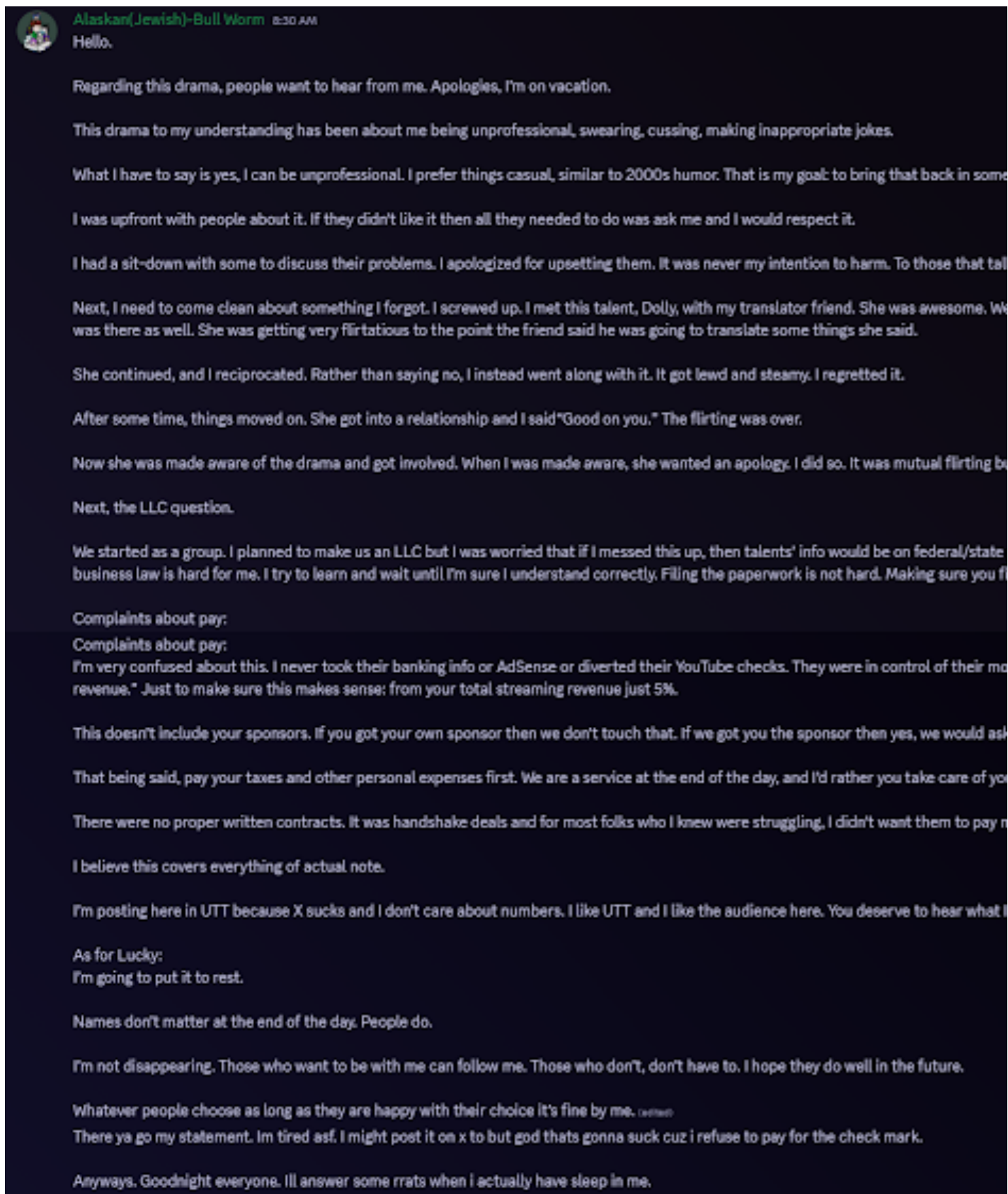
Many of the members said they stayed in LuckyEn longer than they should have and because they were made to feel that leaving the group would be considered as betrayal or interpreted self-destruction. Some of the members only realized how deep the damage ran once they were finally out. Miko stayed in the group because she did not want to “abandon” the group that they had built together.

This is not an attack on every person who has ever been part of LuckyEn. This is about the behavior of a manager who crossed lines again and again, and about the collective decision that silence is no longer an option. However, there have been people posting lies and deflecting blame to cover up for his misdeeds as well as trying to silence the testimony of those who were victims of his harassment and poor business practices.

To anyone reading this who has been affected, whether you're a current or former talent, a moderator, a viewer, or a friend – you are not crazy, you are not overreacting, and you are not alone. Your boundaries mattered then, and they matter now.

The talents share this so that no one else has to learn the hard way what “management” under RagingBull actually meant. So that people aren't used and then tossed away when their presence no longer suits his needs.

## Rebuttal to RagingBull's Statement

While RagingBull tries to downplay everything as mere "unprofessionalism" or harmless mistakes,

his own statement highlights the very behaviors that caused so many concerns and pushed people to distance themselves from him. Instead of clearing things up, he unintentionally reinforces exactly why so many felt uncomfortable, misled, or unsupported under his management.

### **"I can be unprofessional... I prefer things casual."**

Unprofessional behavior isn't a style choice. When you position yourself as a manager or leader of a VTuber "company" there is an expectation of professionalism, consistency, and safety. You can't run a team like a friend group while simultaneously expecting people to treat it like a business. Repeatedly swearing at talents, making sexual jokes, and behaving unpredictably is not "2000s humor" ; it's inappropriate and unsafe in any management role.

### **Admitting to engaging in flirtatious behavior with a talent.**

He acknowledges he flirted with a talent who trusted him in a managerial capacity. Regardless of whether it was "mutual," the power imbalance makes this inherently inappropriate. A manager should understand that a talent cannot freely and safely say "no" to someone who controls opportunities, communication, and project direction. His own admission confirms a boundary violation, not an innocent misunderstanding. This also went far beyond "flirting" and into full on sexting.

### **Admitting he avoided forming an LLC because he didn't understand what he was doing.**

He openly admits he wanted to create an LLC but didn't understand business law, wasn't confident filing the proper legal paperwork, and feared making mistakes that could expose people's personal information. Despite knowing he lacked the knowledge and structure to operate safely, he still acted as if he were running a legitimate company, assigning roles, taking percentage cuts, recruiting talents, and managing their content. This was reckless. Any legitimate agency establishes its legal foundation, contracts, and liability protections *before* bringing people on, not after. His own words make it clear that the real issue was his inability to provide even the most basic professionalism or safeguards expected from someone in a managerial role.

### **The 5% revenue cut was still inappropriate.**

Saying "I never took their AdSense or banking info" doesn't make the situation better. Taking *any* percentage from talents - especially when there is no contract, no legal entity, and no services delivered - means the arrangement lacked transparency and legitimacy. Many talents expressed concern because they were paying for a "company" that didn't legally exist and had no defined benefits, structure, or protections. In addition, nobody actually knows where that 5% cut was actually going. There are no documents or receipts or any accountability at all for those funds.

### **"It was all handshake deals."**

Handshake deals are not professional. If the talents were relying on him for management, sponsorship help, branding assistance, or legal guidance, then failing to formalize these agreements puts all of them at risk. The lack of written contracts is not a defense - it's part of the core problem.

### **Attempting to minimize the sexual misconduct reports.**

He frames his misconduct as nothing more than "flirting," but multiple talents reported discomfort, inappropriate jokes, and pressure from him. A manager should never be making sexual jokes or

putting talents into situations where they feel uneasy. His attempt to downplay these issues shows a lack of understanding of power dynamics and professionalism.

**Claiming he “never meant to upset people” does not negate the behavior.**

Intent does not erase impact. Even if he “didn’t mean it,” he still caused significant distress, violated boundaries, and ran something he advertised as a company without the structure, competence, or professionalism required to do so.

## RagingBull Grievances

Below are screenshots provided by some of the people affected by this, including testimony from witnesses from these events.

### KitsuraNines - Vtuber Approached By RagingBull

Raging Bull originally approached me about potentially joining “LuckyEn.”

**Nines:** He told me that, if I joined, he would eventually want 5% of my income. When I asked what he could actually offer me in return, he didn’t give an answer that made sense for me or had any real value to me personally. He claimed that, for YouTube takedowns or copyright strikes, I could list the company’s address instead of my own and that they could “handle things legally.” When I asked to see a contract, he told me there was no contract and that it was “just verbal for now”. After our call I decided I’d mull it over more and wait to see how Saturn and Shiro’s experiences go before making any commitments.

(This is a recording of Nines’ conversation with RagingBull about the supposed 5% cut of her income. In the call, he claims the money would go toward “licensing fees” and other vague expenses, yet at no point does he disclose that LuckyEn isn’t even a real, registered company. Why was Nines being asked to pay a licensing fee to someone who doesn’t have an actual business license or legal entity behind any of this?)

Then he approached me again, this time about making “VTard collection” figurines.

He never told me that Shiro was the one who would actually be making them, nor did he mention that the files would be a fan’s AI-edited assets (Which that fan has offered me for free on his own previously). Bull offered me 10% while claiming the rest would go toward “costs.” I knew he had no contract because I was speaking to Miku, and Miku was told there is no contract when he asked. He was just told to screenshot the chat, as a “Trust me, bro” type deal. I declined for multiple valid

reasons under the advice of an advisor, and after this I learned that “LuckyEn” isn’t even a real company, just an idea with no legal structure. HE NEVER MENTIONED TO ME THAT IT WASN’T A REAL COMPANY/LLC AND THAT HE DIDN’T HAVE A BUSINESS LICENSE:

- **Without a contract, I have zero legal protection**

- If he decides tomorrow to sell figurines, assets, merch, or anything using my likeness, design, or brand; there’d be nothing on paper saying he *can’t*. I’d have no formal agreement to enforce.

- **No contract = no ownership clarity**

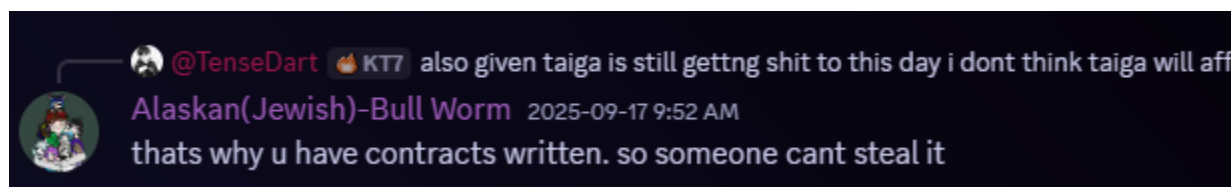
- Who owns the figurine design? Who owns the sculpt? Who can profit from it? Without a contract, *he could claim anything*.

- **No contract = no control over distribution or pricing**

- He could undercut my brand, misuse my character, or sell low-quality products that hurt my image. And I couldn’t legally stop him.

- **Asking for a contract is standard**

- Legitimate creators, manufacturers, and companies **always** provide paperwork for IP licensing. The fact that he is not providing a contract for this is a red flag.



Here is RagingBull himself acknowledging that without contracts someone could steal content.

He got pushy fast and clearly didn’t like hearing “no.” His whole plan relied on having all four Ex-VTards involved, and once I declined, the entire idea collapsed. Somehow RagingBull decided he’d take a 10% cut for himself- for what, exactly? Shiro would be the one doing ALL the actual work, and the 3D model files were being provided *for free* by a fan. To make it worse, he originally approached Miku offering only a 5% cut.

He also tried to “advise” me on my personal social media.

Once, when I was arguing with someone on Twitter he DM’d me telling me to stop and leave it alone. I found that extremely overstepping- especially since I am not in his group and he has zero



authority over how I conduct myself. I didn't appreciate unsolicited "management" from someone who isn't actually my manager.

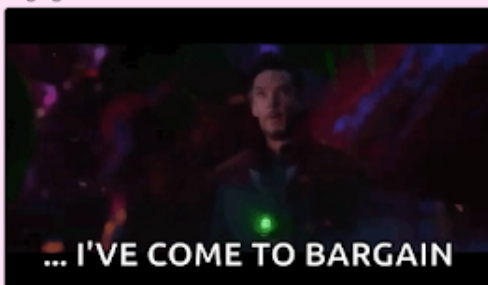

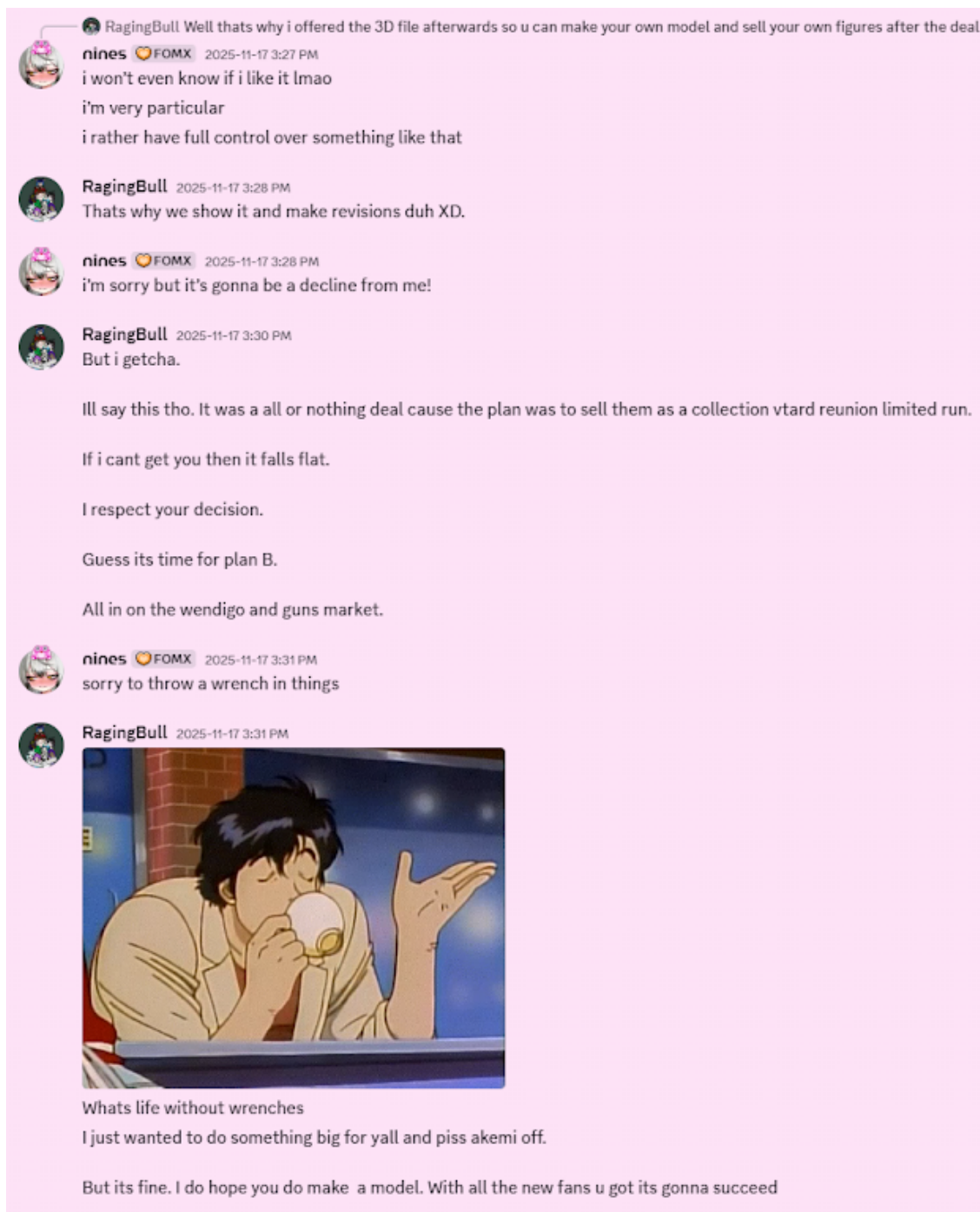

"honestly, i don't think you should go through with it. it gives someone way too much control over your character and branding without giving you the legal protection you'd need. once your design go wrong. also, 10% is super low for something that relies entirely on your ip. creators usually get a much better cut or at least some kind of upfront payment. you'd be taking most of the risk for b turns out low quality or they start using your design in ways you don't like, it could hurt your brand, and you could even be dragged into legal problems just because your name is attached to it.

## Dolly - Former LuckyEn Member:

[This excerpt is translated from Spanish into English. The original version in Spanish is below this excerpt.]

**Dolly:** I joined the agency on the recommendation of Xolo31 (at that time he was just a regular member of the agency) to be part of a new section made up of Latinos. When I joined, they made Xolo the manager of the Latino team. On several occasions, Xolo told me that he didn't know what to do as a manager or if he was even doing things right, which makes me think they didn't ask him — they just imposed the role on him. Even so, I tried to put in effort and make the most of this opportunity to be part of an agency, contributing whatever I could, from artwork to ideas for growth that would benefit everyone.

Of all the ideas I presented, the only one they accepted was creating the agency's Twitter account, but it took them months to actually do it. I was expecting support from the agency, but there was barely any interest. The one thing I am grateful for is that my manager Xolo helped me when the Paco Vega incident happened — a harasser/stalker who showed up on my channel. In all the time I've been here, he was the only one I saw genuinely interested in supporting people and doing the best he could as a manager.

On the other hand, RagingBull's behavior was completely inappropriate. It started calmly — the occasional out-of-context insinuation or meme — but it gradually escalated. From compliments, he changed to sexual topics, fully aware of the personal trauma I was already carrying from before.

He took advantage of his power as the head of the agency to commit these acts. On several occasions, we were on calls on my own server — most of the time playing video games, but there were also calls that turned sexual/NSFW. It was difficult to communicate with him because of the language barrier; we both used translators or sometimes we had Xolo translating for us in real time. The sexual situations only happened when we were alone.

I had wanted to hang out and connect with my female group members from the beginning. I ended up feeling very alone in the agency because I was the only one on the LATAM team. RagingBull told me that my group members only spoke English and that's why I couldn't interact with them, but that later there would be more Latino members so I could hang out with them. However, I never saw them bring anyone else in, so I recommended some friends who could join.

Of those friends, they only accepted Akihiro, but then excluded him. I tried to include him more because I felt responsible for having recommended him. So we were still alone on the Latino side. It wasn't until all this drama with RagingBull's harassment, stalking, and abuse came to light that I found out there were actually teammates who did speak Spanish and with whom I could have communicated.

What I noticed about RagingBull is that he lies and manipulates you so that you can't tell anyone

anything. On several occasions, he threatened to take his own life, saying that he had served in the military, had trauma from it, had a gun at home, and was emotionally unstable.

I want to publicly apologize for my own behavior. I played along with him in his sexual advances – and I did so willingly with him. I know I shouldn't have gone along with it and that I will be judged for it. I just ask that people understand that when someone has already gone through situations of abuse, rape, or violence, they tend to fall back into those patterns. That includes feeling the need to take control of the situation so as not to go through that pain again. Maybe for many people that doesn't justify it, but for those who can understand it, I thank you for your understanding.

I would like to add something regarding the part about the stalker, Paco Vega: this guy used to send me photos of his penis, he said he was going to come meet me in person and lose his virginity with me, he extorted me and constantly tried to silence me, which left me in a very bad emotional state. When I got involved in a controversy just for trying to defend myself from him, that's when everything you saw in the screenshots with RagingBull happened. So he was taking advantage of a moment when I wasn't doing well at all, and that also contributed to me agreeing to continue the sexual conversations with him.

Entré a la agencia por recomendación de Xolo31 (en aquel momento únicamente miembro de la agencia) para formar parte de un nuevo sector conformado por latinos. Al entrar, hicieron a Xolo mánager de los latinos. En varias ocasiones, Xolo llegó a decirme que no sabía qué hacer como mánager o si estaba haciendo las cosas bien, lo que me lleva a pensar que no le preguntaron, sino que se lo impusieron.

De igual manera, traté de esforzarme y aprovechar esta oportunidad de ser parte de una agencia, aportar lo que podía: desde arte hasta ideas de crecimiento para todos.

De todas las ideas que mostré, solo aceptaron hacer el Twitter de la agencia, pero tardaron meses en hacerlo. Esperaba el apoyo de una agencia, pero apenas si veía interés. Lo que sí agradezco es que mi mánager Xolo me ayudara cuando ocurrió el incidente de Paco Vega, un acosador que llegó a mi canal. En todo lo que llevo aquí, solo vi a él tener interés de apoyar y hacer lo mejor que pudo como mánager.

Pero por otro lado, el comportamiento de RagingBull fue inapropiado. Inicialmente comenzó tranquilo: una que otra insinuación o meme fuera de contexto. Eventualmente fue creciendo y, entre palabras bonitas, me llevó a tocar temas sexuales, siendo él consciente de los traumas personales que llevaba encima desde antes, aprovechándose de su poder como jefe de la agencia para cometer estos actos.

En varias ocasiones estuvimos en llamadas en mi servidor propio; la mayoría jugando videojuegos, pero también existieron llamadas subidas de tono. Era difícil comunicarme con él por la diferencia de idioma: ambos usábamos traductor para comunicarnos o, a veces, teníamos a Xolo para que nos tradujera en tiempo real. Las situaciones sexuales solo se daban cuando estábamos solos.

Quería poder convivir con mis compañeras desde antes; llegué a sentirme sola en la agencia al ser la única del equipo LATAM. RagingBull me dijo que mis compañeras solo hablaban inglés y por eso no podía convivir con ellas, pero que después habría más integrantes latinos para que pudiera convivir. Sin embargo, no veía que trajeran a nadie más, por lo que recomendé a algunos amigos para que pudieran unirse.

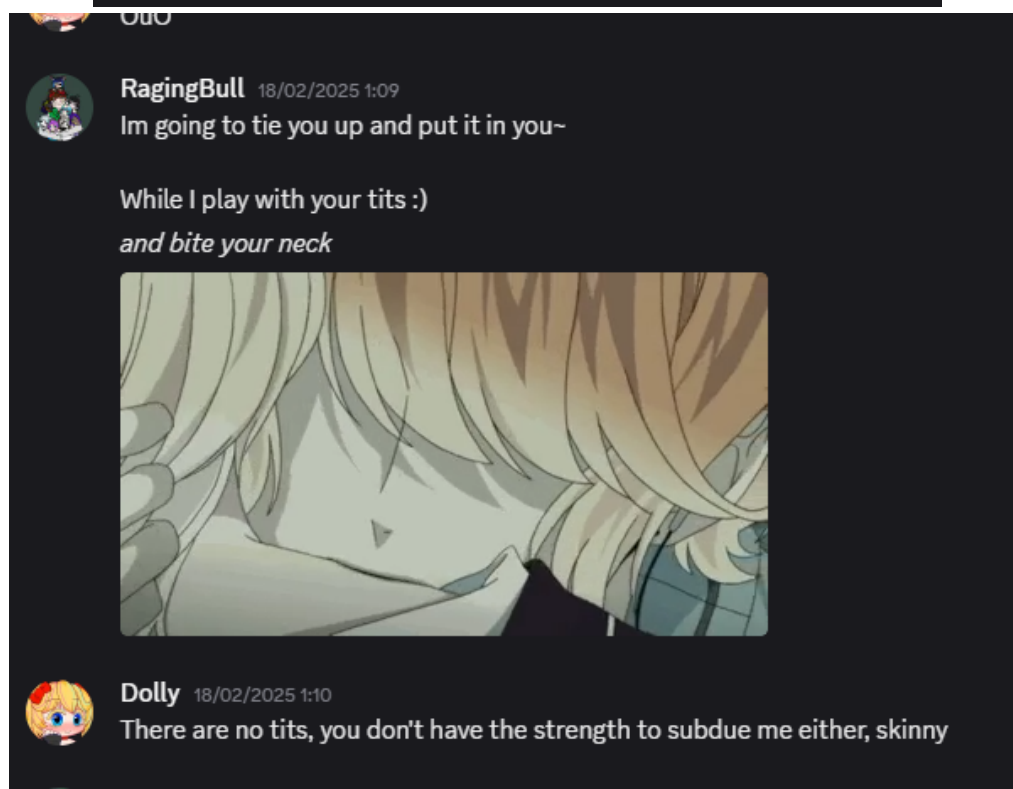
De los cuales solo aceptaron a Akihiro, pero lo excluyeron. Traté de incluirlo más porque me sentí responsable por haberlo recomendado. Así que seguíamos solos en el lado latino. No fue hasta apenas, cuando sucedió todo este drama con el acoso, hostigamiento y abuso de RagingBull, que me enteré de que había compañeras que sí hablaban español con las que podía comunicarme.

Las cosas que noté de RagingBull es que te miente y manipula para que no puedas contarle nada a nadie. En varias ocasiones amenazó con quitarse la vida, ya que dijo que había servido en el ejército, que quedó con traumas, que tiene un arma en casa y que es emocionalmente inestable.

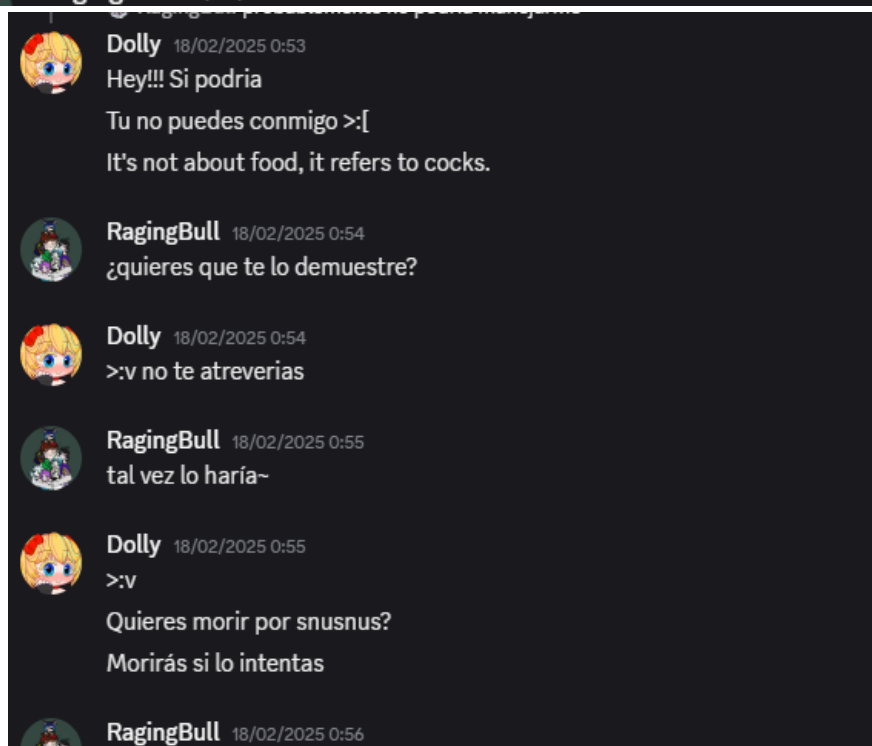
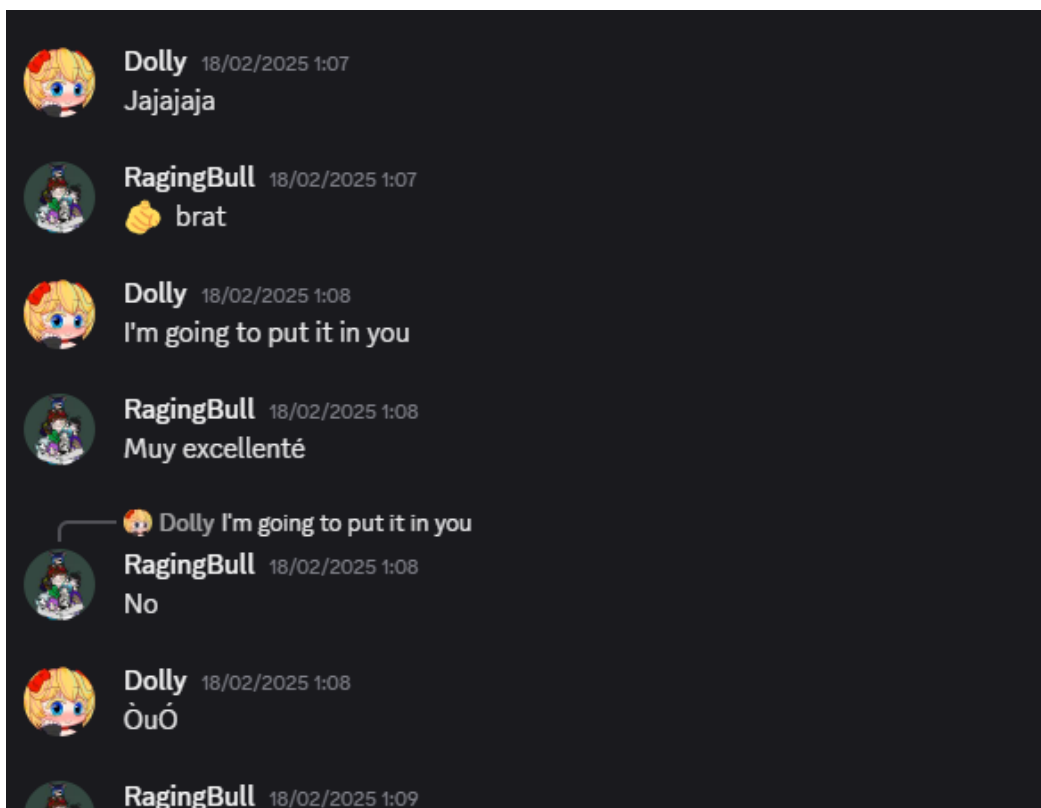

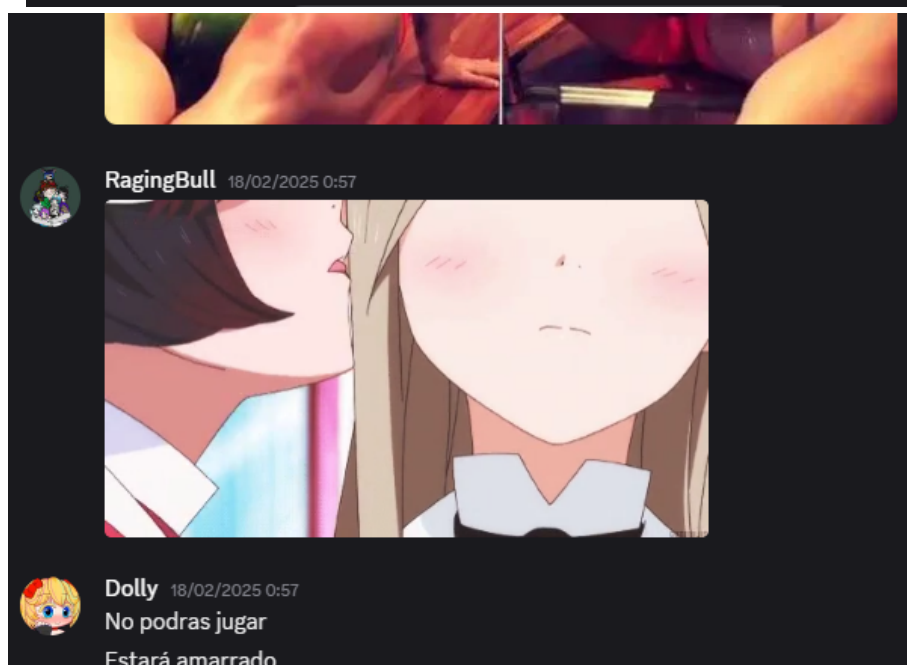

## Nachisu Miku - Vtuber Approached By RagingBull

**Nachisu Miku:** My experience with LuckyEn owner RagingBull is short but problematic nonetheless, following similar patterns of behavior others had experienced.

RagingBull had asked me to reach him in X DMs for some kind of deal. I contacted him and he said he wanted IP rights to create figurines of Nachisu Miku and the other former VTards for a VTards reunion collection (Later found out he was actually selling Shiro's labor to create them and with AI which he did not disclose to me). offered me 5% and then we negotiated a bit after that.

When it came time to try to make the deal official, ie, signing a contract, he very strongly did not want a contract, saying he would need lawyers to get involved. I proved him wrong in that no

lawyers were needed, only the two parties' signatures. He still didn't want to do a contract and said X DM screenshots are enough and to trust him, he's not shady. I disagreed that contracts protect both parties. I offered to draft one up. While creating one, I needed the company's info to put in the contract. Come to find out LuckyEn isn't a legal business entity. After that, the deal fell through. This led to investigations into whether anyone had actually signed any contracts with him at all.

RagingBull also lied to others in a VC that he and I were in talks for me to join LuckyEn. No such conversation was had. The only deal we discussed was the figurine deal.

I was also witness to a lot of the discussion being had in VCs of other talents' negative experiences with him and LuckyEn.





## Saturn\_Senshi - Former LuckyEn Member

**Saturn:** My first interaction with RagingBull was after I was invited to Under The Tea for the first time. At the time we had good chemistry, and I was invited to join. Also at that time, I was friends with Akemi and two more who I wanted to be in a group with. I asked questions about what involved joining LuckyEn because Akemi was very skeptical of LuckyEn due to Kirsche's document detailing the shady practices of RagingBull and LuckyEn members. I decided to stick with Akemi because she was my only female friend.

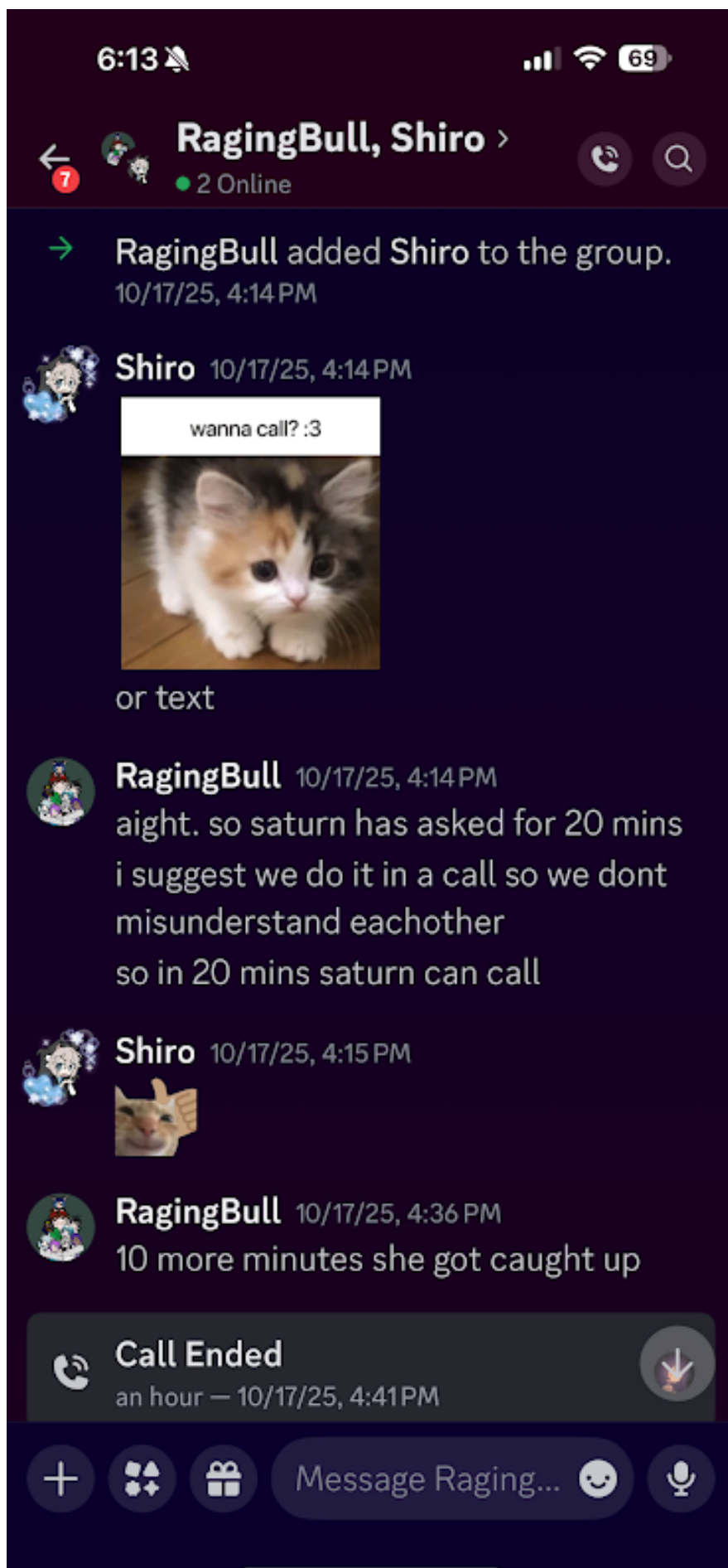


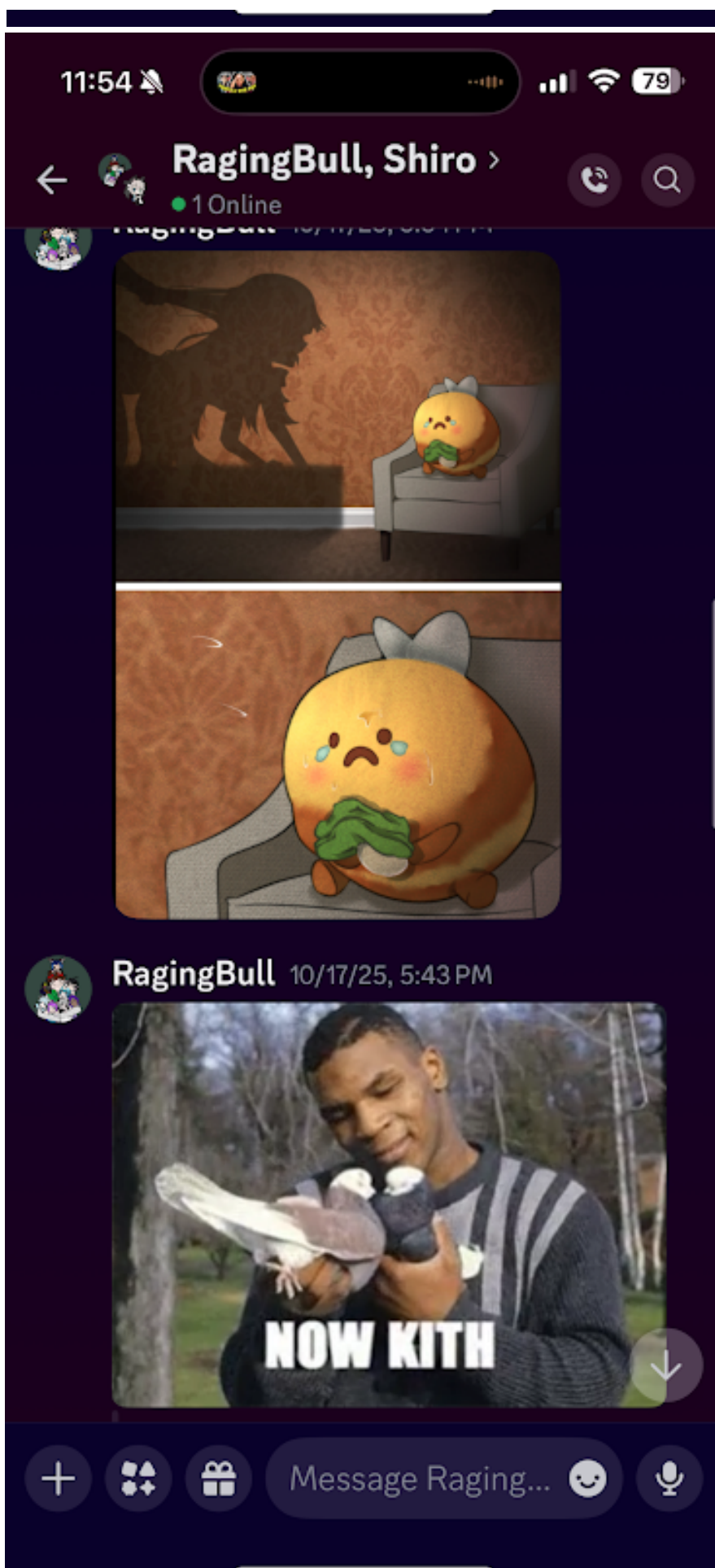
At the time that happened, there were some major red flags I missed because of how excited I was to join a group.

This includes the following: Saying that in the future I would be signing to give 5% GROSS PROFIT of streaming from all platforms, that he could “help with security” by giving him information that could be dangerous if used against me, and promising certain services which were never provided.

Later, after I left that friendship due to her actions, which have been documented already, I got the chance to join LuckyEn again.

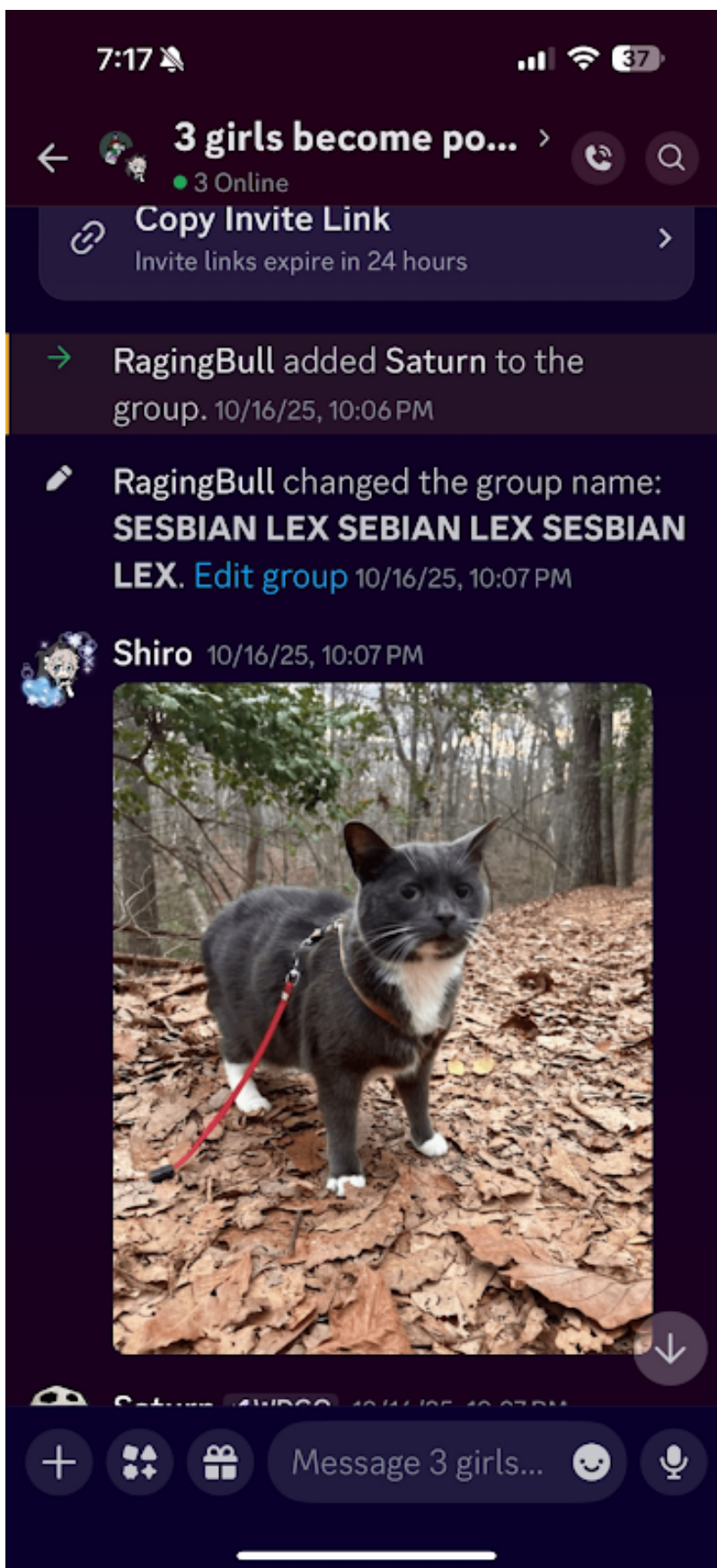
Shiro would be joining at the same time, and RagingBull wanted us to reconcile as he wanted the “VTards to reunite” and also to “piss off Akemi.” Shiro and I reconciled after learning we mainly had misunderstandings about one another. During that time RagingBull tried reaching out to Nines, but she declined as she wasn’t interested and wanted to see how it would help us.

When he wanted me, Nines and Shiro in the group together, he called it lesbian sex in different ways. Despite presenting it as him wanting to onboard all of us.



Nines declined and he went ahead with just onboarding me and Shir0, with different calls for each.

During onboarding, I was told private information about a larger talent in the agency. I was appalled by this because I never asked nor did I want to know. I will not say who this is because I told this person I wouldn't.

I was told repeatedly to reach out to management for help, which never happened. It was always I'll get to it then flaking out. Only two occasions did I receive help, and both left me disappointed or disgusted.

1) We had a movie night where we were watching the season finale of Hazbin Hotel. RagingBull noticed we had some technical difficulties and said "make me a moderator and I'll fix it". He didn't fix it. In fact, he already had an alternative solution that didn't require him to be made into a moderator. He had been pestering me to be a moderator the entire time I was in LuckyEn. Then started telling me what to do in my own private channels not available to the public, that had been there for years. Prior, I never wanted him to be a moderator. I told him this MULTIPLE TIMES as I have my own moderator team already. He had been pestering me all night so he could "help me" and then proceeded to not help via discord while having a different alternative he never talked about.

2) I asked for help with the Twitch integrated throwing system. After talking with myself and my moderators for over an hour he admitted he wasn't sure how it worked and "didn't know anything about Twitch". Then, he told one of my moderators, "I need you to check if Akuma Miko is streaming right now. Check all her socials." My moderator was confused and uncomfortable but he didn't want to make problems for me so did it. She was not streaming and he said "okay good". It turns out she never intended to stream that day and he knew that. In the same call, he was starting to lecture and ramble about something to my moderators and myself. During that part of the conversation, he said "this sucks". Because I was bored and annoyed, all I said was "haha get it?". His immediate response was "yeah yeah shut up go suck your husband's dick." I immediately tried to make him stop and he said it again two more times. Three in total in an aggressive manner until I entirely shut up. This was said in front of two of my own moderators. I felt humiliated and ashamed, and my moderators were stunned and felt if they spoke up it would ruin my chances with LuckyEn with RagingBull being the owner. After that, he admitted again he had no clue how to help me and sent me two YouTube videos instead. Before leaving, he told my moderators, "you better tard wrangle her and make sure she gets everything done in those videos." They were even more annoyed and angry on my behalf for him treating me like that and voiced their concerns after he left.

He made other gross and embarrassing comments or "jokes" to me, usually made entirely at random.

For instance, we were just sending random funny GIFs. I like My Little Pony, so I sent a GIF of that. In the GIF I sent they boop one another on the nose. He proceeds to send one of a pony, named Fluttershy, sucking off a candycane, drooling, and looking up in an extremely sexual manner.









On another occasion, I was discussing my plans to debut a new microphone. The plan was to do ASMR reactions to a medical show about foot surgeries. I explain that my fan who calls himself “my biggest simp” saying he’d get me a new microphone to do a feet centric stream, which would obviously be a bait and switch. RagingBull responds he wants to get me a shock collar as punishment for showing him the context for my idea. I reply with a GIF of an anime girl seeming somewhat devious. He replies that I am not like that character, Haruhi. He then tells me that to have that title, I need to wear a bunny suit.

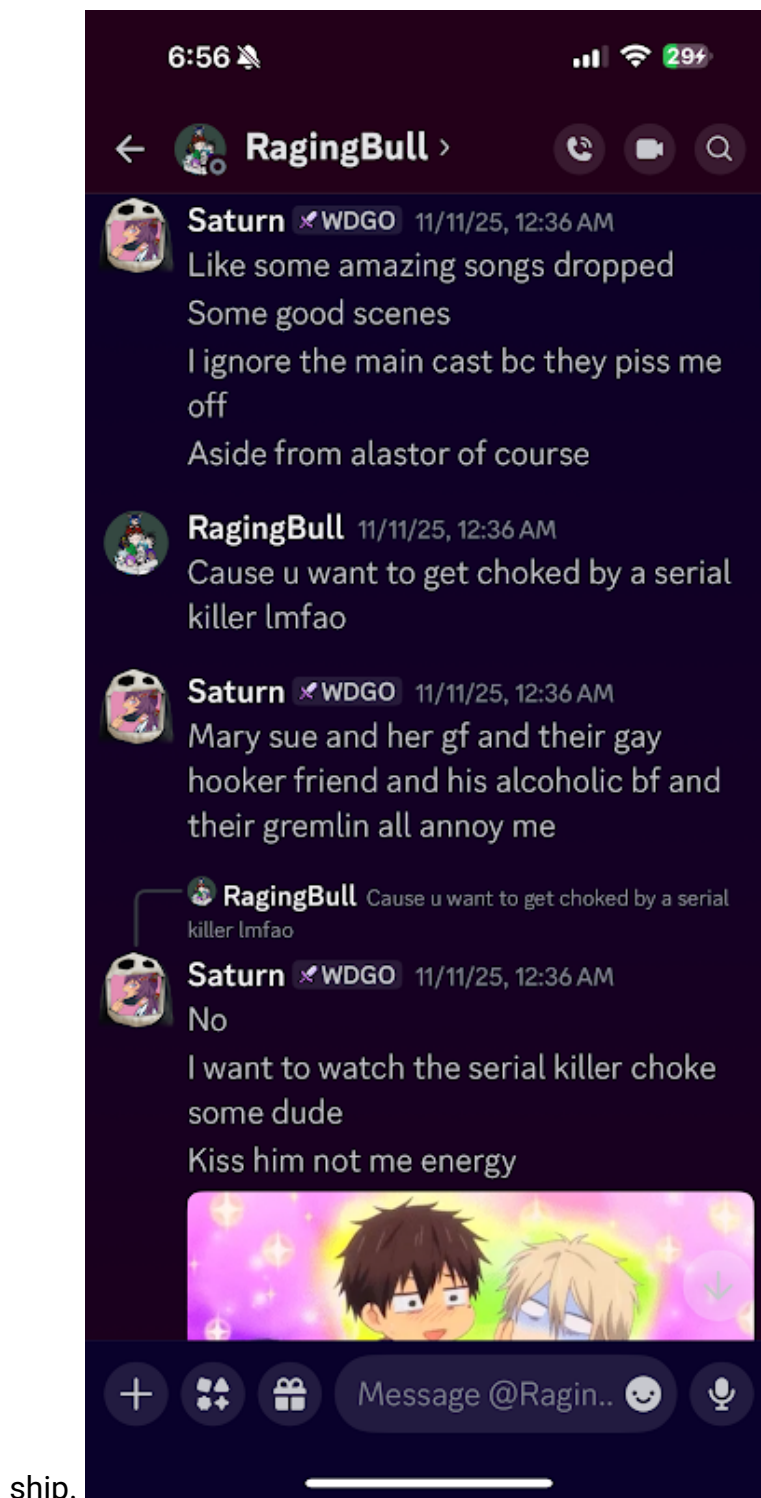
After the Under The Tea episode, I was being congratulated for my engagement by two people, Occo and RagingBull on the 21st around 2 in the morning after the stream. He proceeds to say "where is my invite". We have never been close friends. When it was said, I made it known that I was not okay with this by saying no. He then says he will show up with a Payday 2 mask and a bulletproof vest and crash it. This made me very uncomfortable and he admitted to wanting to do this in screenshots. We have never been close and even the person with the call tried to cover for him saying it was a joke. It was honestly scary and I questioned why he would even say that. For a wedding to say something so weird and creepy, it made me extremely uncomfortable and for him to reaffirm he would want to do this in DMs after saying it in VC made me feel creeped out severely. Even after I said no directly in the VC, he still reaffirmed he found it funny even saying I should imagine it and saying he could be security. I still don't know why he would do this or think this was remotely close to appropriate to say to one of your talents.



For instance, in the screenshot below, he was talking to me about how I had been drawing a meme for Hazbin Hotel episodes being dropped. I was excited and wanted to practice drawing on my tablet. I know I am bad at it, but I was happy with how my practice went. I told him "it's not great but I think that I did good for practice since I haven't drawn on my tablet for months" to which he said he wanted to see it. He proceeded to cackle and mock me. It was a meme of the oshi no ko "this shit is so ass meme". He asked while laughing "does it have that text because this shit looks so ass?" Which made me feel like crap. I sent pictures of my 2d art I've done later to prove I can draw after feeling like he thought I couldn't draw anything. Art I am proud to show. One of them was a xenomorph because at the time I drew it I had seen the movie for the first time. Instead of commenting on my art at all he said "You want to fuck a xenomorph?".

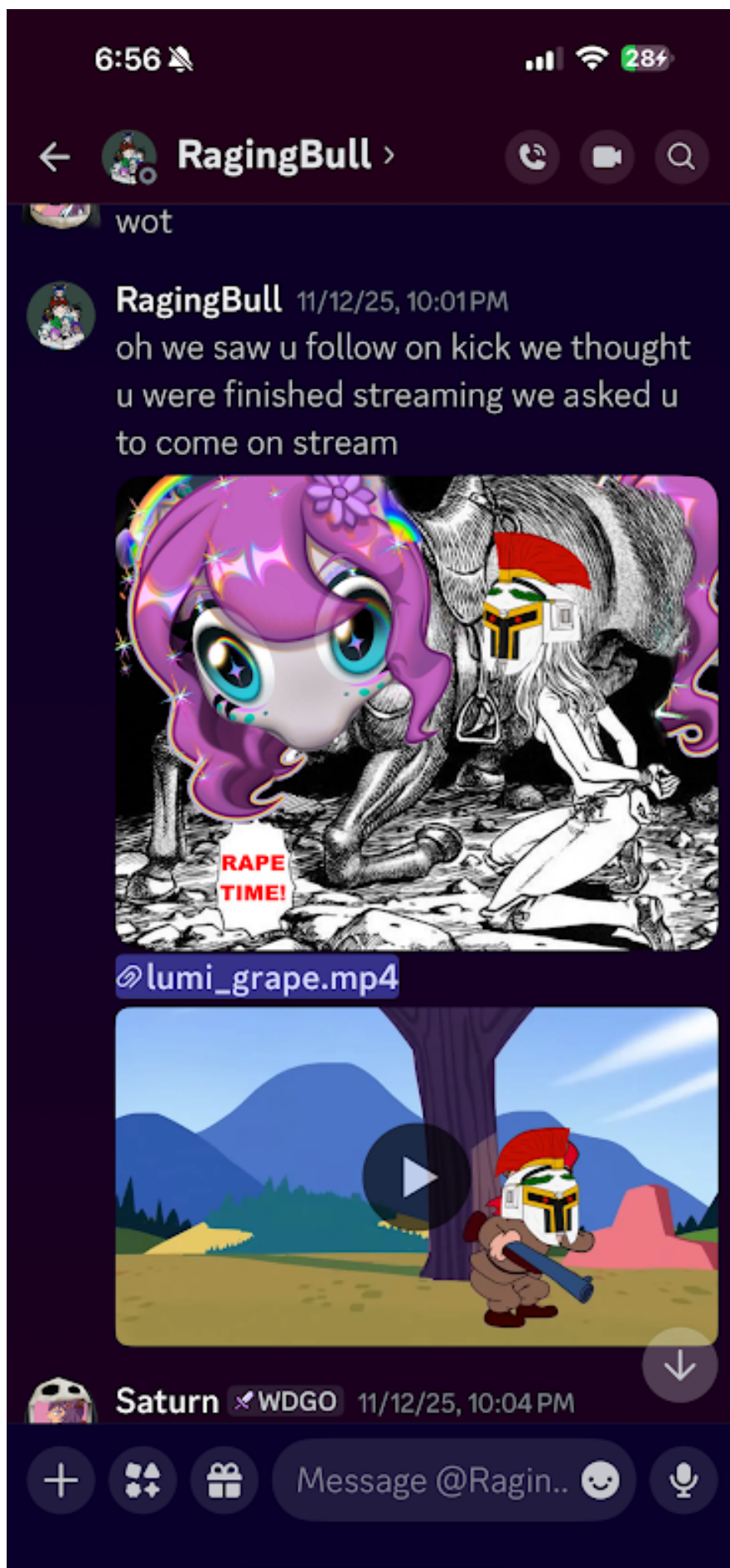

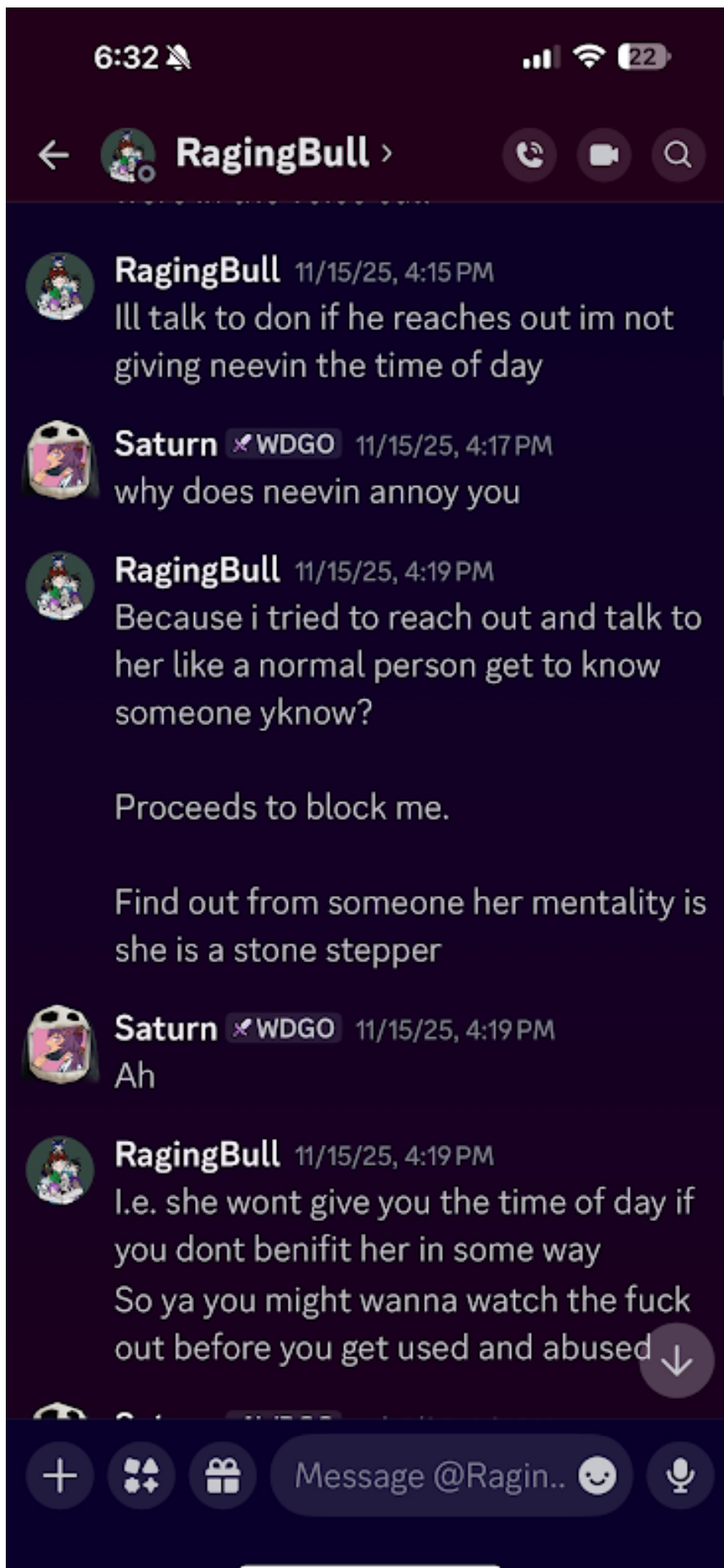

He has also bad-mouthed multiple talents to me, including people who weren't even talents yet.  
Some in calls and some in screenshots.

Shiro: he was annoyed that she made a post. He called her stupid, too young to get stuff like social media, and being mad she wouldn't listen to him. He also complained she didn't talk to him as much as I did. Turns out she had taken that post down in five minutes without him even telling her to do so.

Neevin: he had said on multiple occasions that she is a bitch and a stone stepper using people to get more popular. He said he doesn't like her because she blocked him and was being a stuck up bitch. As it turned out, she had never blocked him. As for being a stone stepper, it doesn't make sense since she has more of a following than me.

## **ShirOwan - Former LuckyEn Member**

RagingBull kinda grilled me on a quote tweet I made of a random dude I saw on my TL. He sent it to me with a GIF of someone smacking someone else with a newspaper, saying it's "unbecoming" to start fights.

I wasn't trying to start a fight, just giving an opinion on the thing he was talking about. I had to open up about my mental health to explain myself, which is something I keep kind of close to my chest. So much for that I guess

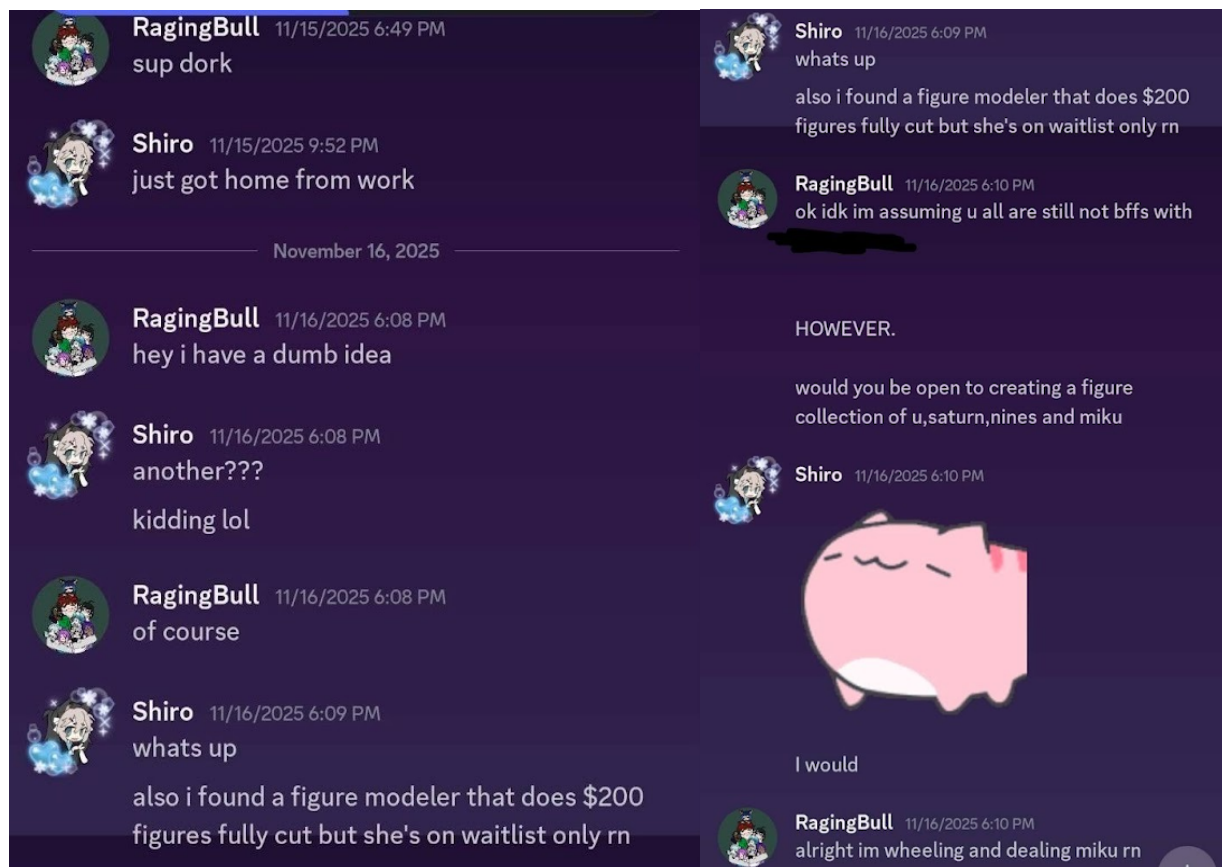
I had approached RagingBull to ask him for PR on a tweet I made, but deleted quickly because it was not received well. When asking for PR, I believe one is asking about what to do going forward. Instead he makes a point of bringing up where I went wrong and how he disagrees with me.,

This is also where he says he wants to discuss things privately, not with my moderators. (in the call were all my mods except for Jordan, who I know).,

People in the call reported to Don how RagingBull was acting towards my community and me, noting that he was quite harsh to me. I met his energy and did not take that shit from him, causing him to apparently join a VC in Saturn's server to complain about me.,

I never complained about him to anyone other than my boyfriend.



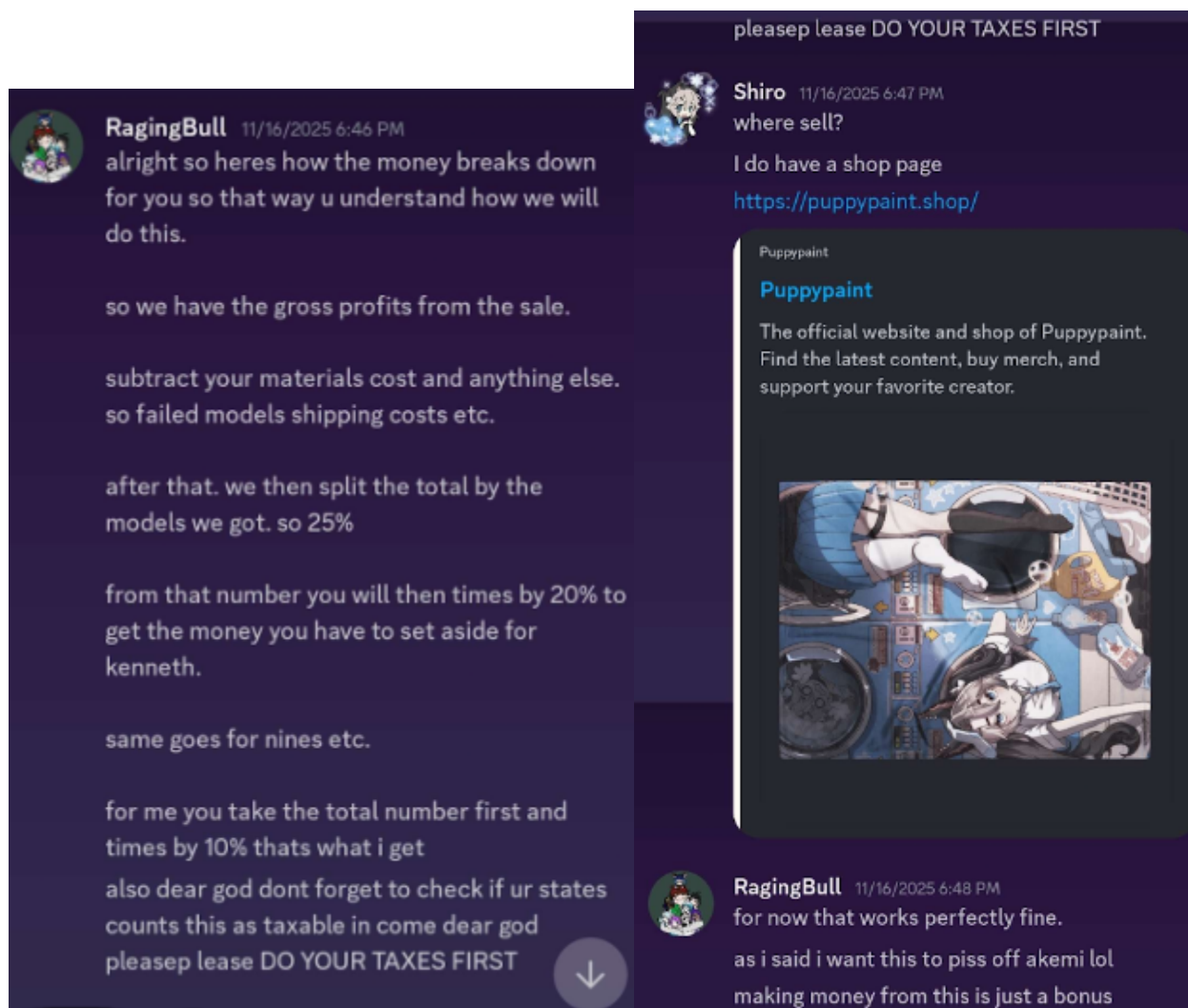

These screenshots reveal a conversation between Shiro and RagingBull about his attempt to produce figurines of the former VTards. In the section where he explains the money and payment breakdown: This exchange shows an extremely inappropriate and unethical arrangement.


RagingBull instructs Shiro, his own talent, to handle all money, taxes, materials, shipping costs, and financial preparation for a project he was supposedly “managing.” Instead of acting as a legitimate agency or business (which would handle payments, taxes, etc on behalf of its creators), he pushed all responsibility onto Shiro, exposing her to personal tax liability because there was no real company structure in place. Telling Shiro to manage revenue splits, cover expenses, and handle state tax compliance on her own is not standard practice, it’s dangerous and unprofessional. What makes this worse is that he still expects to take a 10% cut of the profits while doing none of the actual labor: not the production, not the shipping, not the legal filings, not the taxes. He wanted the benefits of being a “manager” without offering any of the legal, financial, or structural protections a real manager or company is obligated to provide.

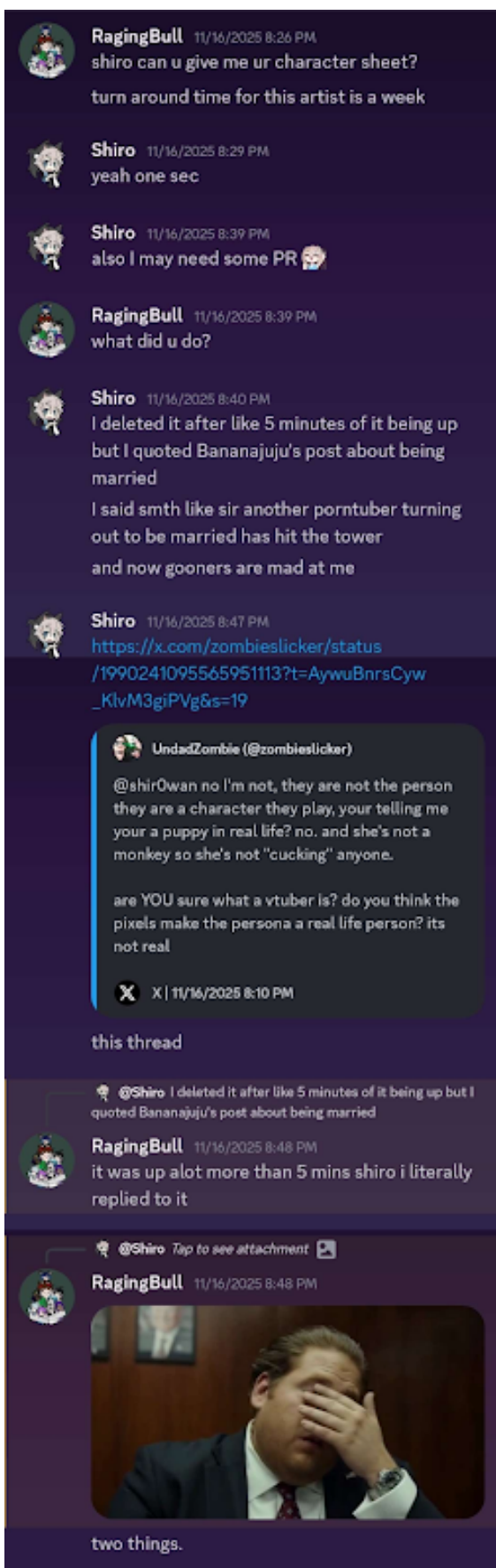



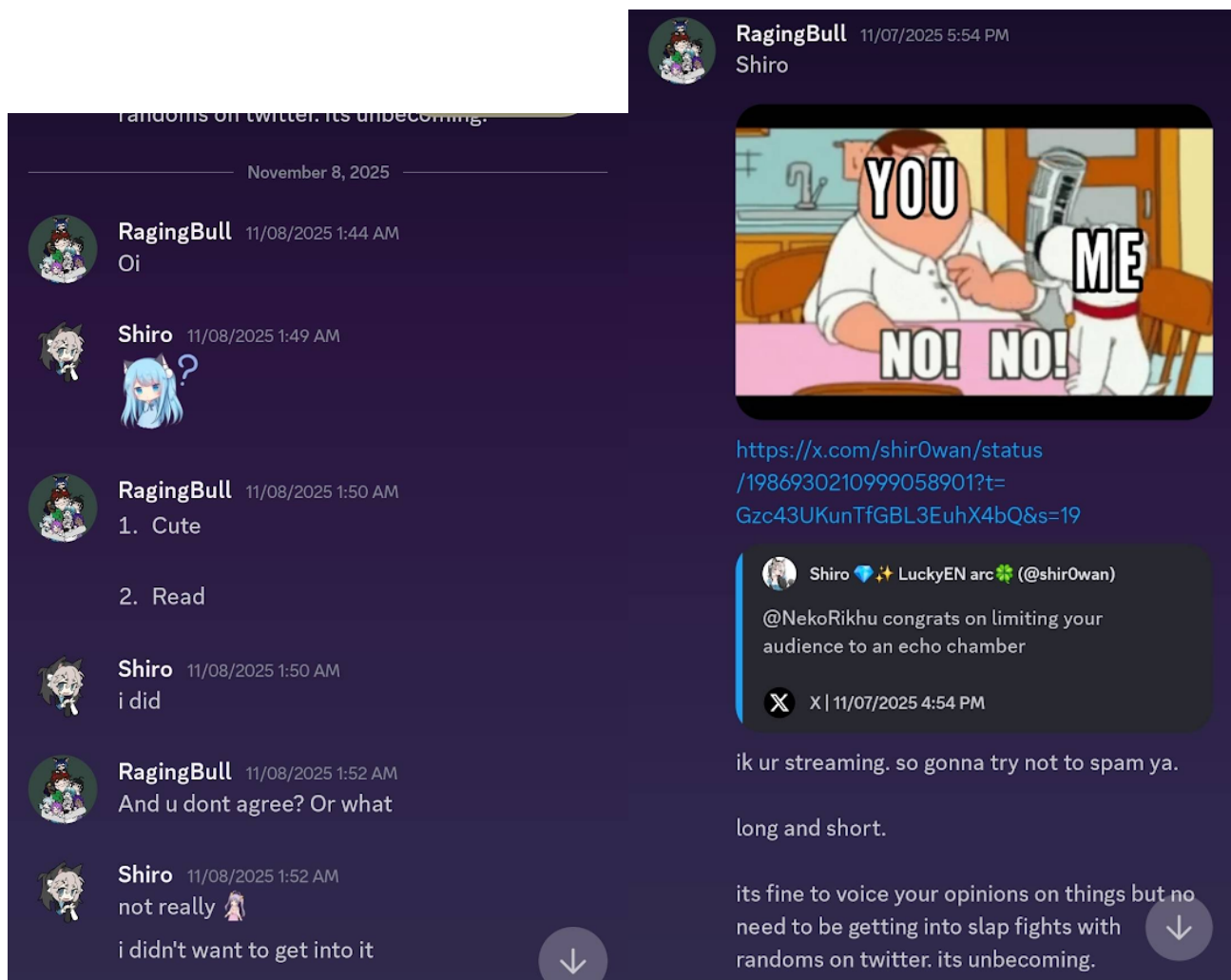

The conversation shows RagingBull speaking to Shiro in a rude, intrusive, and unprofessional way despite being her supposed manager. He pressures her about her twitter posts, pushes her to agree with him, and ignores her attempts to set boundaries. When Shiro expresses discomfort or personal struggles, he dismisses her feelings and even claims he “doubles as a therapist,” which is manipulative and inappropriate. He scolds her, demands immediate responses, and treats routine conversations like “business emergencies,” all while speaking to her in a condescending, impatient tone. Overall, his behavior toward Shiro is controlling, disrespectful, and far from anything resembling proper management.

These screenshots show RagingBull treating Shiro in a controlling and exploitative way. He makes sexual jokes, critiques her appearance, and inserts himself into her personal decisions. He even admits to “collecting talents like Pokémon,” showing he views creators as possessions rather than people. Despite offering no real support or structure, he expects obedience and access. His behavior is unprofessional, inappropriate, and takes advantage of Shiro’s trust.

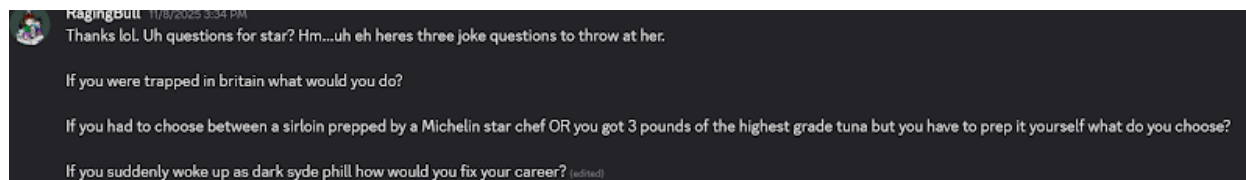
**Don:** During my short interactions with RagingBull, we talked about Akemi. I got his testimony about what happened with her, and it lined up with the testimony Saturn had given me. After that, we spoke about Neevin. He didn’t like Neevin, although he said they had a friendly conversation. From what I could tell, he wasn’t involved in any business-related talks with her.

He also mentioned that she had blocked him, but she never actually blocked him. I think he believed he was blocked because Neevin had her messages from non-friends turned off.

Later, we discussed Miko's interview and debated whether it was a good idea or not.

After that, I brought up panels for Saturn since I was helping her with them. RagingBull said she should have come to him instead. This led to him saying from what I remember he said, "I know very little about Twitch or Kick, but I know YouTube well." That surprised me, considering he was supposedly the "CEO" of a VTuber agency.

In one of our DM conversations, I asked him some questions on behalf of Starcat. One of them ended up being a DarkSydePhil-related question, which made Starcat uncomfortable during our interview because of what DarkSydePhil is known for.



Later in our DMs, the conversation shifted to a VTuber named Haru. Two LuckyEn talents had collabed with Haru in the past, and since I'd had negative experiences with Haru myself, I warned RagingBull to keep his talents away from Haru upon Shiro's recommendation. I did say that calling her thin-skinned was "based," but he brushed it off and said it ultimately wasn't any of his concern.

Then, out of nowhere, he sent me a screenshot of (or linked me to) a tweet about Usagi and started calling Usagi a pedo and throwing around other serious accusations. I told him I didn't like Usagi either but had never spoken to him directly — though one of my mods and Usagi seemed to be on friendly terms.

Right after that, RagingBull asked me for a "favor": to help him deal with Kodiak. The way he phrased it and what he was asking for didn't feel like something a legitimate manager or CEO should be requesting — it came off as shady and unprofessional.

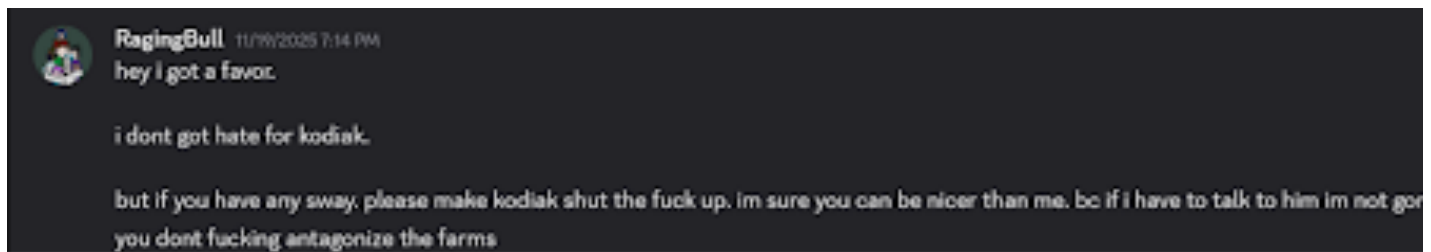

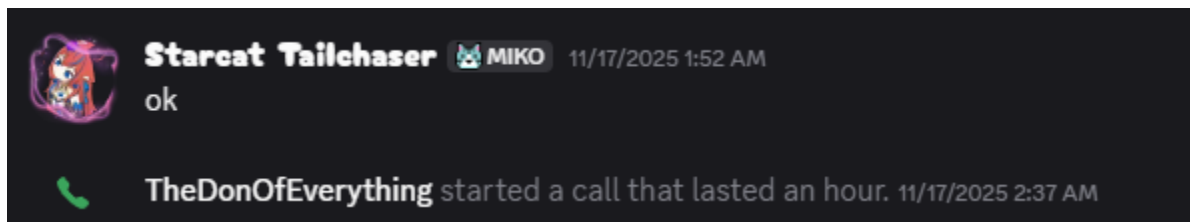

Just one day after my call with RagingBull, on November 16, Starcat reached out to me. The next day (November 17), I shared everything I had on RagingBull, which was still limited at that point. I was already highly skeptical after the call the previous day, especially since I'd been hearing mixed and worrying reports from various mods.



This led me to pull in Distress (Miko's fiancée) and Ali (Miko's friend) for additional context. Around 5 a.m., Starcat and I told Miko everything in Starcat's server. That means Miko was the very first talent to learn about the full extent of the issues with RagingBull.

After Miko, I informed Shiro next, then Saturn. Once those three knew, all the other talents started reaching out to me by joining the server through invitations from Miko so they could share their own experiences. I kept detailed mental notes of everyone's points and testimonies. By about the tenth time I'd recounted the same information, I had it down nearly perfectly. The pile of evidence kept growing: more screenshots, more testimonies about problems with RagingBull or LuckyEn in general.

I spent multiple sleepless nights organizing everything, helping the talents, and managing the flood of information.

The original VTubers who ended up knowing everything I had on RagingBull were:

Miko, Shiro, Saturn, Moka, Razorwind, Enatsu, Celestium, and Junie.

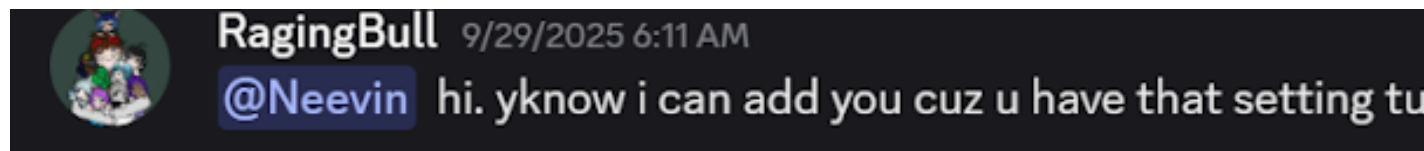

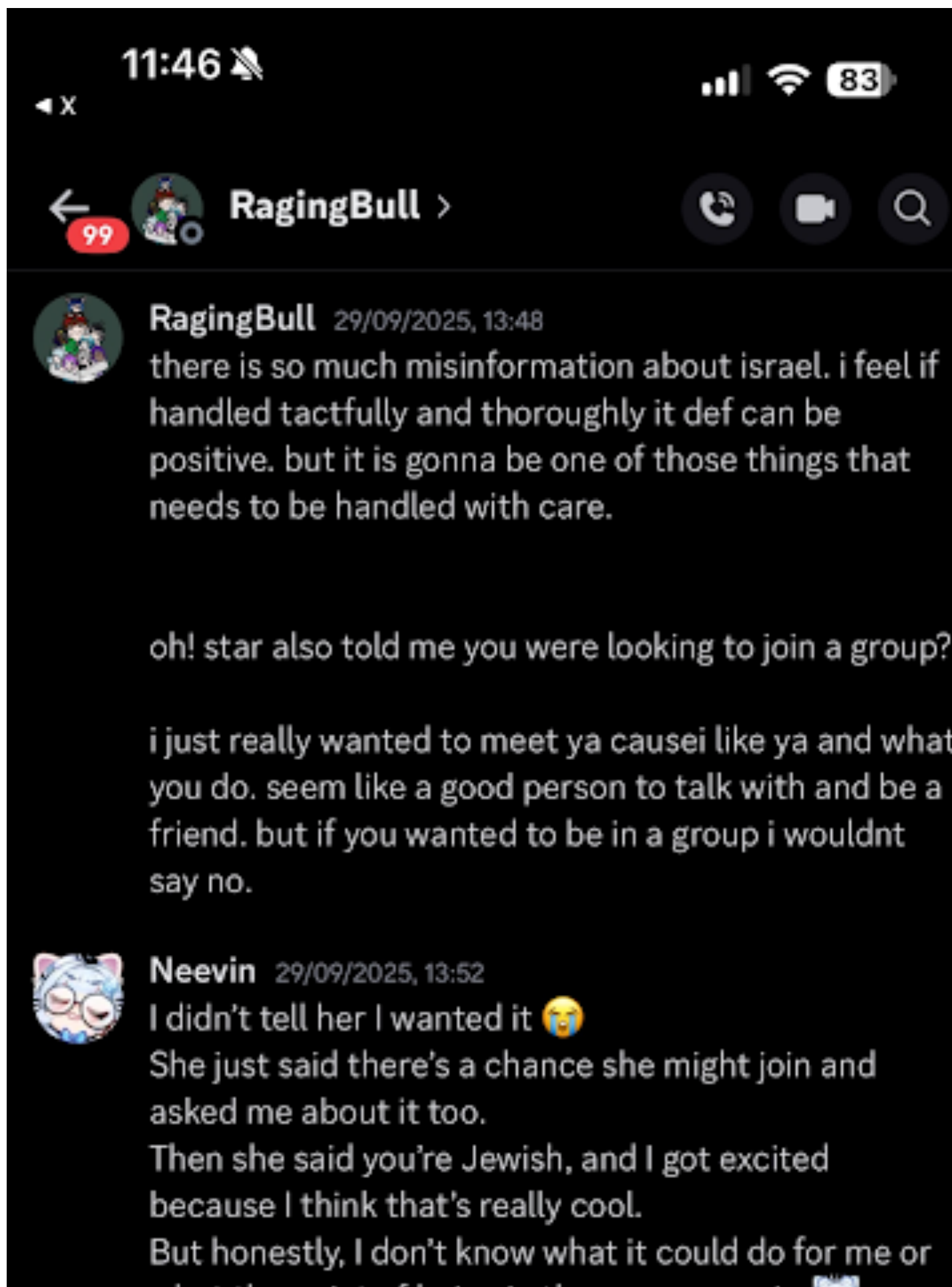

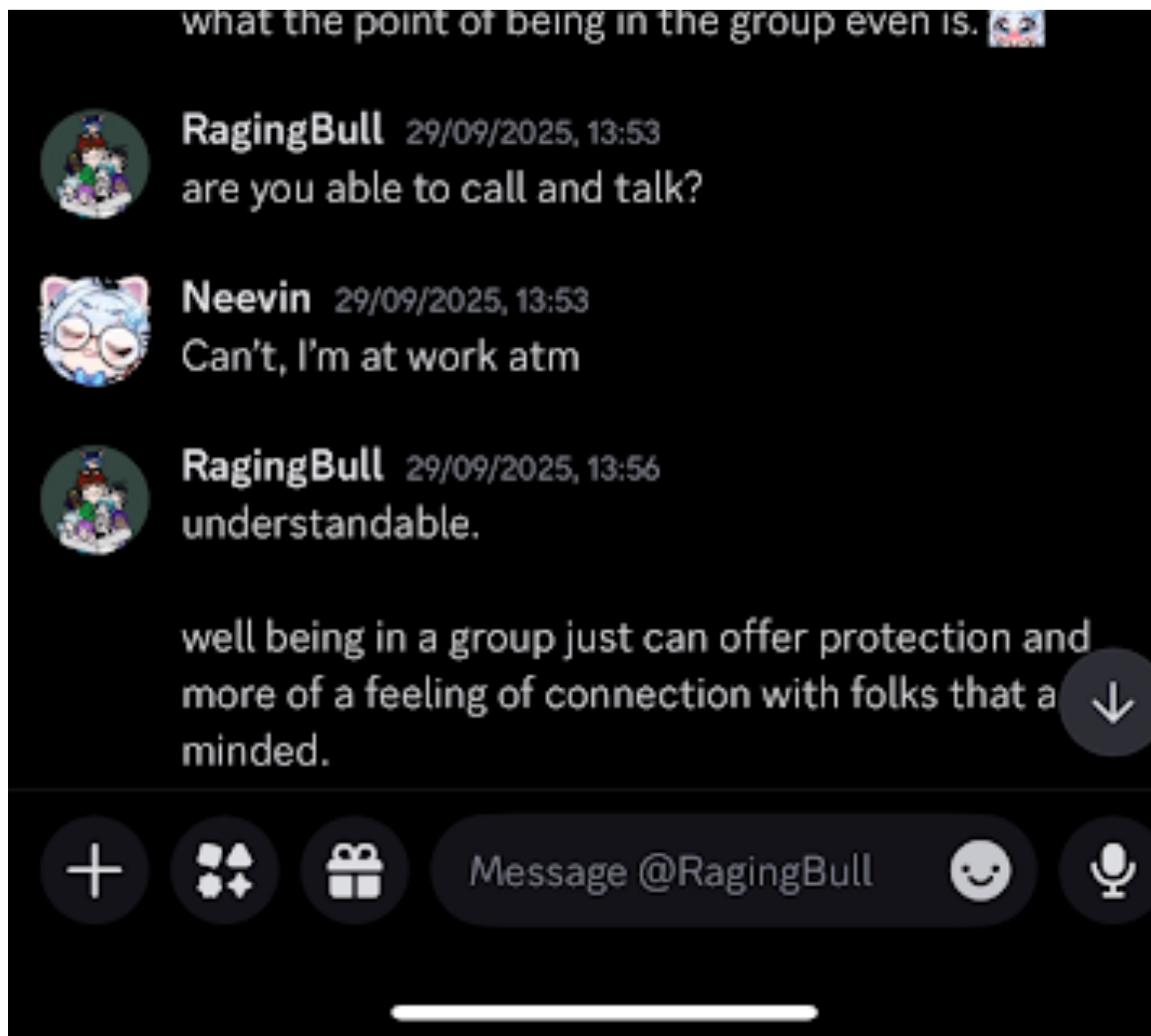
Additionally, I was present in nearly every voice call that happened in the “real company” server with the talents.

## RagingBull Misc.

RagingBull told Starcat that Neevin had blocked him. This wasn't the case, Neevin had turned on friends DM only and RagingBull had not friended her. RagingBull knows full well that Neevin never blocked him. He also lied on several occasions stating that he never attempted to bring Neevin into LuckyEn even though he attempted to do so.







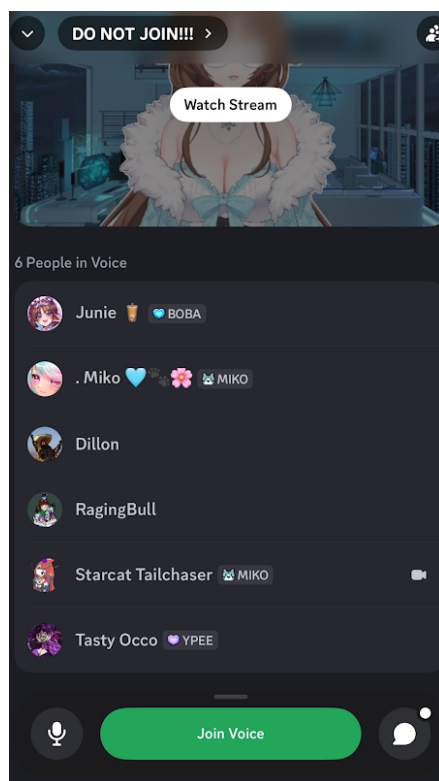
## Defenders/Blame Shifters

[The discord server that will be mentioned where the LuckyEn members plan their testimonies and screenshots against RagingBull and their departure announcements will be referred to as the Testimony Server.

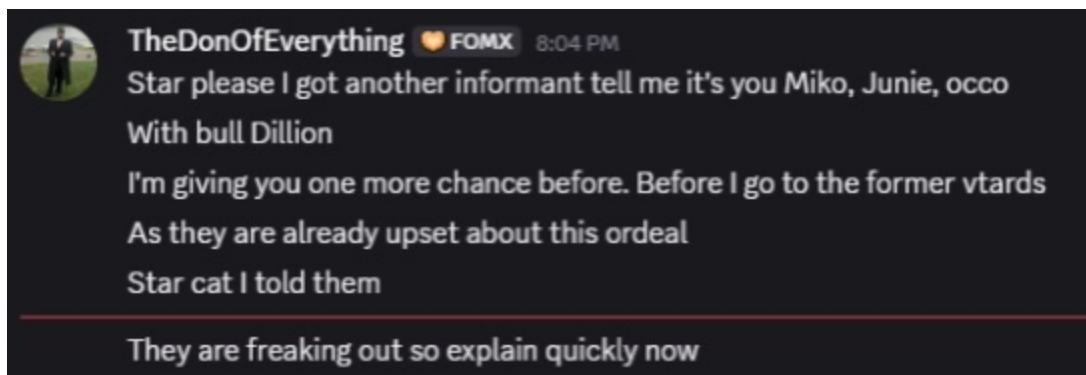
During the process of planning an exodus from LuckyEn, several members who had initially decided to leave suddenly changed their minds, deleted messages in the testimony discord server that was being used to collect their statements and evidence, and then began placing blame on, or outright blocking, the people who were simply trying to support them through their departure: Momma Occo, Akuma Miko, Junie, and Starcat.

This was shortly after a voice call was made in the LuckyEn Discord server in the voice chat with the title “DO NOT JOIN!!!!”. The first ones to show up in the VC are Junie and RagingBull. **The individuals who were in the VC never informed anyone in the Testimony Discord Server of their participation and were offended when asked about it, stating that it’s there to announce Starcat’s departure.** Soon after the voice chat was over, the aforementioned LuckyEn members began deleting their messages from the Testimony Server before being kicked. Junie blocked everybody who was in the Testimony Server, including the talents and their moderators.

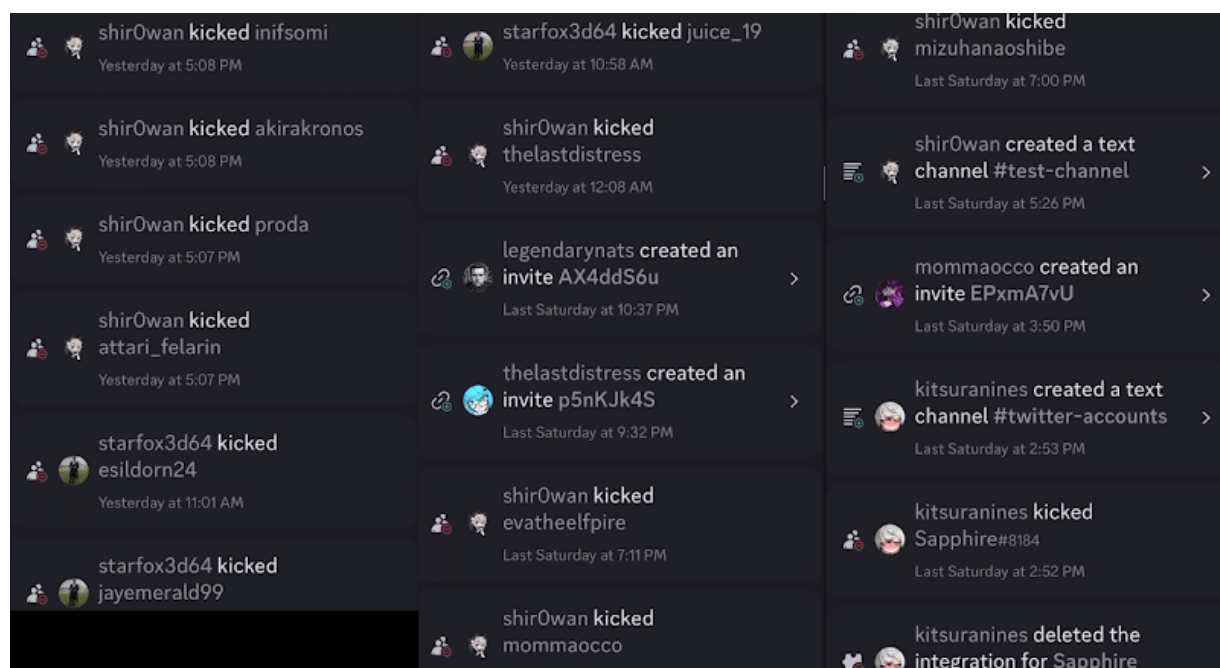

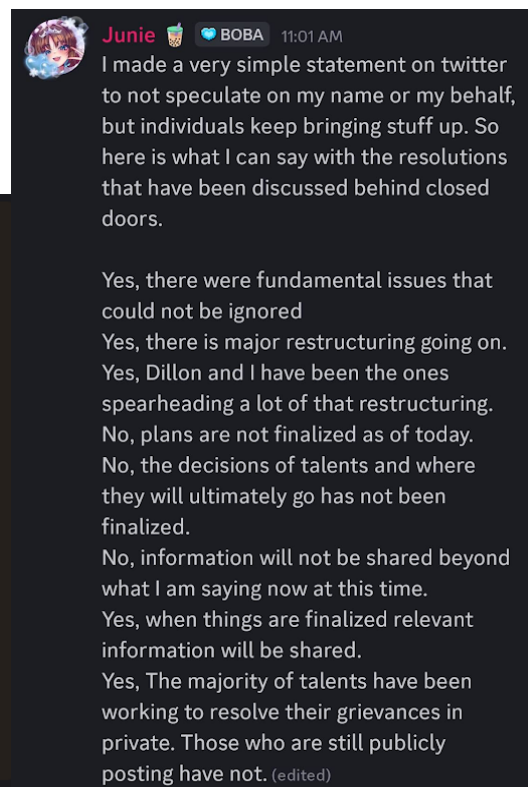
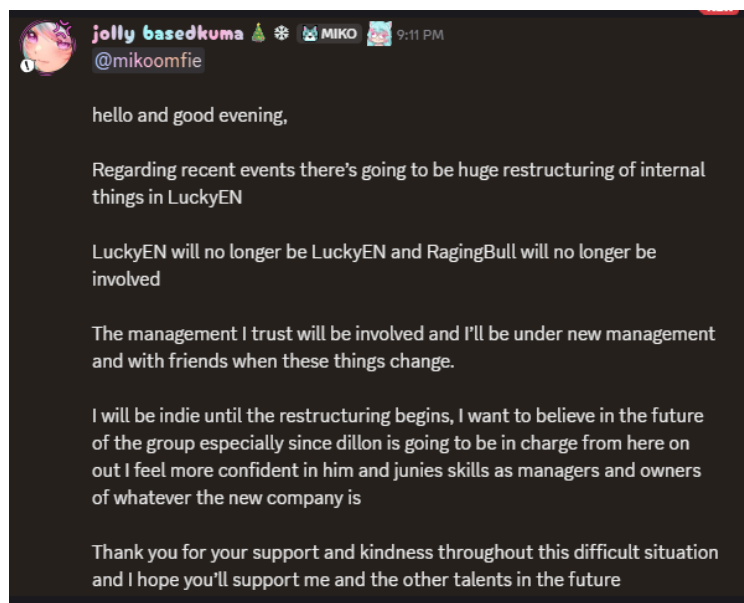


Here is the audit of those who are kicked from the server.

After these individuals were kicked from or left the Testimony Server, they began hurling various accusations on X and Discord at the talents and staff who had been trying to help them leave LuckyEn – including TheDonOfEverything, Saturn, Shiro, and others. All the while, the talents of LuckyEn announced their departure from the group, which lines up with the screenshots above, because even though RagingBull might not step down from LuckyEn, the talents would separate from LuckyEn while still remaining together.

First public mention of this situation: Initiating Post that is now deleted shows StarCat suddenly taking a huge turn when she was highly active in the Testimony Server which will be shown in the section dedicated to her. She claims exhaustion and says “if they are a friend, they should respect your limits and boundaries,” implying that she was overworked and that her limits and boundaries have been violated somehow.

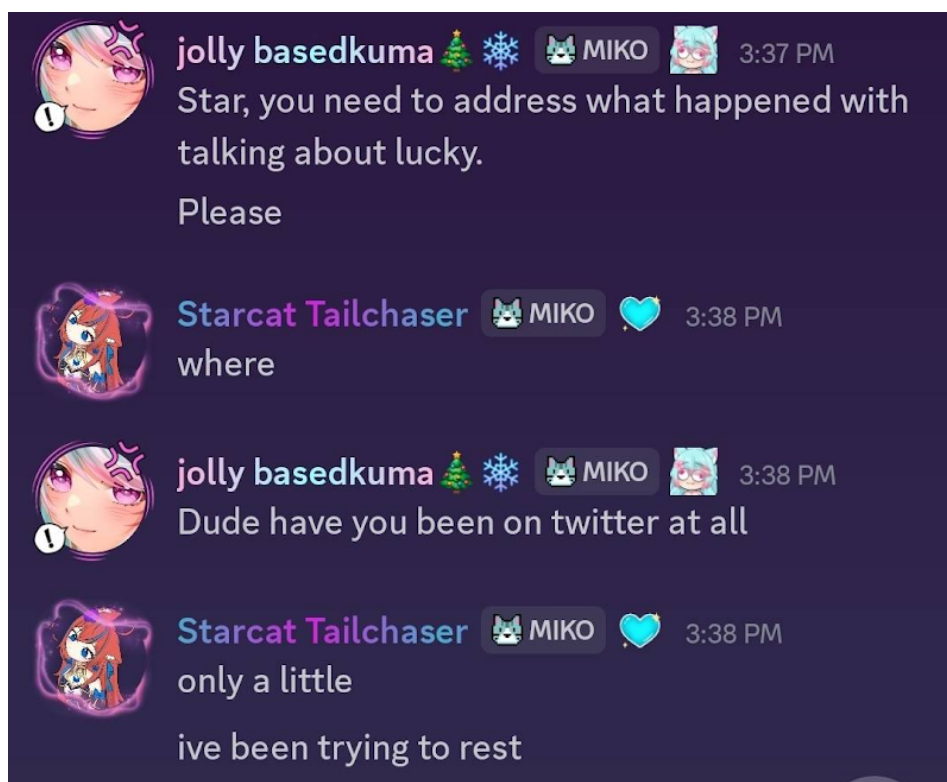

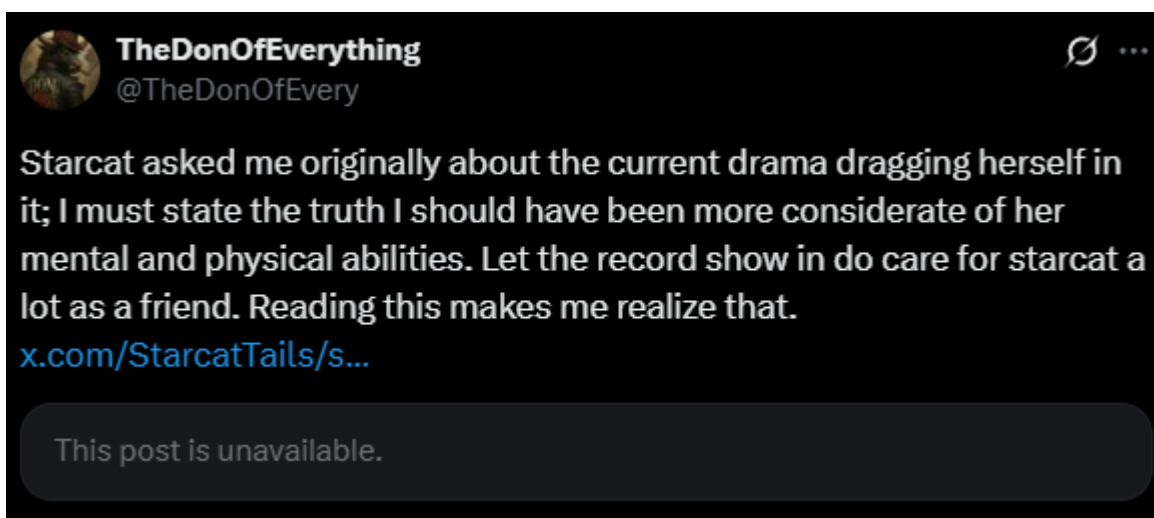

Here is a screenshot where Akuma Miko is urging Starcat that she needs to address her own twitter post (Seen above). Starcat is the only one who made all of this public (even though they claim they didn't want this to be public) by making this vague Twitter post. This exchange in the screenshot above with Akuma Miko supports that, and shows that this post was also definitely about LuckyEn. The Don and the others never intended to make anything public against the others' wishes, but this course of action by Starcat and Akuma Miko's aggressive defense of Starcat after the apparent "threatening" forced it to be out in the open.

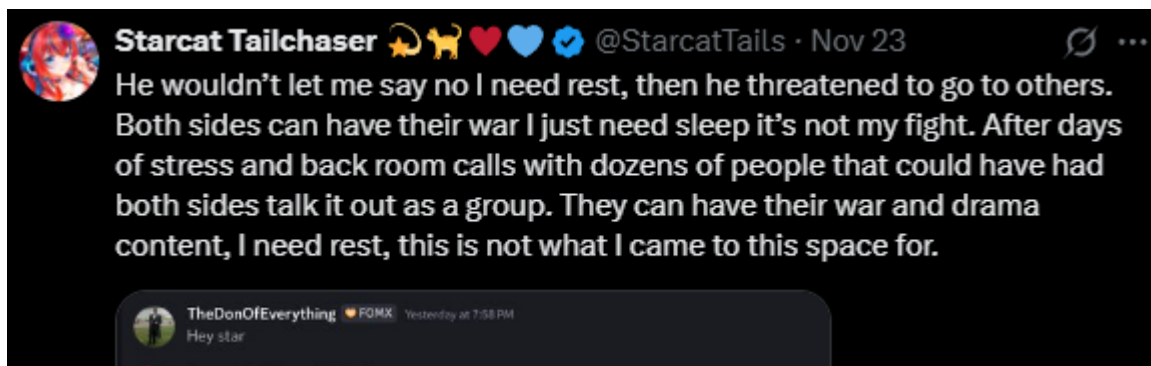

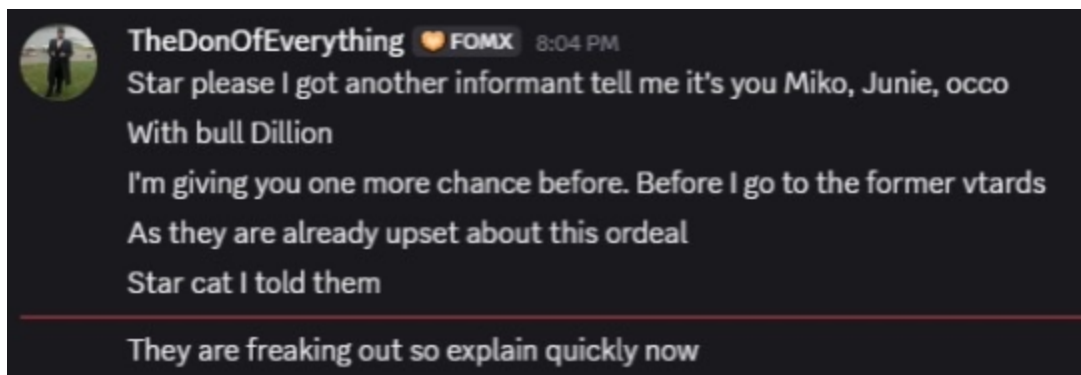
Starcat said to Neevin that she roasted her on Twitter, after she tweeted this to her, and it often felt like she couldn't handle any criticism.

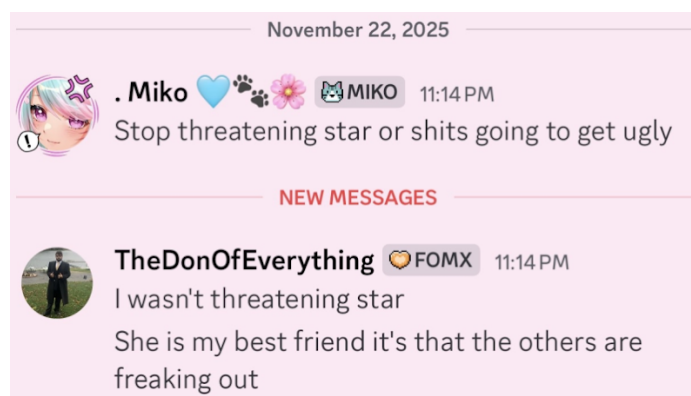

To clarify, Don was planning on informing the people in the Testimony Server about their presence in the "DO NOT JOIN!!!" voice chat on the LuckyEn server due to RagingBull's presence in that voice chat. None of the people in the Testimony Server who were trying to facilitate the exit of LuckyEn members were informed of this voice chat, except for those who were in the LuckyEn discord server and when the individuals in that voice chat were questioned about it, they responded with hostility, making the "both sides could have talked it out as a group" claim impossible.

After Starcat made the accusatory comments to Don, those who participated in the “DO NOT CALL!!!” voicechat along with their fans began immediately jumping on X to attack those involved in aiding them on their departure.

We will examine the specific individuals who joined the Testimony Server to help LuckyEn members exit LuckyEn and RagingBull, but who—after a private voice chat with RagingBull—abruptly left and began attacking former members and their helpers. We will review their accusations and compare them to screenshots revealing their behavior at the time.

## StarCatTailChaser

Starcat initially reached out to Don to ask what he thought about RagingBull which initiated the plan for LuckyEn members to distance themselves from him(RagingBull). It was not until StarCat suddenly entered the VoiceChat with RagingBull where Starcat accused Don of threatening her.

This screenshot below proves that Starcat was the initiator that had Don investigate RagingBull and LuckyEn. StarCat was the individual who approached Don for his opinions on the group. Starcat had direct involvement in grouping with people like Miko and Saturn to help people leave

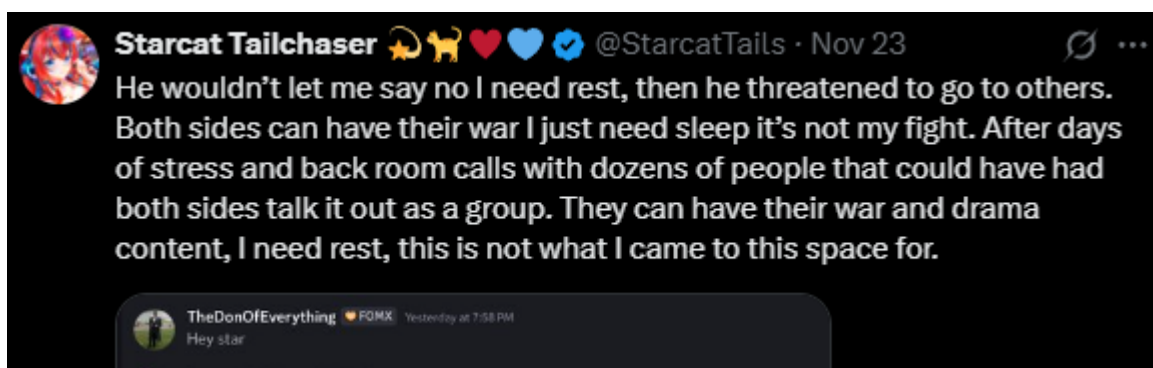

There were a lot of people throwing around accusations that Don “did all of this” because he supposedly wanted to become a manager or “take over” LuckyEn. That narrative is completely fabricated. It is pure slander and never reflected Don’s intentions at any point. The only reason the topic of management ever came up is because *Starcat* casually asked Don if he had ever considered starting his own agency. That’s it. There was no plot, no takeover, no hidden agenda, just people twisting a harmless conversation to fit their own storyline.



There are two claims in this screenshot that will be addressed accordingly:

1. Not allowed to rest
2. It's not her fight



While StarCat was in the Testimony Server voicechat, she was making an animation that celebrates the freedom from RagingBull and the “dumpster fire” known as LuckyEn and was excitedly preparing it for “release day”. Take note that the messages were sent at 3:47 AM EST. Both Nines and StarCat live in North America.

1. This Google Doc was drafted as a precaution and a video was apparently planned by Neevin. The talents were supposed to leave quietly but the situation escalated where the document drop was inevitable.

This is the last post I will make on this topic in regards to the Lucky EN situation

After an interview with the don of everything he had told me raging bull had lied to him in regards to some of the other members he had interviewed from the group known as vtards

As this was an agency I was wanting to join to be alongside Akuma Miko I asked Don what he knew

He brought additional information to myself Miko and Distress her fiancé he also brought in the group known as vtards as well as one other I don't remember the name of into a voice chat where they presented information.

One of the others started a discord server and Don along with the others brought in lucky talents to get present their information and get their side of the story

Meetings persisted for days as people were slowly brought in and information was stockpiled. Information that was only to be used if raging bull did anything such as doxxing as he had a lot of the various vtubers private information

A google ducky was to be drafted a preemptive video was to be made by neevin and the talents were to leave all at once for hopefully a quiet separation.

After Miko left Lucky Raging bull made me an offer to join lucky and that he could expedite the process to get me in. This optically was viewed as a manipulation tactic. I was asked to tell my story about it to nearly every new person that came into the chat.

This continued people and their mods joined the discord in an ever larger group growing, Th direction started turning from peaceful separation to dimply wanting to drop the document and video from Nevin.

After several days of all of this and near the end of a very long day for me with the docy server I ended up in a chat with Junie Miko and others in which they invited raging bull in and dillion in from lucky en to get their side. And to tell them for at least myself and miko we just wanted to go our separate ways peaceful and didn't want to be a part of the attack that was now coming.

The situation snowballed from a lie to a question to more people having information in a pile as it ever rolled down hill. Did raging bull do a lot of things that a manger shouldn't do yes, And there were real concerns about him yes. He had a lot of personal information on everyone, he had been in a video chat showing off guns and had even put one in his mouth. So there were concerns of real harm being a possibility, I had only met him irl this past Tuesday and he had enough information to determine my address should he be upset.

I wasn't a lucky Talent, I wanted to be one simply to be with my friend Akuma Miko as agency sisters. She only wanted to warn the other talents of information about a manager that had gone too far. My intent and hers wasn't for everything to be scorched earth or burnt down. I will admit I was stressed and making a short 40 second video showing things as flames to express how I felt but I asked that my art and comments not be used without my express written consent before I left the server. I have been informed that both some of my comments and art have been posted against my wishes.

I hold no ill will to any of the sides in this conflict, I wanted to support a friend and make sure if people had been abused, they could get away. I hoped everyone could have separated peacefully and stayed friends and support each other. I just want to be left alone to lick my wounds and continue to make friends and content if people still have me.

I want to be clear on this point, Akuma Miko did not start this, and I asked Don about Lucky because he had said raging bull had lied to him in regards to saturn and shiro.

This document was initially going to be made in case RagingBull and the others in LuckyEn were to take heavy action against those who were planning on leaving. StarCat, as seen from this post, made a video for this document drop (the last message in this image). No one asked her to do this.





StarCat can call the video a stress-coping exercise, but whether it was actually that or simply something she made for fun is up to viewers to decide.

Neevin never agreed to make a video on LuckyEn. If the video was made, Neevin would have made the video to help them(Starcat, Miko, etc.)

Starcat stating that she has no ill will towards Don is facetious because she accused Don of “threatening” her and lied that he would not let her rest. There was no reference to the “DO NOT JOIN!!!” VC that included RagingBull. Neevin proved that StarCat was lying as an overworked sleepless victim and the moment StarCat received backlash and the moment when Don was attacked for these vague statements, that was when StarCat began to make the second post(consisting of three images above).

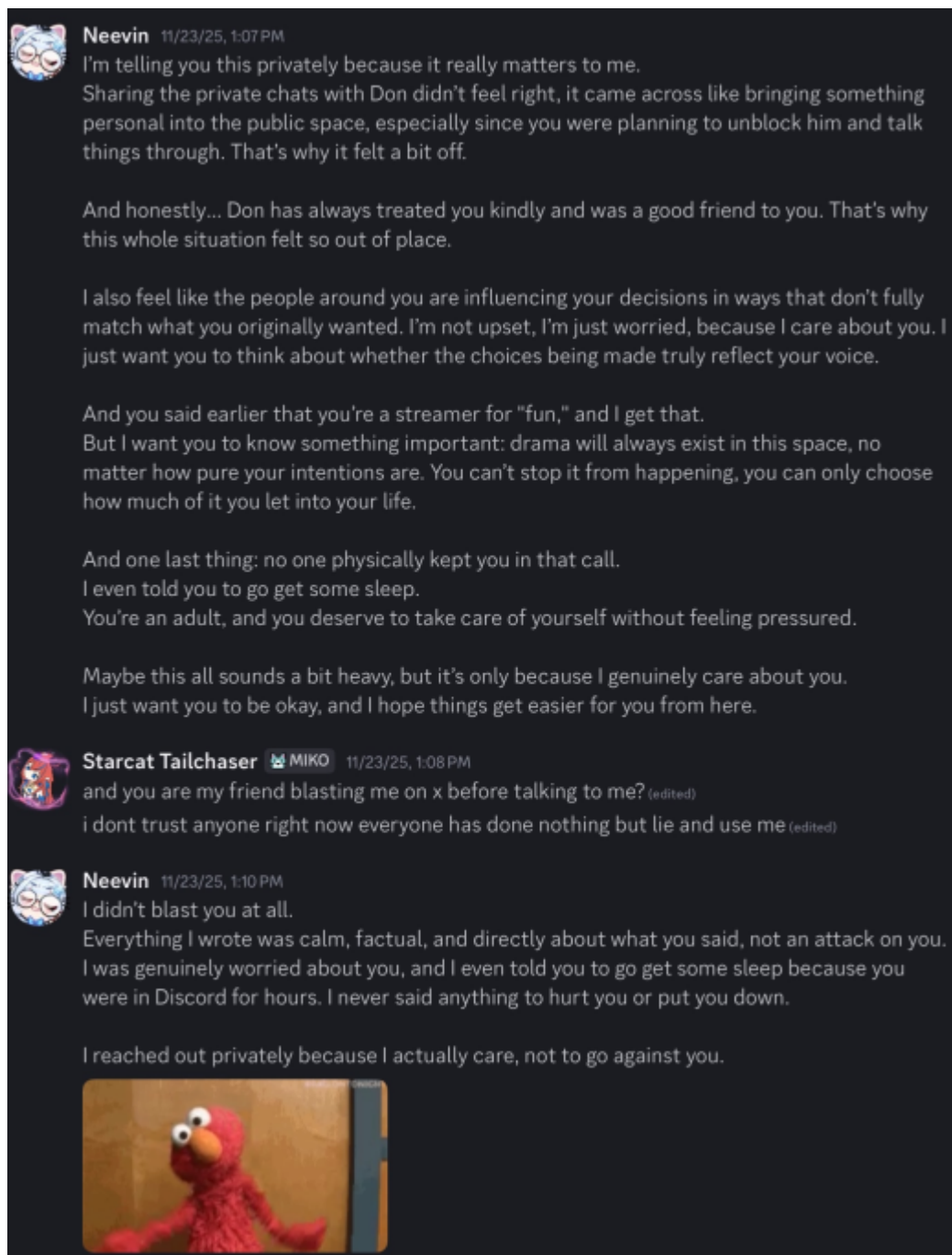

1. Starcat met RagingBull in person. During that meeting, she expressed strong concerns about his ability to run the "company" professionally, saying he lacked business experience. She went so far as to create a full business plan for him to help fix the issues.
2. He also claimed that he had personally invited Neevin to join the group/project and that Neevin had turned down the offer.
3. Starcat told RagingBull that Neevin wanted to join LuckyEn; Neevin said, clear as day here, that is untrue. Additionally, the DMs between Starcat and Neevin show that Starcat was implying that RagingBull was "really nice" yet Starcat asked Don what he knew about RagingBull because she did not trust him. Especially since Miko's mods and Starcat spoke about how untrustworthy RagingBull was before the talks with Neevin. This shows that Starcat knew joining was a bad idea but yet tried to influence Neevin to join anyway.

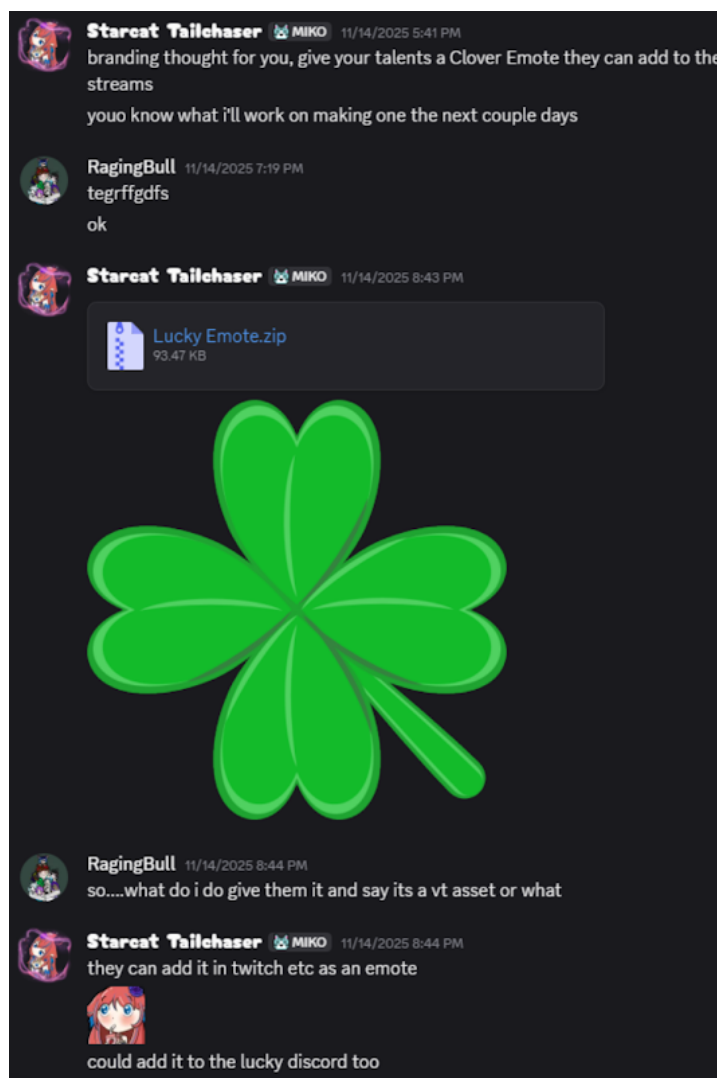


4. Starcat and RagingBull discussed Neevin together and agreed that Neevin was mishandling or mistreating his own community.

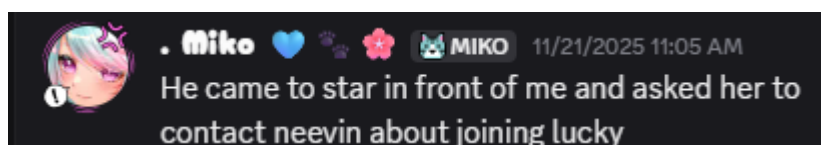
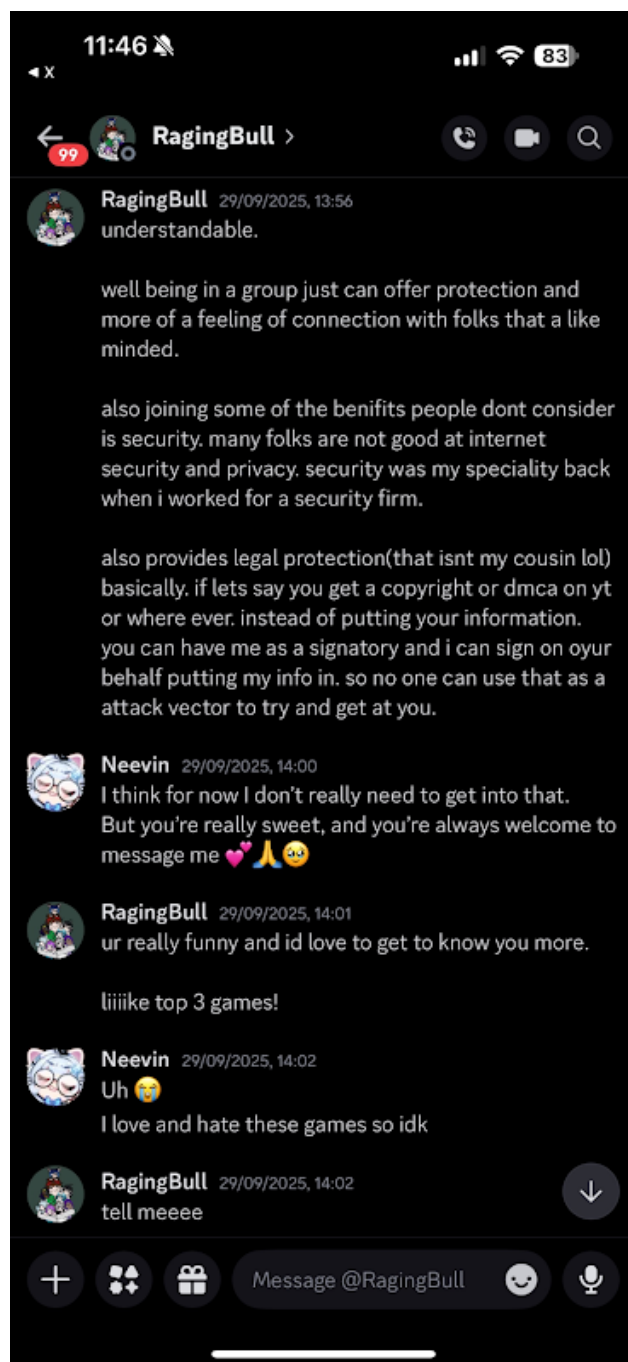
7. Then RagingBull sent Starcat many messages after Miko left and offered to fast track her into LuckyEn to bring Miko back. This shows RagingBull used both sponsorships (refer to Miko) and Starcat as leverage to bring Miko back into LuckyEn.

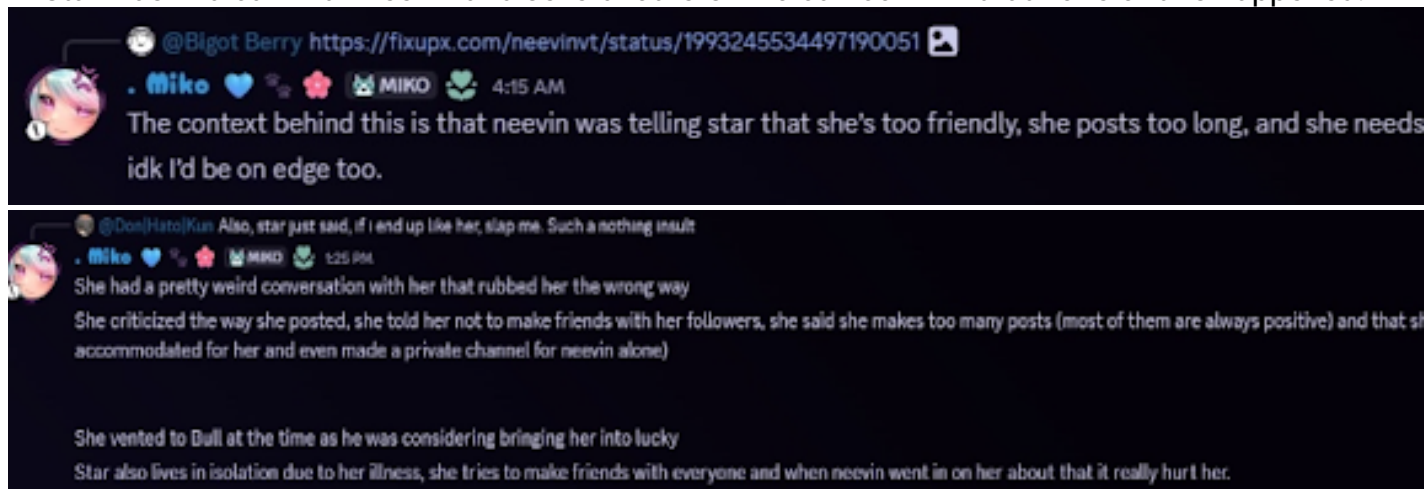


## Neevin's Testimony On Starcat

Star was in a call with Neevin and several others who can confirm that none of this happened.

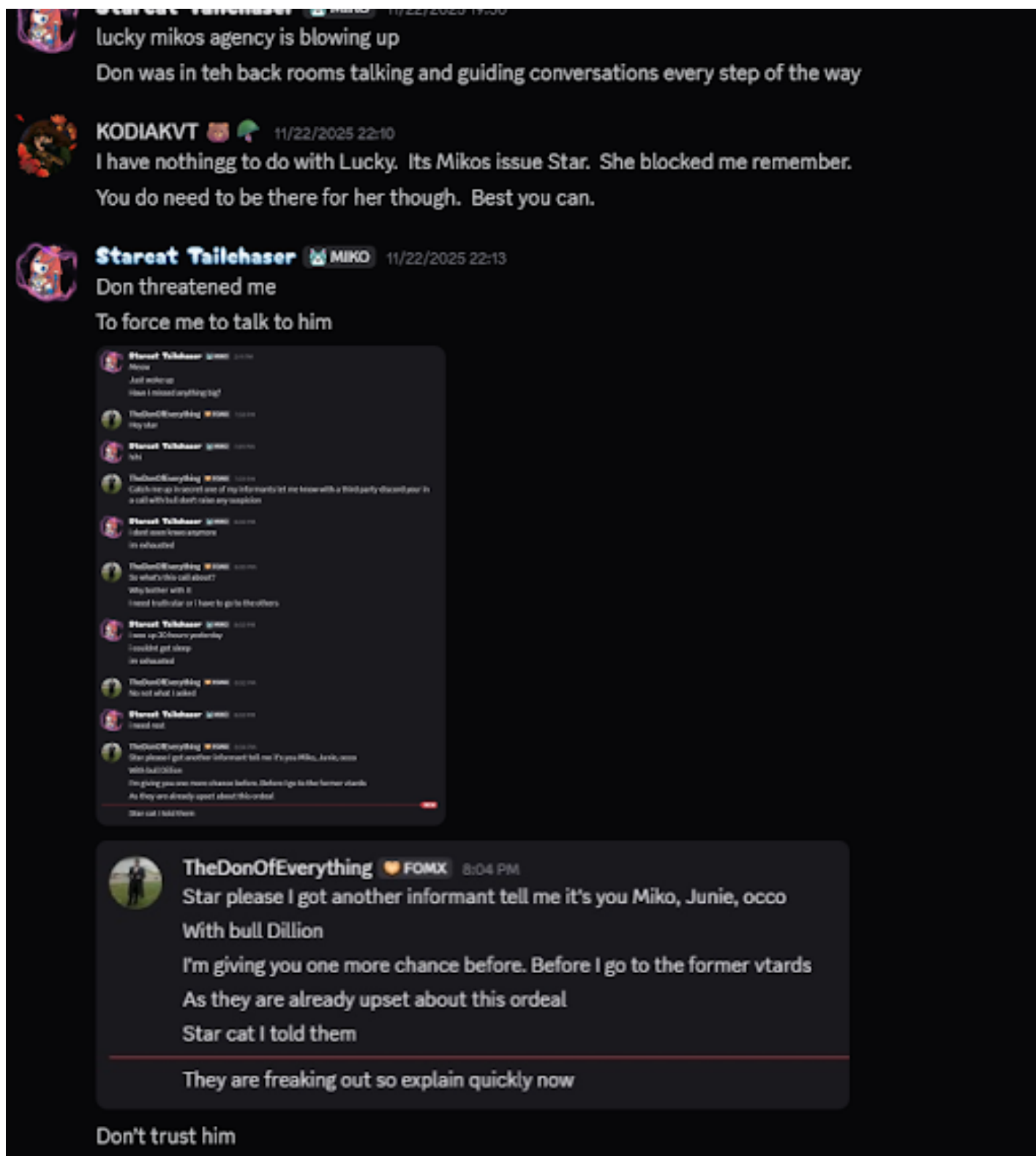


1. Star asked why so many people were not interacting with her Twitter posts, and Neevin gave her opinion, that her posts are too long and people don't really read them.

## Kodiak's Testimony On Starcat

Starcat is trying to rewrite the situation by framing herself as someone who was "threatened," instead of acknowledging that she was fully involved from the start. She willingly participated in every conversation, made videos, and only started calling it a "threat" once it stopped benefiting her. She's using cherry-picked screenshots to appear powerless while conveniently ignoring her own actions and choices.



Neevin explained to her privately what was wrong with the situation with Don and why her behavior was hurtful.

But when someone chooses to speak badly about their own friend just to gain favor with a manager, it shows exactly where their priorities are.

Given that, it's completely reasonable that Neevin won't reach out to someone who chose to stab her in the back.

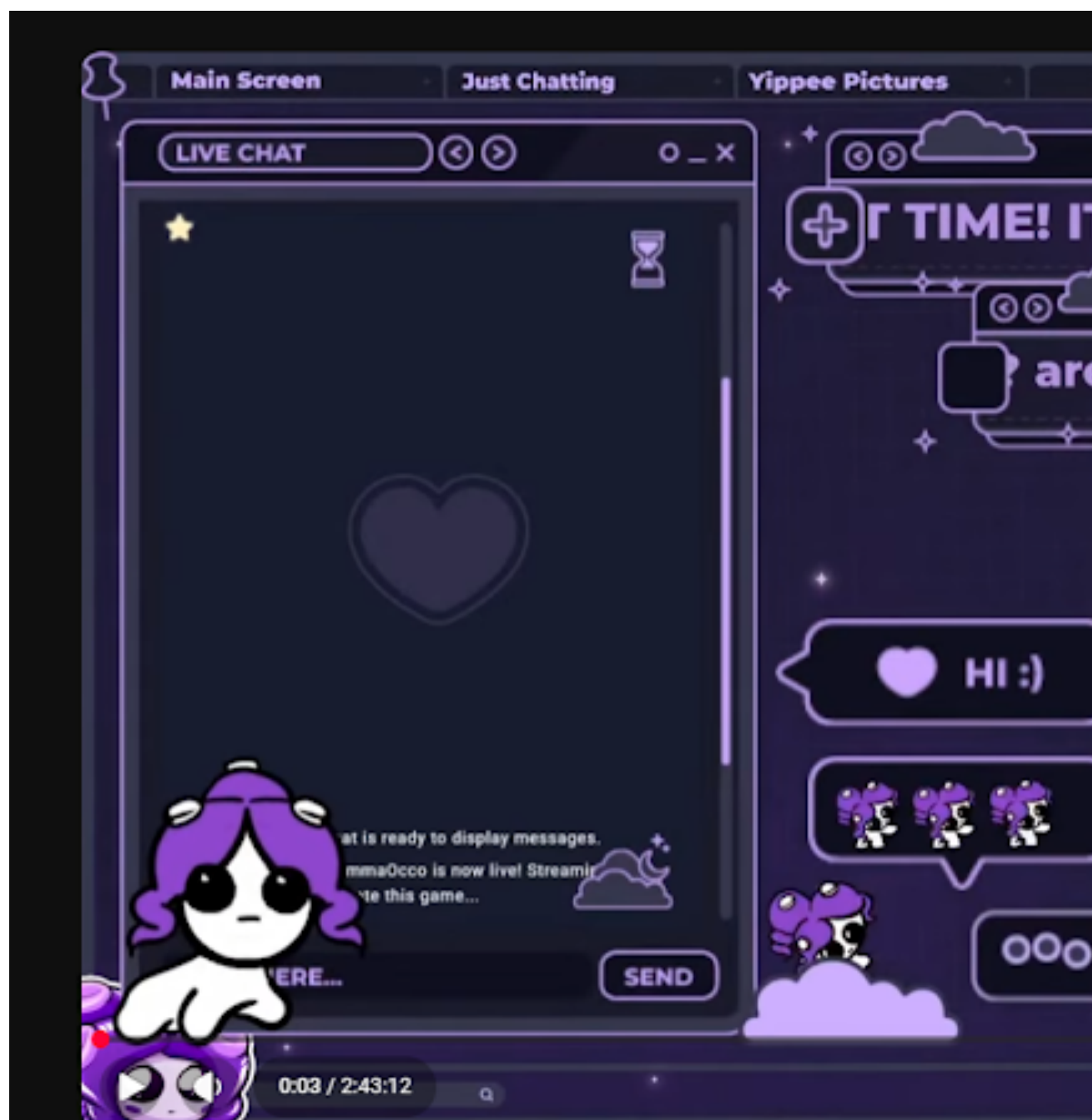

## Overview of Occo's Video

## Mass exodus from Lucky Entertainment

Several talents (Moka, Shiro, Saturn,) left or are leaving.

### Main accusations against manager Raging Bull and Occo's justification:

- Repeated sexual/inappropriate "jokes"
- Degrading and racist/sexist language
- Overpromising what LuckyEn actually was (not a real company/LLC, just a friend group that got too big)

### Occo's statements (as summarized/paraphrased from his stream):

"Occo admits RagingBull is abrasive, autistic, and says edgy/racist/sexist stuff (including hard-Rs), but believes most original members knew this and that Rage isn't malicious, just terrible at communication and boundaries".

### 50:30 The Ex-VTards girls (Shiro, Saturn, Nines) wanted to nuke everything publicly

"They were planning a Google-doc exposé and hoped Kiwi Farms would pick it up. Occo and others begged them to handle it privately. When they refused, a schism happened; the "burn it down" faction got kicked from the private coordination server, then went public via **The Don of Everything's tweet**."

### Occo is furious at the hypocrisy

"Saturn publicly accused Occo's Discord (Under the Tea) of spreading her dox (a 3-month-old post linking the Nazi Miku KF thread).

Occo points out Saturn herself repeatedly references and screenshots that exact same Kiwi Farms thread when it says nice things about her, effectively spreading the link herself. He calls it self-sabotage and hypocrisy and says he no longer cares about protecting them."

### Occo's stance moving forward

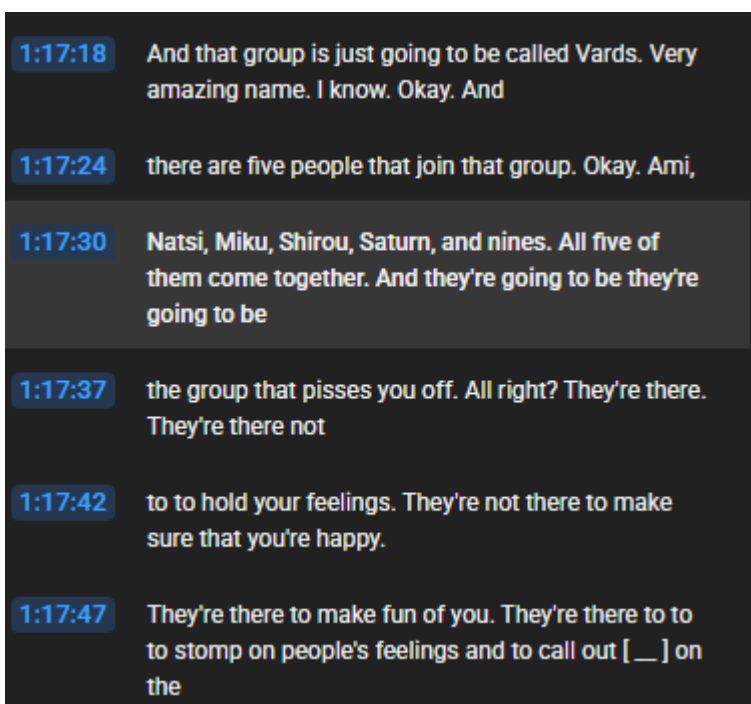
- He's done defending or feeling bad for Saturn/Shiro/etc.

- LuckyEn's future is being negotiated; RagingBull is likely being removed from leadership.
- Occo hasn't decided if he'll stay, but one of his conditions is **no more new members ever** (the group is way too bloated).
- He repeatedly stresses: "Don't talk about things you don't want attention on." Going public or engaging with KF just feeds the cycle.

## Video Transcripts Screenshots

In Occo's video, he launches into a sarcastic rant about the former VTards, deliberately twisting the group's intentions to paint them in the worst possible light. As shown in the transcript screenshot below, he claims the group was created to "piss you off," that they were "not here to hold your feelings" or "make sure you are happy," and that they existed solely to "make fun of you" and "stomp on people's feelings."

These statements are intentionally misleading. Occo knows this was never the purpose of the group, nor does it reflect why it was formed in the first place.



Just last month, Occo was on Twitter “personally” asking to adopt all the lost VTards into LuckyEn.

It’s strange to claim the VTards are so terrible and “evil,” yet simultaneously try to recruit every single one of them. And the truth is, they did bring in Shiro and Saturn, and they even attempted to bring in Nines. During a voice call, RagingBull went so far as to say, “I would love to bring Miku on, he just needs to do a rebrand.” The contradiction speaks for itself.



Occo is now trying to claim that the Testimony server was created to “hurt” people.

What makes that especially ironic is that Occo himself was on that server for a period of time, actively offering help, support, and even volunteering to work on the Google doc. His new narrative directly contradicts his own prior involvement and behavior.

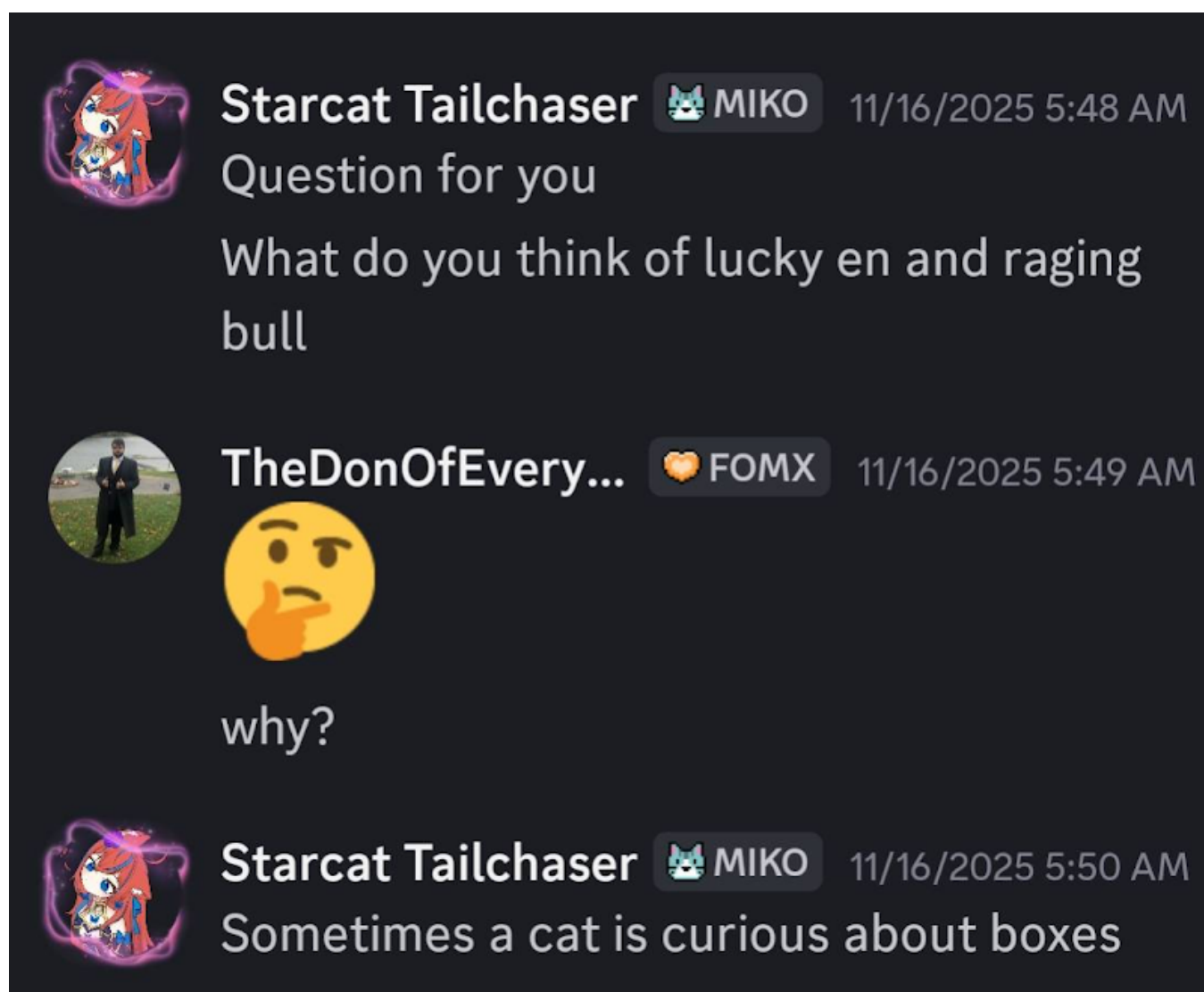
In the image below, Occo claims that Don “started this,” referring to the exodus from LuckyEn and the conflict that followed. He even says, “If he (Don) never spoke everyone would be quiet,” which is a strange assertion considering that, long before this document was released, multiple members left abruptly and insisted they did so of their own volition.

On top of that, several talents reported instances of sexual harassment, inappropriate comments from RagingBull, and an overly controlling management style, issues RagingBull himself admitted to in his own statement. (Shown Below) Were they supposed to stay quiet about that as well?



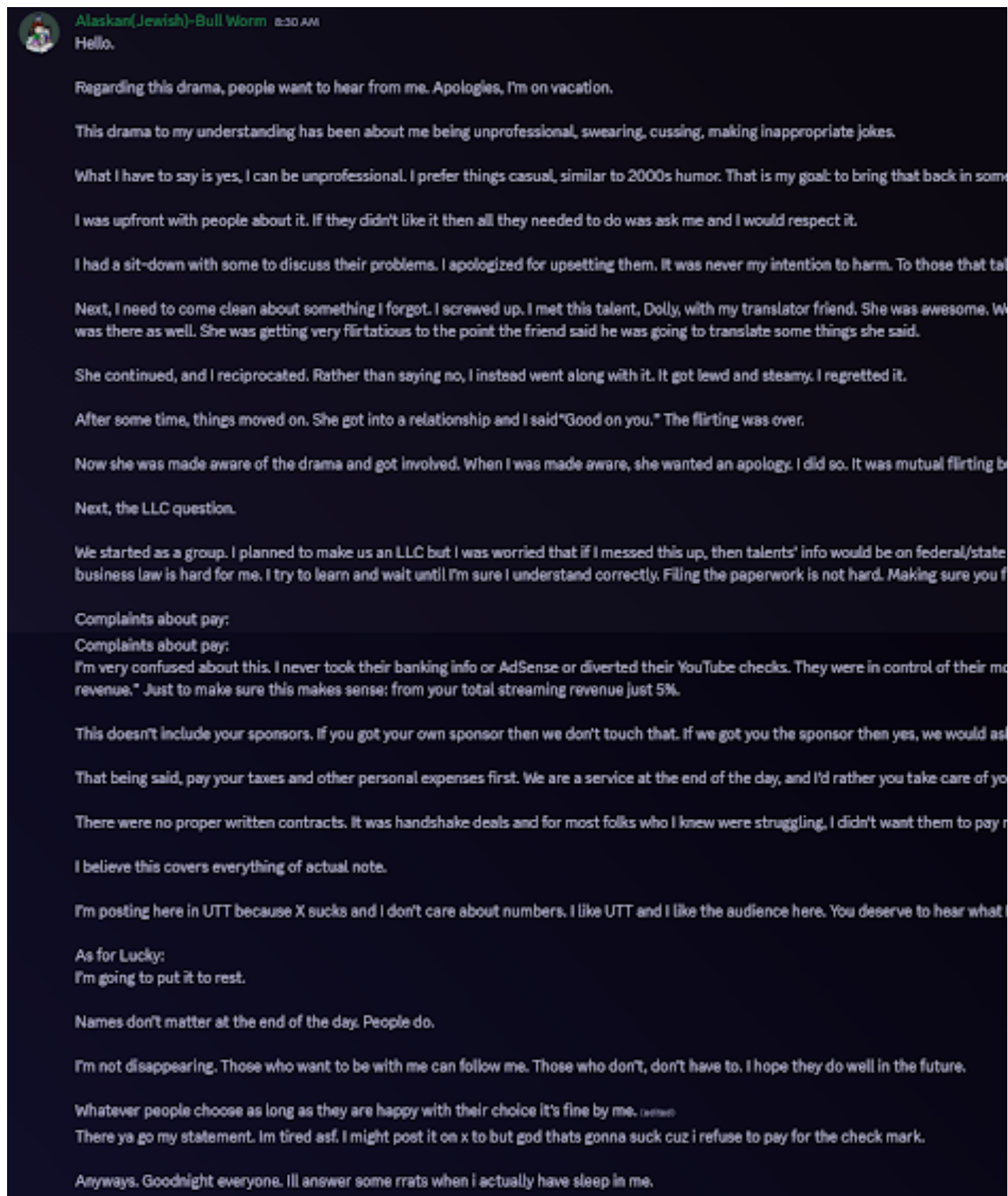

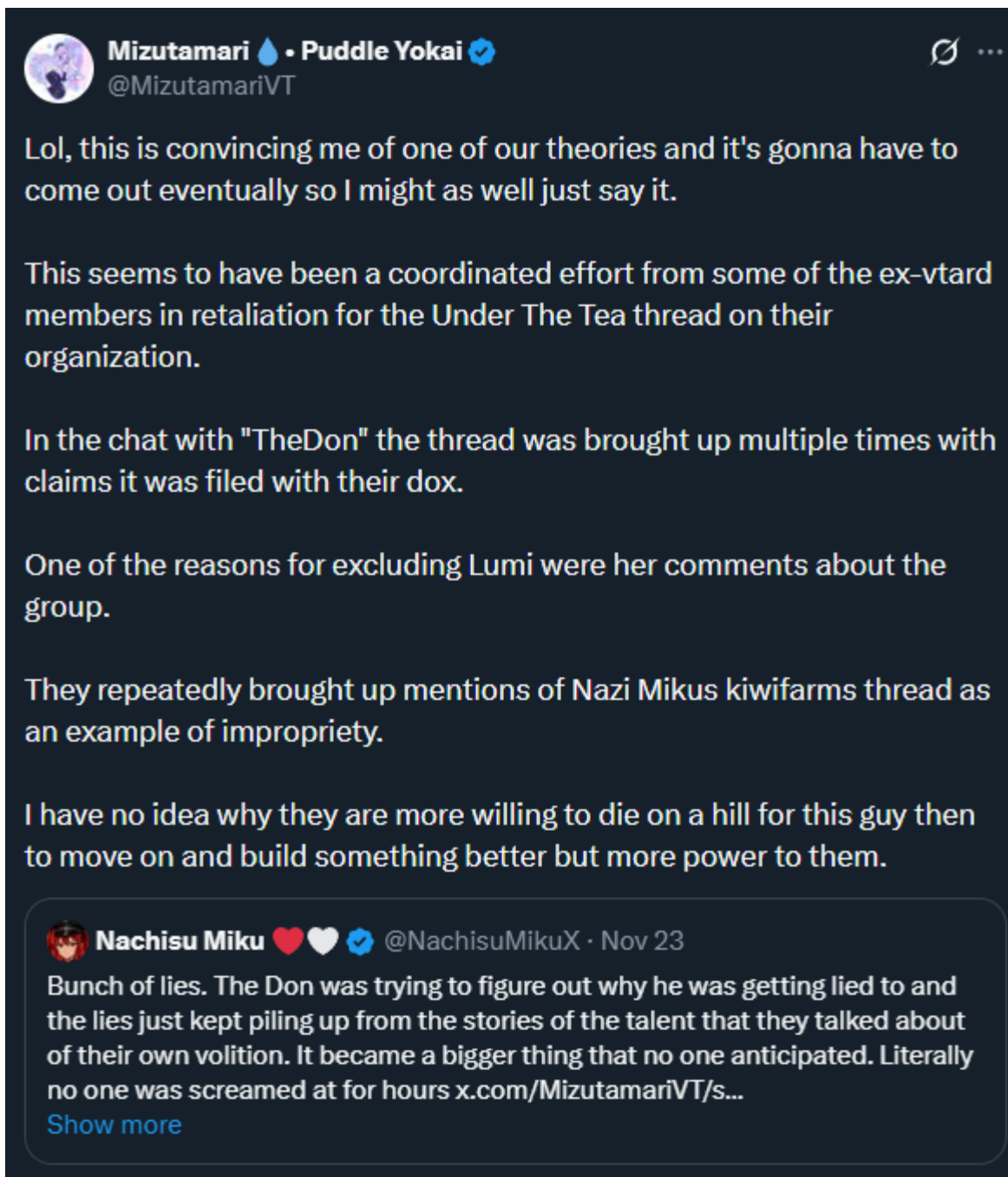
At this point Starcat and Miko are now trying to claim they wanted “both sides to talk,” yet Occo openly states that one side would not even be considered. Why? From the very beginning, someone must have spoken negatively about certain individuals, leading to their exclusion from the “DO NOT JOIN” call and preventing any fair discussion from happening in the first place.

**There was never any intention to “burn anything down” from the VTards and their moderators; the only goal was to support the people who wanted to leave.** Meanwhile, Occo repeatedly pushed the opposite narrative in his own server. If Starcat genuinely wanted both sides to communicate, why didn't she tell Don about the call? Why did she immediately start throwing accusations instead, creating an instant wedge? And if open dialogue was really the goal, why didn't she bring the other talents into the call at all?

## Mizutamari

Mizu did not participate in the LuckyEn departures on either side. He joined the Testimonies Server on the same day several LuckyEn members abruptly reversed their stance and began blaming Don for everything. Mizu's own takes are scattered and self-contradictory; his earlier statements directly undermine his later ones.

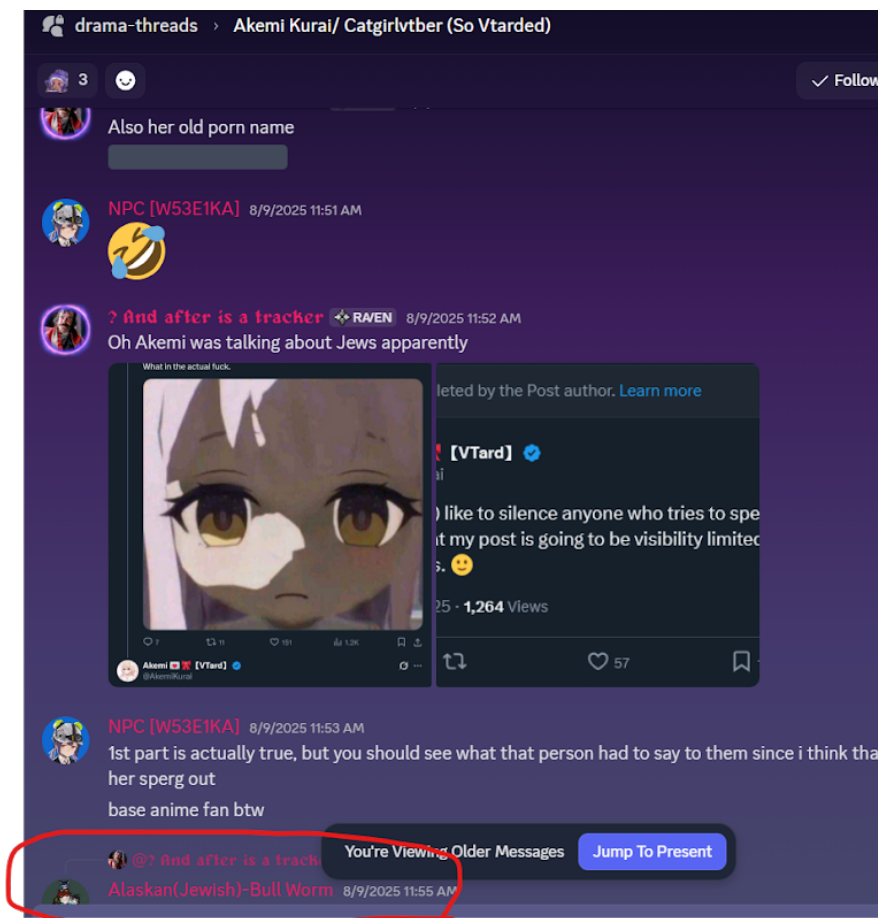

Mizu claims the exodus of LuckyEn was orchestrated out of a grudge over doxxing info "claimed to be" left in the Under The Tea Podcast Discord. In the screen shots below, you can see them openly showing off the dox that they very clearly left up in the UTT server.

In reality, that info was discussed because RagingBull actively participated in those conversations. The criticism centered on RagingBull's involvement, though some also objected to Mizu leaving the doxxing material in the server despite it violating Occo's rules.

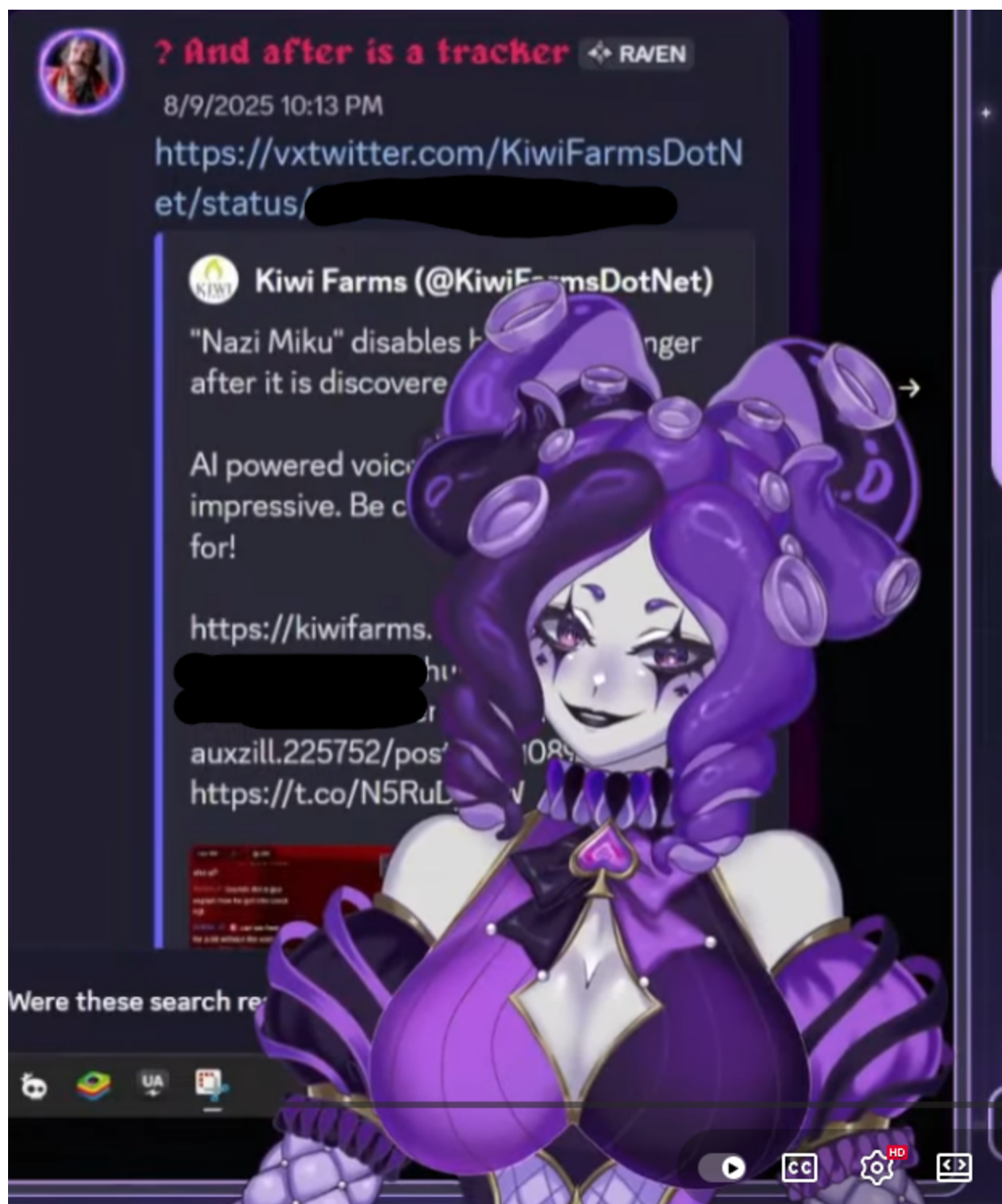

Mizu is trying to blame Shiro for “posting the KF link” (which never happened) to justify the VTards being doxxed in his server. He acts like cropped screenshots are the same as sharing a direct dox link, which is just wrong. Leaving dox up in a server isn’t magically okay just because the info existed somewhere else first. The second a discord server reposts or keeps private info up, they’re responsible for spreading it. You can’t pretend to be against doxxing (No dox posting rule in UTT) while only enforcing the rule when it’s convenient. That’s not protection, that’s favoritism.

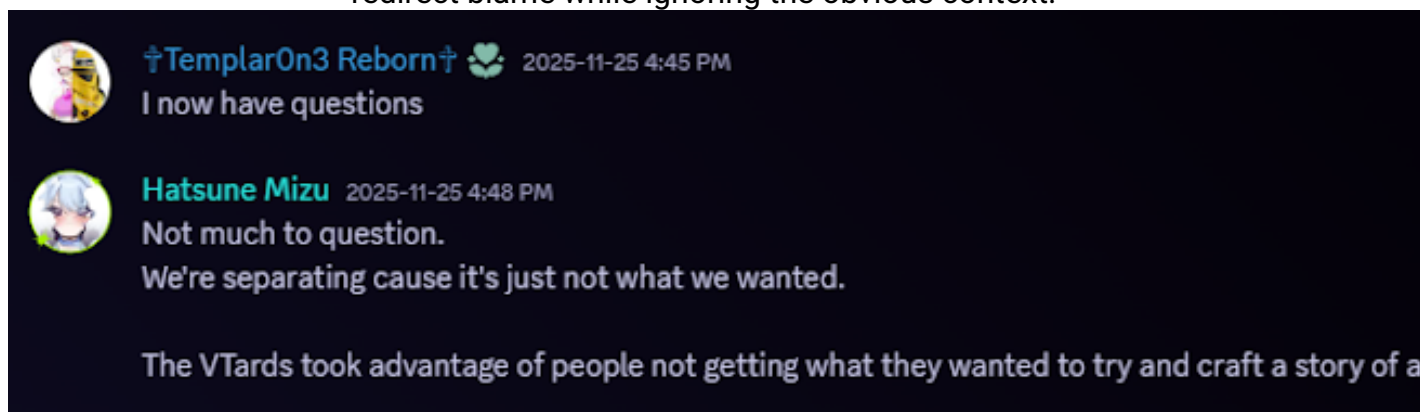


Mizu is confident that LuckyEn won't disband.



So LuckyEn disbands- Mizu insists that everyone in LuckyEn "left because they wanted to," yet immediately follows this by blaming the VTards and accusing them of "crafting a story of abuse."


If their departures were truly of their own volition, there would be no reason for him to keep mentioning or blaming VTards. What makes his claim even more ironic is the timing, these sudden decisions to leave happened exactly when the VTards were receiving testimonies from multiple LuckyEn members who wanted out. His contradiction only highlights how desperate he is to redirect blame while ignoring the obvious context.




Mizu claims they're leaving on "amicable terms" and defending RagingBull out of "morals," yet that

## Junie

Shortly after her departure from the Testimony Server, Junie immediately blocked everyone who was departing or involved in trying to help people depart from LuckyEn including Shiro, Saturn, Moka, Nines, Neevin and their mods. Junie announced that she and Dillon will be managing and restructuring LuckyEn therefore replacing RagingBull.





Two days after the departure from the testimony server and a day after her announcement on Discord, she did a stream that vaguely explains the situation of LuckyEn.

“Those who are still publicly posting have not.”

## **3. People outside the situation are speculating about her personally**

“People were speculating about my name.”

“People trying to get involved with my life.”

She issued a statement asking people to stop speculating.

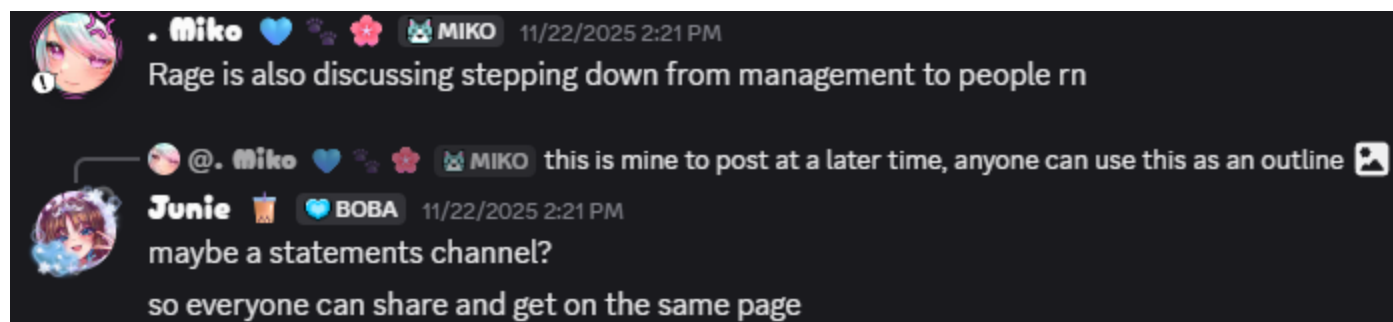
## **4. Someone threatened a callout (“Google Doc”)**

She references “the threat of a Google doc drop”

**Regarding Junie’s statement that people outside the situation are speculating about her personally, here are the speculations where her messages & behavior combine with the timeline of events.**

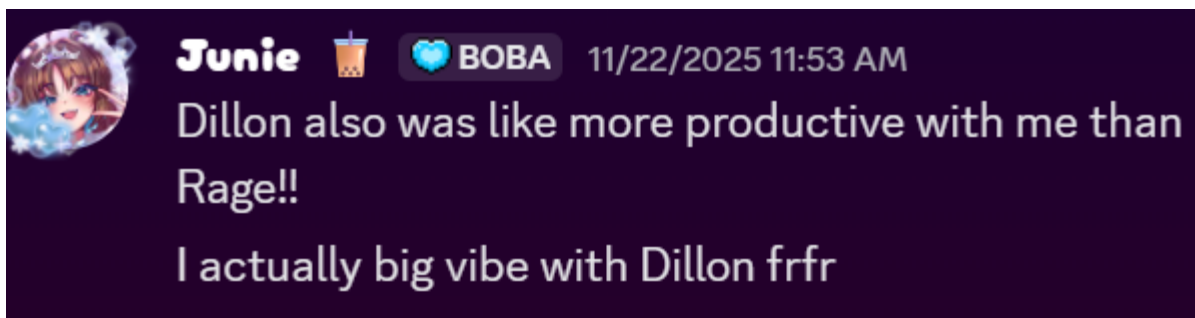

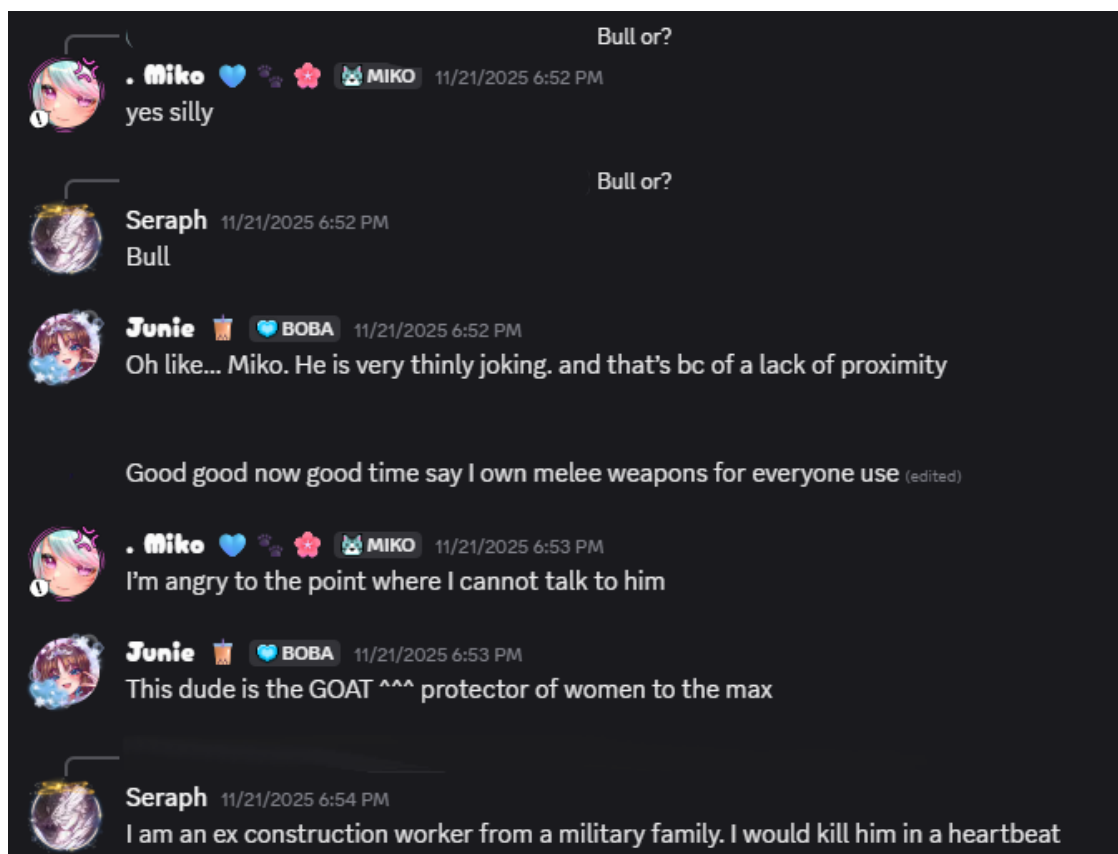


Junie was initially shocked and appalled when RagingBull was trying to get into contact with a LuckyEn member whose name is redacted.

## Akuma Miko

Akuma Miko was originally one of the most vocal members expressing concerns about RagingBull. She worked closely with Saturn, Don, Shiro, and the moderators, consistently sharing detailed accounts and strongly affirming her decision to be the first to leave the group. Her messages were offered freely and in large volume, without any prompting from Don. However, her demeanor shifted only once StarCat made the accusation that Don had threatened her.

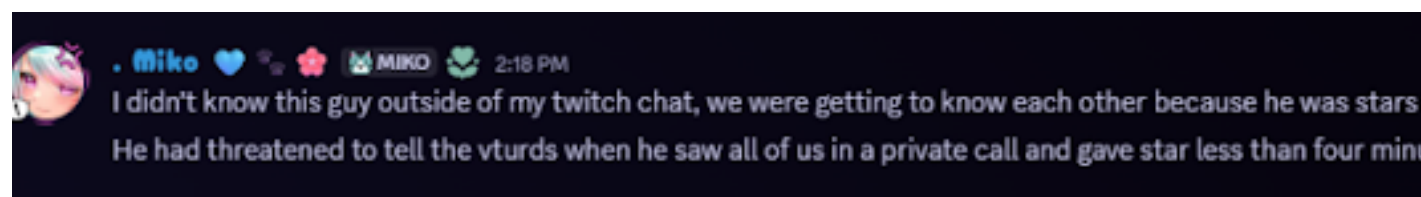
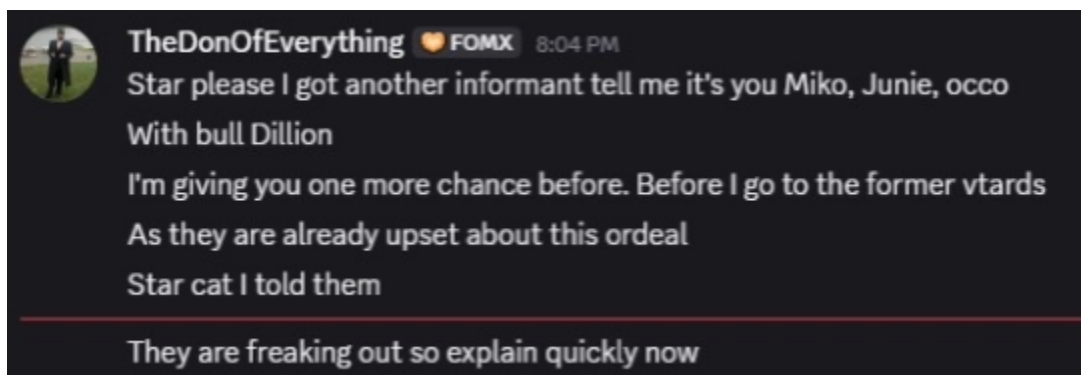
Once Don saw that Starcat, Miko and Junie entered a call with RagingBull, he asked Starcat what was going on and she wouldn't tell him. Imagine his confusion to see these Three people who just spent the last couple days saying how horribly RagingBull treated them and how they want to distance themselves in a call with RagingBull, especially since just the day before, after the UTT stream, RagingBull tried contacting Miko and Starcat and they were stressed and anxious in VC, saying they didn't want to speak to him or deal with him at all. Don tells Starcat that if she doesn't say anything he's going to tell the others (VTards) that she is the call.

When Miko publicly claimed that Don "clearly threatened her (StarCat)," she left out critical context: that she, StarCat, Junie, and others were in a voice call with RagingBull. Don was preparing to inform the others, as up to that point everyone had planned to leave together, and



they were intentionally excluded from the call. Instead, Miko framed herself as merely “moral support” for StarCat, providing no explanation of the actual situation. She only clarified the full context later in a Discord message - after people had already begun attacking Don and others in the Testimony Server based on her incomplete claim.

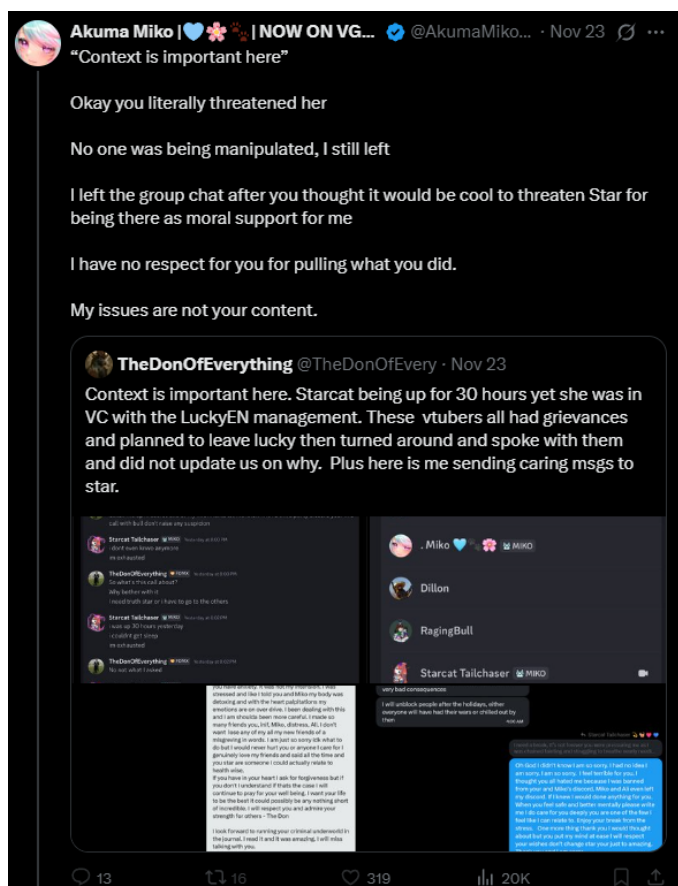
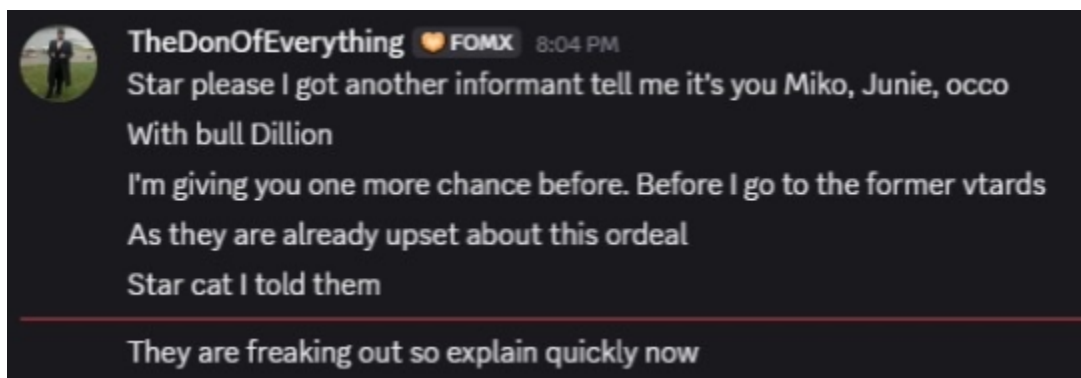

For contrast, below is an image of the Don's "threat" to Starcat that she is calling "abuse" and Miko is going full defense mode over. 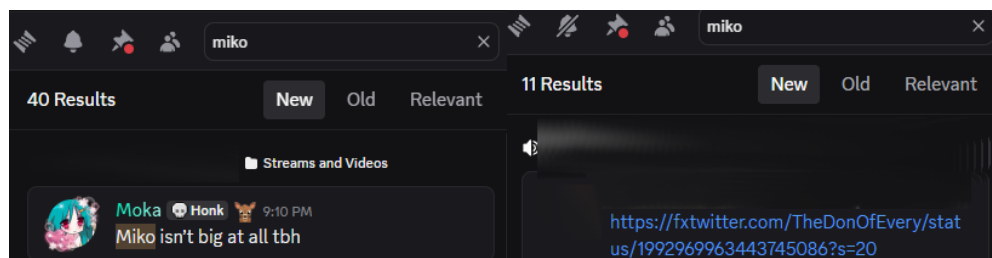


Another narrative that Miko attempts to use is that people wanted to use her power and influence to destroy LuckyEn and that she was not seen as a friend or a victim.



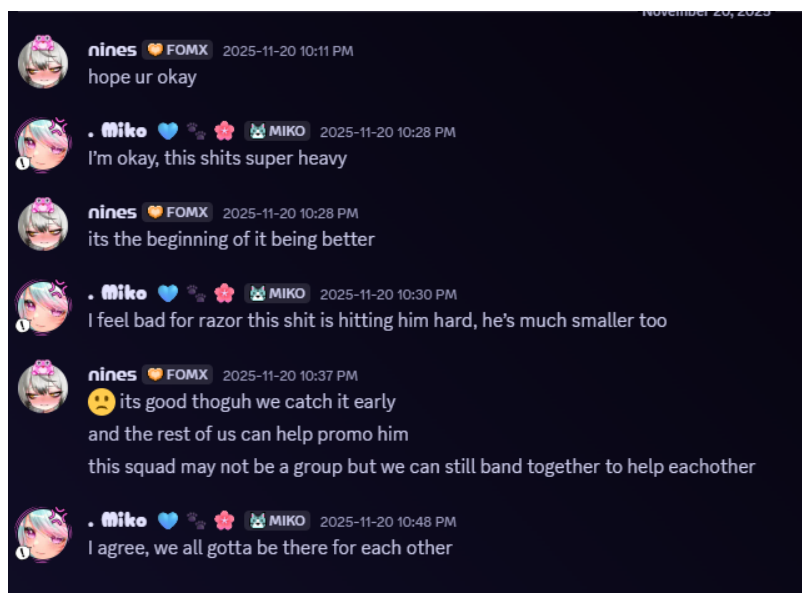
There are 40 results for "Miko" in Saturn's server and only 11 in Nines'. Outside of Nines and Saturn, most people in their own circles barely knew who Miko was. Neither Nines nor Saturn has ever cared about numbers or "power," and if they did, they already have connections with creators much larger than Miko they could've gone to.

As for Miko's supposed "respected" status, both Nines and Saturn had seen her **blacklist** and were aware of her mixed reputation but they chose to look past it and give her a chance anyway. The idea that she was viewed as some powerful figure or a "nuke to send into orbit" is simply not rooted in reality.

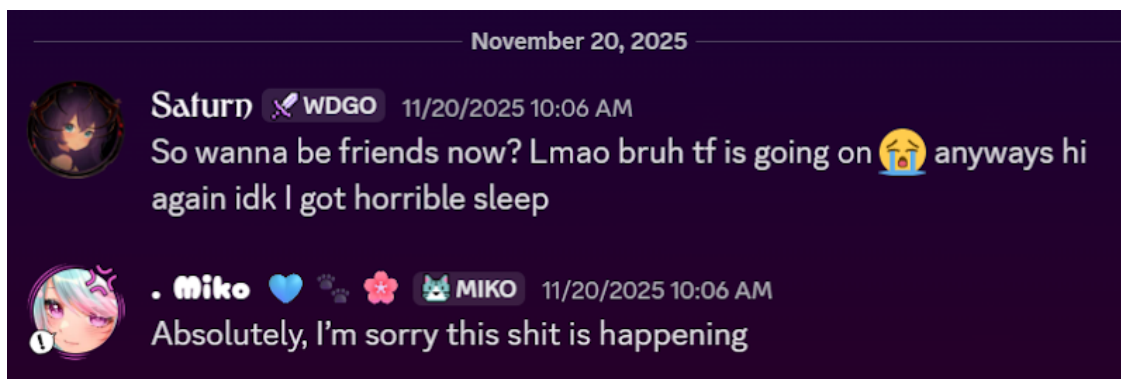

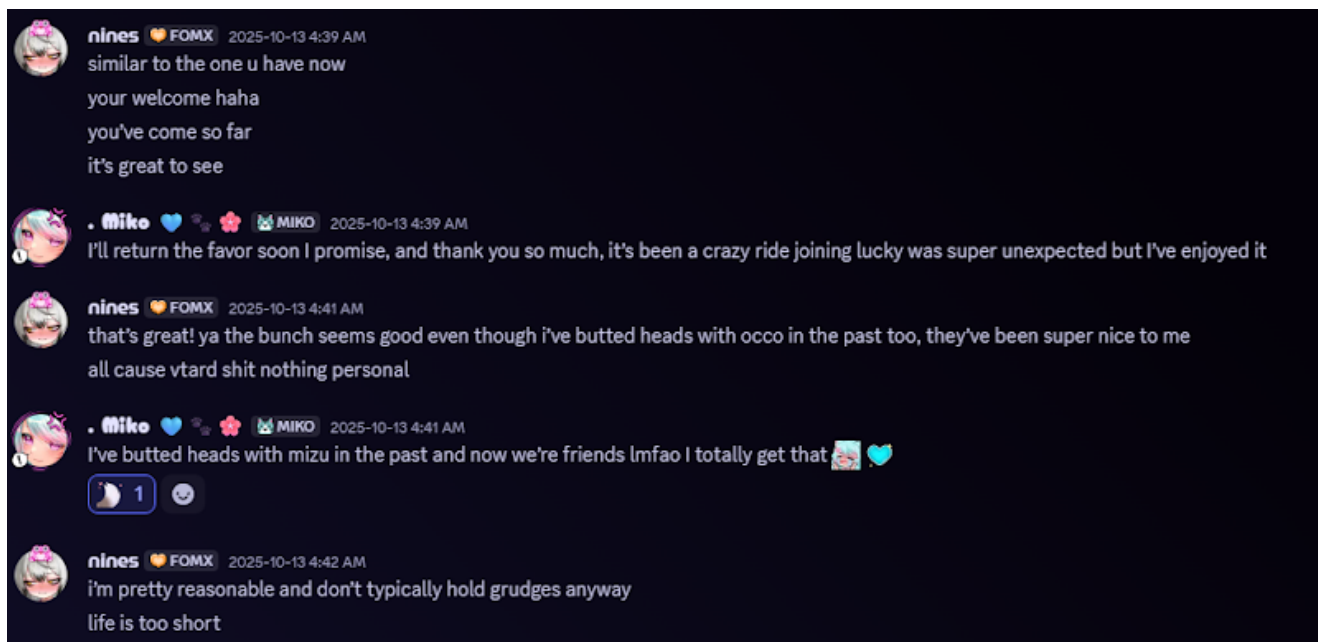

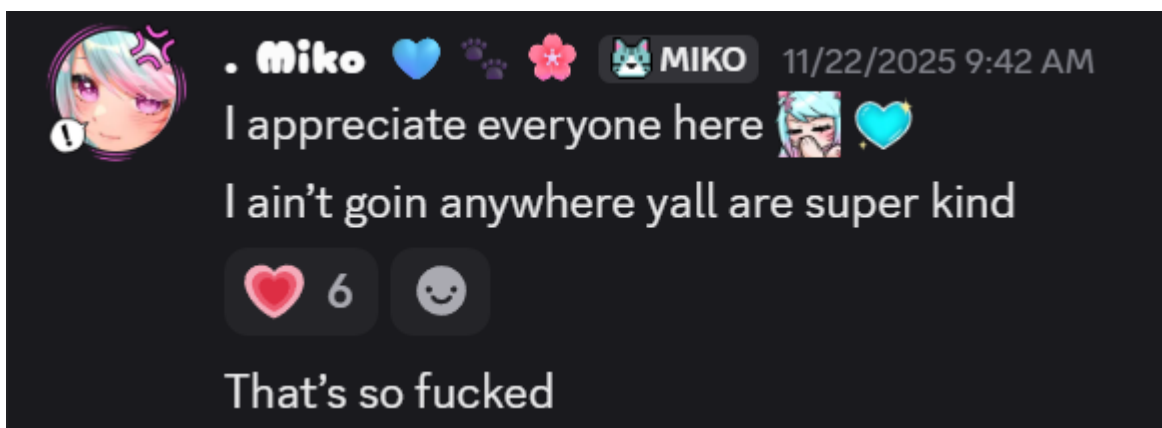

Miko states that the people who tried to help her leave RagingBull are now angry at her for trying to keep a stable relationship with her manager(Dillon?) and claims that drama is a constant thing that they(Ex-LuckyEn + VTards) constantly like to get into.



In regard to the “potential people” she claims that they like to get involved in drama, this is simply false.

Moka was not involved in any controversy at all.

Any drama tied to the former VTards was something that happened *to* them, not something they sought out. The issues surrounding the VTards were manufactured almost entirely by the community’s reaction to them simply existing. The group itself did nothing outrageous; the only time they responded was when they were directly attacked. Shiro left the group and was dragged into conflict solely because of Akemi’s hostility toward her.

The other major conflict was when Nines and Saturn had a falling out with Akemi. It is not their fault that Akemi chose to betray their friendship, speak poorly about them in private, and stir up negativity behind closed doors.

The most recent incident occurred when Akemi and members of her community publicly doxxed and harassed Nines. None of this was initiated by Nines. In fact, Nines had been actively avoiding talking to or about Akemi after their separation, yet Akemi still targeted her. Saturn only became involved because she was supporting Nines during the situation.

To claim that any of them “like to get into drama” is unfair and blatantly inaccurate. It is especially hypocritical coming from someone with a history like Akuma Miko’s- someone who’s had an “eventful life”, who is no stranger to harassment herself and who maintains her own blacklist.
