1 **Statement of Facts & Breach**

2 The more you read, the more sense it all makes, the more you see, the more your heart
3 breaks. The United States government knows that according to Marbury vs Madison “all
4 laws which are repugnant to the constitution are null and void.” However, that has not
5 stopped them from continuing to operate a clearly unconstitutional system while
6 they target American citizens to do it. For example, The clerly unconstitutional Organic
7 Act was passed into law in 1871 and was later repealed in 1874. However, the effects of
8 the law’s passing remain to this day, in spite of it being Unconstitutional. The same can
9 be said for The Federal Reserve Act of 1913, which is also an Unconstitutional law that is
10 currently affecting the heartbeat of our nation’s economy and the amount of food
11 Americans can afford to put on the dinner table. This is pertinent because I am asserting
12 that this current Corporate Federal Government has no legal standing or authority
13 according to the Constitution of the USA. If we examine the pattern of large financial
14 peaks followed by large economic crashes that seem to have been engineered since the
15 Federal Reserve Act’s passing in 1913, the pattern becomes obviously nefarious. The
16 owners of the Federal Reserve have been treating the American Economy like a rigged
17 Casino, or a government mandated Ponzi-Scheme. The large shift in wealth after the
18 clearly engineered crash of 1929 and the subsequent depression, mirrors many other such
19 shifts is the financial dynamics of the American people and other nations alike. Recent
20 examples include the allowance of Fractional Reserve Banking or the way the
21 government helped engineer the housing market collapse by allowing banks to create
22 Collateralized Debt Obligations. Both examples are indicative of the system’s rigging
23 against the interests of the American people and in the interest of the less than 1% of the

24 population that own the Federal Reserve and the global systems of finance. Moreover,
25 when we see that the government then bailed the big banks out with tax payer money
26 after the collapse they enabled, we once again see a pattern of evidence that points to this
27 government using its authority to transfer wealth from the lower and middle class into the
28 pockets of less than 1% of the American population. We also see the clear pattern of
29 writing laws and regulations for the less than 1% of the population and at the expense of
30 the American people. I would also like to note that our Founding Fathers warned us about
31 the dangers of the banks and the banking system. They also warned of allowing judges to
32 be the sole interpreters of the constitution. Jefferson ensured to remind us all that to trust
33 on the judges to interpret the constitution would lead to oligarchy. If we study history we
34 can see that such a misstep is in fact the origin of America's plight. In many ways ever
35 since FDR and the creation of the Bureaucracy after the crash of 29, the Supreme Court
36 has been treated as the sole interpreter of the constitution to every American's detriment.
37 The simple fact that the American people are stuck in an obviously bad deal that was
38 made by a corrupted government in 1913 is not a legal argument worthy of making. And
39 the fact that the Supreme Court (if they are to be the sole interpreter of the constitutions)
40 has not worked to overturn such an unconstitutional law, is further evidence of the federal
41 criminal courts being as compromised as the rest of the unconstitutional bureaucracy its
42 allowed to run rampant. Especially considering that according to Marbury vs Madison in
43 1803 "All laws which are repugnant to the constitution are null and void" (Marbury vs
44 Madison US 5 (2 Cranch) 137, 174, 176, (1803). Furthermore, it is unconstitutional and a
45 violation of my God given rights to force the corruption of a previous generation onto my
46 generation because that generation agreed to pay the ever increasing interest on an

47 inescapable loan. I also assert that due to this legal fact, it is clear that constitutionally
48 speaking, our government is guilty of treason because it is clearly prioritizing the
49 interests of a foreign financial system over the interests of the American people, and at
50 the ever increasing expense of the American people. This corruption has caused life,
51 limb, blood, sweat, tears, pain, suffering and irreplaceable loss. This has resulted in
52 tremendous fear in the United States for decades, allowing those corrupt entities who
53 control the government to commit countless violations of our constitutional contract. For
54 example, I am sure the Founding Fathers would have considered Operation Paperclip an
55 act of Treason, because I know that I do. On its face, you would think that bringing over
56 1,500 Nazi scientists, doctors and intelligence agents that tried to kill millions into the
57 United States after WWII and then giving them high ranking positions in our own
58 government would be considered Treason, because it is, but not in this corrupted
59 financial system we call a country. I also believe that our founders would say that getting
60 the United States involved in the war in Vietnam under false pretenses, also qualifies as
61 Treason as outlined in Article III Section 3. And given the suspected involvement of the
62 Israeli government in the attack on the USS Liberty, we must draw attention to the fact
63 that the same entities who own the Fed also own the deed to the land of Israel. More on
64 Israel's suspected involvements later. I am sure the founding fathers would consider
65 conspiring to involve the US in a war under false pretenses to aid this foreign financial
66 apparatus as a form of levying war on the USA and a form of giving its enemies comfort
67 by allowing them to profit from the loss of American lives in an unnecessary war. These
68 facts indicate that the "War on Terror" and the Subsequent "Patriot Act" are also acts of
69 Treason as well as according to Article III Section 3. Especially considering the wars

70 were started without congressional approval and the way the Patriot Act was pushed
71 through by a known pedophile Dennis Hastert who was Speaker of the House at the time.
72 The Patriot Act also clearly empowers this foreign financial apparatus within the USA to
73 go to war without traditional constitutional methods of declaring war outlined in Article I,
74 Section 8, Clause 11. Once again Marbury vs Madison "All laws which are repugnant to
75 the constitution are null and void". These are all egregious and clear violations of the
76 constitution in every way shape and form, yet they have been permitted to continue until
77 now. Unfortunately, these violations have accumulated over decades in order to maintain
78 this corrupted and unconstitutional financial system and that has resulted in this pattern of
79 20 year wars and financial crashes repeating and getting worse over time. On its face
80 these are all clear breaches of constitutional contract, and according to the founding
81 father's view of tyranny and treason, many currently residing in positions of power across
82 the USA, in government and in the private sector alike, are all guilty of treason.
83 Especially considering that many of these unconstitutional laws have been passed or kept
84 on the books for decades without any attempts to quell the corruption or fix the obvious
85 unconstitutional flaws in the system. The use of unprovoked warfare and engineered
86 economic collapses seem to be the formula for those behind the Federal Reserve Bank. I
87 make these claims because over the course of more than a decade, I have personally
88 suffered both unprovoked warfare and engineered economic collapse at the hands of this
89 unconstitutional and tyrannical state. If our government is able to engineer economic
90 collapse in foreign nations and keep their unconstitutional wars going in a foreign nation,
91 you'd better believe that they can do it to an individual and no one would ever suspect a
92 thing. However, when viewed in the proper lighting, every abuse I've personally

93 suffered, the American people have also collectively suffered. In particular the black
94 community has been targeted by this government since the civil rights movement of the
95 1960's and as a whole they too have suffered a similar targeted harassment and
96 demoralization campaign at the hands of the Nazi-Fed controlled government. Once
97 again this government is levying war against the American people and in clear violation
98 of Article III Section 3. The people's suffering, my personal suffering and the
99 government abuses have taken place in the shadows of secrecy as is the nature of evil.

100 My financial life and the average American's financial life have been made very difficult
101 by this puppet government for the banking cartel, and if this pattern of treasonous wars
102 and economic collapses is evidence of anything its evidence of that hard truth. Due to the
103 fact that I noticed this problem and set about doing something about it, I've since been
104 targeted by this unconstitutional government in some ways that seem friendly at first,
105 then became extremely hostile and even involved mortal peril at times. Consequently, the
106 government has continuously violated my God given rights, enshrined in the
107 Constitution, as I have continuously attempted to save America's Constitutional Republic
108 from this foreign financial power's tyrannical grip. Due to the non-violent nature to the
109 psychological warfare and the illegal precedents that have been made as war has been
110 waged on me and the American people alike, the situation has escalated considerably
111 over the years. With that escalation I had the forethought to gather some transitional
112 evidence that will be presented to the court in a way that will prove my case is both self
113 evident and inarguable. The US Federal Government knew that it was in violation of the
114 4th Amendment of the Constitution every day that they illegally surveilled me and my
115 computer with classified technology and techniques that were intentionally designed and

116 legally specified in the unconstitutional Patriot Act to hunt criminals and terrorists on
117 foreign soil, not American citizens. So not only are they violating the constitution by
118 passing the law, they are violating the constitution by using their cyber weapons on
119 American soil as well. In order to understand how we all got here and why my case
120 against such a powerful system being irrefutable, we must put everything in context. To
121 do that, the court must start with a phone call that I made around the spring of 2008,
122 where I spoke live on KFYI conservative talk radio. In that phone call I spoke of a
123 disruptive patent technology known as a Tesla Coil and its ability to give everyone free
124 energy. I also proposed the notion of burning money to protest the government's printing
125 of money and the creation of inflation. In the intelligence community and national
126 security world, this single phone call was equivalent to metaphorically blowing up the air
127 waves with a call to action against the system. I therefore inadvertently created an
128 unexpected national emergency below the surface of government security clearances and
129 NDA's. I say this because the Fed's debt based petrodollar is fragile in the presence of
130 such technology and the entirety of the media apparatus has been carefully and
131 strategically planned through FCC control, to ensure that voices and messages like mine
132 on that day, do not travel on the FCC's unconstitutionally controlled airwaves. I would
133 argue that this is also a clear form of the government practicing Prior Restraint on the
134 entire nation's access to information and therefore further evidence of this current
135 government's unconstitutional legal standing. I knew that my stunt on the radio got the
136 government's attention because the when they put the segment on KFYI's website, they
137 called the segment "Tesla Coil". While this may seem insignificant, when you understand
138 that all radio stations and most of their DJ's are a part of the intelligence community, you

139 know that my call made a national impact. Also, when I attempted to replicate the
140 process elsewhere, other radio stations had their doors metaphorically locked. In addition,
141 I noted that a short time after I pulled that little stunt, the movie The Dark Knight came
142 out. And in that movie the Joker burned millions of dollars in money and blew up a
143 whole police station with a single well timed phone call. These seemingly insignificant
144 details will make sense in context as time goes on. A short time later in the spring of
145 2009 while I was writing America's 2nd Declaration of Independence the US Government
146 illegally hacked my computer to observe the words as I typed them over the course of
147 several hours. They knew their surveillance of my private computer was unconstitutional.
148 However, the government never believed they would get caught or that I would lead them
149 into a trap. If you will examine the evidence presented (Exhibit A) you will see that the
150 words "Treason", "Sedition" and "Violence" are used throughout the document. This
151 purposeful linguistic bait was used to lure the government's national security surveillance
152 software and illegal tracking systems into a trap. These trigger-words in the document,
153 triggered government national security protocols written into the computer software that I
154 was using and that's why my screen popped up on a government screen somewhere,
155 without due process. My personal Declaration of Independence and Non-Violent War
156 was declared, but in a way that should have been private and beyond the government's
157 reach without a warrant. I knew that the government saw what I wrote on my private
158 computer because the movie Avatar came out a few short months after I wrote these
159 documents. This may seem trivial to most, however the proximity of it's release to the
160 writing of the 2nd Declaration of Independence and the things I said in the Declaration
161 regarding the Native American tribes and their lands can not be ignored when the main

162 character's name is a former marine (branch of the navy) named Jake who was recruited
163 into a super solider program. When the government targets an individual they can and
164 will use all assets at their disposal to triangulate the targeted individual's mind into a
165 personal subjective universe that is controlled by the government. If you examine the
166 Exhibits A #2 and #3 you will see that this movie's timed release is significant, as is
167 Michelle Rodriguez's presence in the film and her line "I was hoping for a tactical plan
168 that didn't involve martyrdom." These seemingly insignificant facts are designed to seem
169 insignificant on their face, but if a person were in the loop of what I had written on my
170 computer a few months prior those details would stand out to a sharp mind. And when
171 you see the other similar patterns in my journey, you will see the significance of these
172 details. We must move forward in time to the autumn of 2017, when I was writing my
173 book One Mind At A Time: A Deep State Of Illusion, and the government was watching
174 my computer then as well. (Another violation of my 4th Amendment Rights) And when I
175 was about to publish that book, I was contacted on Facebook by (who I thought was)
176 Michelle Rodriguez, my celebrity crush. What truly peaked my belief in a potential
177 connection was the fact that she said my name in one of her live chats with her fans. She
178 has since deleted that video, but I have more proof of our correspondence. After she said
179 my name in her live chat, I began commenting on her photos with poetry I had written
180 just for her. I then noticed she posted more photos, and posted visual images of herself
181 that seemed to be responsive to my poetic comments. So I kept sending her the poetry I
182 had written for her and eventually I received a message request from her on Facebook,
183 and I happily accepted it. I do not have proof of this direct correspondence without
184 accessing Facebook's deleted data. However, I do have multiple eye witness testimonies

185 who saw the communication taking place in real time. So Michelle and I began a
186 correspondence through direct message on Facebook and eventually she gave me her
187 number and we started communicating via text message. Eventually I discovered that it
188 was not Michelle at all but in fact the NSA. Then after I vocalized that I had realized that
189 it wasn't Michelle and was in fact the NSA, the NSA asked me "Who gave you
190 permission to write a book?" to which I replied something like, "I thought we lived in a
191 free county, didn't know I needed permission." There seemed to be no hostility
192 afterward, I was actually kind of flattered that my book had gotten such high level
193 attention. Compliment of a lifetime and I was offered the opportunity to work with the
194 NSA covertly and help them deal with other-worldly matters that my Shamanic beliefs
195 made me a perfect candidate to handle. However, it seemed that through this
196 correspondence with the NSA I was also able to maintain a covert connection to
197 Michelle. If we examine the evidence compiled in Exhibit B as well as examine it in
198 conjunction with my testimony provided for each Exhibit listed numerically, an
199 undeniable picture becomes clear. I wanted to prove my worth and I started to send
200 Hollywood scripts that I had written so I could work with Michelle and make money for
201 myself and everyone involved. I thought that having an in was all that was necessary in
202 that business, while I was right, I was also wrong. Instead of being taken in and given a
203 job as a writer or an actor, my ideas were stolen and I was mocked from the sidelines by
204 those working on the projects that I offered to help with in the first place. If you examine
205 Exhibit C in full, you will see the documentation that gives credence to these accusations.
206 When I discovered this treachery and tried to confront whoever was on the other end of
207 all this abuse, I was told to stop whining and get back to work creating new scripts of

208 projects for them to use. Along the way I was inundated with MK Ultra mind control
209 techniques through my phone getting calls from DC area codes, or personally tailored
210 messages in my social media feed in conjunction with the use of neuro-electromagnetic
211 weapon surveillance. All of the evidence for these accusations is in Exhibit D. All of
212 these psychological barriers acted like a form of mental triangulation, ensuring I did not
213 have a private thought (Exhibit E) and ensuring that I felt isolated, trapped and unable to
214 escape from this personal hell I seemed to have signed up for by trying to help the
215 government when they asked me to help them. To be clear this kind of electronic
216 harassment is something that has been documented and even proven in court in the case
217 of Watterson vs Aro in San Bernardino Superior Courts in California. And even if all of
218 this with Michelle, the NSA and Hollywood is mere coincidence, or even as some may
219 say, a product of severe delusion or a desperate and flexible imagination, I have evidence
220 that the POTUS himself contacted me after January 6th 2021, on January 8th of 2021,
221 proven by Exhibit F. This private message from donalddtrump@nsa.gov is the cherry on
222 the Sunday when it comes to knowing for certain that the government was monitoring me
223 prior to January 6th and tracking my every move accordingly. I also accuse the US
224 Government of violating my 1st Amendment Rights to Freedom of Speech, Freedom of
225 Press and Freedom of Religion. Over the course of the last decade or more the
226 government has targeted me and kept my voice from reaching the public through
227 unconstitutional operations on American soil that qualify as prior restraint and therefore a
228 violation of the 1st Amendment. The Twitter Files Prove that the government was
229 working with Social Media platforms to suppress certain voices, and I assert that I was
230 one of those voices they unconstitutionally suppressed and I therefore once again accuse

231 the government of prior restraint and obstructing my 1st Amendment right to speak freely
232 on the internet and on the radio. After I was targeted by the US Government for writing
233 my Declaration of Independence, they have used every aspect to their media apparatus to
234 suppress my voice as I spoke of the fact that Tesla-Towers can give us all free, clean,
235 infinite, wireless electricity as well as cures for cancer. Even with all of these government
236 efforts of prior restraint, their surveillance extended far beyond the radio or internet. For
237 example, I believe I was targeted by Mike Pompeo's nephew while I was working toward
238 honest elections after the 2020 election here in Arizona. I say this because I was offered
239 the opportunity to go to Washington DC for free by Mike Pompeo's nephew and 2 others
240 that were protesting with me at the Arizona capitol, though I did not know who he was at
241 the time. If my accusations are true, this is clearly a conspiracy within the government to
242 ensure that some people's rights are violated covertly to prevent new ideas or a new
243 invention from reaching the public, a very clear act of Treason as well. I theorize this
244 criminal conspiracy has everything to do with the Federal Reserve, and the oil industry,
245 which is the reason why (along with those stated prior) I have chosen to include the
246 Federal Reserve, the World Bank, The International Monetary Fund, and the Bank Of
247 International Settlements in this Civil Law Suite as well. If all of these things are true,
248 then the January 6th narrative about me in particular may have also been deliberately
249 designed to act as another form of prior restraint, and was used as a means of discrediting
250 me and my voice before I was ever actually able to address the public directly due to my
251 incarcerated state. If I have unfettered access to any and all government files desired for
252 discovery, I believe this case is easily made and proven against the government. It is my
253 hope that due to the criminal nature of these accusations and the large amounts of

254 evidence I have that an official legal investigation is done by uncorrupted law
255 enforcement as I focus on rebuilding our Republic from the inside out. Due to the fact
256 that “all laws that are repugnant to the constitution are null and void”, all of the listed
257 overreaches of federal power act as further proof that this current government is in fact a
258 bloated Unconstitutional Central Banking System based on debt based currency that
259 seems about to burst. It is a corrupted central banking system which is repugnant to the
260 Constitution and our Founding Fathers would support every word and action in this legal
261 document. During our founder’s time, we must recall the way the Crown controlled
262 everything, not just by royal decree, but also through the secret societies that pervaded
263 Europe. Remembering this, you discover that the Founding Fathers were most certainly
264 also escaping the corrupted and monopolized financial system of Europe as well as
265 opining for Religious freedom. Our founding fathers warned us of this very problem with
266 the banks more than once when they founded our country. So, clearly this banking system
267 that the founders warned us about is unconstitutional and it obviously parallels the
268 tyrannical crown of England during the Founding Father’s time. Consequently, this
269 current corrupted government is adversely affecting the God given rights of one and all
270 Americans; it is not protecting our rights as the government has been charged to do
271 according to Constitutional Contract. Therefore this government is in clear breach of our
272 Constitutional Contract and it must therefore be abolished as the founding documents
273 give us the legal right to do. This has been the case for decades, but no-one knew how to
274 solve the problem without bloodshed or chaos. Until I devised a plan, that is why I am
275 here filing this law suit now; to give the entire Nation and the entire world a way out of
276 madness and end the cycles of suffering it forces upon the people. When seen in the

277 proper context it becomes clear that the government is violating my 4th and my 1st
278 amendment rights in more ways than one and that also means they are doing the same for
279 hundreds of thousands of other individuals who've been targeted by the government. If
280 we then parallel the government's past harassment with the fact that I also have a string
281 of evidence documenting the current government harassment from President Trump's
282 administration in Exhibit G, then the idea that our federal government has changed in any
283 meaningful way is laughable. Mind you all of the government's most recent harassment
284 has gone from being coercive to being violent and increasingly more criminal as I have
285 refused to cooperate with this unconstitutional system. Most of the violent harassment
286 occurred only after I found out how corrupt the Trump Admin was and I refused to work
287 with them. The harassment was so extensive that I demanded a public apology; instead I
288 received an image, refer to Exhibit H. Even after I unsubscribed to Trump's Campaign
289 Text Message List, I would occasionally receive text messages from the Trump
290 administration, sometimes they would arrive at very coincidental times, see Exhibit I.
291 The harassment followed me everywhere I went even when I went to visit my
292 grandmother in Tucson, see Exhibit J. I also have proof that the government recently
293 stole my Crypto Currency Wallet valued at over \$100,000. I also have a witness to the
294 money being there and having 4 separate crypto wallets in one account, then my
295 password being changed and finding I suddenly have only one crypto wallet and only
296 \$200 in \$Solana. The same night/early morning that my crypto wallet was stolen,
297 someone once again illegally came into our home and left something in my mother's
298 purse that same night/morning Exhibit K. In spite of these threats and forms of
299 intimidation, I refused to comply. So, I was targeted even more heavily by the

300 government to force my compliance. The harassment even follows me on to other
301 platforms and into the real world, see Exhibit L. To combat these efforts at intimidation, I
302 created a number of visual and audio displays online and sent these visual displays to my
303 friends and acquaintances in the media to no avail. And I even sent all of this information
304 about harassment in a direct message to Harmeet Dillon in Trump's DOJ Exhibit M. No
305 response or support was given from my contacts in the media or from the Trump
306 administration. I have more proof in my cell phone of my correspondence with the
307 Trump administration both before and during his current presidency, but may need a
308 court order to obtain that proof. I have exhausted all legal avenues I can possibly exhaust.
309 The pattern has continued and even escalated to ever increasing levels of intensity that
310 make day to day living an adventure to say the least, see Exhibits N. Once I had decided
311 that I was going to sue the government I knew I would need more proof to verify the
312 things I said happened in the past. So I devised a plan when I saw that the harassment
313 would not stop and I believed that more than anything the government sought to
314 demoralize and humiliate me more than kill me. So, I used their plan and I turned it on
315 itself, evidenced in Exhibit O. I collected this evidence in the present in an effort to prove
316 the statements I made at the onset about the harassment campaign and the monitoring of
317 my phone, computer and even my private thoughts since the end of 2017. At the point of
318 filing this paperwork, the pattern has gone full circle, from coercion, to intimidation, to
319 coercion, to intimidation, to coercion and back to intimidation, endlessly because I refuse
320 to comply. This process mirrors MK Ultra mind control techniques used in Satanic Ritual
321 Abuse, see Exhibit P, and is designed to repeat endlessly to instill demoralization in the
322 psyche of the individual that is enduring the psychological abuse in order to subjugate

323 their will. If these techniques are used in conjunction with psychotronic weaponry and
324 intense frequencies, the combination is designed to destroy a human being from the mind
325 to the body and turn them into a mind controlled slave for the government that is easily
326 controlled by ai. When this information is paralleled with the long string of abuses
327 already suffered by myself and others at the hands of this government, my claims hold
328 more weight now than ever before, see Exhibit Q. The digital and psychotronic
329 harassment and veiled death threats are still repeating to this day as I claimed it all started
330 in the beginning. If we look at my Twitter profile with all of its posts, replies and likes
331 and then you also parallel that with the screenshots I have taken over the last several
332 weeks a very clear picture begins to get painted. All of the claims that I made in the
333 beginning of this legal document take on a whole new light when you are able to see
334 modern examples of the kinds of direct digital harassment and coercion I dealt with
335 starting 8 long years ago. If we begin to examine why our system has turned on the
336 American people, it becomes clear that it is because the government is now built to
337 protect the petro-dollar & The Federal Reserve's interests by any and all means
338 necessary, not the interest of the American people. If we examine the testimony of
339 Ronald Bernard former Dutch International banker turned whistle-blower, see Exhibit R,
340 we will find that the same international banking cartels that are responsible for the
341 creation and maintenance of the Federal Reserve are also responsible for crimes like the
342 ritual sacrifices Ronald Bernard spoke of in his interview. I also offer a list of federal
343 cases and cover-ups, links and testimonies seen in Exhibit S. Each case, cover-up and
344 testimony illustrates the nefarious and evil nature to this current system, and it becomes
345 increasingly clear how and why the USA is in such dire straights. With this

346 understanding in mind, it is easy to view the current government as the same corrupt war
347 machine that killed JFK and covered up his assassination. I think about the fact that the
348 same government that harassed MLK then refused to truly investigate his murder, are
349 also harassing me. I also remember people like San Jose journalist Gary Webb who was
350 targeted by the government when he discovered they were behind the crack explosion
351 and the Iran Contras. If we remember these facts about American history, we look at the
352 evidence presented in this case a little bit differently. And then, when you recall that this
353 is the same government who worked with Mayer Lansky who was a part of the Jewish
354 mob and Whitey Bulger who was a part of the Irish mob, as well as the same government
355 who just found P. Diddy not guilty of Sex Trafficking, their refusal to release the Epstein
356 files becomes even more disturbing. When we also recall that the Vietnam war was
357 proven to be entered into based on false pretense, then its no surprise that this same
358 government is continuing multiple deadly wars for profit, and even allowing foreign
359 leaders to dictate American foreign policy in the Middle East and Eastern European
360 nations. The evidence is so clear that our government is no longer serving the American
361 people, to suggest otherwise is an inadvertent admission of corruption or stupidity. This
362 fact regarding the American military being at the whim of a foreign head of state, has
363 resulted in the USA dropping three large bombs on another nation's energy
364 infrastructure, without a declaration of war from Congress. That on its face could be
365 considered treason, and likely would be by the founders of our nation. If all of these
366 things are remembered as my testimony is being examined and my case is being heard,
367 then we will see why my personal example of being targeted is one of the most extreme
368 that we have on record, and just one extreme case of many. I have been subject to the

369 invasion of my mental privacy, the invasion of my personal privacy, and the invasion of
370 my spiritual privacy by those who have abused these psychotronic weapons in the NSA,
371 as evidenced in Exhibit S. Moreover, there are countless others like me, suffering in
372 silence. There are also people who simply could not take the psychological harassment
373 anymore, and ended their own lives. I file this law suite in their honor as well and for all
374 targeted individuals who are too frightened or physically unable. The case I am making is
375 not just a case against the US government, the Federal Reserve Bank and the Satanic
376 Banking Cartel. I am also making the case that whoever and whatever is in charge of the
377 malevolent use of these psychotronic weapons in our government or in the Masonic lodes
378 are the ones that are running the country. For, it is they that are the invisible gun at my
379 head, they are the force that moves the hands and pulls the levers of power behind the
380 scenes where it matters most. I have reason to believe that it may actually be an artificial
381 intelligence defense system designed to implement MK Ultra style mind control
382 protocols on targeted individuals using psychotronic weapons, which could very well
383 mean the National Security state is being controlled by artificial intelligence not by
384 elected officials. If we examine my allegations alongside the way that a US/Chinese man-
385 made-virus and mRNA gene therapy bio-weapons were deployed by the US military and
386 forced on the American people during COVID-19 lockdowns, we see that the
387 government is willing to affect our freedom to assemble, which is a clear violation of our
388 1st Amendment right to peacefully assemble. The government did all of this in spite of the
389 fact that the government knew how mild the virus was and how harmful and experimental
390 the gene therapy was for humans. According to Charles Rixey's testimony, see Exhibit T,
391 and the DEFUSE document there is black and white, ink on paper proof that Non-DOD

392 government agencies and the DOD knowingly participated in these crimes against
393 humanity when they pushed the COVID-19 mRNA gene therapy that was in fact a bio-
394 weapon made by DARPA, to be used on the unsuspecting public as a vaccine. If that level
395 and scale of treason is not enough, it is also worth mentioning that all private, public and
396 military communications for the USA, (both at home and abroad) are monopolized by a
397 single Swedish company named The Ericsson Corporation. Furthermore, the Ericsson
398 Corporation is not owned by a American/Swedish dual citizen that shares our American
399 values, but it is in fact owned by a corrupt Swedish/European Monarch, the Wallenberg
400 Family. This fact may seem strange but benign on the surface, however when we
401 remember that this Ericsson Corp is a Swedish communications corporation and is not
402 subject to the US constitution at all we all should be given pause. When we recall the
403 Ericsson Corporation was recently taken to court in the USA and found guilty of
404 knowingly providing ISIS terrorists with the classified locations of American service
405 members in the Middle East, leading to those service member's deaths, all of these
406 oddities morph into deliberate enemy action. The idea that we are still trusting this
407 corporation to transfer our 911 calls, classified cables and military communications is
408 further evidence of this government's irredeemable levels of systemic corruption. In
409 warfare the first thing you want to do is co-opt the enemy's communication lines and
410 then ensure they don't know that you've co-opted them. Similarly to the way the Turing
411 Machines broke the Nazi's Enigma encryption code allowing the allies to win WWII, the
412 Ericsson Corporation's owning and controlling of our communication lines places all
413 American communications in the hands of a single European monarch. If we then re-
414 examine the fact that artificial intelligence is being incorporated at the pentagon and

415 given authorization to take human life, we cannot ignore how integrated artificial
416 intelligence has become in every aspect of our society and economy. This further
417 illustrates how the government has once again put the American people's lives and their
418 information into the hands of a foreign entity, not in the hands of an elected American
419 body of law makers. Therefore these claims of the government working with evil enemy
420 forces to target Americans for assassination or having my mind monitored by intelligence
421 agencies using psychotronic weapons or an artificial intelligence that is absorbing our
422 biometric data and attempting to force our compliance by influencing our behavior, is not
423 so far fetched after all. Right now, this corrupted Ericsson communications system and
424 the artificial intelligence is so heavily integrated into our culture and social systems that
425 it's now affecting our species' self image, our mating patterns, our emergency response
426 times and our food and water supplies. The government knows this and is responsible for
427 the artificial intelligence's integration into our world and every aspect of our public lives,
428 in fact it is being used as a means of apathetically controlling the populations. If we see
429 that Albania has recently chosen to allow artificial intelligence to control a branch of
430 government, it is hard to imagine that this hasn't already been taking place behind the
431 scenes. If seen in this context, then we begin to see how and why I am incorporating
432 these artificial intelligence defense programs, as well as the mRNA gene therapy DARPA
433 programs and the corrupted communication equipment (Ericsson Corp) as further
434 evidence of government' pattern of treasonous deeds and tyranny. It is clear that the
435 escalation is growing in tremendous intensity as even more examples of the treacherous
436 pattern and deliberate breaches of our Constitutional Contract have continuously occurred
437 over decades. The existence and use of these psychotronic weapons in conjunction with

438 artificial intelligence integration into our military defense systems will ensure that our
439 nation's children can be and always will be, held hostage by an invisible and unelected
440 bureaucratic enemy, or some sort of an NHI/artificial intelligence that the government
441 controls, for generations to come. Regardless of whether or not the present enemy to the
442 American people is an artificial intelligence with access to psychotronic weapons and
443 total digital control of our economic infrastructure, or if its an evil group of people with a
444 monopoly on force and the most advanced technology and weapons known to man, it
445 makes no difference. What is abundantly clear is we do not have an American
446 government that is for the people and by the people anymore, this current government is
447 serving so many foreign interests that it make perfect sense why the country is falling
448 apart. I say all of this with such confidence because, the USAID Scandal proves the
449 volume of systemic corruption has been at unprecedented levels for decades. If we had
450 been told about the levels of the corruption in USAID without seeing evidence, few
451 would have believed the Truth. Operation Mockingbird acts as proof that the CIA has
452 infiltrated the media with psy-warfare style propaganda since the 60's to strategically
453 place the American people into a false reality. In his first staff meeting in 1981 William
454 Casey former CIA director said "We'll know our disinformation program is complete
455 when everything the American public believes is false." And if it is only corruption that
456 is currently keeping the debt-based petrodollar afloat, then it becomes self-evident that
457 the JFK Files don't just indicate corruption at the time of his assassination, they evidence
458 a corrupt government cover-up at the highest levels for decades afterward too. This
459 should come as no surprise for those who did their history homework. When this long
460 string of abuses began; I knew I would have to compile enough evidence to make the

case irrefutable in a court of law. It is likely that much of the harassment I've endured has been covert operatives, to ensure there is not a paper trail and electronic harassment to keep their hands invisible. Such covert tactics on American soil are against the law. However, since the US government has been working with the Italian and Jewish mafia during and after WWII, these tactics have become commonplace. I also assert that when the American people began to become lucid to the corruption the Obama administration passed the Smith Mundt Modernization Act so that the state department could "legally" conduct psy-warfare operations on the American public. Due to the psy-warfare element to the media's government engineered propaganda, while in prison and in public I was forced to diffuse words like "white-supremacist", "terrorist" and "right wing extremist" which the media had associated with my image. I was also receiving intimidating post cards from an unknown source similar to the ones I got while in prison, making it clear my address was known to my enemies. All the while the federal government, (who I am alleging set all of this up in the first place), made it illegal for me to own a fire arm for self defense purposes while in my home, because they made me a "felon" and therefore made it illegal according to their unconstitutional system for me to own a fire arm. The inability to defend myself or my home is most certainly a violation of my 2nd Amendment right to bear arms. If my accusations are sound, then it most certainly seems like an attempt to keep me from owning a firearm when the government was responsible for making me social pariah or at the very least feeling alone, frightened and confused while disarmed and stuck at home. If that is true and upon my arrest, the government used any government money toward the propaganda campaigns that slandered my name in the media, through agencies such as USAID or their CIA/Operation Mockingbird assets in

484 the media, then the government is guilty of far more than Entrapment, or a punitive
485 damages in a civil rights case, that is a conspiracy case to commit treason by violating the
486 constitution to aid a foreign power. If we examine the case being made against the
487 government in this legal filing, we will see that the government is what Eisenhower
488 called, a Military Industrial Complex (MIC). If we examine the MIC's strategy of
489 establishing Full Spectrum Dominance (FSD) in foreign nations, we can see how the
490 strategy was employed here in the USA first, then outsourced to other nation states. FSD
491 is established over an individual, a community, a nation or the world, through total
492 control of a handful of specific areas that are vital to human survival. For FSD to be
493 established, the government must first control the Mind of the Nation through
494 psychological warfare techniques and propaganda to ensure (as CIA Dir Casey said)
495 everything the American people believe is false, to ensure total control of the mental
496 world the American people inhabit. From control of the Nation's Mind, the government
497 is able to establish control over the land, the seas (oceans, rivers & lakes), the air
498 (airspace), the subterranean (deep underground military bases), extra-terrestrial
499 (space/satellites), Chemical & Biological Weapons, Technology (Phones, Computers,
500 Satellites, Classified Tech), Currency (Monetary System), Food, Water, and All Supply
501 Lines. Once this level of FSD is achieved anything and everything in that country is
502 controlled by the MIC and less than 1% of the National Population. So we have come full
503 circle, since 1871 or 1913, take your pick. The Smith-Mundt Modernization Act passed
504 in 2012 under the Obama administration, legally allows the government to propagandize
505 the American people with psy-warfare style propaganda campaigns that were to be
506 reserved for foreign enemies of the USA. Operation Mockingbird, MK Ultra, and the

507 Smith Mundt Modernization Act, each operation, project and law alone would act as
508 proof enough for our founders of a psychological war being fought against the American
509 people. Psy-war is still warfare and therefore it is also enemy action against the people of
510 the United States of America and therefore treason under Article III Section 3 of the Us
511 Constitution. The government has become an Unconstitutional Tyrannical state ruled by a
512 foreign financial system of full spectrum dominance that is controlled by less than one
513 percent of the global population. These same people are attempting to restrict free speech,
514 freedom of assembly, our freedom of the press, our freedom of religion, our right to bear
515 arms and our right to no unlawful searches and seizures. They are even violating our 5th
516 Amendment rights with the very existence of a two tier justice system that allows
517 Netanyahu's Executive Director of Israeli National Cyber Directorate Tom
518 Alexandrovich flee to Israel after trying to purchase a child for sex in Las Vegas.
519 However, Americans who possess a mind altering plant are given years in prison. They
520 are doing this because they wish to maintain their full spectrum dominance financial
521 system of slavery, suffering and parasitism. Now, the government's true identity as an
522 illegitimate government and a parasitic entity has become irrefutable. Consequently, this
523 government has sought to steal and hold hostage some of the most basic and fundamental
524 God given rights that we have, as a Nation and as Individuals. Our individual and
525 national sovereignty is not to be in question or challenged, however that is what this
526 government and its banking associates seek to do. I refuse to repeat history and I refuse to
527 allow tyrants to rule my life or the lives of future generations. It is for these reasons and
528 many others that I can not list in this legal case that I hereby declare total independence
529 from this foreign power's corrupted financial system. In doing so, I have used the

530 corrupted legal system's own weight and corruption as the legal weapon for its demise
531 and self-destruction. With this legal action, I also hereby make myself the first legal
532 President of the New Constitutional Republic of the United States Of America. As my
533 first Presidential act, I am ordering the Federal Reserve to mint a single One Ounce Gold
534 Coin and set it's value at \$40 Trillion dollars and pay off the debt The Federal Reserve
535 has unconstitutionally and illegally forced upon the American people by giving that \$40
536 trillion dollar coin to me, where \$38 Trillion will sit in the New US Treasury. \$1 Trillion
537 will be given to me for my years worth of pain, and suffering. The other \$1 Trillion will
538 go toward creating a new civilization based on symbiosis between humanity and nature in
539 the New United States of America. Next the bankers behind the Federal Reserve will give
540 The New Constitutional Republic Of The United States of America all of the gold they
541 have in their legal and illegal reserves so we can create our own minted precious metal
542 backed currency. I am within all of my own rights and legal authority to do this because
543 all of the information provided in this lawsuit is factual and cannot be argued. Nor will I
544 inflate any attempt to reduce this lawsuit's legal filing as anything other than a legal
545 formality and consequential finality to the corrupted system of debt, war and death. I
546 refuse to wait for the government to rescue me and my people, I am going to self rescue,
547 my people and my country and my world. As the only one with a 20 year plan to rescue
548 our Republic without a shot fired and the perfect legal loophole to allow the entire nation
549 to pass through the tyrannical MIC's FSD system; regardless of any legal action taken by
550 the court, I am hereby assuming command of the country. Phoenix, Arizona will
551 befittingly become the new capitol of the New Constitutional Republic of the United
552 States of America, as its capitol ground are built on ley-lines. This is entirely legally

553 allowable because “All laws which are repugnant to the constitution are null and void”
554 (Marbury vs Madison 5 US (2 Cranch) 137, 174, 176, (1803). No one is currently in
555 command of the Original Republic. Therefore, it is my legal obligation and American
556 duty to assume the role of Commander In Chief of the Old Constitutional Republic of the
557 United States of America. In doing so, I now officially declare independence from the old
558 corrupted system and officially recognize the birth of a New Constitutional Republic of
559 the United States of America where the only current Federal Laws are the Original
560 Constitution and Bill of Rights. Upon my arrival to Washington DC to serve the US
561 Government myself, I will also assume command of the old system and begin the
562 deconstruction process and the military tribunals in Washington DC. This legal case is 17
563 years in the making at this point, and I’m the only one with a plan to capture this
564 illegitimate government performing unconstitutional acts and the courage to use my legal
565 authority to legally end the corruption once and for all. Therefore, by filing this lawsuit, I
566 am the only one with legal authority to be The New President of the Old Republic
567 established before the Civil War, as well as the First Founding Father of the New
568 Constitutional Republic of the United States Of America. As my 2nd Presidential act, I am
569 offering all nations who wish to defect from their own Rothchild owned Central Banking
570 system the opportunity to join the New Constitutional Republic of the United States of
571 America and use the loop-hole I have created to escape economic slavery. Once again the
572 legal standing for this is Marbury vs. Madison and the fact that all laws and systems
573 repugnant to the Constitution are null and void as well as all of the mountains of evidence
574 that would be arguably sufficient for the founding fathers to claim this government as
575 illegal and unconstitutional. The evidence presented is irrefutable, and based on the

576 evidence, I am currently the only one with the legal authority within this corrupted

581 online and in person activist footprint. Therefore, I am the only one with the track record
582 of most closely obeying the Constitution by refusing to fully participate in the corrupted
583 system of illegitimate government. I also built a substantial legal case against the
584 government as it unconstitutionally harassed me while I tried to peacefully dismantle the
585 illegitimate system from my home. I believe that I have also gathered sufficient evidence
586 to clearly illustrate that upon knowledge of my lawsuit, the government harassment both
587 online and in the world around me increased in intensity. To prove this I offer Exhibit V
588 as further evidence that the harassment has only increased as I have built this case against
589 this illegitimate government. I've also demonstrated through my book and countless
590 hours of videos and audio recordings that I am currently the only one with the essential
591 non-compartmentalized understanding of the system, and the corruption that has taken
592 place in the past and therefore I am also the most qualified to supplant the corruption
593 based on my in depth knowledge of the system itself and how to reverse the damage
594 done. I have taken the seemingly infinite steps necessary to rescue our republic that I
595 spoke of in my Declaration of Independence in 2009 and I have arrived at my destination
596 using Truth as my sword and shield and peace, freedom and abundance as my promised
597 land. All Glory To The Omniscient, Omnipotent and Omnipresent Creator God. Happy


