

Certificate of Incorporation

C3 Brooklyn, Inc.

(New York Religious Corporation)

THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledges this Certificate of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of New York.

THE UNDERSIGNED, all being persons of full age, of whom at least two-thirds are citizens of the United States, and at least one a resident of the State of New York, for the purposes of incorporating an unincorporated church, pursuant to Article 10 of the Religious Corporation Law, hereby certify as follows:

FIRST: A meeting of C3 Brooklyn, an unincorporated church was duly called and held in conformity with the aforesaid Article 10 of the Religious Corporation Law on March 27, 2015, at 84 North 9th St. Apt 307, Brooklyn, NY 11249 here at which meeting a majority of the duly qualified voters of said organization, being at least three in number, were present.

SECOND: At said meeting Joshua Kelsey one of the subscribers hereto was presiding officer; Michael Lark and Georgina Kelsey, the other subscribers hereto were inspectors of the election.

THIRD: At said meeting, it was duly decided that the said Organization should be incorporated.

FOURTH: The name of the proposed corporation as decided on at the said meeting was known as the C3 Brooklyn, Inc.

FIFTH: The specific purpose for which the corporation is organized to establish a place of worship, conduct the work of evangelism, create departments necessary to support missionary activities, to train and ordain ministers of the gospel and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. Said organization is organized exclusively for religious, charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SIXTH: The foregoing clauses shall be construed both as subjects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be construed or held in limit or restrict in any manner the powers of the within Corporation.

SEVENTH: The number of Trustees thereof shall be three (3).

EIGHTH: The first meeting of the Trustees was held on March 27, 2015. The determined date for the meeting of Trustees shall be not more than fifteen months thereafter, January 1, 2016, on which the annual meeting of the Trustees thereof after such meeting shall be held.

NINTH: The names of the persons elected as TRUSTEES and the TERMS OF OFFICE for which they were respectively elected are as follows:

TENTH: The principal place of worship is:

84 North 9th St. Apt 307
Brooklyn, NY 11249

ELEVENTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Fifth hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so

disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

TWELFTH: That all of the subscribers of the within Certificate are of full age, two thirds are citizens of the United States and all are residents of the State of New York.

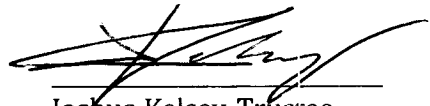
THIRTEENTH: That no other application or record has been made for the above Certificate of Incorporation of a Religious Corporation.

FOURTEENTH: The date of commencement of corporate existence shall be when the Certificate has been filed with the county clerk and approved by it and the respective filing fee has been paid; the term for which the corporation is to exist shall be perpetual.

FIFTEENTH: This Certificate of Incorporation may be amended in the manner provided by statute or in the following manner:

Every amendment shall be approved by the Board of Directors.

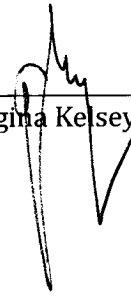
