Dear Mr. Robinson,

We are contacting you in our capacity as producers of the film *Legacy of Lies* to formally address and correct several public and private misrepresentations concerning your involvement with the film.

Let us begin by acknowledging that you participated in *Legacy of Lies* as a featured extra, appearing briefly in the role of "Burns." As such, you are entitled to reference your credited acting appearance only in a factual and non-misleading manner—for example, on your personal resume, IMDb, or social media pages.

However, we must address multiple concerns arising from your continued and repeated misrepresentation of your role in the project. Specifically:

Misuse of Producer Title and Claims of Ownership

We have observed repeated public references—in social media, websites, promotional materials, and business content (including that of Undisputed Films Ltd)—in which you present yourself as a producer, co-producer, or executive producer of *Legacy of Lies*. These claims are factually inaccurate and potentially misleading to the public.

You were not involved in the creative, financial production operations, or logistical production of *Legacy of Lies*. Any suggestion that the film was produced by you, under your authority, or by your company is demonstrably false and unsupported by the film's official records or credits.

Unauthorized Use of Contractual Documents

We are aware that a document titled *Film Equity Investment Agreement* is being circulated by you as evidence of producer involvement. That version of the document:

- Reflects a different name ("Marco Robinson") than the originally offered contract, which was issued under the legal name "Mark Lawrence Robinson."
- Contains a signature that does not match Grant Bradley's known or verified signature and was not executed by him.
- Was altered after the fact, including changes to parties' names and visual modifications to the signature field.

To be clear:

An agreement was originally offered to you in 2017 under the name Mark Lawrence Robinson, with the understanding that a significant financial contribution—reportedly \$250,000—would entitle you to an executive producer credit. When that investment was not delivered, and you later cited financial hardship in written communications, the agreement was rendered null and void.

You did provide a substantially smaller sum, for which you were instead granted a minor on-screen role.

Any presentation of this altered document as valid, or any claim that it justifies a producer credit, is inaccurate. The producers of the film do not recognize this tampered version, and Grant Bradley confirms he did not authorize or sign the circulated version in question.

Unauthorized Commercial Use and Association with Undisputed Films Ltd

We have also reviewed the website and promotional materials of Undisputed Films Ltd, which prominently feature the official *Legacy of Lies* poster, alongside language that falsely suggests your company was involved in producing or financing the film.

This is not the case.

Legacy of Lies is not a production of Undisputed Films Ltd. Any such representation is a material misstatement and constitutes unauthorized commercial use of intellectual property.

DEMAND TO CEASE AND DESIST

We hereby demand that you immediately and permanently:

1. Remove all references to *Legacy of Lies* from Undisputed Films Ltd's website, social media platforms, and promotional content, including the film's poster and any language implying ownership or production involvement.

2. Cease claiming or implying, in any medium, that you served as a producer, co-producer, or executive producer of *Legacy of Lies*.
3. Refrain from using the film's festival awards, Netflix rankings, or marketing success to promote your business ventures, courses, or coaching programs.
4. Cease circulating the modified or tampered version of the "Film Equity Investment Agreement" which does not reflect the original contract, was never honored, and was not properly executed.

LEGAL NOTICE

We reserve all rights to pursue appropriate legal remedies—including injunctive relief, fraud claims, and intellectual property enforcement—should these actions continue. A pattern of misrepresentation was already substantiated in prior legal proceedings in the UK civil courts.

This letter is written in good faith and is intended to resolve the matter privately. It is not defamatory, and all factual representations are supported by written documentation, film production records, and verified communications.

If you do not comply within seven (7) calendar days of this notice, we will initiate legal proceedings without further warning.

To be clear: *Legacy of Lies* is not your film. It is not a production of Undisputed Films Ltd. You did not serve as a producer, and no valid contract exists supporting such a claim. Any continued public or private misrepresentation will be treated as a legal violation.

Govern yourself accordingly.
