ADDITIONAL WITNESS STATEMENT OF JEFFREY THOMAS FERGUSON LOUGHRIDGE

I, Jeffrey Thomas Ferguson Loughridge, of 28 Milverton Avenue, Karrinyup, Perth, Western Australia, 6018, make this statement in support of the Claimants, Ms Andrea Bizderi Whelan & Ms Jessica Peters, in the matter against Mark Lawrence Robinson (Defendant) (also known as Marco Robinson).

I voluntarily make the following statement in respect of the above mentioned court cases regarding my own unfortunate experiences with the Defendant and I am providing this in respect only of court cases mentioned in this statement. It should not be construed as participation in any legal action to which I am not a party.

I provide this statement truthfully and to the best of my knowledge, understanding the legal implications of presenting false information in a court of law.

Additional Witness Statement of Jeffrey Thomas Ferguson Loughridge

I, Jeffrey Thomas Ferguson Loughridge, make the following voluntary statement in connection with small claims court proceedings referenced in this document and involving the Defendant.

1. I invested a total of £112,000 into businesses owned and Fraudulently Misrepresented by the Defendant between 2015 and 2018.
2. Of this amount, £39,710 has been recovered, including £12,000 from company administrators — not from the Defendant himself.
3. As of today's date, The Defendant still owes me £72,290, and I have not received any repayment from him or his companies since January 2018.
4. Subsequent to my Trustpilot review published in 2024, by email response, the Defendant threatened me with legal action. In the same email the Defendant also confirmed that he had not paid back in full. He stated, "**You have also been repaid a significant portion of your investment**". I have made this email available to the Claimants to use as required.
5. I understand that during the proceedings of Case 566MC787 on 6th May 2025 with Claimant Ms Anu Verma, the Defendant falsely claimed under oath that he had paid me back in full.
6. This is not true. The Defendant has not repaid the outstanding amount, nor has he made any payments to me in over seven years.
7. I invite the Defendant to submit bank statements to support his claim if he maintains that repayment was made.

8. To reiterate: The Defendant (Mark Lawrence Robinson) has not paid me back. Any suggestion to the contrary is false.
