
# I. INTRODUCTION

This document details the immoral and hypocritical actions of Roblox YouTuber Parlo during his prolonged break from the internet. Included with these claims are leaked screenshots, archived web pages, audio evidence, witness testimonies, and more.

Parlo has participated in and incited the **defamation**, **doxxing**, and **harassment** of multiple minors while trying to play the role of a victim. Parlo has also knowingly associated with multiple **doxxers** and an **alleged pedophile**. The following leaked screenshots include Parlo using **slurs**, making **racist remarks**, glorifying **nazism**, sending **death threats**, and even trying to **justify** his distribution of gore to multiple minors.

While Parlo is a victim of doxxing and harassment, he privately participated in the very things he **publicly disavowed** and even claimed were **illegal**.



The screenshots shown have been modified to remove any personal information. However, this document will link to archived web pages of the material discussed which can be accessed by clicking on any <u>underlined blue text shown</u>. Archives may include potentially sensitive content.

# **II. ASSOCIATION WITH DOXXERS**

Despite regularly criticizing others in the past due to who they associated with, Parlo would work and become friends with two serial doxxers: <u>Soulless</u> and <u>SC99</u>. Despite Parlo being aware of these two's actions, he would use their help in an attempt to dox the individual Parlo believed doxxed him. This would lead to multiple minors being doxxed by Parlo as detailed in the next section.

## SOULLESS

<u>Soulless</u> has not only taken part in the <u>doxxing of Parlo</u> (As Parlo would later <u>state himself</u>), but also <u>nine other Roblox creators</u>. This includes friends of Parlo such as <u>Pyndrex</u> and <u>Nattie</u> <u>Forsyth</u>. Soulless has also created several expose videos and documents alleging Parlo to be a pedophile, racist, and more. [1] [2] [3] [4]

### SC99

<u>SC99</u> is a doxxer who works with Soulless and contributed to the <u>doxxing of Parlo</u> as well as several other Roblox creators. SC99 works with Soulless by creating throwaway accounts in order to mass spam the personal information of others in twitter replies. [1]


## **III. ASSOCIATION WITH A PEDOPHILE**

## NATTIE FORSYTH


Parlo has continued to associate and befriend an **alleged pedophile** by the name of Nattie Forsyth. Nattie Forsyth has had multiple allegations of being a **sexual predator**. These allegations range from <u>sending gore content to minors</u> on a public Discord server, <u>asking a</u> <u>12 year old for nudes</u>, <u>exchanging nudes with a 16 year old</u>, and even **creating a** <u>NSFW</u> <u>twitter account</u> and <u>promoting it to her young fanbase</u>. Parlo, being fully aware of this, has been recently featured in her <u>videos</u>, live streams, and has even <u>met her in real life</u>.

It would be less of a point to bring up if Parlo denied the allegations, but anytime Nattie Forsyth's allegations are mentioned, Parlo goes quiet and avoids commenting on them. He has also indirectly indicated he believes the allegations are true, or at the very least he does not deny them. Parlo has even made jokes about the allegations and tries to justify his friendship with the reasoning that she can promote his documents.

It is likely Parlo only associates with Nattie Forsyth so he can use her for free promotion, but Parlo has disavowed others for significantly less allegations. It does not make sense why Parlo would acknowledge the allegations as being potentially true, yet still have no problem associating with her.

# IV. DOXXING & HARASSMENT

### **XDGAMER420**


<u>XDgamer420</u> or <u>Furryblox</u> was a Roblox troll who created similar provocative content to Parlo when he was a <u>Roblox troll</u> from 2019 to 2020. Parlo created an <u>expose video</u> on him in late 2020 alleging XDgamer420 to have sent unsolicited gore content to others and participated in server raiding. Parlo also encouraged his audience to mass report the XDgamer420 YouTube channel, which subsequently led to the channel being deleted. XDgamer420 later abandoned the alias and all social media accounts linked to him went inactive and have had very little activity since.

When Parlo was doxxed in late 2022, the information was uploaded under a throwaway account with the username xdgamer. Parlo assumed that therefore XDgamer420 must have posted the dox and began compiling personal information on XDgamer420 with the help of doxxers. There was **no** evidence of XDgamer420 taking part in **any** of the doxxing besides the doxxer having a similar username. Frevv, a member of the group, was able to get into contact with XDgamer420 who <u>denied the allegations</u>.

Despite the group being <u>unsure</u> of whether or not XDgamer420 had doxxed anyone, Parlo would repeatedly ask doxxers for the personal information of XDgamer420. This eventually led to Parlo spreading XDgamer420's name, face, and city on Discord while the doxxers he worked with would post XDGamer420's personal information on twitter. Parlo also made multiple death threats directed towards XDgamer420.

While the age of XDgamer420 is unconfirmed, Parlo referred to him as a kid in his expose video, SC99 alleged that <u>XDGamer420 was a child</u>, and XDGamer420 claimed to be a minor in his <u>twitter bio</u>. There is **no** evidence to suggest XDgamer420 was or currently is an adult.

After a few days, Parlo <u>backtracked</u> and claimed that XDGamer420 **did not** publish the dox or run any of the twitter accounts that doxxed him. Parlo still claims that XDGamer420 participated in the distribution of his dox with **no** evidence and does not elaborate on **how**. In reality, XDgamer420 **never** participated in the doxxing of Parlo and this was likely said in order to try and cover up Parlo's distribution of a dox of a minor.





## SYDICED

On Dec. 22, 2022, Parlo spammed and doxxed a **15 year old** Roblox YouTuber by the name of <u>Sydiced</u>. Parlo maliciously posted his face, location, and name while falsely accusing him of illegal activity **with no proof**. <u>Parlo would completely disregard Sydiced repeatedly pleading ignorance and denying the allegations</u>.

The doxxing of Sydiced began when Roblox YouTuber <u>Nattie Forsyth</u> posted a <u>tweet</u> accusing Sydiced of mocking her suicide attempt and leaking her "lewd" content to doxxers. The images attached were two screenshots of a throwaway account posting a gif of Nattie's suicide attempt and a video of Nattie nude. **There was no evidence to suggest this account had ever belonged to Sydiced**.

In the replies of this tweet, Parlo <u>posted</u> personally identifiable information of Sydiced alongside additional screenshots of the throwaway account and an old screenshot of Sydiced claiming he knew Parlo's city due to it being visible on a livestream. **This is not proof Sydiced had anything to do with the doxxing of Parlo which occurred many months later.** Parlo also posted claims of Sydiced threatening to swat kids, exposing porn to kids, doxxing kids, and being racist. Parlo did not include **any** evidence to back these claims in the tweets.

It was **confirmed** the @YdtRyc/@RevivalRyc/@Parlo\_RBLX twitter account was Parlo's as indicated by the previous tweets [1] [2], friends of Parlo/Parlo himself confirming [1] [2] [3], and the account being followed by friends of Parlo. [1] It is important to note that Parlo <u>directly</u> <u>denied</u> confirming the account was his only **after** the doxxing took place despite <u>previously</u> <u>confirming it</u>. Parlo still uses this account, however, the tweets have been deleted.

The images containing misinformation began spreading rapidly around the community, with those involved in doxxing Sydiced asking for others to spread the information.


Soulless, SC99, and Pyndrex (Associates of Parlo) harassed and doxxed Sydiced and his family members with additional information such as home addresses and emails. [1] [2] Soulless would later post all of this information to doxbin under his <u>account</u> for anyone to see.


Parlo **blatantly lied** and <u>claimed</u> that he told Soulless and SC99 "not to dox [Sydiced]." This is completely untrue and did not occur as these messages do not exist. Parlo not only **allowed** but **endorsed** the doxxing of Sydiced's address by laughing and saying he didn't care what happened to him. Parlo was the one to ask for the doxxer's personal information, and since it was believed the doxxer was Sydiced, Sydiced was doxxed.


It is important to note that while the information provided by Parlo was publicly accessible the <u>definition</u> of a dox is to gather personally identifiable (In many cases public) information with malicious intent. Parlo <u>claims</u> the information he released was not doxxing due to it being previously present on Sydiced's channel through videos, usernames, and Wikitubia. This argument does not make sense. Parlo was doxxed due to his channel's previous usernames and old content, which contained his <u>father's full name</u> and Parlo's <u>face</u>. Parlo's father owned a business in the United Kingdom which by law requires his home address to be public on government websites. Parlo was doxxed through public information. That does not mean he was not doxxed.

Parlo released a 64 page document incorrectly pinning Sydiced as the serial doxxer. Not one piece of evidence provided by Parlo would **directly** link the two individuals, rather, all the evidence was **circumstantial**. This document would lead to mass harassment towards Sydiced and numerous throwaway accounts being created to spam and dox his personal information.


On Dec. 29, 2022, Parlo and others would <u>admit</u> in a call that Sydiced did not dox him or own any of the twitter accounts that distributed his information. [1]






## FALLEN 9

On Dec. 15, 2022, Parlo announced to the doxxing group that he wanted Fallen 9's personal information. Fallen 9 is a small <u>16 year old</u> Roblox YouTuber who had allegedly doxxed another creator in the past. Parlo stated he wanted the next target after XDgamer420 to be Fallen 9. It is unknown if Parlo or the other doxxers actually pursued this, but <u>Fallen 9 would</u> be doxxed shortly after this conversation took place.

### SC99

On the same day of Parlo announcing he wanted to dox Fallen 9, Parlo directly threatened to dox SC99, a **15 year old** doxxer who he had been working with in the weeks prior. Parlo never acted on these threats, however, Parlo claimed himself that doxxing a minor is illegal. Not only has Parlo knowingly broken the law on two separate occasions, he has now threatened to do it two additional times.




## V. USE OF SLURS & OFFENSIVE LANGUAGE


## RACISM

Parlo has a long history of making racist insults towards others. Recently, Parlo repeatedly spammed racist insults against XDgamer420, who Parlo believed to be Hispanic based on the photo he leaked. This was done numerous times over the course of a few days. He also did this to SC99, who stated he was Hispanic. Parlo has also made several racist insults against Asian people. During his break, Parlo also had an islamophobic profile picture which featured MyUsernamesThis depicted as a muslim man with explosives strapped to his torso.







Parlo claiming he was black after making racist comments



Parlo's profile picture in early Dec. 2022 depicting MyUsernamesThis as a muslim man with explosives strapped to his torso










## TRANSPHOBIA

The doxxing group chat Parlo participated in was rampant with slurs, racism, transphobia, antisemitism, etc. Parlo participated in some of this, such as using transgender slurs and replying "sadly" to someone asking if another user is transgender.


# **VI. SENDING TO GORE MINORS**

During the months leading up to Parlo's break from the internet and during his steady mental decline, Parlo would send **self-harm gore** images of himself to multiple **minors**. Parlo even went into a public Discord call to harm himself while others listened, which included minors. The ages of the victims Parlo exposed this content to ranged as young as **13 years old**. Parlo was well aware that this was unacceptable behavior and he has called others out in the past for doing similar actions.


In late 2022, Parlo would admit to continuing to send his self-harm images throughout his break. He even tried to justify it by claiming that others wanted to see his arm and people were doubting the legitimacy of his claims. These are not valid excuses as he had no need to prove his self-harming was real, especially not to children as young as thirteen years old. Despite this clearly being inexcusable, Parlo has refused to take responsibility and blames everything around him, rather than himself.


Parlo's mental health may have been poor during the time he sent those images, but that does not excuse his actions. Parlo knew the ages of most minors he sent these images to.






## **VII. CONCLUSION**

I want to first point out that members of the doxxing group reacted to the original version of this document by admitting it's <u>"kinda true."</u> Parlo, on the other hand, <u>doubled down</u> and continued to defame those he doxxed by claiming those he doxxed are "cp distributors and serial doxxers." Parlo made ad hominem arguments rather than debunked anything in the video, meaning he attacked the integrity of the accuser rather than proved anything to be false. This is incredibly ironic given there is plenty of evidence of him being involved in the doxxing of multiple people, while there is little to no evidence against the people he doxxed. Parlo is so much of a narcissist that he refuses to admit fault and shifts the blame whenever possible.

Parlo is a complete hypocrite and no better than most people he "exposes" in his videos. Parlo has taken advantage of his audience multiple times to use mob mentality against anyone who speaks out against him. As for the doxxing, Parlo has not proven anyone to be guilty. Any and all evidence provided by Parlo has been **circumstantial**, meaning that the evidence could apply to anyone who fits the criteria. There was no **direct** evidence which would have **proven** Sydiced or XDgamer420 to be the doxxer. These actions have caused **irreversible** damage to both the reputation and privacy of his victims and were incredibly **irresponsible** given his influence and trust within the community.

Parlo used people's trust in him in order to convince others that he had <u>proven Sydiced was</u> <u>the doxxer</u>, when this was never the case. It makes no sense why Parlo <u>claimed doxxing a</u> <u>minor was illegal</u>, doxxed multiple minors, and then "exposed" the same minors for doxxing other minors with **no proof**.
