Sub: <u>Celebration of "MEGA APAAR DIWAS"</u> Sir/ Madam,

With reference to the subject cited above, it is to inform you that the status of generation of APAAR Id is **55.8%** for Pre-primary to Class XII and **62.9%** for Class IX to XII as on **28.11.2024**. It also to be mentioned that **3926** schools are yet to generate a single APAAR. As you are aware that providing APAAR ID to the students to facilitate targeted interventions that will help in tracking and monitoring of learning outcome as well as seamless management of academic records. Now, considering the relevance and importance, the process of APAAR generation needs to be accelerated and should be completed in a time bound manner.

As per direction of Deptt. of School Education & Literacy, Ministry of Education, Govt. of India, it is requested to celebrate "MEGA APAAR DIWAS" – a focused initiative to achieve complete saturation of APAAR Id generation and validation on 9<sup>th</sup> and 10<sup>th</sup> December, 2024 in all management schools. Furthermore, going forward the 9<sup>th</sup> & 10<sup>th</sup> of every month will be celebrated as "MEGA APAAR DIWAS" and in case of holidays the next working day shall be observed.

The <u>time line for saturation is November, 2024</u> and remaining cases must be completed within **December, 2024**. The

APAAR ID generation must be completed within the 2024 calendar year. All schools must document the records of APAAR Id creation and keep printout of APAAR Id stored in DigiLocker are provided to students. A google tracker for monitoring of "MEGA APAAR DIWAS" will be shared.
