
1. HOME SCHOOL

"It is midnight so I am in bed and my mind is wandering. I started thinking about school. The school years for me were very negative. My first grade teacher screamed at and physically abused children. Second grade was more of the same, but the teacher did a better job lying to my parents so they did not believe me when I told them about it.

"Early elementary was when I started to deal with school violence from my peers, and middle school consisted of being surrounded by shrieking black kids and abused white kids. I mostly read books and stayed quiet, but this resulted in me ending up suffering a lot of abuse. I had teachers tell me in front of the class I would never amount to anything. Roving packs of feral kids would jump me, mess with me, and I was always outnumbered. Middle school in particular is a huge black blur for me. It is better that way because I would not want to remember it anyway.

"High school freshman year was the first time I considered suicide. I had one particular class where everyone, including the teacher, harassed me. I almost stabbed a guy because they were trying to pull me straight back out of my chair.

"No one does anything to stop it. If I defend myself, it becomes my fault, and I end up suspended or expelled. Even if I did fight back, I did not have gang, and so I would just end up in a lopsided fight where it was me verse him and all of his friends. Drugs were common. Degenerates were everywhere. Sluts were getting gangbanged at parties. Everything was just rotten.

"I do not really know what to think about it at this point. How did we as a society fail so hard? When you are in it, you do not realize it, but dear God! My parents put me into a system for 12 years of abuse. I wonder what my life would be like if I had a real childhood?

"All I know is that my kids will never step foot in a public school. I will be homeschooling. Who could possibly put their kids through what I had to go though?"

"But your homeschooled kid is missing out on socializing."



"My homeschooled son wanted to try going to public school. He thought he would get a better education there, but boy was his experience enlightening to us. He has been at public school for two weeks now, and all of his classes have been soooo ridiculously easy; not challenging at all. He is bored to tears.

"In addition to that, it is just chaos in the classrooms. The kids are heathens. Luke says no teacher has any control. He says they yell, threaten with empty threats, never follow through with any discipline, and it is noisy and insane in class. He has had to bring the work home every night because the classes are so noisy and nuts that he can't even think during class. Plus all the other nice stuff...like having been offered pot twice now, and having been called gay 25 times.


"He only wanted to go there because he felt certain he would get a superior education. He has since changed his mind."

2. HISTORY OF SCHOOLING

The Myth that early Americans were uneducated:

The early English settlers in the New World brought books, printing presses and teachers with them, and they prioritized the private establishment of schools. Puritans founded Boston in 1630 and built Harvard College within six years. After ten years they had already printed the first book in the colonies, the *Bay Psalm Book*. Many more would follow.

The American colonists were so devoted to education—inspired as they were by their Protestant insistence upon biblical literacy and by their hope of converting and educating the natives— that they created a near-miraculous culture of learning. Books were cherished and well-read. A respected minister might have thousands. Sermons were long and learned. Newspapers were devoured, and elevated discussion of ideas filled taverns and parlors. Citizens formed gatherings for the "improvement of the mind"— debate societies, reading clubs, and even sewing circles were created to read and discuss the latest books from England.



The intellectual achievements of colonial America were astonishing. Benjamin Franklin taught himself five languages and was not thought exceptional. Jefferson taught himself half a dozen. It was nothing for a man to learn algebra, geometry, navigation, science, logic, grammar, and history entirely through self-education. A seminarian was usually required to know Greek, Hebrew, Latin, French and German just to begin his studies at university. The language of Shakespeare and classical literature so permeated the letters and journals of frontier Americans that modern readers have difficulty understanding that generation's literary metaphors. All of this, and society did not even have a single government school.

In early America, education was better and more widespread than most people realize, and on a fraction of what government schools spend today. Sometimes it wasn't "book learning" but it was functional, and it was designed to prepare young people for the world they would confront at that time. For example, *The Federalist Papers*, which are seldom read or understood today even in our universities, were originally published in the newspaper. They were written for and read by the average 18th century man.

To illustrate further, a study conducted in 1800 by DuPont de Nemours revealed that only four in a thousand Americans were unable to read and write legibly (=99.9% literacy rate). At that time, parents did not believe the civil government in any way had the responsibility of providing for the education of children. Only one state (Massachusetts) even had compulsory schooling laws before the Civil War, yet literacy rates were among the highest in the history of the world. In contrast, the National Center for Education Statistics states that today, after the implementation of widespread public schools, an astounding 19% of American adults cannot read a newspaper, and 50% cannot read a book written at an eighth-grade level.

The nation's oldest academic institution, Harvard University, was established in 1636 and named for Puritan minister John Harvard. All its presidents were Puritan ministers until 1708. A 1643 college brochure identified Harvard's purpose:

"To advance Learning and perpetuate it to Posterity; dreading to leave an illiterate Ministry to the Churches."

The university's Charter of 1650 calls for "the education of the English and Indian youth of this Country in knowledge and godliness."






Yale, the nation's third oldest academic institution, was established in 1701 by royal charter as The Collegiate School, in response to the efforts of colonial Congregationalist ministers to establish a college in New Haven. The charter was granted for an institution "wherein Youth may be instructed in the Arts and Sciences, through the blessing of Almighty God, may be fitted for Publick employment both in Church and Civil State."



Princeton was originally founded in 1746 as the College of New Jersey, established by royal charter for "the Education of Youth in the Learned Languages and in the Liberal Arts and Sciences." Princeton was founded by New Light Presbyterians of the Great Awakening for the purpose of training Presbyterian ministers. Jonathan Dickinson, a Presbyterian minister and leader of the Great Awakening of the 1730s, was the school's co-founder and first president.



Northwest Ordinance, July 13, 1787

"Article III. Religion, morality, and knowledge being necessary to good government and the happiness and mankind, schools and the means of education shall forever be encouraged."




What is most interesting about this Ordinance is that in the late 18th century, it was commonly understood that schools were specifically intended to teach religion. In other words, it was known that *every school must make some claim on theology*. This claim could be a theistic claim, as was common in early America, or the school could make an atheistic claim on theology, as is common in present-day America. In either case, however, a claim on theology is being made.

To illustrate, one hundred years ago schools would not teach Evolution because Evolution made an atheistic claim on theology, and most schools rejected such a claim. Today, schools will not teach Creation because it makes a theistic claim on theology, and today, most schools reject such a claim. Yet, in both cases, a claim is being made on theology, and so in both cases, religion is being taught by the school.

In fact, in 1925, evolutionists were bemoaning the fact they were not given the opportunity to teach their theory to American students. Dudley Field Malone (John Scopes's attorney) argued, "For God's sake, let the children have their minds kept open – close no doors to their knowledge; shut no door from them." On this basis, atheistic theology began to leak into public schooling.

Over the next century, rather than teaching atheistic theology along side theistic theology, the situation became completely reversed. Atheistic theology entirely supplanted theistic theology in public schools. Where before, atheistic subject matter was barred by law from public schooling, today theistic subject matter is barred by law from public school. Worse still, unlike the theists from last century, the atheists today will not listen to reason; they will not allow the children to have their minds kept open; they actively seek to keep the children locked behind shut doors.

The theistic school system matter is now regulated to Sunday School, which meets only 1 hour each week, which teaches only a fraction of the students, and which receives no public funding. What can they do against a government-mandated five-day, 33-hour-perweek atheistic school system which operates on a \$750,000,000,000.00 budget?



system is our most powerful ally." -Charles Potter, in his atheistic book, Humanism: A New Religion (1930) In 1852, the State of Massachusetts set up the first government schooling system. It was not a smooth transition for the enforcers. Over 80% of the people of Massachusetts resisted the imposition of public schooling, and it required calling out the State Militia to "persuade" the parents of Barnstable to give up their children to the system. Parents rebelled, demonstrated and went to jail. They were convinced this entombment of their children was nothing more than brainwashing. Nevertheless, compulsory schooling became law.



"In 1775, the children in 4th grade were taught to spell and define 4, 5 and 6 syllable words, such as 'abomination' or 'propitiation'. When I was in 4th grade, I distinctly remember a large proportion of students having difficulty spelling words like 'animal' and 'of'."



In the last 100 years, we have gone from teaching Latin and Greek in high school to teaching Remedial English in college. We have not 'come a long way'. We have regressed. Example questions from a 1915 8th grade textbook:

Despite having fallen from its glory in the 18th and 19th centuries, by the 1950's, education in America was still the best in the world. However, vocal elements within society demanded that public schools now take on a social engineering role as well as an educational one.



Violent disruptions of American education were ordered by the Supreme Court for the purpose of breaking down racial barriers. For 30 years, American schools diverted enormous resources into forced integration, quotas, and bussing operations. Many school districts spent a quarter or more of their budgets on transportation. In Milwaukee alone, and in a single school year, 30,000 staff hours were diverted into calculating the race of students to attend the various schools.



The results? Today's students rank at the very bottom worldwide in science and math, some 40 % of American adults are functionally illiterate, and standardized test scores have declined steadily for both Whites and Blacks. Today the average White still scores 200 points higher on the combined SAT than the average Black. Americans spend more on education than any other country in the world and have the worst results. Massive White-flight to escape racial zoning has reduced the tax base of every major American city. In 1983, after nearly two generations of racial experimentation to promote equality, the research arm of the Dept. of Education could not produce a single study that showed Black children were learning appreciably better after desegregation.

After an international assessment, the Hoover Institution discovered graduation rates in America have declined since the 70's, and American 17-year-olds know far less math and science than their peers in other modern nations. They concluded increased education spending will not help and instead favored more parental choice and tougher accountability of schools.

What changed in society that we could trust such activities then, but not now?



By the 1980's, compulsory schooling in the USA has been twisted into a fifth column which promised a voice to the people, but did little more than enslave them to wealthy elites. Based upon the Prussian school system, the American school system now worked to divide children by subject, by age, by rankings on tests, and by many other subtle means, and by so doing, it prevented these children who were so separated in childhood from ever reintegrating in adulthood. This resulted in the creation of a herd of obedient servants willing to work for the betterment of those who control the system.

To accomplish this, public schooling has six main functions:

- 1. Schools are designed to shutdown a student's creativity and critical-thinking skills. This in turn, instills into them fixed habits of reactive obedience to authority.
- 2. By training students to conform to the norm, schools are able to create a generation of citizens who are predictable and easy to manipulate
- 3. Schools prescribe societal roles for students to fulfill, generating expectations for the student to obediently follow and adhere. Any roles which are considered 'dangerous' to those in control are removed as possible options for students to select.
- 4. Students are then sorted by role and trained only so far as their prescribed work requires. Any further education could cause a student to become a threat to those in control.
- 5. Any students who are deemed 'dangerous' or 'uncontrollable' are weeded out of society with poor grades. Though it is claimed that degrees are 'earned', in reality, degrees are bestowed upon the ones who tow the narrative, and they are denied to any individual whose intelligence might work to threaten those in control.
- 6. In order to maintain this school system, an elite group of caretakers is selected based upon their loyalty to the ones in power. This elite group will watch over the deliberately dumbed-down and declawed public in order that the ones in control may proceed unchallenged. If the public was to ever rise up, the members of this elite group will be publicly sacrificed to appease the public, while the ones in power escape not only unscathed.

The purpose of the public school system is to create a harmless electorate and a servile labor force. A well cultivated herd of obedient consumers is very profitable for the ones in control.



Are we teaching American Citizens or training Prussian Serfs?

How do we Americans begin to understand the problems we are experiencing today with our educational community and with our system of education? Oddly enough, the answer to this and other perplexing questions regarding education go back in history to Napoleon's defeat of the Prussian army in 1806. Because of the Prussian failure to defeat Napoleon, Germany took a long hard look at its institutions—primarily its school system. This introspection led to the conclusion that Prussian pride and power could only be restored by restructuring that system.

A strategy was devised in which the Prussian government would set up a forced government educational system which would turn out well disciplined students who would follow orders without questioning authority. To accomplish this feat, the goal of educating children became a national priority permeated with strategies adapted to turn out a national work force rather then an educated citizenry. Every step in the education process was calculated to offer authority figures the least amount of trouble and consequently train a well disciplined albeit docile citizen.

Of course the government's attitude towards ordinary citizens did not carry over to the aristocratic upper classes, about 200 families, that owned most of the property and controlled the purse strings in Prussia—and who were intent on keeping it that way. These families did not want their children attending school with the lower classes and in the course of things the new educational protocol gave the upper classes choice in deciding the kind of schools their children would attend, a choice it did not offer to the average German.

The Prussian system may seem familiar to Americans in that it demanded compulsory attendance, national training for teachers, national testing for all students (important because it gave the government the ability to classify children for potential job training), national curriculum set for each grade, and mandatory kindergarten. Mandatory kindergarten was necessary because it served to break the influence of the mother over the child thus making the child more responsive to government influence.

So how did the Prussian system get from Germany to the United States and what reasons were offered for its adoption here? The Prussian system proved to be a success for that government's purposes. By the late 1800's men in the United States including Horace Mann, Barnis Sears, and Calvin Stove heard about the successes of the Prussian system. They traveled to Germany to investigate how the educational process worked. Upon their return to the United States they lobbied heavily to have the Prussian model adopted.

How it Used to Be

Up until the late 1800's a good education in the United States could be obtained without government interference or oversight. Surprisingly, 50 percent of a population of 3 million in 1776 were indentured servants and 20 percent were African slaves. Yet during that time 600,000 copies of Thomas Paine's Common Sense had been sold in the United States and had been read by countless Americans. By 1812, with a population of approximately 7 million, Pierre DuPont wrote in Education in the United States, "...that out of every 1,000 persons fewer than four can't read or do numbers." He attributed this fact to traditional dinner table debates over passages read from the Bible. In other words, children learned how to read with an understanding of what they were reading and they knew their numbers. All this education took place at home or in one room school houses, or "Dame Schools," primarily taught by women. The children who came out of these schools grew up to be self reliant and individualistic, in marked contrast to the Prussian system which produced an obedient, collectivist trained populace.

Another development added to the growing furor and revolution in American education. In the early 1800's, what is commonly known as the Ph.D. did not exist in the United States. Then a well connected American named Edward Everett went to Germany to take courses and returned to this country as the first American to receive a Ph.D. degree. Eventually, 10,000 of America's wealthiest families would send their sons to obtain the Ph.D. in Prussian universities. Ultimately, this development would affect the educational and intellectual make up of the entire education system from kindergarten through college. These German trained Ph.D.'s took over the educational establishment in the United States and anchored themselves in positions of political and economic power and influence. The substance of the course work in Prussian universities in tandem with the educational philosophy tended to be socialist and collectivist in nature. Consequently, the knowledge and mind set of the Prussian system were passed on to several generations of American intellectuals.

Implementation of the Prussian system was to become the goal of Edward Everett, America's first Ph.D. As Governor of Massachusetts, Everett had to deal with the problem of the influx of poor Irish Catholics into his state. In 1852, with the support of Horace Mann, another strong advocate of the Prussian model, Everett made the decision to adopt the Prussian system of education in Massachusetts. Unfortunately for the children and poor Irish Catholics of Massachusetts and elsewhere, the system produced a willing, cheap labor force with minimal reading and numbers skills. The Everetts of the world understood that people who could read and understand are dangerous because they are intellectually equipped to find out things for themselves, thus becoming a threat to already established power elites.

Shorthy after Everett and Mann collaborated to adopt the Prussian system, the Governor of New York set up the same method in 12 different New York schools on a trial basis. Incredibly, within two weeks he declared the system a total success and took control of the entire education system in the State of New York. In a "blitzkreig" action with no debate, public hearing, or citizen involvement, government forced schooling was on its way in America.

The Results of the Prussian System

The history of American education since the acceptance of the Prussian system is checkered with failure and elitism. From the time of John Dewey, who felt people should be defined by groups and associations and who believed that people who were well read were dangerous, to our own era, U.S. education has suffered. We have in this day and age the disheartening statistics showing 33 percent or our nation's college graduates can't read or calculate well enough to perform the jobs they seek.

Working against the concepts and principles the Founding Fathers provided in the Constitution, the Prussian system has produced a gradual but statistically provable decline in literacy and intellectual capability of typical Americans. We can track the five different stages that American education has gone through: 1750-1852—The idea of government controlled schools was conceived; 1852-1900—It was politically debated in state legislatures; 1900-1920—We had government controlled industrialized factory modeled schooling; 1920-1960—Schools changed from being academically focused to becoming socialized; and 1960 to the Present—Schools became psychological experimental labs.

In the year 1941 the Defense Department was preparing for World War II. In testing 18 million men between 1941 and 1944, the Defense Department found 96 percent of those tested were literate. During this same period, among African Americans who were tested—the majority of whom had only three years of schooling —80 percent were found to be literate. By literate we mean that Americans, both white and black, could read with understanding.

During the Korean War the Department of Defense tested three million men for service and 19 percent were found to be i illiterate. In less then 10 years there had been a 500 percent rise in illiteracy. Perplexed, the Defense Department investigated and found that the same test had been used during the two wars and the only difference was that those men and women tested during the Korean War had more schooling—at a significantly higher cost.

Twenty years later, around 1970, the same test was used at the time of a new war. Among the Vietnam draftees and enlistees who were tested for literacy only 73 percent were found to be capable of reading with understanding the material which they needed in order to serve in the armed forces. Again the major difference between American soldiers in the 1940's and the 1970's was more schooling for the latter group at a higher cost to the taxpayers.

Consider that the billions of taxpayer dollars were spent over the time period from the 1940's to the present increased by some 350 percent with totally unacceptable results despite all the increased spending. In 1996 statistics prepared by the National Association of Education for Progress showed that some 44 percent of African Americans can not read at all. The same set of statistics shows that illiteracy among whites has quadrupled. Incredibly, educating Americans continues to cost massive amounts of taxpayer dollars to achieve unacceptable and devastatingly poor results.

Conclusion

The cost to America can't be measured in just dollars and cents. While the economic cost is monumental as indicated by the \$30 billion annual Department of Education budget and billions more spent by local communities, the lack of results for the dollars we spend is catastrophic. We are paying billions to maintain a system which is ineffective and dangerous—because it is not teaching people the critical intellectual skills which are crucial to making economic and political decisions for themselves.

What is the answer? While the privileged class may choose to send its children to private schools, most Americans have only one option, public education. Public schools are the country's largest employer and the largest mediator in contracts. Unfortunately, the public education establishment is so powerful it can outlast public outrage. Consequently Americans face a dismal educational future unless we insist on parental choice. Until then there is little likelihood that a Prussian inspired educational system will change and deliver the desired results—a literate, intellectually capable citizenry.

3. PUBLIC SCHOOLS


Homeschooling is not new.






Our Education System



The problem is not students being uneducated.

The problem is they are educated just enough to believe what they have been taught, and not educated enough to question what they have been taught. Schools ought to identify a student's strength by exploring their talents from a young age and then work to grow those skills over time. Instead, they prep students for college and almost completely ignore educating people on trade work. Many students do not want to attend college, but are being lured there with a questionable promise of increased earning potential. Other students simply drop out of high school because if the student determines college is not what he or she wants, then what good is it to spend your days taking classes that are effectively just college prep?



However, public schools ought to provide both options, because only if students are taught both sides will they then have a real choice in what they want to do. Public schools have not given them a choice because they have not given them the skills and training they need to begin a trade career. Since today's students lack such skills, our students are forced into college because they have no idea what else they would do or even *can* do, and they then pay for that for the rest of their lives in both limited opportunities and lost earnings.



We are churning out a generation of poorly educated people with no skill, no ambition, no guidance, and no realistic expectations of what it means to do a hard day's work.





"We have a curriculum to follow, and national standards to meet. Textbooks are usually mandated and given directly by big brother. When you are free to use your own textbooks, such as in college, you must remember that you are fighting against years of grade-school indoctrination. Working directly against such indoctrination will cost you your job and your career. The same holds true of lectures.

"Public Schools and teachers are judged based on how well the students can answer nationally mandated exam questions. If the students do poorly at these exams, the school loses money, teachers get fired, and a more liberal teacher is brought in to "produce results". You cannot subvert the schools because you must first change the entirety of the federal education system.

"The best thing we can do as teachers is attempt to support anti-establishment groups and clubs which naturally form. On college campuses, you can be the patron of something benign like a debate club and use that as a front to reach minds. However, even in this case you are fighting against a decade of mind numbing indoctrination. Converts will be few. Further, if you become too open in your intentions or too open in your political alignment, they will come for you. Staff, students, parents, anyone, will demand you be fired and ostracized from your career of choice for daring to go against the norms. No one goes against the school system because to do so is to almost guarantee personal destruction with the most minimal results imaginable as your rewards.


In comparison, the average cost to *homeschool* a single student is \$600.


Yet teachers are one of the lowest paid professions.



Some schools in Vancouver are reported to be doing away with the old-fashioned pronouns "he" and "she" for their transgender pupils in favour of a new gender-neutral word, "xe".

The school board in the Canadian city has approved a new policy which allows pupils to be referred to as "xe, xem and xyr" instead of "he or she", "him or her", and "his or hers". "We're standing up for kids and making our schools safer and more inclusive," board member Mike Lombardi **told the Vancouver Sun**. 

My daughter thinks she's transgender. Her public school undermined my efforts to help her.

I pleaded that my daughter's school call her by her legal name, use female pronouns. By refusing, they prevented her from getting the help she needs.

In April 2016, my then 14-year-old daughter became convinced that she was my son. In my attempt to help her, her public school undermined me every step of the way.

Throughout my daughter's childhood, there were no signs that she wanted to be a boy. She loved stuffed animals, Pocahontas and wearing colorful bathing suits. I can't recall a single interest that seemed unusually masculine, or any evidence that she was uncomfortable as a girl.

The only difficulty she had was forming and maintaining friendships. We later learned why: <u>She was on the autism spectrum</u>. She was very functional and did well in school, helped by her Individualized Education Program (IEP), a common practice for public school students who need special education.

At her high school, my daughter was approached by a girl who had recently come out at school as transgender. Shortly after meeting her, my daughter declared that she, too, was a boy trapped in a girl's body and picked out a new masculine name.

Our school kept parents in the dark

She first came out as transgender to her school, and when she announced that she was a boy, the faculty and staff — who had full knowledge of her mental health challenges — affirmed her. Without telling me or my wife, they referred to her by her new name. They treated my daughter as if she were a boy, using male pronouns and giving her access to a gender neutral restroom.

In an IEP meeting just after she told us about being a boy, I told the school that our wishes are to call her by her legal name at all times. The social worker present at the meeting stated that we have that right to make that request, so I assumed school staff would follow our directive. I followed up that meeting with an email, but later learned that my request was ignored and school staff continued to refer to her by the male name.

We met with the school district's assistant superintendent, who told us the hands of school personnel are tied and that they had to follow the law. But there was no law, only the Obama administration's "Dear Colleagues" letter of May 2016 that said schools need to officially affirm transgender students. Just three months later, in August 2016, a federal judge in Texas blocked the guidelines from being enforced. And in February 2017, the Trump administration rescinded the Obama-era guidelines, leaving it to the states to set their own policies.

I also learned that the ACLU has sent threatening letters to schools stating that it is against the law to disclose a student's gender identity, even to their parents. But this letter appears to misunderstand federal law. The federal Family Educational Rights and Privacy Act requires that schools allow parents to "inspect and review" their child's education records as long as the child is under 18.

My daughter told me that the school social worker was advising her about halfway houses because he thought we did not support her. The social worker confirmed this when I scheduled a meeting with him to discuss it. This felt like a horrifying attempt to encourage our daughter to run away from home.

We had our daughter evaluated by a psychologist approved by the school district. He told us that it was very clear that our daughter's sudden transgender identity was driven by her underlying mental health conditions, but would only share his thoughts off the record because he feared the potential backlash he would receive. In the report he submitted to us and the school, he did not include these concerns that he would only share in person.

A national policy epidemic

In my attempts over the past several years to get help for my daughter, what I have learned has shocked me.

The National Education Association has partnered with the Human Rights Campaign and other groups to produce materials advocating automatic affirmation of identities, name changes and pronouns, regardless of parents' concerns. In 18 states and the District of Columbia, including in my home state of Illinois, there are "conversion therapy" bans, which prevent therapists from questioning a child's gender identity. No wonder my daughter's therapist would only speak to me off the record.

Some agencies, like the New Jersey Department of Education, warn school districts to "be mindful of disputes" between children and their parents over gender identity. The department's "Transgender Student Guidance" document refers educators to the state's "Child Abuse, Neglect, and Missing Children" webpage, suggesting that school staff might be encouraged to report parents if they disagree with their child transitioning.

When parents are willing to go along with their child's transitioning, the process can move at a frightening pace. Doctors with the Endocrine Society rewrote the guidelines for treating young patients who say they are transgender in order to give hormone treatments to children younger than 16 years old. Even more concerning, surgeries such as mastectomies and orchiectomies (the removal of testicles) are performed on teenagers.

Parents are afraid to speak out

Through all this, I've learned that I'm not alone. Many parents just like my wife and me are often afraid to speak out because we are told we are transphobic bigots, simply because we do not believe our children were born into the wrong bodies.

When our daughter returned to high school to finish her senior year, I contacted the principal to let him know I expected her legal name to be used at graduation. Once again, the school refused to honor my request.

Now, thanks in large part to my daughter's school, my daughter is more convinced than ever that she is a boy, and that testosterone may be necessary for her to become her authentic self.

She turned 18 in late June and life-altering, dangerous testosterone injections are just one "informed consent form" away. 6. GENDER — Parents


VICE's article about Nickerson sympathetically portrayed him, an individual who openly admits wanting to molest children, as a victim of right-wing "vigilantes".





Given 50.7 million U.S. students in thirteen grades, with a 9.6% chance of being molested at some point during a 13-year public school career: ((50.7 / 13) * 9.6%) / 13 = 28,800 students are sexually molested each year in public school by school employees.

Given 170 school days each year: 28,800 / 170 = 169 children are sexually assaulted in public school every single day by public school employees.

She started homeschooling this past August. Homeschoolers in Mississippi have a considerable amount of freedom, but they must still file a notice of intent with the local school attendance officer. The cutoff date is September 15, more than a month about public schools begin.
