

THE FILES BY ZOEY

Hi I'm Zoey (BlossomZoey on Twitch). I've been a part of The Finals community for 2 years now. Jeshi and I are the ones who came forward to PHL(OG). We appreciate how much PHL(OG) has kept their promise to keep every person's involved identities private up until the very end. The backlash we saw them go through several weeks ago for standing on their principles made us realize that we have to come out to the public and explain the truth.

To understand the full context, PLEASE take the time to fully read the document and **do not summarize it through AI**. Use the LEFT TAB to see the table of contents. Use CTRL+F to search for any keywords.



This document is part 2 to [Jeshi's part 1](#), which covered more of the systemic issues on how the top pro players, tournament organizers, and the developers themselves played their part in enabling this environment. I will be covering my experience with Bizzy and "H" from the time that I've met them until now. "H's" identity is already publicly known, which was initially exposed by a Reddit leaker who was "former HF member", but this

document will respect their request for privacy by redacting their name and any personal identifiers. The primary intent is not to air out dirty laundry out of malice, however, the toxicity of Bizzy's behaviour has spread beyond the privacy of their relationship and amplified by the echo chamber of Holtow's Finest in their collective efforts to shelter him from any consequences.

As previously mentioned in the Jeshi files, attempts to resolve this privately were exhausted and we were cornered into this decision due to group harassment, witchhunts, threats and other intimidation tactics that happened behind the scenes. While PHL(OG) courageously stood up for what was right, despite the apparent backlash that followed, Embark stood by, even throwing PHL(OG) under the bus in the interest of protecting Bizzy, Normalize, and themselves.

For those who are attempting to dismantle these files with their 100x magnifying glasses, losing sight of what's important, you will not find video recordings of physical abuse, or this would have become a legitimate court case long before it reached your screens.

After seeing what's in this file for yourself, would you rather have waited for more serious events to take place before speaking up? Would you have preferred to continue supporting them and their behaviours in their ascent to more advantageous positions in the scene?

While this doc contains evidence of infidelity, I want to be clear that this isn't just "e-dating drama". Infidelity was just one tool used in a broader pattern of abuse. Regardless of how you feel from a legal, criminal justice perspective, the following document and its supporting evidence further demonstrates the true characters of pro players that not only represent a game we love, but ones that many of you continue to support. If you are still proud to support the behaviours of these public figures who abuse their position, you may continue to do so. However, as victims of the toxic behaviour of not only certain individuals, but from a collection of Holtow's Finest members (evident in their collective efforts to harass, silence, and threaten us), we would rather the pro scene be completely rebuilt with players we would actually be proud to support, not only as players, but as people.

ADDRESSING THE STATEMENTS

Reading Bizzy and "H's" statements proved my reasoning to be correct on why we didn't reach out to "H", because they've still been in contact with Bizzy this entire time, even after what they told me. We aren't trying to advocate for "H" because it is a fact to me at


this point that they will always defend him even if he's been tormenting them for over 5 years. This will become apparent in the screenshots of this document portraying "H's" own words of the situation.

In OnyxGrave's statement, she states that she went directly to "H" to verify the claims by Jeshi in December. She failed to acknowledge the severity of the situation in her lazy attempt to verify the truth, naively accepting "H's" statement without considering likelihood of its coercion and manipulation given the circumstances. She never responded to Jeshi and chose to accept the narrative she was fed.

While it is true that, as she stated, she is not the proper channel for allegations of this nature as content creator, a human, an SA survivor, and also a prominent figure in the scene. But it's truly unfortunate that her deliberate dismissiveness and ignorance allows for the convenience of continued collaboration and support of the perpetrators. It's hard to believe that someone as integrated into the scene as she is had absolutely no idea about the degenerate behaviours of so many of her fellow collaborators. Very disappointed, to say the least.

We've also observed how selective and hypocritical certain individuals have been with their empathy and reasoning, particularly with claiming to "support the victim" while dismissing Jeshi's personal experiences that were shared in part 1.

SS of a member of HF dismissing Jeshi's experiences, supported with documented evidence, while apparently supporting "H". Both are victims, choosing to side with the perpetrators is clearly out of convenience. Members of HF seem to only advocate for the victim as long as they don't challenge their standing in the comp scene.



Perhaps driven by the ecstaticism of potential clout, "debunking" documents, notably the one from Tactics (Bizzy's friend) exemplify pathetic attempts to dismantle Jeshi's document. He generously attempts to offer a technical perspective on how the


document was written, appealing to the sense of legitimacy through the deliberate use of pseudo-overintellectualised terms and phrases. While we welcome genuine doubt and scepticism in pursuit of uncovering the truth, his document provides no real substance in regards to the genuine investigation of the circumstances. Rather, from the meaningless tunnel-visioning into the technical breakdown of writing, it should be clear to his readers that his entire document is written in bad faith, in tone and in substance, with the intention to cause confusion, protect the perpetrators, and distract from the reality of the situation.

This type of analysis may have been helpful during 3rd grade English class, but is clearly misused here. We urge Tactics to realize that this is not English class, but a situation where real people are affected by the degenerate behaviours of prominent figures in this space, and will continue to be affected because documents like Tactics's attempt to "debunk" personal experiences.

SS of an HF member confirming that Bizzy and Normalize have known about their allegations as early as December 2025 and had already been deleting evidence since then. He also admitted that HF has been aware that Normalize and Bizzy are guilty.



People also need to realize that in other esports, players get banned from tournaments and dropped from their orgs for “IRL” misconduct all the time. Why treat this any differently? Toxic behaviour that transcends digital spaces should be considered bannable, especially when it starts to affect others in the scene. Just because it doesn't affect you personally, just because you're not the one being targeted, doesn't mean it's “not a big deal”.

Jeshi and I originally planned on dropping both of our docs at the same time, but due to my sudden hospitalization, Jeshi took the step forward first because of the new PHL not honoring the original PHL's bans. For the past week, I've observed the domino effect from my hospital bed. I watched certain people scramble to cover themselves, twist the narrative, and villainize Jeshi, all while assuming that my evidence would never come to light.

SS of HF members labelling Jeshi as a “nut case” and “annoying” for defending herself in a public Discord server. This is an example of why victims never come forward because they’re often met with ridicule and harassment.



To those who picked a side before the full picture was public, your rush to defend something/someone indefensible is noted. And if you’re mentioned in this document, I urge you to consider what stance you’re really taking. Do you really want to defend the truth or continue pushing false narratives? When you finish reading this document and learn the full story, the choice of being “neutral” towards those involved is no longer an option. Consider how that can allow these behaviors to continue going unchecked.

HOW I MET BIZZY AND “H”

I met Bizzy back in August 26, 2024, as a viewer who was new to The Finals community and within the chat I met another girl named Jeni who I became close with (unfortunately not friends anymore) and played the game with. We would talk in Bizzy's public Discord voice channels and that's how I slowly began to befriend Bizzy and meet more people that are/were friends with him.


I first heard about “H” through one of Bizzy's mutual friends, Keyludio. “H” was brought up during a voice call that Jeni and I and another mutual friend were in. Keyludio started to talk about how Bizzy was taking a week off from streaming because “H” was coming to visit Bizzy for the week. The mutual friend asked who it was, and Keyludio name dropped “H”. The mutual friend asked “Isn't that one of his mods? I've seen them around in the chat”. Keyludio confirmed that it was “H” and left it at that.

After that, Jeni and I privately got into a voice call and I told her “We are not to tell anyone about “H”. At the time, I felt like we had to keep “H's” identity a secret since Bizzy wouldn't have wanted his business out there and he had always displayed signs of wanting to be very secretive and to himself. I would've brought this up to Bizzy but at the time I felt intimidated by him because I was still new to the community. I later did tell him about it which led to Keyludio losing his moderator role in Bizzy's Twitch since Bizzy felt it was a betrayal of trust between them, when Keyludio spoke about Bizzy's business without his permission.


I met “H” back in October 19th, 2024, solely because Lycommit outed “H's” identity through their Steam account that Bizzy would use as an alt account. Lycommit then boasted in a public voice call, where Bizzy's mutuals and I were in, about how dumb Bizzy was and how he wasn't being careful enough to hide it. Lycommit then said “I mean, not bad looks” hinting at the fact that he was talking about “H” looks, and then brought up their ethnicity and how “not bad of a job” Bizzy did. I found it disgusting how Lycommit was speaking of their relationship and about “H” especially when at the time Bizzy didn't want his business out in public.

I messaged Bizzy privately to let him know how Lycommit was airing out his business to others in the voice call. At the time of this happening, Bizzy was taking “H” to the airport so they could head back home. Bizzy then joined the voice call, telling Lycommit to shut up and stop spreading his business to people and then left. Lycommit just laughed it off and said “At least this will teach him to be more careful” and then followed by “Who fucking snitched?”



I then reached out to “H” because I felt the need to apologize to them about what happened, even if it didn’t involve me directly. “H” let me know that they didn’t mind and that I’m “W” for letting Bizzy know about the situation. I had also reached out because I wanted more female friends since I was new to gaming online (on PC).

SS of “H” and I’s first conversation. I asked them why they can’t play Minecraft, “H” had responded telling me they had to ask Bizzy for permission to play with me. I found it odd but it was my first time meeting her so I just assumed that’s how their dynamic worked. In the ss you won’t see her say that and that is because “H” deleted their message but they did react to it






THE BEGINNING

November 10th, 2024, “H” and I were having a conversation when they had Bizzy respond to them asking them why “H” was texting Sloth. ”H” had expressed how Bizzy was on their case when they weren’t dating at the time.”H” had expressed this is why they also asked mutual friends to delete their messages in fear that Bizzy would find out they’re in contact.


SS showing “H’s” and I’s conversation and also SS of Bizzy getting on their case about texting Sloth.



I noticed really early on how Bizzy was digitally gatekeeping “H” and how weird it was that “H” had mentioned that they needed to ask Bizzy for permission to play games with me. I also noticed that while “H” was modded in Bizzy’s Twitch chat, they weren’t a member in Bizzy’s Discord server at all.

When I messaged Bizzy saying “also, tyty for letting “H” play mc (Minecraft)” it seemed like he was surprised that I would say that because his response was “what are you talking about”. I thought maybe I shouldn’t have said that to him because it might've gotten “H” in trouble. Anytime “H” was “in trouble” with Bizzy, he would call them names and degrade them.


Another telling sign of early abuse was how “H” regularly deleted their messages. “H” would go back through our private messages and delete any mentions of having to ask Bizzy for permission to play games with others. On November 11th, 2024, “H” and I exchanged phone numbers so we could discuss what messages we’ll delete on Discord so we could freely text on iMessage without having the feeling of being watched by Bizzy.



“H” only started being included more and granted access to Bizzy’s server solely for the reason being that I wanted to play with them. Bizzy couldn’t protest that or else he’d be showing his controlling behavior too early on and he needed to appear normal to me and others.


SS showing the date when “H” and I first exchanged numbers and immediately started to talk about deleting messages.

The left SS is “H” showing me how to delete messages on Discord super fast. This is an example of how frequently they used this feature to scrub any evidence of them talking about Bizzy in private.

Right SS is “H” telling me not to reply to them on iMessage because they will be deleting their conversation and doesn’t want to get caught by Bizzy.







November 12th, 2024, "H" and I were playing Overcooked 2. Sloth joined us instead of playing The Finals with Bizzy, which led to Bizzy crashing out at "H" for **"self inviting"** to play with Sloth and I. "H" told me Bizzy called them a **"dumb bitch who never follows anything he says"** (There are no SS of this because it happened on Snapchat). This would lead to me and a mutual friend always having to ask "H" to play with us in front of Bizzy so "H" wouldn't have to ask Bizzy for permission to play with us and him denying "H" of gaming privileges with us.

SS of "H" and I's conversation about Bizzy degrading them and accusing "H" of trying to steal Bizzy's friends away from him.





November 15th, 2024, "H" and I were speaking about behaviors when they admitted to me that Bizzy has a bad temper, especially when they don't cooperate with Bizzy on games and let him win, because Bizzy is competitive. "H" told me they felt like they can't even make their own decisions whenever they play a game with Bizzy, whether it be real life or online.

SS of "H" and I's conversation about Bizzy's behavior and making "H" cry in front of his family.






This slowly led to “H” opening up to me when I brought up how I assumed another girl was Bizzy’s girlfriend at the time, and that’s when she decided to drop some lore about Bubbz (juztbubblez).

Bubbz and Bizzy met during OW2 (Overwatch 2) and after he had met her, his behavior changed. On December 21st, 2024, “H” had expressed to me that Bizzy wasn’t the same guy “H” had first met and showed me a SS of how Bizzy used to text/treat “H”. I knew of Bubbz because when I first watched Bizzy’s streams, she was always in his games and playing. I always assumed that they were dating based on their flirtatious relationship. After “H” told me the entire lore on how Bizzy cheated on them with Bubbz, I was shocked. Before “H” told me all of this information, I never knew they even existed.




SS of “H” telling me how Bizzy used to treat them before he met Bubbz.



From what “H” told me, they said that Bubbz always thought it was only her that Bizzy was in love with and no one else. Bubbz had no idea “H” was also in the picture. “H” told me how Bizzy would only keep Bubbz around because of her chest size and because she was his “sugar mommy”. He would save up the money Bubbz sent him to buy “H” gifts. “H” also told me **“Bizzy said that he would never actually date her because he doesn’t like that she’s black.”**

Another female Finals community member that frequented Bizzy's community was Jeni (the girl who I first became friends with). I didn't learn until later that she was involved with Bizzy sexually. It was only brought to my attention because of another situation that happened. She was cheating with Bizzy as a distraction from her own abusive relationship. She later admitted to me that she cheated with multiple guys in The Finals community through Bizzy's Discord.

"H" had known about Jeni as well, and told me they knew Jeni and Bizzy were planning to go on a trip to New York to visit Grad.


"H" also told me how Jeni had bought Bizzy a remote sex toy called Lovense, which they used together two days before "H" went to visit Bizzy in November.

"H" sent me screenshots from Bizzy's phone showing explicit videos of Jeni doing sexual acts for him. I don't have these screenshots because "H" immediately deleted them after I saw/read them.


I will say that "H" admitted to me that they weren't together at this point in time and they were in a middle of another relationship break, so maybe they were coping like it was no big deal, but it must have really bothered them since they were showing/telling me about all this in the middle of the night and going through his phone in the bathroom while Bizzy was asleep.

"H" stayed at his house for the next 2-3 months even after finding all that stuff on his phone.

While "H" was staying at Bizzy's house, they were using his PC to play with me and other mutuals whenever Bizzy wasn't using it. During this time "H" had received a Steam message from "rippitydippityx" (Jeni's steam name) telling "H" **"bizzy cheated on you with jeni and had e sex with her as well as asked for nudes some months ago, she also sent nudes to sloth and cheated on me with all 4 of them. dont ask why or how im messaging you from here but just know youre being played by that dude"**.




SS from December 4th, 2024, between a trusted mutual friend and I discussing what "H" told me when they found explicit photos of Jeni on Bizzy's phone.



On January 3rd, 2025, "H" was permitted screen-time at Bizzy's house to play with me. It was late at night when we were in a queue-time for World Tour with a mutual friend. "H" told us that they were going to go use the bathroom while we were loading into a game. "H" still had Bizzy's bluetooth headphones on (so they could hear everything that was happening in the voice call) . We then heard Bizzy speak to me and our mutual friend through the mic, saying "**goodnight jits**". "H" immediately disconnected from the game and Discord call. Bizzy had turned off the PC while "H" was in the bathroom without asking them first.

"H" did not protest and never ended up returning to the game or call. This left a bad taste in my mouth because of how entitled he was behaving to their time and personal space, and it felt like "H" could never have proper communication with us while playing without him supervising at all times.

February 16th, 2025, "H" and I had a conversation about how they always have to do what Bizzy tells them to do or else Bizzy lashes out by getting mad, blocking them and breaking up with "H". "H" said there's previous history, meaning this is a repeated pattern that Bizzy does when "H" won't cooperate.





When “H” came back from staying with Bizzy over the holidays, they wanted me to put them in contact with Jeni.


Around February 20th, 2025, Jeni came back into the picture and wanted to apologize to “H”, so I asked “H” if that would be ok with them and “H” said yes because they also wanted to know the timelines of Jeni’s and Bizzy’s relationship. I sat in a three way call with them on February 24th, 2025, while they both talked about their experiences with Bizzy. “H” was asking Jeni for specific timelines to see if both of theirs would line up, like when he would cheat on them or while they were on a break. They both agreed that Bizzy was a manipulator and that he gaslights both of them.





Bizzy manipulated them into believing that they both hated each other. After the phone call, “H” and Jeni began a friendship for a while, but Bizzy found it suspicious and would question “H” about it. In the end, it didn’t matter because Jeni eventually ended up disappearing for a while/hiatus.

This SS is one of many instances where Bizzy gaslit “H” into believing that Jeni doesn’t like them.



Jeni returned back to the community as BoopyOopy in Normalize's Twitch chat, and for some reason, Normalize realized how Bizzy started to panic and act differently when he noticed her in there. Bizzy said "I'll be right back" and left. At the time, one of our mutual friends was in the call/chat and suspected BoopyOopy to be Jeni.

On October 5th, 2025, Normalize came to me asking for info about BoopyOopy.




Normalize was curious as to why this girl was making Bizzy so anxious, so our mutual friend asked me if I could tell Normalize the “Jeni x Bizzy lore”. I said sure, but only if Normalize can keep it to himself.

He obviously didn't, since he went and told Jeshi in an attempt to speak badly about Bizzy and paint an ugly picture of him, which caused Jeshi to establish a negative impression of Bizzy.

Normalize actually twisted the truth and painted Bizzy much more badly than I did. Bizzy eventually reached out to me and asked what exactly I told Normalize. I told him that Normalize was dumb and just twisted what I originally said, because the trip of Bizzy flying Jeni out never even happened. Normalize only heard what he wanted and retold the story to Jeshi in a way that he wanted it to sound like. Typical Normalize behavior tbh.

It became even more apparent to me how much “H” would stress over deleting our messages and call logs so Bizzy wouldn’t find out that “H” had been confiding in me or telling me anything about their relationship, which could expose the type of person Bizzy truly is.





“H” and I would sit in voice calls deliberating which messages to delete and up to what conversations so it didn’t seem suspicious if the conversations would just drop randomly. “H” and I exchanged phone numbers in case of Bizzy obtaining their Discord login so he wouldn’t be able to have access to “H’s” messages.

November 13th, 2024, I had a conversation with “H” about streaming COD Zombies and they said they were down to play and stream the game but weren’t sure if they could stream with face cam. I asked if it was because of Bizzy, and they said yes. I reminded them that they weren’t even dating at this time and asked why it even mattered to them and why he had so much control over their streaming stuff. “H” speculated that Bizzy didn’t want others to see what “H” looked like.

If "H" didn't cooperate, Bizzy would retaliate by kicking them out of his server ("H" created this server for him). Bizzy would continue to demand "H" to ask permission to use face cam, as well as permission to simply stream.



On November 14th 2024, "H" and I were having a conversation about Bizzy's behavior. We discussed his frequent gaslighting towards "H", always making them believe that they've done him wrong. "H" revealed to me that Bizzy has threatened to blackmail

them with revenge porn before and stated **“He said he'll send our nudes and shit to my parents”** as a way to control “H”.



December 22, 2024, “H” would have conversations with me about how they wouldn’t feel up for wanting to do sexual acts with Bizzy in video calls when they would be too tired from a stressful day or just in general. Bizzy would get upset that “H” wasn’t being cooperative in doing what he wanted from them. This would lead to Bizzy ignoring them for hours and degrading them until “H” would just give in. “H” showed me a conversation where Bizzy wanted them to turn on their camera on Discord and touch themselves. “H” originally complied but Bizzy took too long so “H” lost interest and went offline. When Bizzy was finally “ready”, he got upset which made “H” feel the need to get back on to make him happy so he wouldn’t get even more upset with “H”.




On February 19th, 2025, an incident occurred between “H” and Bizzy in a voice call that I was in and my husband. “H” was just finishing up their stream and raided another female streamer. “H” didn’t look into the streamer’s details, but Bizzy did.

He screenshared her Instagram and scrolled through her feed, which had mostly explicit photos, while commentating stuff like **“Damn “H”, who did you raid into? Woah!”**. “H” then told Bizzy to stop looking at the pictures because it clearly made “H” uncomfortable that he was actively looking/scrolling at them while in the voice call with us, and that it was disrespectful to them (they were together at the time).

This went on for like 20 minutes of them going back and forth about it. “H” then sent a chat to the streamer saying **“You should ban Bizzy. He’s a weirdo”** followed by Bizzy typing in chat saying **“I’m sorry, I have to unfollow. “H” doesn’t want me supporting you”**. The streamer ignored what was going on in chat, as she was in the middle of gaming, and it appeared to be an awkward experience for her. “H” then proceeded to call Bizzy a cheater in front of us. I said **“Then why stay with him?”**. Bizzy immediately said **“Yeah, why stay with me? Okay, we’re breaking up.”** and then kicked “H” from the voice call and from Bizzy’s server.


Bizzy then went back to watching his show (Fall Out) which left my husband and I in an extremely awkward state. I then texted “H” asking if they were actually broken up and if they were okay. “H” asked me if Bizzy said anything afterwards, to which I responded with **“No, he was fine. Just watching his show”**. “H” said that by calling Bizzy a cheater in front of my husband and I, his ego got hurt and this was his way of “disciplining” them.


The following details were shared with me by “H” in a 44 minute call on December 11th, 2025. They were under a lot of emotional distress and needed to confide in me about what happened in Sweden and the aftermath.



On December 11th, 2025, I saw that Bizzy went live on Twitch so I decided to pop by and see what was up. I noticed he was sick so I asked if he had taken any meds. He said no, but mentioned that “H” had the worst of being sick, so I left the stream and texted them asking about their trip in Europe.

“H” said it was good, but there were ups and downs. I asked them if they got into any arguments and they said that they did a few times, but then later admitted that they can't do vacation alone with Bizzy ever again.

Obviously that sounded pretty bad to me, because what could've happened that made them think they can't travel alone with Bizzy again? So they asked if I wanted to call them to talk about it, because they were in the middle of working, which is a remote job that allows them to be able to take personal calls.



We called and the call lasted almost an hour of them telling me everything that happened in Sweden and after. It started off normal with them telling me how nice it was to meet everyone, and then I asked them what they meant by “arguments” earlier. They told me how upset Bizzy got at them for taking “too many photos”. They also told me that Bizzy was very fixated on managing his image, and he was only affectionate to them when they were in front of people (during TGM25 event). “H” specified how every time they were around people, he would have his arm around them. But the moment no one was around, he dropped the act.

I asked “H” if he had only brought them to Sweden so that they would pose as his “partner”, since he had already bragged to the other players and his viewers that “lil jit” was also going to Sweden and that he was gonna get that “plop plop”.

“H” admitted to me in the call that they did not want to go to Sweden, and planned on breaking up with him, but that Bizzy coerced them into going by saying he covered the entire trip and that they won’t have to pay for anything. But they still adamantly expressed that they did not want to go, and that's when he threatened them by saying how he will just drop out and not participate in the Major and sabotage his teammates, which caught “H” off guard.

They told him **“You have to show up since your team is participating”**. Bizzy told them **“I'll just make up an excuse and not go if you don't come”**.

“H” was ultimately coerced into travelling to a foreign country with this guy because they felt financially indebted, and so that his other two teammates (Stewj and Stn2k who were on the ENVY roster with Bizzy at the time) wouldn't get disqualified and left in the dust.

This part shows how unprofessional Bizzy was by treating the biggest tournament in The Finals competitive history as a bargaining chip for his personal goals.

Bizzy is obsessed with controlling and tracking people in his circle. During the Grand Major event, “H” told me that Bizzy was always searching for Sloth, which was odd to me. I asked what they meant by that, and they said that anytime Sloth would walk away from the group on his own, Bizzy would immediately go searching for him and repeatedly ask **“Where is Sloth?”**. This happened even when “H” had to go to the bathroom or was hungry and wanted to buy food. He wouldn't allow them to go until they successfully found Sloth.

“H” told me they spoke to Sloth about him wandering off and asked if he could just let Bizzy know where he was going first so that he wouldn't be asking for his location all the time. Sloth initially agreed, but the next day, Sloth would continue to wander off and not let Bizzy or anyone know where he was wandering off to, which led to Bizzy to continue being hyperfixated on where Sloth was at all times.

This upset “H” because Sloth did not follow through what they agreed on. This led to “H” telling Bizzy **“Why did you even want me here if you're always asking for Sloth? You asked me to be your girlfriend but you're asking where Sloth is. Maybe you should just date him”**.

During the TGM25, Bizzy had a strict rule for “H” which was that they had to be attached to his hip at all times. They were also barred from exploring the event venue or talking to people independently.

Any time they attempted to wander off on their own, they got shut down by Bizzy who demanded that they stay within his immediate vicinity at all times. There was a witness at the event, who doesn't want to be named, but they had an interaction with Bizzy and “H” where they told a joke that made “H” laugh. The witness immediately caught Bizzy's reaction, which they described as “He looked upset that “H” laughed at my joke”.

At any point in time during the Grand Major event where they weren't with Bizzy, they were being practically babysat by Tactics, one of Bizzy's friends who he met through OW2 (Overwatch 2).

On one occasion, Bizzy disappeared with HotCrossBunTV for over an hour without letting “H” know. They were distressed and spent over an hour searching for them rather than enjoying the event.

When “H” found them, HotCrossBunTV visibly noticed the tension and attempted to play it off cool to mask the awkwardness. Bizzy’s behavior shows his hypocrisy because he wanted freedom for himself but felt entitled to their autonomy.

It’s like he treated “H” as an accessory or trophy at the Major, while at the same time preventing them from engaging in their own social connections at the event.

During the last day of Sweden, “H”, Bizzy and Grad took three polaroid photos where they were all wearing matching designer jackets (this is important details for what she told me towards the end of the call), and there are three different copies of this polaroid. Later, at their AirBnb, an argument between them broke out. At the peak, “H” started to raise their voice. Bizzy demanded them to lower their voice or else the others would hear them. He was very hyper aware of how he could have been perceived by others and was afraid of ruining the image of him being a sweet and loving boyfriend.

After the TGM25 event was over, Bizzy and “H” went to travel and explore the EU, hitting different countries (France, UK, Norway). Throughout these trips, they would have arguments about where to eat and where to go. “H” wanted to have Bizzy’s input in making these decisions, but all he had to say in return was **“Just pick. I don’t care. I’m just paying for everything.”**

He would also get annoyed at them for stopping at certain places to take photos and at one point, “H” was really upset they couldn’t get a photo in front of the Eiffel Tower in Paris. They said **“Of course I’m taking lots of photos. This is like a once in a lifetime opportunity and I don’t know when I’ll be visiting the EU again.”** By rushing “H” and devaluing their memories, he made his convenience more important than their enjoyment.

“H” was also ill throughout this tour. Instead of Bizzy providing comfort or care, he didn’t want to be near them. He was more annoyed by the fact that they were ill in the first place and treated them like a burden. Bizzy also got annoyed at how much time “H” spent shopping for souvenirs and just doing normal tourist activities. He would say things like **“You’re taking too long. You need to walk faster.”** “H” pointed out his hypocrisy, which was how they would be patient with him, even when he took his time walking or looking around.

POST SWEDEN

Then the phone call progressed to “H” telling me about the incident that happened at the hotel in their hometown. This was the day Bizzy’s flight was back home and also the day they broke up (for the 10000th time).

Bizzy expressed that he wanted to keep all the polaroids that included Grad that were taken on that final day in Sweden. “H” told him they wanted to keep the only copy of the polaroid where they felt they looked pretty to themselves, and that Bizzy already had his own copy of the polaroid anyway.

“H” said **“I spent my own money on the film and it’s my camera.”** Bizzy got upset and jealous, asking why “H” wanted to keep a polaroid with Grad specifically. “H” responded **“Because, these are memories.”** and refused to hand it over to him.

Bizzy then proceeded to get up from the bed and ransack “H’s” suitcase looking for the polaroid. This made “H” get up and lay on top of their suitcase to stop Bizzy from taking the polaroid. This is when Bizzy got physical and put his hands on “H”, grabbing them and throwing them onto the bed. “H” got up and ran back to their suitcase. This fight turned into a back and forth for a while where he physically overpowered “H” by repeatedly grabbing, shoving, and throwing their body across the room every time they ran back to their suitcase to protect their personal belongings.

“H” told me **“I was a frog protecting my eggs”** then sent me an image of a frog on iMessage, demonstrating how they were using their body as a shield to protect their suitcase.

SS of “H” saying they can’t do vacation with Bizzy alone again and sending me a photo of a frog to demonstrate how they were protecting their suitcase from him.



This fight got to the point where “H” told Bizzy **“If you don’t stop it, I’m going to start screaming”** and that’s when Bizzy stopped. He didn’t stop because of empathy or because he realized what he was doing was wrong, but only because of the threat of being exposed to others at the hotel, which mirrors that AirBnb incident where Bizzy wanted “H” to lower their voice during an argument so that his teammates and friends wouldn’t hear.


“H” then told me how Bizzy has a polaroid that was taken in Sweden that included HotCrossBunTV, “H” and him. He told them how he wanted to keep that polaroid to make “H” jealous, to which they replied that they didn’t care and led him to getting angry again and saying **“We’re breaking up over a polaroid”**. “H” acknowledged this and said **“Yeah, over a polaroid that you’re making a big deal out of”**. Bizzy responded by calling “H” a **“narcissistic retard”** for wanting to keep the polaroid with Grad where they thought they looked pretty, then proceeded to try to rip that polaroid apart but failed. “H” then told me that Bizzy has anger issues and refuses to travel alone with him ever again. After “H” had finished wrapping up the story, I was shocked and told them **“You do realize that’s domestic abuse, him putting his hands on you, right?”** “H” then went quiet, like they were trying to take in what I said and process it. Then finally

they responded with “Really?”, in a laughing manner. I realized just how deep “H’s” conditioning went. This isn't the first time “H” has downplayed a serious situation to cope with their emotions and the severity of incidents like this, since they have been subjected to manipulation and gaslighting by Bizzy for so long.

That was the end of the call between “H” and I, which left me shocked and concerned to the point where for the first time I seriously felt like I needed to tell an outsider who could validate my concerns without the influence of “H’s” nonchalant attitude about it, and that person was Jeshi.

SS of me messaging Jeshi at the same time I was sitting in call with “H” talking about their trip. I relayed the information to Jeshi in real time.

Please note how the time stamps show December 11, 2025. My call with “H” began at 11:14 PM for 44 minutes, and my logs with Jeshi began from 11:21 PM to 12:04 AM.



A month later, Jeshi became a target of Bizzy, Normalize, and HF, not because she was spreading rumors, but because she knew about the reality of Bizzy and “H’s” relationship, which Bizzy was desperate to keep a secret and under control.

This escalation triggered when ChudDemi leaked her private conversations with Jeshi (who explained her concerns regarding Bizzy) to Normalize, who then showed them to Bizzy.

Bizzy then coordinated a mass ban with HF against Jeshi, using his connections and clout to silence her, then framed her as a liar so that even if she did ever speak up about it, everyone would already have been conditioned to doubt her (shows in the case with Onyx).


When Bizzy angrily confronted “H” about how Jeshi knew all these details, instead of addressing the abuse, “H” deflected the blame by accusing Jeshi of lying and then attacking her appearance to me over the phone, saying **“I don’t understand why all these guys are fighting over her. She’s literally average. There’s Asians that look better than her”**

“H” sided with Bizzy to redirect his anger away from himself and towards Jeshi, despite “H” being the original source of the information and spreading it in the first place.

We were concerned that if Bizzy knew that “H” was the source of information, that they’d be in a position of actual danger. Our reaction seems over the top from the outside, especially since Bizzy and “H” live in different states. But given that I’ve now shared Bizzy’s history of blackmailing “H” and his threats to send revenge porn to their family (which would lead her to being disowned/estranged from them), we were genuinely concerned that exposing “H” for being the source of information would put them in immediate danger.

I was also afraid of his retaliation at the time because of the social backlash that Jeshi had faced and I didn’t want my husband, who is an active member in the community, to suffer for it as well. It was only after Jeshi faced further harassment from HF that we realized we couldn’t be quiet anymore.



On June 27th, 2025, I reached out to “H” asking if Bizzy and them were still together. “H” told me they weren’t together anymore and had not been since April 2025, and then told me everything that had happened between them and what led to the break up. They told me that Bizzy initially blocked Bubbz to try and mend him and “H’s” relationship but it didn’t work out in the end, so he went back to Bubbz.

Goal of Hoovering:

TESTIMONY FROM OUR MUTUAL FRIEND

The following is a verified statement from a close mutual friend of "H", Bizzy, and I. It will be presented here in his own words to preserve the integrity of his experience and observations:

I didn't know that Bizzy and "H" were a thing or that "H" even existed until 4 months after I met Bizzy. **Bizzy hid their relationship and would get mad every time she was around.**

I met him on The Finals while playing and streaming the game, and then I joined his Discord server.

"H" came to me when the whole Jeni shit happened. Jeni is a very flirty person and was like that with everybody in the group. I was single at the time so I was flirting with her too. Jeni and Bizzy were also flirting. She bought him a Lovense, which she was able to jerk him off from her phone or something. That's the craziest shit I've ever heard in my life. "H" didn't even know that Jeni was talking to and flirting with everybody.

There was a guy in Jeni's life and she would paint him as a creep, so we would try to protect her from him. We banned him and kicked him from everything, but it turned out she was dating him the whole time and he was abusive. She gave him over \$10,000 throughout the course of their relationship. **Bizzy was involved with her, Bubbz, and "H", all at the same time.**

She would always come to me and vent about Bizzy. **Bizzy would get mad whenever she would wanna hang out with the squad** (The Finals players and friends) in the voice channels, who would come and go. They'd just want to hang out, but Bizzy did not like that. She always wanted to spend time with him, but he'd always be playing or streaming the game. I thought it was crazy how he couldn't make time for someone he "loved". **He would constantly kick her from the call or ban her from the Discord server.** Anybody that was around, could see that their relationship was not good and that something wasn't right.

At one point, we all played in a Minecraft Bedrock world. **She really wanted to play but Bizzy would not let her join until everyone had their "2 week Minecraft phase" and left.** So by the time she joined the world, there was nothing else to do and nobody there.

She tried to become friends with us for Bizzy. **He'd push her away, yell at her, degrade her, ban her, etc.** All she wanted to do was spend time with him. **He didn't like that she was making friends with people in the community at all.**

I told Bizzy that Lycommit and Bubbz were a "thing", which was a lie to get Bizzy to lose his shit and focus on Bubbz, so that he'd get away from "H".

After that, I left his server and distanced myself from everyone because I didn't want to be involved with these people anymore. I don't know why I stuck around as long as I did, but it was because of people like Zoey, Anton, and Smelvin.

I didn't want her to tell me stuff anymore because I got tired of hearing her vent to me. Being a part of all that wasn't healthy for me.

I felt like I was around degenerate online people doing degenerate things. They made me feel like I was stagnating in life. **She would still come to me, even now to this day, even after I set boundaries about not wanting to hear any of it. The only thing we'd ever talk about was Bizzy. Something was always going on.**

Her deleting messages was very much a thing. Part of the reason why I can't provide screenshots or messages is because **I'm missing bits and pieces of our conversation from her, always deleting her parts. Especially on Discord.** I'm not a big texter and prefer to have phone or video calls.

Bizzy would go through all of her messages, and if Bizzy found something he didn't like, he would lose his shit and do what he does. Manipulating her and being an asshole.

A lot of what's left of our text message is just her asking me to play The Finals and Minecraft.

Bizzy gatekept her for months while flirting with other girls. He never talked about her to anybody one bit.

Zoey and I tried really hard to get her away from him but she's "sped/slow". I hate being angry. I'm very bubbly, but she really pissed me off. I can't help her and it makes me so mad.

When her PC blew up, I told her to take that opportunity to walk away and block everybody, but she didn't.

There was never a point, when I was a part of Bizzy's community, that there wasn't tension between the two. **Bizzy would drag us into different calls when she joined. He made channels that she couldn't join to keep them away. He did everything in his power to gatekeep her and keep her away and keep her quiet.** She would always be too scared to talk or even make a sound. Anything they said, Bizzy would be like "Nobody's even talking to you" or just ignore her. **Sometimes it was like watching her talk to a brick wall.**

She definitely confided in Zoey the most. I had more boundaries. I tried helping her and gave them solutions but she'd keep going back to him.

I asked her why she didn't stream with face cam. **She told me that Bizzy didn't want her to. He's a fat chud and didn't want people seeing her, because if someone saw how beautiful she was, they'd take her from him.**

I was hoping that someone would come along and offer her something better and that she'd take it, but honestly I don't know if she would have.

She mostly would come to me to vent and ask for advice. **I would straight up tell her “That’s manipulation” and other clear signs of abuse.** Bizzy has her wrapped around his finger and it’s so deep you can’t even see the end.

She doesn’t even realize what’s going on. She’s just gonna keep going back to him. It’s like she’s in a trance that she can’t get out of.

If Bizzy wasn’t around, she was a different person. She was bubbly, a good bit talkative, it would be okay. She’d be yapping and asking questions about games. **If Bizzy was around, she wouldn’t talk, like she was too scared to talk.** She’d sit there, quietly in the VC. Then she’d be crying at the end of the night when everyone left. **It was like talking to two different people.** If you tried to talk to her, she MIGHT answer you.

I asked her at one point:

“Do you love yourself?”

“Well, I don’t really know”

“Then how could you love anybody else the right way?”

I felt like she was basically saying that she DIDN'T love herself.

They’ve been together for 6 years now. At any point in our friendship or that I’ve known her, that woman NEVER seemed OKAY. She seemed either exhausted or mentally drained from dealing with Bizzy. She looked like a zombie at some points.

Her parents never approved of Bizzy, because she is part of a [ethnic group] tribe. They wanted her to be with someone of the same ethnicity.

At no point did Bizzy ever go visit her. He even called her a bum at one point while he was the one just sitting at home playing games all day. **She said she even stopped going to school for Bizzy, because he couldn’t handle the long distance.** I told her that at that point her life became stagnant, because she stopped chasing her dreams. She stopped everything she was doing for Bizzy. I told her, “Someone who says they love you wouldn’t stop you from chasing your dreams. They’d help you reach those goals.”

To say that some of the stuff that she confided in us with, to say that it’s false, is like, you can’t make stuff like that up. **There’s no way you can make stuff like that up; it was very much real, and she knows it.**

Part of the reason I told her to stop telling me stuff was because I felt like she got off on my sympathy. It seemed like our conversations didn’t benefit her at all. She would just take what I said and it would go in one ear and out the other. I didn’t want to hear it anymore. **She will always end up defending him.**

After Jeshi’s doc dropped, Bizzy, “H”, Bubbz, and others were all in a call trying to piece together how Jeshi knew. Bubbz pieced together that Jeshi must’ve known from Zoey, and Zoey must’ve known from “H”. She asked “H” directly if this was the

case. **“H” didn’t say anything and lied for 3 whole days before she admitted that it was true.**

The day after part 1 dropped, I was on the phone with Bizzy. He said “I don’t know why Zoey’s doing what she’s doing.” I told him, “You know why. She already explained this to you.” I reminded him that he was never kind to Zoey. He always treated her differently than everybody else, like she was the oddball out. It seemed like Bizzy did not like Zoey and she expressed that. Everybody could see it. He was never a good person to her. He just doesn’t see the harm in his ways.

He asked me why I haven’t been around much anymore and I told him because it’s always drama with him and I didn’t wanna be around it anymore. I just wanted to play the video game.

He was crying and said he hasn’t been able to keep food down. I told him, “Stop crying. I don’t wanna hear that shit. And stop putting your personal shit out there. This is all your fault.” **He admitted how toxic their relationship was and said that if part 2 comes out he’s going to self harm.** I didn’t want that on my conscience so I reached out to “H” and Bubbz. **Bubbz confirmed to me that Bizzy has gone to her making these threats of self harm as well.**

Then I was on the phone with “H” and I told her, “You know what’s coming.” Then I asked her “I know that Zoey is the person you confided in the most. **How bad is the info that she has, on a scale of 1-10?**” She said, **“Anywhere from 7-9, depending on the info.”** I said **“Oh, that’s an issue. If it’s 7-9, and YOU’RE telling me that, then you’re cooked.”** And then I told her she needed to call Bizzy’s dad or else I will. She agreed, but when I asked her to send me proof that she actually contacted his dad, she only sent me screenshots of Bizzy getting mad at her. I didn’t trust her, **so I took it upon myself to contact his dad.**

I spoke to Bizzy’s dad and he told me he had a feeling that something was going on with Bizzy, since he’d been making threats of self harm, which isn’t the first time this has happened. He took precautions by hiding all the guns in their house. I told his dad that I’m done with Bizzy after this and I can’t be around him anymore. He thanked me for calling and letting him know.

I reached out to Sloth. Sloth told me when he talked to Bizzy he seemed fine. But when I spoke to “H” and Bizzy, it seemed like it was the end of the world. **It’s like he’s a completely different person depending on who he’s talking to, which I consider highly manipulative.**


I told “H”, “Multiple people have told you to keep your relationship to yourself and not live online, but here we are.”

To Bizzy: Grow up. I don’t know how anyone can find joy in being the person that you are, waking up everyday and choosing to be angry.


To “H”: You could do better. I’m not saying you’re better than Bizzy, but by no means are you as bad as him. You should get offline and go live your life. **Bizzy is not good**

for you and you are not good for Bizzy. I would go hang out with people who I know love me, and not with something that's online and made up. Half the people you meet online are just personalities and put on personas. Life is passing you by. Wake up.



Leading up to the release of part 2, Bizzy has been claiming that he would self harm if this was published. Our mutual friend who provided this testimony has personally spoken to Bizzy's father, who confirmed that Bizzy has a history of making these threats during times of accountability. His father assured that his family has already taken the precaution of hiding all the firearms in their home. This behavior is a recognized pattern within his family and all the real world measures are being taken by them currently. We're proceeding with this report because these threats do not grant someone the right to maintain their platform or continue a pattern of abuse in the community.

Left SS is the conversation between "H" and the mutual friend, when he asked her for proof that she contacted Bizzy's dad, after Bizzy made threats of self harm.

Right SS is the conversation between “H” and Bizzy when “H” confronted him about his threats to self harm.



Alongside Bizzy's threats of self harm, he has also made legal threats targeted directly solely at Jeshi, who authored part 1. Despite my direct involvement in all of this, this selectiveness is an ongoing attempt to isolate Jeshi and suppress the investigation (mirroring the coordinated mass bans from before). We view this behavior as a SLAPP tactic (Strategic Lawsuit Against Public Participation), as well as part of the same pattern of coercion that is a hallmark trait of his at this point. It is also considered a bad faith attempt to use the legal system to gag a whistleblower.

Throughout this journey, “H’s” behavior in defending Bizzy has never been a surprise to any of us involved. A victim’s word is not the end all be all, especially when that person has been stuck in a limbo of control for years. We empathize with the complexity of “H’s” situation while still prioritizing the safety of this community. Just because a victim isn’t ready to speak up doesn’t mean the abuse didn’t happen, and it doesn’t mean that Bizzy hasn’t been an absolute nuisance to others. Our reports and documents have never been a “SAVE H” mission. “H” is a grown adult woman making their own choices.

FINAL

Now you have the full context that was hidden behind all the gatekeeping, intimidation, and harassment. It’s up to everyone else now to decide if this is the standard of conduct you want to represent your scene.

The patterns and behavior documented here are not unique to this situation. If you recognize these signs in your own circle: friends who become “zombies” when their partner is present, loved ones who are forced to drop out of school or work, or people who are isolated from their support networks, PLEASE reach out. It requires a community that refuses to look the other way.



UPDATE: March 7th, 2026

Despite my efforts to redact every piece of personal identifying information for the main witness and victim, "H", them and others have responded with escalation.

Jeshi and I have documented that my private phone numbers were leaked to Bizzy's family. I will be redacting the sister's name and their phone number for their privacy.

At 6:30am on March 7th, 2026 (Japan)/March 6th, 2026 (North America), I woke up to a phone call and I thought nothing of it. I thought it was a scam call until I received a second call and I checked my notifications and saw a bunch of missed calls from them and saw that Jeshi sent me an image and asked "**u think its his sister?**"





Jeshi confirmed that it was his sister since she had received messages from Bizzy's sister on Discord, as well as calls from another user, who we assumed is another one of Bizzy's family members. They were demanding Jeshi and I to join a call, but Jeshi wanted some more information as to what they wanted to discuss.




The allegations of him being an "abuser" and a lot of false information being spread around
It would be easier to talk then text about it because there's a lot to be said.

Please note that Jeshi's timezone is EST and my timezone is JST. **I received the first call at 6:37am JST, and was then subsequently bombarded by several more calls.** The screenshot also shows that they attempted to call before, on Wednesday. These calls were all happening at the same time Jeshi was responding to messages from Bizzy's sister from 2:14pm EST to 5:44pm EST. Jeshi checked the area code of the phone number that was calling me and further confirmed that it was from Bizzy's end since it was coming from his hometown.




I immediately blocked the number. I suspected that "H" was the one leaking my private American phone number to Bizzy's family, since they are the only one who has that number as well as direct contact with his family. I consider this a massive violation to my safety and boundaries. Jeshi sent them a warning message, as well as gave them an

opportunity to debunk any of the allegations over text. But we did not agree to join any voice calls with them because of the harassment I just received.




Following Jeshi's message at 5:24pm EST/7:24am JST, I received another call from the same number, but to my private Japanese phone line, at 5:33pm EST/7:33am JST.



Since the boundary that we placed had been violated, Bizzy's sister became extremely hostile and aggressive. She also did not provide the list of evidence or corrections that Jeshi requested.

This reaction shows that they refused to coordinate in a civil manner and escalated with more harassment by "H" doxxing my other number to them. Jeshi decided to cut contact with Bizzy's sister and block her.



It's pretty clear to us that Bizzy, "H", and his family have no intention of engaging with the evidence in front of their eyes. They don't actually care about the "truth" or "privacy" or holding their son accountable. They would rather continue suppressing this document through intimidation tactics.

They have also reported the original Google doc to be taken down, which it was, as of March 7, 2026. I will be posting this as a PDF so it will be available again to read.
