but in the aggregate in respect of products liability.

This policy is subject to the War, Hi-Jacking and Other Perils Exclusion Clause AVN.48B with all paragraphs except (b) deleted subject to Extended Coverage Endorsement (Aviation Liabilities) AVN52E as contained in the policy for a sub-limit of USD350,000,000 any one occurrence and in the aggregate except in respect of

passengers to whom the full policy limit shall apply.
