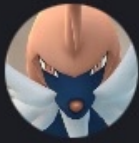

1. Debunking her claims.

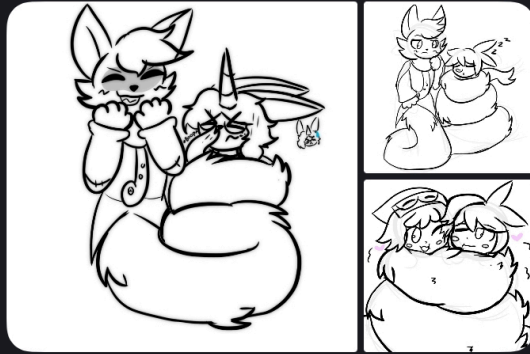
Snicks is not a very good liar, and since she's going into this completely blind, she quite literally doesn't even have an idea of what was actually sent to EPPC's mod team that got her permanently banned. So, in response, she speculated the hell out of this!

The claim was I drew fetish/kink art of several minor characters in Puyo Puyo those being Sig, Maguro, Ringo, and Ecolo - said via a screenshot I have no access too but backtracking I can pinpoint where exactly I shared said art around late October in a private group chat that consisted of 9 members (as of 11/18, 6/9 left- though 11/14 just 2 days before the accusations). As well, I did share said art so some others in DMs (those some people are from the same GC). I did however posted an edited/crop version of the not fetish art in a Public Discord Server around October, I did not think much of it and many took it the wrong way. As well, I was claimed to be roping people into a fetish.

1. She did, in fact draw fetish art of minor characters! Below will be the images in question compiled into a pretty collage! These were labelled as "Requests."
I personally don't believe anyone had gone out of their way to request something Snicks has kept a "secret" unless they were..
 - A. Aware of her coil fetish and enabling her
 - B. Literally just her doing this unprompted.

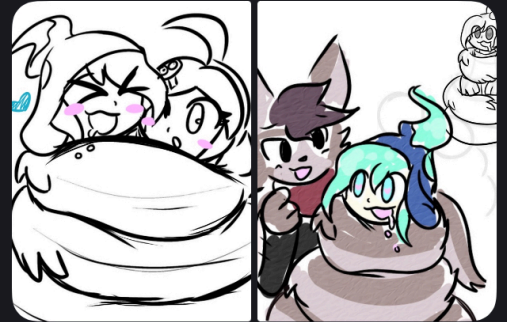

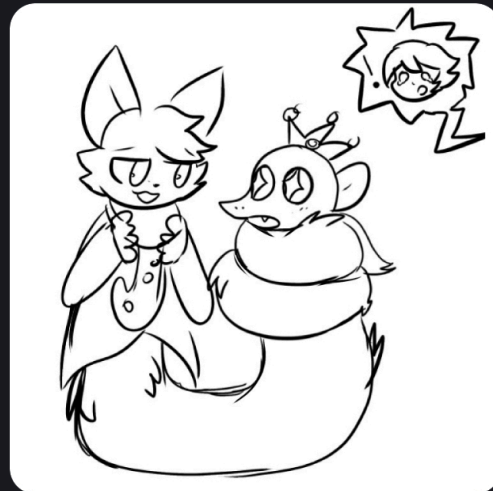

These were the supposed art leaked. Art consisted of some puyo characters and my OC Jataro.



Let get the facts straight:

- I drew such artwork. (True, it exists)
- However, said artwork was **not kink** at all. (Falsley claimed)
- OC drawn with them, **is also a minor** (15 years old) (Claimed it was an adult)
- I do have such little kink but, it was **not my 100% intention to implement** that in my work and the overall art work was not sexual in nature. I gained **ZERO SEXUAL PLEASURE** out of it.
- Last truly nsfw/kink art I drew was in 2023, with an adult OC that was explicitly kink. Have **not** drawn intentional kink art since.

1. Saying Jataro's age is a little irrelevant to me personally. But considering that he would be your "Secret Coil Kink OC". Him suddenly being 15 is.. Weird! Considering you drew Roquier, (grown man!) being coiled by him. But, her saying it isn't kink art at all is a bold-faced lie, because why would you share this to your Personal Server's KINK CHANNEL if it weren't kink-related? And why would you crop the Ecolo art in EPPC? Hmm?
 2. You intended to implement that into your artwork because you yourself have bragged about how "People are preferring Jataro!" because of his tail, and "You know what they are." ... Weird if JATARO is 15.
 3. Your usage of "leaks" Is interesting, when the Ringo/Maguro artwork was literally posted to your Twitter, publicly, with over 30 likes.
 4. You literally drew kink art of Roquier on the 7th of November.

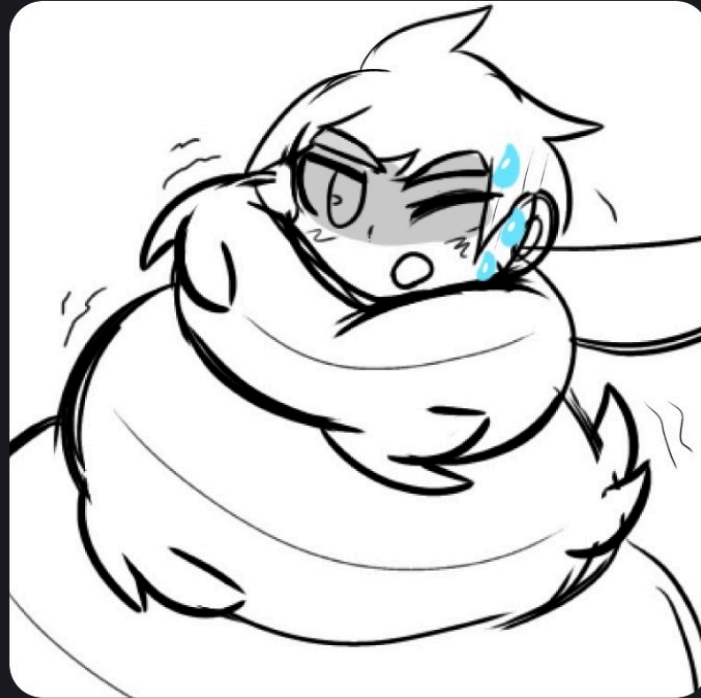

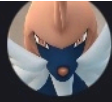

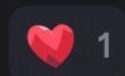

(that weren't actually requested by anyone.)

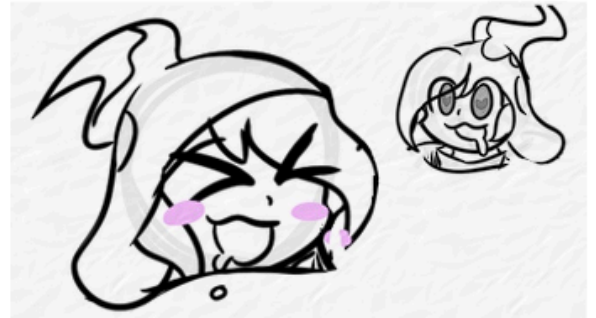

- Those aware of my mature interests know I would not draw minors in such an explicit manner, those in GC are aware and did not judge me at all - **I did not rope them in, in fact I was encouraged or consented too. Said art was requested.**
 - If I did make anyone uncomfy, they should have called me out on the spot rather than sending an out of context screenshot - the people who reported me claimed to be 'uncomfortable' 'afraid to confront me' despite me being a very open minded person. Say something.
 - I famously **decline kink art of minors or any NSFW art in that nature no matter what.** Recently someone tried to commission explicit minor nsfw art but I declined it.

1. If people in the GC were “aware” or even REQUESTED this artwork, why did they leave the group chat immediately after ACTUAL evidence of your fetish art was sent?
By the by, there were 2 minors in this groupchat... Why would they be “aware” of a KINK of yours and OK with it if they’re minors?

Addressing the WRONG Response

When I first was accused it was before the 'screenshot as proof.' I was very scared of being confronted when I posted one art awhile ago, I am assuming the report was in queue for awhile. I posted the crop version of the Unusual Ecolo art encouraged by the user who requested such art - someone who has zero fetish intentions. The person simply liked my OC, and wanted art of what I exactly said.

When I was asked, they wanted the art. I went back to GC and asked what to do, then knowing the full art. I was suggested to alter it to avoid any more drama, since they and even myself were afraid if they saw the true, not-fetish drawing they would say something. Looking back, was a mistake and I did not do a good job covering up.

I even said I would not draw

anything in that nature, that if so it was one off (even after, those art were not NSFW in nature). Being dishonest was a sin against God, and I should have been honest.

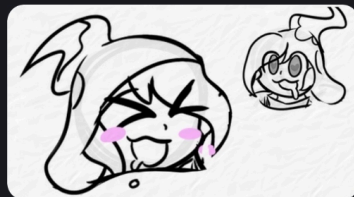
So yes, I lied. Because I was afraid of being judged of being misunderstood - I panicked because it was such a strong confrontation. I was crying and loosing breath, my sanity. The confrontation made me scared and I texted in such a frantic way, it reminded me of the police. I was simply not okay and not in a good mental space as the situation escalated.

Either way it was still wrong posting such personal (gift) art without full context to such a public server even if it was not kink in nature. I should have thought better.

NOBODY in the GC suggested she lie and alter the art; she altered the art on purpose, sent it to the GC to "double-check," and sent it, thinking she had a case.

This gift was literally not even wanted by the recipient, as he's disclosed to me that seeing that the request to draw Uecolo had resulted in kink art that he literally didn't even want or appreciate, upsetting him.

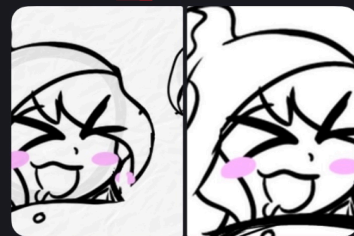

'snicks Has A Fetish' - Is This True?

Very layered question.

If you want the short answer: **yes**.

For the long answer. For me, it is a kind that is very lowbrow, almost SFW in a sense, but the key is I would **NEVER EXPLICITLY** draw minors in such an explicit scenario. There is a key difference in my own personal kink art and innocent doodles that happen to appear kinky even if it's not.

Stated earlier, my last time I drew super explicit kink art was 2023 with my adult OC.

Do I still follow such accounts that do kink art online? Yes. Do I repost that? No. For me, I don't partake in drawing such things anymore, unless it's a super rare commission kind though I have not accepted that work in a long time. When I was in the Monster Prom fandom, that is where I took those kinds of commissions from but when I left in late 2023/early 2024 I stopped doing the work.

Though, even though I don't draw such works I still have a very small friend circle on my server that talks about kink. Even then, these are very borderline and 'tasteful.' The close friends who accept me or have their own kinks have access to it.

Back to the whole topic: the artwork I sent was not kink at all. But ***I do have it***. So should this be contradicting my whole claim that it was not fetish art? It sounds like so, but to me I see it as this: there are people who happen to like a certain design or scenario in such a way, but not all the time it is sexually triggering then. To me, that is my thing: it can be both that or intentional. In this case with the art, it was not intentional at all

More word salad, literally look at everything above: WHICH HAPPILY INCLUDES: NOVEMBER 7TH 2025 ROQUIER ADULT MAN PUYO PUYO CHARACTER KINK ART WITH 15 YEAR OLD MINOR PUYO PUYO OC JATARO!!!

Going back to 'roping my friends into it.' ... I kinda see it now. I did not mean it at all, even then these were people who seemed to give me the okay. Plus I did not always see it as 'fetish play,' but I understand if one felt that way. It was wrong regardless, I should have 'controlled' myself. Plus some art was ideas given to those friends, and mine too. As well those I trusted also had some sort of kink, so I am curious if anyone felt uncomfortable.

Remember this for later, everyone.

Other's Opinions

I did share all the art I was accused of by people who were not involved or seen my art before, just for extra validation or at least if my claims could be true - I told them everything going on.

This is literally irrelevant to the argument, as they're already your friends and the judgment comes VIA public, not people you know.

CLAIM 2: Supporting Pedophilla

Just like before, I **DO NOT** see this claim as true. Though, this is more so an aftermath of the fetish claim. I am not told an exact screenshot / evidence of me vocally supporting MAPs but given people think if I drew 'kink' art of minors, I must find them attractive.

This session is much shorter due to my obvious moral stance with my first claim but to make clear: **I do not find minors attractive.** I have never. If I found a character attractive, I would know their age. If it was a minor, I would not be 'freaky' about it.

I do not proship, pay/do commissions of said work or groom anyone.

If I did partake such kink, it would have to be with a consenting adult that we both agreed too - I never pushed it.

Saying such a thing is against everything I stand for. Plus, I myself am a huge victim of it and more worse things. Not online, rather in-person via my own father.

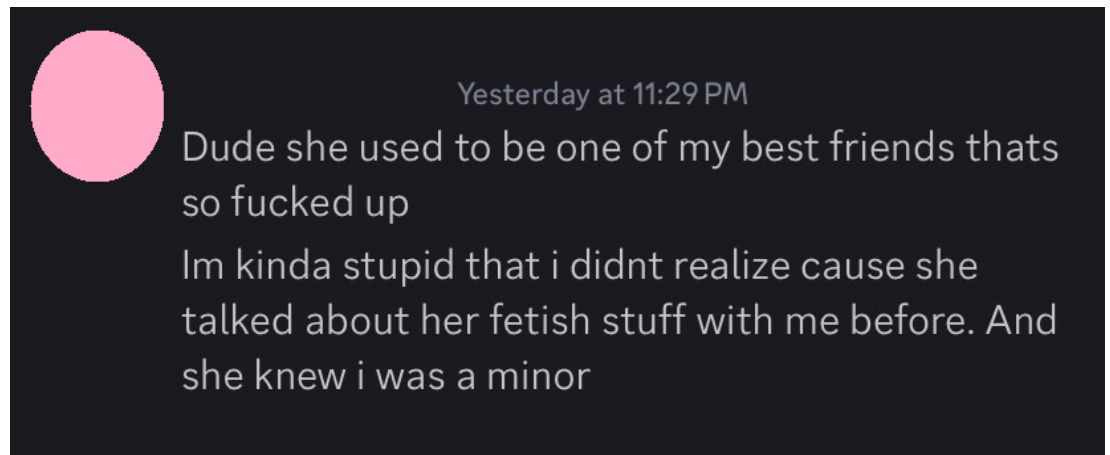

So, without further ado.

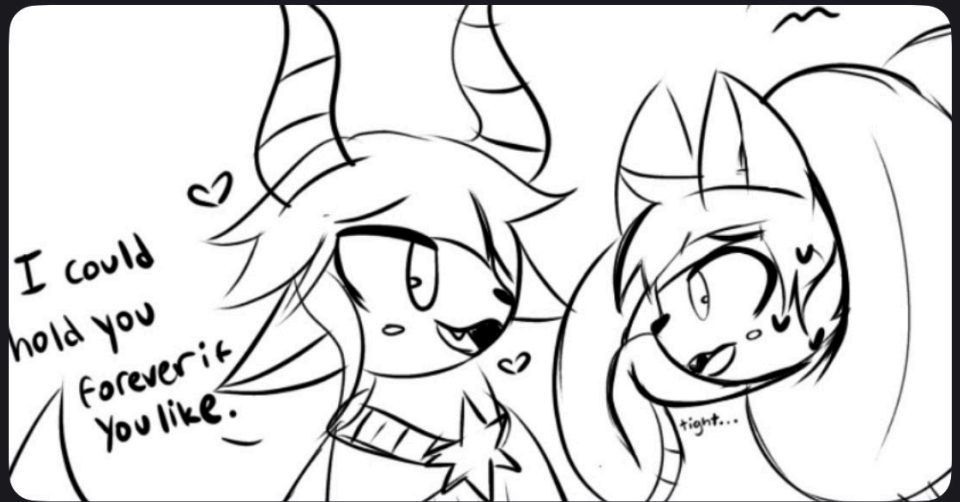

4. My PERSONAL Experience with Snicks.

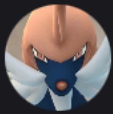
I personally met/befriended Snicks in EPPC around February this year.

Why? I'll let her say it herself.



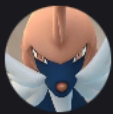

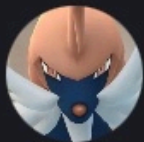

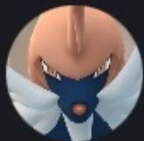

The plot was, Nerizumi snuck into a cave and got interrogated by two Nagas. It was supposed to be a silly thing, and I didn't WANT it to be kink and did not CONSENT to

the kinks involved.

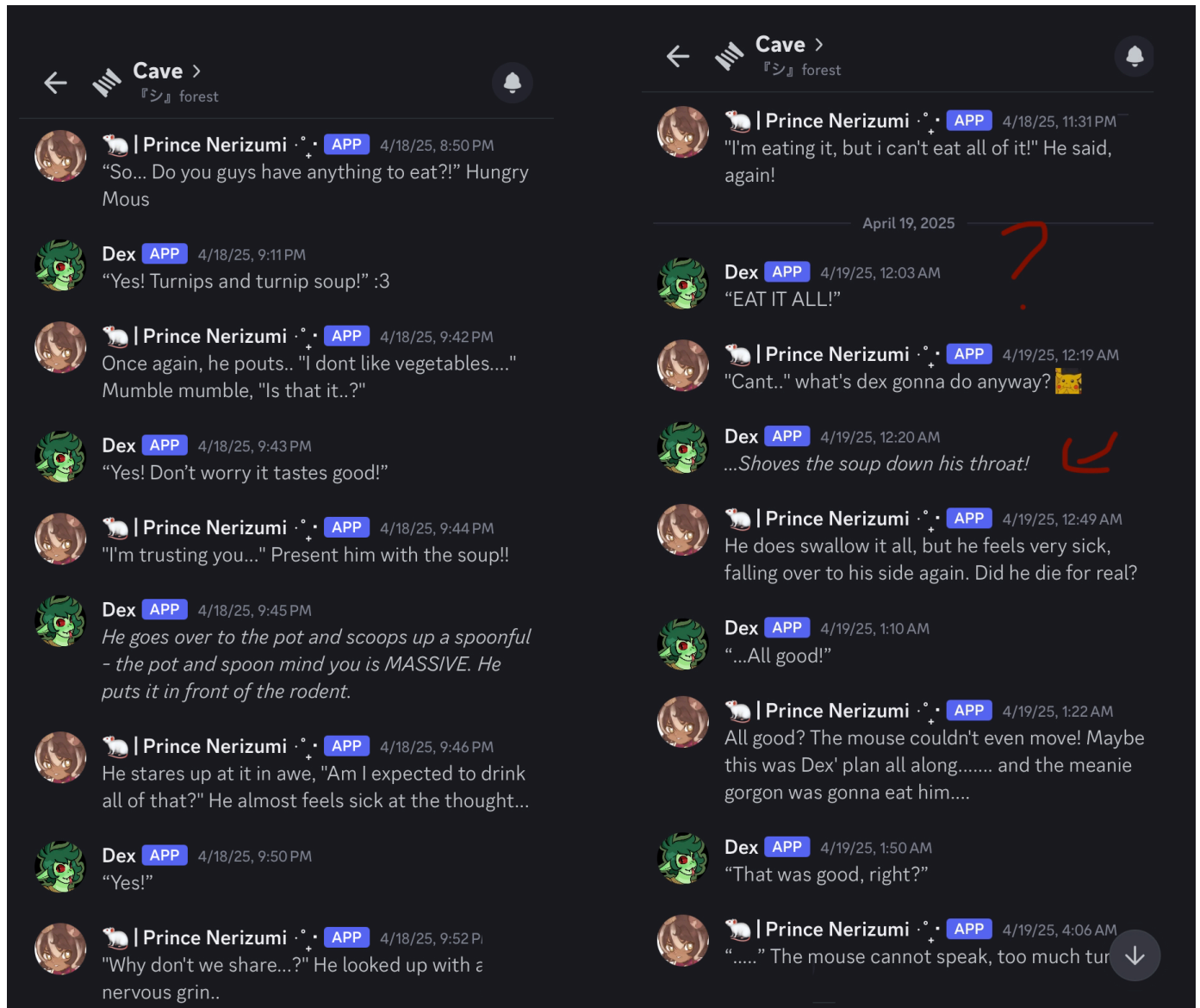

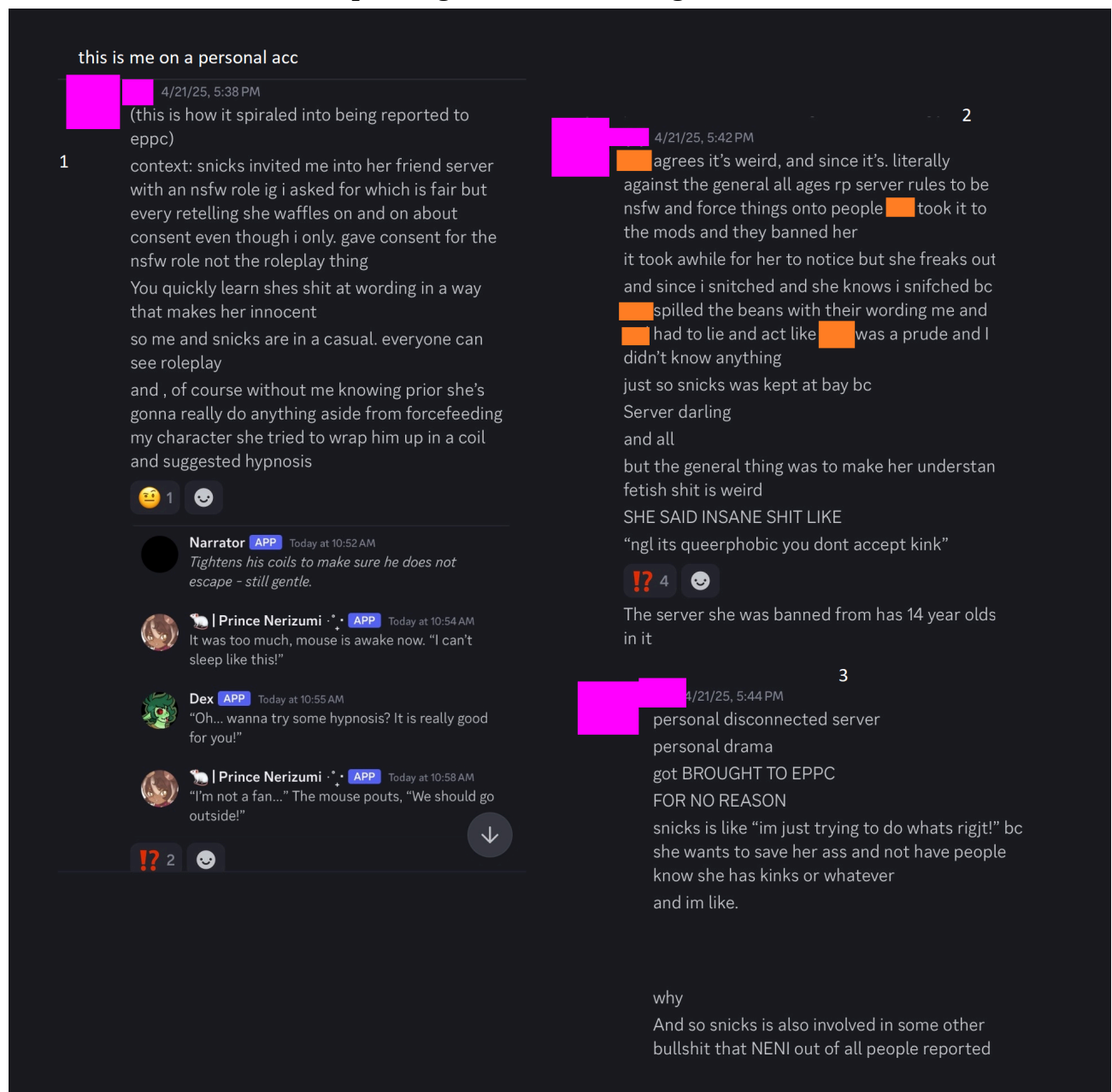
I was still 18 at the time of this roleplay, and I was just getting “closer” to Snicks personally, so I didn’t want to upset her by saying “hey, this is kinda weird.” In front of her face, considering by this point I understood that the people around her would SHIELD her with their lives.

Which, She had built up such a surrounding on purpose.

So... I went to a close friend about it considering they were also skeptical of Snicks.

I disclosed that I was in a weird fetishy RP with Snicks, said friend owned the RP server. They said in all seriousness that it was weird and fetish-mining, and since I didn’t consent to this, nor did I have any idea prior/it was never discussed... They said this is ban-worthy. As much as I wanted to protect Snicks’ image as in “no no you dont have to do that.” Said close friend insisted it was weird.

What followed suit is basically what I vented about in a personal server on an alternative account, which does more explaining than I'm bothering to do.



Neni name drop part 2, which I explained I'm not bothering to censor due to her actions and inactivity DESPITE having the evidence. Opting to remove the vent role from Snicks instead of banning her. I believe she left the server on her own.

Throughout this, Snicks was forcing me to consent, even telling me to tell people I "consented" to this roleplay and "aware of what she is"

Immediately after the situation, Snicks was somehow admitted to a mental hospital.

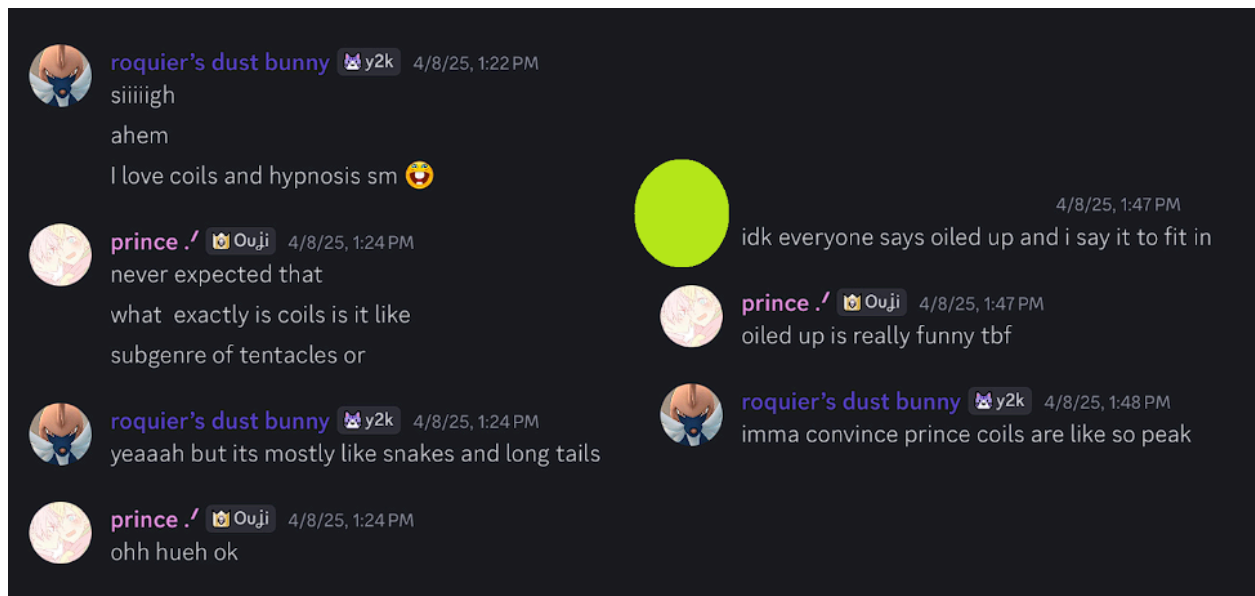

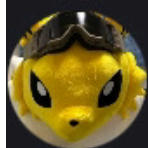

5. Conclusion.

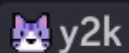
I will immediately be cutting off all contact with Snicks after I post this counter-claim and removing her from anything even remotely associated with me.

If you're less concerned about the person who took PRIDE in "knowing people would defend them and disregard this situation."

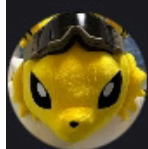

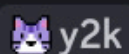

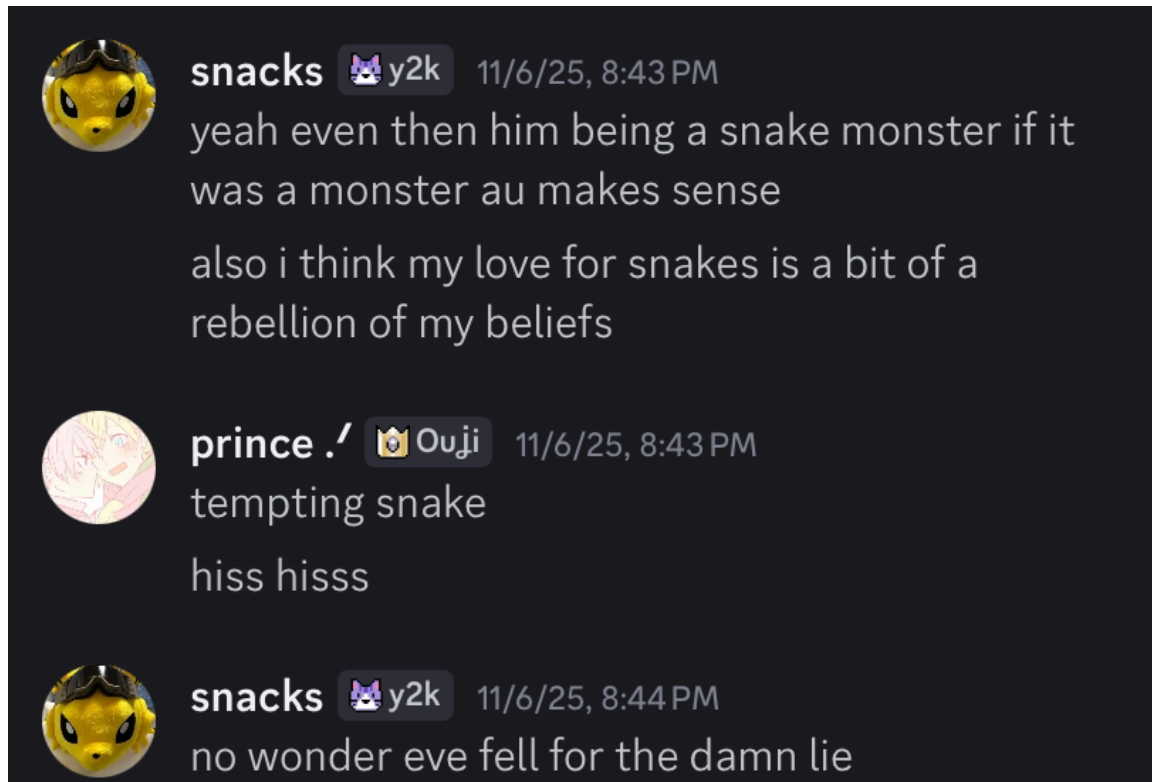
